MINERS STRIKE

"Showdown time is here!" That's

what thousands of southern West Virginia coal miners are saying as a district-wide strike against Federal Judges sitting in Charleston, West Virginia, begins its third week. The first week of the strike centered around several different but interrelated issues; including the firing of a local union president in Logan County West Virginia: the slowness of the grievance procedure; extreme dissatisfaction with United Mineworkers' President Arnold Miller and most importantly, the coal operator's constant visits to the Federal Courts to get TRO's (Temporary Restraining Orders), injunctions, and contempt fines against UMWA local unions who go out on strike.

Events came to a head on August 15 when Sim Howze, a Negro national minority local union president from Logan County, was sentenced to 90 days in jail for contempt of court. Howze told a Federal Judge that neither he nor his men would cross a picket line even though his local had been on strike for a week and a TRO had been issued against them. Because Howze took a public position in court protecting the rights of the working class, he was held in "per-

sonal contempt" of the court! The miners of southern West Virginia strike more often than any other organized section of the USNA proletariat. The Federal District Court of southern West Virginia has issued almost 200 TRO's so far this year and there have been between 300 and 350 wildcat strikes. The coal companies cause and provoke these strikes by their frequent and flagrant violations of the UMWA contract. The miners file their grievances as required by the contract, but here again, the coal companies obstruct and delay (they "stonewall") the grievance procedure. leaving the miners no choice but to "come off the mountain together." And in the mines of West Virginia, one leaves the hill alone! When the miners walk out, the companies run off to court and get a Temporary Restraining Order, and often an injunction against striking for the life of the contract. When the men refuse to return to work, contempt orders and fines are imposed which are bankrupting many local unions. These fines are especially galling because the law requires that they be paid to the companies - which means the miners re-pay their hard earned wages back to the coal operators! In this way, the coal operators use the courts to conduct their labor relations and to force the miners to work under court order, fines, and now jail sentence! There is no clearer case of the way in which the state apparatus serves the interests of the ruling class. The Judges are only too happy to give the coal operators what they request, for they consider the miners to be "naughty children" and often publicly "scold" them in court. A revolution is the process of dismantling the existing political superstructure and the ensuing struggle of each of the classes to erect a superstructure which corresponds to its individual interests. Therefore the revolutionary process is one of constantly making and shifting alliances. It is this aspect of the Portuguese revolution which confuses many people who have not had the opportunity to witness such a social process. Because the present political motion in Portugal is so poorly understood, and in order for our readers to more effectively support that revolution we present the following background to the current rapid political developments.

Portugal is the poorest country in Western Europe, with an average income of just under \$1000 per year as well as the highest illiteracy rate in Europe. Nor could fascism have existed in Portugal for 50 years without having won-over ideologically a considerable section of the population. The reactionary Catholic church was the main instrument in this cultural struggle. While 50 years of repression and a fascist ideological diet have left

the principal state institution. The necessity of garrisoning their colonial world and later fighting the decade long imperialist war in Africa slowly transformed the Portuguese army from a professional army into a people's army and planted the seeds of revolution. Almost immediately John Doe injunctions against picketing came out from the courts. These were then reprinted in full page ads in newspapers all over the Range. The plant itself was kept running with a combination of supervisors and scabs who were flown in by helicopter! After nine days the strike ended under the threat of heavy fines. The original grievance was resolved and the courts ordered that no strikers should be discharged unless convicted of destroying property. U.S. Steel responded by suspending over 90 workers and declaring that in their opinion the courts could never tell U.S. Steel who it could or could not fire. This strike has pointed out

lish an anti-communist democracy (e.g. the overthrow of Trujillo in the Dominican Republic and of Diem in south Vietnam).

Spinola's main political base was the Popular Democratic Party. Flanked by the old line fascists, Dr. Azeredo Perdigao, Col. Megeul as Defense Minister, and Gen. Silverio Marques as Governor of Angola, Spinola accepted state power from the butcher Marcello Caetano. The Revolution of Carnations was underway.

The big monopoly capitalists moved to bend the revolution to their interests. As the popular "Dynamizing Movement" of the revolution fanned out into the countryside to teach the people of their new rights, the Portuguese "paleo-capitalists" formed their "dynamizing movement of business and society." Their aim was to coopt the public treasury extensively to finance redevelopment in order to be competitive with other European cap-

An example of the concentration. of wealth in Portugal is seen in the 168 enterprises of the Jorge de Melo combine (Companhia Uniao Fabril), whose assets total \$21/2 billion. These enterprises include a tobacco monopoly, chemicals, shipbuilding, fertilizers, soap, textiles, mining, cellulose, refining, insurance, real estate, tourism and restaurants. Through his Banco Totta Alianca this vast network includes interest in all large southern African firms, especially the Union Miniere Du Haut Katanga (the largest mining firm in the world). Many joint ventures with the multinationals, and especially his Standard and Chartered, 15% owned by Chase Manhattan Bank, connect him with world imperialism.

The second largest monopoly capitalist is Dr. Miguel Quina, who holds a group of 60 companies concentrating in southern Africa. He holds a 10 year monopoly on Rubber in Angola, is a big holder in General Tire and Rubber Co., has interests in the City Bank of New York, and is a major stock-holder in J. Walter Thompson Advertising and Marketing.

These "revolutionaries" grouped around Spinola were willing to lose Guinea and the Cape Verde islands, but would fight to the death to hold Angola with its booming economy in oil, iron, ore, diamonds, coffee, fishing, cattle and cash crops.

MFA

The revolutionary core of the MFA opposed Spinola and his neocolonial plans. Ousting Spinola, the MFA declared: "We have no desire to construct a neocolonial community. We are interested more in the formation of a socialist interdependence, and that only to the extent that our brothers in Guinea, Mozambique and Angola accept, desire and demand." The clumsy attempt by Spinola's group to restore the political power of the monopolies was easily crushed. Spinola fled. The MFA moved closer to the people and especially to the proletariat. The new ruling group consisted of President Francisco Da Costa Gomes, a former leftist but now middle element; Prime Minister Gen. Vasco Goncalves, formerly a moderate who has developed steadily leftward, and General Otelo de Carvalho, formerly head of the military committee of the MFA. Presently military Security Chief of the present government, Carvalho at one time was a leftist but is being wooed more and more into the support of "democratic" soc-

With all the hullabaloo in the capitalist press about the growth of the counter-revolution and the danger of civil war, we must assess the objective position of the revolution. At least in words, all the major groupings are committed to some sort of a socialism. However, we Marxist-Leninists that a phase of the revolution inevit-

prevent a mass movement and estab- understand that the political form of socialism is the dictatorship of the proletariat. This can be accomplished only if the proletariat is the vanguard of society. There is no such thing, anywhere in the world, as "democratic socialism", unless one is to point to the cronies of the 2d International -Indira Ghandi's India, Golda Meir's Israel, or Willy Brandt's Germany. Such caricatures of socialism can be found in the history of the British Labour Party and social-democrats throughout the world. However, with the rise of Khrushchev revisionism, the concept of monolitic communist unity came to an end, and with it the former definitions, such as Marxist-Leninists, which used to identify the ideological and political unity of groupings and parties. Today in the absence of such monolithic unity, and every Marxist-Leninist bears the responsibility of following the class motion and deciding what is right and wrong in relation to the goal of the working class - to raise the position of the proletariat to the position of the ruling class.

> Is it possible to attack the Portuguese Communist Party as revisionist without concretely examining each tactic? It is not possible. Yet agent provocateurs operating under the mantel of "ML" have joined the fascist mobs in the burning of Communist Party Headquarters and assaulting individual communists. Behind this Trotskyite-like maneuvering is the formulation that it is the Portuguese Communist Party and not the fascists that are the main danger to the revolution. But with us, no phrasemonger can cover counter-revolutionary activity with ideological formulations. We have paid dearly and have learned our lessons well.

> The idea of a "revisionist" revolution doesn't deserve comment. Revisionism is a subjective, unscientific anti-Marxist trend within Marxism. It is the polarity - the internal opposition to Marxism. But revolutions are not ideologies. Revolutions are class struggle. Anyone who attempts to fit a revolution into an ideological pattern is bound to be tossed aside. We must develop the ability to describe the form of things both in its unity with and in its opposition to its content. That the army seized power in Portugal in no way describes the content of that struggle. The antifascist content is clear to all. But it is also clear that the next step of the revolution is the splitting of the revolutionary forces. We support the tactic of "revolution in permanence" which demands the rallying of the broadest social forces against an isolated enemy; and also demands that the revolution turns against inherently reactionary forces who assisted in the overthrow of the former state. Above all, the party of the proletariat must remain independent of revolutionary forces. The unfolding of the revolution in Portugal has confirmed this tactic. The alliance between the people and the MFA is the cornerstone of the revolution at the moment. It is the only possible condition for the development of the influence and the steeling of the PCP.

ably requires the Army to fight itself. The fact that a section of the Army is in the process of deserting the revolution is no cause for alarm. but rather indicates the deepening of that revolution.

CIVIL WAR DANGER

The reported immediate danger of civil war in Portugal seems to be based on rather superficial assessments. The process of polarization is proceeding very rapidly and must eventually lead to such a civil war. Never in history has a deposed class failed to fight for its restoration. But before such a war can be launched, it is necessary to group together the counter-revolutionary forces. Of course this is being done, but more slowly than the capitalist press would have you believe. For example, the situation in the North of the country actually is one of the trade unions, MFA dynamizing teams and the PCP penetrating into the stronghold of Feudal-Clerical reaction. The gains made by the revolution are not reported - only the fascist terror unleashed by the landlords and the church. In fact, the situation in the North is characterized by the struggle against the organization of the agricultural workers much more than an attack on communism

Nonetheless, we should be clear that the counter-revolution is powerful and international. The rag-tag gang clammoring for the blood of the revolutionaries consists of the reactionary hierarchy of the Catholic church, the landlords who maintain an almost feudal regime in the North and the big monopolies, as well as nearly 300,000 Portuguese settler refugees from the African colonies. Imported thugs from Brazil's death squad and elements of the Spanish Falange lie at the core of this grouping. Assisting and shielding them are the socialdemocrats of Portugal, the Mitterand group of France, Willy Brandt and his gang from Germany and the Right wing of the Labour Party of Britain. Flanking these misleaders are the traitorous and revisionist right-wing communist parties of Spain and Italy, assisted by a big portion of the CP of France. Working through and utilizing these groups and parties are the British Military Intelligence and CIA. The refusal of certain socialist states and communist parties to recognize and support the revolution has hurt both the revolution and these states.

While the line up against the revolution is formidable, it is weak and isolated compared to the hundreds of millions of toilers who support it. Civil war in Portugal would have a galvanizing effects on the workers of Europe. Thousands of honest radicals and progressives have already gone to Portugal to help. with great clarity the growing viciousness of the attacks on all workers. It also pointed out how important it is for us to "clean house" of I.W. Abel and his supporters!

But probably the most enduring struggle in Minnesota and throughout the Upper Midwest has been the battle by the Indian peoples over hundreds of years for control of their lands. Testimony to the increasingly violent and revolutionary character of this struggle are the 43 murders this year on the Pine Ridge, South Dakota Reservation alone. Clearly the USNA state has no intention of letting any of these valuable grazing lands or mineral deposits slip from its grasp. In Minneapolis, the massive unemployment of the Indian workers (80%) has objectively linked the struggle for control of reservation lands with general cry of the working class for jobs with peace.

Over the last year, both Indian and Negro workers have been beaten and terrorized in increasing numbers. We should realize that in spite of Minneapolis' liberal image, there is a vicious undercurrent of white chauvinism, particularly in the Minneapolis police force. This was clearly demonstrated when Officer Raymond Presley, a Negro, was suspended for exposing the unjustified beating of a Negro by two Anglo-American officers in the Cassius Bar and the fact that the police department forged records to show that the Anglo-American officers were not drunk. Officer Presley was suspended for revealing these facts to the public.

In late June, following the shooting in the back by the police of an unarmed 14-year old Negro burglary suspect, public hearings were held by the State Human Rights Commission, the Urban League, and the NAACP to get testimony on other incidents of police attacks. Following these hearings, the NAACP held a press conference to "declare war on police

Fellow workers, in the face of these increasing attacks on our political and economic rights, we absolutely must stand together and fight shoulder to shoulder for the good of all. This Labor Day, the Communist Labor Party is proud to join with a dozen other progressive organizations ranging from the United Electrical Workers' Unemployment Committee to the Minneapolis NAACP in holding a picnic and rally for Jobs with Peace. used to control and repress the work-

ing class, not to insure "justice". Southern West Virginia contains two United Mine Workers of America districts, District 17 and 29, and about 30,000 miners are employed in the two districts. The region also contains the world's richest deposits of metalurgical coal and steam coal, so it is obvious why the bourgeoisie has moved in recent years to curb the miners' strike movement. The moves of the bourgeoisie include the use of the courts and the elimination of the "right to strike" clause from the current contract settled in last year's negotiations. They were aided in this attack by the vacillating "leadership" of UMWA President Arnold Miller. Miller, elected on a reform program. has no ideological basis for standing up to the coal operators' attacks, for he and the leadership around him do not perceive any alternative other than preserving and protecting capitalism. That means the right of the coal companies to increase their profits at the expense of the health and safety of the coal miners! Miller promised a long strike in 1974 for a decent contract, and encouraged the miners to prepare, but when he sat down at the table with the Bituminous Coal Operators Association (BCOA), he immediately collapsed and gave up the right to strike, something the miners have always had. The bourgeoisie clearly understood that their victory was key to coal profits. Dean Witter and Company, an analyst for big stock investors, told those who were thinking about buying stock in coal companies in March of 1974 that "In order to win the last UMWA election, Arnold Miller had to make many promises to the miners, like any politician...Though Miller is both honest and sincere, he is not charismatic, and it seems likely there will be at least a short strike, if only to solidify his leadership;" and "...any dollars and benefits agreed upon must be in return for a workable grievance procedure and union-initiated disciplinary action to prevent unauthorzied walk-outs and excessive absentee-("The Renaissance of Coal" by Joel Price, CFA for Dean Witter & Co., March, 1974, p. 19, 21) This was six months before contract negotiations! It is clear that the bourgeoisie knew where Miller's reformist Jeadership would lead!

The coal miner's response to this attack on their basic right has been to fight back with a strike movement of massive proportions - an organized fightback led by vanguard workers. It is not the first mass strike the West. Virginia coal miners have carried out in recent years. In 1969, the miners shut down the entire state to get Black Lung benefits passed by the legislature. In 1974, they shut it down again in a winning protest against the government's policy of rationing gasoline during the phoney "energy crisis". So, the current TRO strike is certainly not a unique experience for the West Virginia coal

Although a powerful weapon in the hands of the working class, such strikes will remain only a defensive weapon of of attack by the state. With all this background, Roger Thompson, a young Anglo-American president of Local 1302, of Amherst

August 4, allegedly for instigation of a work stoppage. On August 6, the company obtained a TRO and, on the 7th, a contempt order. During this time Local 1302 refused to work and picketed out about six other coal companies in Logan County. These other coal companies also immediately obtained TRO's from the Court.

On Sunday, August 10, a large mass protest meeting against the slowness of the grievance procedure and the absence of the arbitrator panel was held in Marmet, West Virginia. Arnold Miller attended and spoke, along with Jack Perry, President of District 17 and the District 17 lawyer. The miners did not like what they heard

Coal in Logan County, was fired on body of men attending the circumstances under which he had been fired. As a result, all 33 mines in Logan County were shut down that night by roving pickets as well as a number of mines in neighboring Boone and Kanawha Counties. During the rest of the week, these mines remained shut by pickets and more were added to the list as the picketing spread throughout District 17.

More TRO's and contempt orders were obtained as the coal companies obtained expensive but valueless pieces of paper in a vain attempt to force the miners back to work. On Friday, August 15, Roger Thompson's Local 1302 was back in court along with three other Logan County locals, and Miller was forced to flee the including Sim Howze's Local 8584 of wrath of the miners. return to work, and on Monday, August 18, nearly 300 miners came to Charleston with Sim Howze to show their support for his position. By the middle of the week of August 25, the strike had spread to Ohio, Kentucky and Illinois, with new reports of mines closing constantly coming in.

This strike is part of the working class' constant fightback against fascism and the erosion of their hard won rights. Through such struggles as these, united with the science of Marxism-Leninism, the working class will realize its historic task, overthrow the capitalist state and build the dictatorship of the proletariat and socialism. Then working class people will judge their former judges and we can be sure that they will remember the Federal Judges of Southern West Virginia.

FASCISTS MANEUVER

NEW HARLAN FRAME-UP

BESSIE LOU

Due to the militant support and defense of Bessie Lou Cornett, the charges of kidnapping, have been dropped! Since Bessie's arrest six weeks ago, workers and progressives from coast to coast have been demonstrating, marching and rallying to free and defend her. The weekend of August 22-23, Bessie spoke in Washington D.C., Baltimore and New York City. In New York, workers stayed after work outside of their factory to first attend a rally in support of busing and then received.

But Bessie is still under the hammer assaulting a police officer on a picket line, has been reactivated. She and six other workers will go on trial next month. This arrest resulted from militant activity around a hospital strike in Pikesville, Kentucky. This hospital

The fight to defend and support Bessie Lou must continue. Although she has been freed on the kidnapping charges, the state in conjunction with the coal operators and the Klan are trying to stop her and her fellow workers' activity in their struggle for the rights of all working people. SUPPORT BILINGUAL EDUCATION

is a struggle for integration, and equal, quality education. Detroit's population is predominantly Negro national minority, and for them segregation and poor quality of education has been a way of life. There are also about 100,000 Spanish speaking workers, most of whom live in the southwest section of Detroit. Because of the large number of Spanish-speaking students in Detroit schools, in addition to the struggle for busing, there also exists a struggle to maintain and expand Detroit's bilingual program.

The bilingual program in Detroit is presently concentrated in Webster and Maybury elementary schools in the southwest section of the city. The bilingual program had its beginnings in 1971 when parents, teachers and a few "Latino" social service agencies held meetings and discussions with the Detroit School Board to demand equal and quality education for Spanish speaking children. The need for a bilingual program was made evident: "the percentage of Spanish surnamed fourth and sixth grade pupils underachieving one year in reading is 63%, while the percentage of eighth grade reading underachievers jumps to 80% and the 10th grade reading deficiency is 61%." (Initial plan for the implementation of a bilingual education program, Board of Education of the School District of the City of Detroit, March 3, 1972, p. 13) These deficiencies still exist, not just in reading, but other subjects as well, and are reflected in the large number of drop-outs at Earhart Jr. High and Western High School.

The bilingual program was finally implemented in school year '72-73 at Webster and Preston elementaries after much struggle on the part of the community. The original program was funded for \$150,000 to service the Kindergarten thru Primary grade 2 at Webster, and two preschool classes at Preston. The proposal also called for the expansion of the program to the next highest grade each year until the program would be operating at the preschool thru 6th grades.

This year the bilingual program at both the Detroit level and the federal level, has been changed considerably when the director of the bilingual program resigned at the end of the school year. She then pointed out some of the factors which have held the program back: the general lack of cooperation on the part of the Central School Board as well as the Regional Board and administration, the chauvinism expressed in Webster school by non-Spanish speaking teachers, and the failure to integrate the bilingual program into the instructional program already offered at Webster. All these things have contributed to keeping the program from achieving its goals. The director also pointed out that both she and the Community Advisory Council were forced by the School Board's administration to submit a proposal for this coming school years' program, which was neither to their liking nor in the best interests of the community.

The proposal was poor because the large federal cutbacks by the Ford government aimed at welfare and social services have also hit education. The cutbacks in education are reflected in the bilingual program in the requirement that the programs serve only "children of limited English-speaking ability". (Federal Register, Vol. 40 No. 29, Wednesday, March 12, 1975, p. 11592) Thus, in Detroit the budget for the bilingual program has been slashed to \$110,000 for '75-76, leaving only two lab teachers and one cultural heritage teacher (out of the ten previously hired), as well as cutbacks in the number of community persons hired as teachers aides. MURDER CHARGES

JOAN LITTLE FREED

The case of Joan Little has been international news. All around the world, workers and progressive people have spoken out in her defense. From all corners of this country, money and support were given to her case. And with great joy we note that Joan Little was acquitted of the murder charges against her.

The CLP supported Joan Little and showed how her case was integrally connected with the struggle of the Negro people and the struggie of women for equality. And we are filled with happiness that she has been acquitted. But we do not accept the explanation that the reason Joan was freed was because the justice system works and there exists equality for-Negroes in our society.

The justice system in this country was built to serve the bourgeoisie. From its inception this sytem only let those go free who worked in the interests of the capitalist class. The runaway slaves never went free. The poor farmers never went free. The factory worker never went free. The point is, that the reason Joan Little was allowed to go free was because she had the money and the lawyers and because rallied around her were influential sections of society.

There are hundreds of Negro workers, both men and women, in the Negro Nation in particular, sitting on death row. In South Carolina alone, once a week one person is sentenced to death. And the vast majority of these prisoners are Negro.

This individual case of freedom is important and shows that with the proper amount of support it is possible to struggle successfully. But no matter how many Joan Littles go free, the national oppression of the Negro people will remain. After the Scottsboro boys went free, the lynchings of the Negro people did not stop. After Angela Davis went free, the brutality against the Negro people did not halt!

The solution to the arrests and executions of workers like Joan Little is not to fight solely in the courts for the freedom of an individual. The struggle must be extended and based upon the struggle to free the Negro Nation-to break the chains of bondage that daily shackle the Negro people. There is only one way to change the justice system in this country and insure equality for all peoples that solution is socialism.
