OIL COMPANIES MAKE SUPER— PROFITS WHILE PEOPLE SUFFER!!

Why gas lines? Why are the prices rising every day? Is there really a gaso-line shortage? Who is responsible? These are some of the questions that are running through all of our minds these days, as we sit and wait in gas lines wasting our lives waiting for gas, while some people get rich off our misery and are somewhere laying in the sun chuckling at how they chump us off!

First of all there is no gasoline shortage! Like the hyped up "Energy snortage: Like the hyper up Lineryy Crisis" of a few years ago, the present gas shortage is a fake aimed at raising prices to unheard of levels. Once the "Oillies" reach about \$1.50 (maybe even \$2.00 some folks are saying) then there will be all the gas you need - until they get ready for the next price hike.

Why is this? Because supplies of fuel oil are controlled in this country by only a few gigantic oil companies. In fact this squeeze is directly attributable to the capitalist greed of the group called The Seven Sisters, who control most of the oil in the world. They are: Exxon, Shell, Texaco, Gulf, Mobil, Standard of California, British Petroleum. Five of these are American corporate giants. Shell is Dutch & English, BP, of course is

English as well.

These corporations fake shortages to jack up prices! They try to blame it on the Arabs, the reason for this is for many years these corporate bandits literally got the oil for no-thing. In 1970, they paid the Arabs \$1.80 for a barrel (55 gallons!) of oil. But the rise of revolution throughout the 3rd world (Africa, Asia, Latin America) have forced the oilies to have more money for the oil. But even today they pay \$14.55 a barrel! Or about .26 cents a gallon, and out of the same barrel they use the "waste" to manufacture plastics, fertilizer, insecticide, heating oil. In the 50's and early 60's the oilies paid

New York's Judge BRUCE WRIGHT Criticizes Bail System

Judge Bruce Wright of New York City's Criminal Court came under at tack again, this time by Mayor Koch and Patrolmen's Benevolent Association's President, Sam DeMilia. Judge Wright had granted release without bail (in his own recognizance) to a Mr. Jerome Singleton, who later was an alleged suspect in the slashing of a

At the time of Singleton's appear ance in court, there was no indictment presented by the DA's office within the 72 hours allotted for a felony inthe 72 hours allotted for a felony indictment, as is the usual procedure. Since Mr. Singleton was a respected community member, a full time student, married and the father of 2 children with no previous arrest record, he was released. The furor is over granting this right to a black man, rather than using the bail system, as is too often the case, as a means of having poor people serve time before trial or hearing because they are unable to meet bail.

attacked saying that, not only has Mr. Singleton's case been prejudiced by Koch's and DeMilia's outbursts imply-Koch's and DeMilia's outbursts implying guilt before trial, but that as a criminal court judge he's resist the improper use of the bail system which has been used to consistently violate the democratic rights of blacks and other oppressed people. This call was strongly supported by hundreds of H. Daughtry's church for an Easter Sunday service to hear the Judge

Why China Counterattacked Viet Nam Hegemonists

In late February, Chinese troops launched a military action against Vietnam. The last Chinese troops withdrew across the border on March 16.

China acted to defend its territory in response to a long string of aggressive actions on the part of Vietnam. The Vietnamese authorities have stationed 50,000 troops in Laos, effectively subjugating that country; they have conducted a campaign of persecution against the Chinese residents of Vietnam, expelling tens of thousands of them; they are invasion force of up to 20,000 troops, and lie that they are uninvolved; they committed thousands of border violations against China in which hundreds of people have been killed or wounded. To support all of this they made a military-political alliance with the Soviet social-imperialists, the most aggressive and dangerous pack of imperialists in the world. These acts pose a grave threat to world

A number of organizations in the U.S. have tried to operate under a "Marxist-Leninst" cover in order to becloud the issue. Leading the way is the Communist Party, USA, loyal servant of Soviet social-imperialism. This revisionist party claims that Vietnam's Soviet-backed invasion of Kampuchea is an indigenous uprising! It follows that they have accused China of "aggression" for defending itself against Vietnam's incursions on its territory.

Some are repeating USSR—CPUSA lines while claiming to be "anti-revisionist". The so-called Revolutionary Communist Party thinks that it can get people to swallow the notion

China drew the only logical conclusion: the Vietnamese authorities will desist from their outlawry only when forced to do so.

The Chinese counterattack was a thorough military defeat for the Vietnamese hegemonists, China wants no more than a peaceful border and has kept no Vietnamese territory. Nevertheless, the Vietnamese authorities persist in claiming that China occupies their territory. This shows that they have yet to negotiate genuinely to settle the question of the border.

The Vietnamese authorities have turned against revolution and socialism and abandoned the people's cause. They think that they are invinceable, but without the people they are weak. Vietnam is bogged down in Kampuchea just as the U.S. was bogged down in Vietnam 15 years ago. The Vietnamese hegemonists will be defeated, just as were the U.S. imperialists. Neither will their anti-China adventures bring them any success.

that China's action is a "US-Soviet proxy war". The RCP say that China is a capitalist country which is dependent upon the U. S.! To the RCP, China's achievement of normal relations with the U.S. is a matter of collaboration with U.S. imperialism. The Soviet rulers say the same thing! This historic turn of events poses a great obstacle to their hegemonic ambitions. RCP's unity with the USSR & CPUSA stooges shows that it is the RCP, not the Communist Party of China, which collaborates with imperialism. The cockeyed "leftism" of the RCP revisionists becomes more flagrant every day.

IRAN

On January 16, 1979, Shah Mohammed Riza Pahlevi was driven out of Iran by the Revolutionary uprisings of the masses of Iranian people. Yes, it is a joyous day for the masses of people of Iran and other working people and oppressed nationalities around the world.

After 37 years of neo-colonialism and imperialist domination, the masses of people rose to smash this oppresive regime. As the revolutionary spirit of the masses reached a turning point in Iran, the Shah no longer had visions of "neo-colonialism forever", but was rewarded with bricks, bottles, bullets, and whatever other kinds of materials the masses could lay their hands on in order to show their resistance against imperialist and neo-

colonial oppression.

With the Shah's departure from Iran, a puppet government was appointed by him to continue the carrying out of his orders. The new government was made up mainly of the Shah's former cabinet members, and headed by Prime Minister Shahpur Bakhtiar. The U.S.A. immediately sent out a call stating that they supported this new government, and that the masses should cooperate with this new government. But the masses, based on their understanding of imperialist politics, clearly knew that the Shahpur Bakhtiar government was the same as that of the Shah.

With unrest still at a high point in Iran, the masses cried out for the return of Ayatollah Ruhollah Khomeini, the Moslem religious leader who had been in exile for a number of years. Upon the return of Ayatollah Khomeini, the masses of Iranians rejoiced with great enthusiasm. At last, the masses

felt that the hated Shah was gone and perhaps they could have a government that would reflect the aims and sentiments of the entire Iranian population. These aims and sentiments were best expressed upon his arrival in Teheran when he stated, "We must struggle to cut off the tentacles of colonialism in Shah of Iran. The masses of workers closed down plants,

stopped production of oil, and closed down schools, stores and small shops, to show their solidarity for the movement. Although this affected the local economy of Iran, one cannot help but to rejoice over the fact that it primarily affects U.S. imperialism in Iran. The people of Iran must wage a

The people of Iran must wage a consistent struggle against all forms of imperialist aggression. This is important because throughout the world when colonialism, capitalism and imperialism have been defeated, they will try to revive themselves unless there is consolidation of the working class struggles, and the democratic revolution, such as is the case in Iran, can move to the next stage, socialist revolution, led by a revolutionary Marxist-Leninist Communist Party, based on Marxism - Leninism - Mao Tsetung Thought.

STATEMENT OF AFRO-AMERI-CAN SOLIDARITY WITH LIBER-IAN RESISTENCE

We, the undersigned list of Afro-Americans, at this time state our unrestricted solidarity with the struggle for freedom ensuring inside the borders of Liberia.

We condemn the use of force utilized by the Liberian government on April 14, to dispel a peaceful demonstration, and unmitigated murder of over 200 men, women and children. In as much as there has been no evidence or proof given by the government that the demonstrators fired upon by the police in Monrovia on April 14, were armed or that those demonstrators intended to display any acts of violence; we, the undersigned, mourn their deaths as Liberian Freedom Fighters. Furthermore, because there is no evidence or proof given by the Liberian Government that intervention by forces outside of indigenous Liberian protestors were present at the demonstration or that there was foreign intervention on April 14th, we the undersigned condemn the use of troups from Guinea and Sierra Leone against the democratic aspirations of the Liberian people as a willful act of aggression, and political agreesion.

We believe that any government should be expected to look after the needs of all the people and not follow the whims of a social elite. We, the undersigned condemn the

we, the undersigned condemn true imprisoning and torture of the political opposition leaders in Liberia. We suggest that all of the names of the dead and wounded be released and that a truthful statement be released by the Liberian government naming what precipitated the violence and killings. We also condemn the abridgement of human rights as stated by the Liberian constitution and extended to the general population. We cite Liberia as a client of world capitalism and call on all freedom loving people the world over to condemn the abject poverty to which the Liberian indegene is subjected to, in view of the luxury in which the privileged ruling class of Liberia sprawls.

On April 14, 1979, In Monrovia (the Capital of Liberia), the Liberian People held a peaceful demonstration to register their protest against the governments proposed increase in the price of rice to \$35 per 100 lb. bag, The average wage in Liberia is \$80 a month! Although this was a peaceful demonstration, the Rev. William Tolbert, president of the U. S. dominated government & a rice grower himself, ordered the killing of 300 peaceful demonstrators, including women and children, and wounding 600 others. Rev. Tolbert and his entire neo colonial government must be condemned and made to answer for their Murderous acts of aggression against the Liberian People. This senseless slaughter shows that oppression as well as its oppressor has no

particular color barrier. This same Murderous Government closed down all universities, fearing that the students and workers were beginning to educate themselves, politically, socially and economically

The Union of Liberian Associations in America, along with other workers, women and progressive forces have written letters and held demonstrations to protest the brutal killings and senseless slaughter of the Liberian people. Although in some cases, these demonstrations have been small in number, it is the Revolutionary Spirit and drive of the Union of Liberian Associations in America, along with other workers, women and progressive forces, that has spearheaded and brought to the forefront, the cries of the Liberian people for justice and equality.

We encourage Revolutionaries, workers and advanced forces around the world to support the struggle of the Liberian People against colonialist oppression by the Reactionary Government of Rev. William Tolbert. We also condemn the Liberian Government's use of foreign troops from Guinea and Sierra Leone to murder Liberians and demand to know why these governments are interfering into another nation's internal affairs.

REVOLUTIONARY MOTION

NAMIBIA - - - - -

As the people's war led by SWAPO in Namibia intensifies, the UN plan for a ceasefire negotiated by UN's Secretary General Kurt Waldheim and his special envoy Martti Ahtisaari is in deep trouble. South Africa's foreign minister Roelof Botha has arrogantby resisted end settlement that would change continued dominance of the white minority. This cockiness is on the staunch economic and military support South Africa receives from the U. S. and four other Western nowers to the time of \$83 billion nowers to the time of \$83 billion. powers to the tune of \$8.3 billion as of 1978, a \$1.1 billion increase over 1977, Similar to South Africa's "in-ternal settlement", Namibia's Turn-halle Alliance is a hand-picked group of economically and politically dependent Bantustan leaders and their white counterparts who are attempting to usurp power through so-called democratic elections in the name of the black majority.

Other stumbling blocks have been South Africa's resistance to the ceasefire: 1) composition of the peace keeping force known as the UN Transitional Assistance Group, 2) its Moni-toring functions, 3) the forms of the ceasefire plus, 4) the allowance of SWAPO bases in Namibia.

However, the Namibian people with SWAPO at its head is clear that only their people's war will bring demo-cratic rights and liberation for the black majority.

After years of internal strife, poverty, unemployment, etc. Idi Amin's government has been toppled by a combined force of 20,000 Ugandan patriots and Tanzanian troops under the banner of the Ugandan National Liberation Front.

Over the 5 months of border wars between Uganda and Tanzania many Ugandans fled, seeking refuge in Kenya and Tanzania. It was many of these same patriots who returned as victors, despite the efforts of Amin's own troops (many of whom were Nubian mercenaries) and nominal Libyan support. The turning point in the stop and go war which the OAU unsuccessfully tried to mediate was Libya's threat to Tanzania to "withdraw or suffer the consequences." Tanzania then ordered its troops to march to Kampala

The main factor was that the Ugan-dan people were fed up with 8 years without basic necessities such as salt, sugar, cooking oil, etc; the disappearance and off times murder of friends, family and loved ones, etc. Ugandans throughout the country greeted the UNLF as victors. Despite Amin's broadcasts to the contrary, the self-proclaimed leader for life (who came to power in a coup engineered by Israel, West Germany and the U.S.) has been deposed and the struggle to return the country to democratic rule by the people under the provisional government of Yúsef K. Lule can be-

GRENADA: OPPRESSIVE RULE OF ERIC GAIRY COMES TO AN END.

On March 13, 1979 the Gairy reign of terror that existed for 15 years ended when the New Jewel Movement headed by Maurice Bishop led the peo-ple in seizing power. The New Jewel Movement has a long history of strug-gle in the Carribean and particularly in Grenada. During this struggle in Grenada the organization has learned from past mistakes and gone forward to lead a popular movement against a

government known for brutality and continuous violations of human rights. Two factors led to the takeover; one was the plan by Gairy on Saturday, March 10th, to search and detain key members of the organization. Those on the detention list went under-ground. It, was further learned by inside sources, that Gairy had made plans to completely wipe the NJM and supporters out. These two developments, coupled with the increased re-pression in the past few months, led to the planning of an immediate as-

Since the seize, the revolutionary government has been recognized by Jamaica and Guyana. The Associated States, (governments of the smaller Caribbean islands states) won't recognize the new revolutionary govern-ment until there is a return to the "constitutional process". This is a reaction by the heads of states of these islands to what has happened in Gre-nada, namely fear that the masses on islands might deal with them in the same manner. It is also an attempt to ignore the welfare of the Grenadian people. Under Gairy the so-called "constitutional process" was merely a license for Gairy and his "mongoose squad" to rig elections and violate the democratic rights of the Grenadian

The current movement in Grenada is one stage in a long on-going struggle but will serve to inspire the masses in Carribean and worldwide to organize and struggle against oppression and eventually make revolution!

BRITAIN

The Labor Government of Prime Minister James Callaghan lost a vote of no confidence by one vote recently.
This led many to believe that Conservative leader Margaret Thatcher would become the first women Prime Minister as well as lead Britain further

towards the right.

Britain's government has been hard pressed by Ireland's national liberation struggle over the last decade. And both Scotland and Wales have been pushing for "self-rule" which, when denied broke up Labour's precarious support and pushed the Callaghan govern-ment to the brink of no confidence. measure of Britain's problems has been consistent strikes and labor has been consistent strikes and labor troubles. Recently, sanitation, school, hospital workers and ambulance drivers have broken through Callaghan's 5% wage increase guidelines. Because of these and similar labor struggles including truckers, miners, etc. no British government in over 20 years have have able to seven more than has been able to serve more than 1 term.

As long as Britain's government continues wage guidelines which insures workers falling further behind the almost 10% inflation rate (over last year), relies on personal income tax for the bulk of its budget (some wages are taxed as much as 83% while corporations are always lightly taxed), continues a "minimum" 6%+ unem ployment rate, etc., in short as long as the government represents the capitalists whether "Labor" or Tory, the workers will always respond with a vote of no confidence. NJ State College System Teachers Strike

On Tuesday, March 20, over 3200 teachers of the New Jersey State College System went on strike for better wage and contract provisions. The strike was successful beyond all expectations. More than 90% of the faculty stayed out and an even higher percentof students. The strike had great political impact.

On Wednesday, March 21, State contract negotiators cut a deal with the bureacrats of the American Federation of Teachers, AFL-CIO, who sold out the faculty and students. The bureaucrats accepted what amounted to the State's original wage offer, plus a plan for bonus payments to be given for "merit", i.e., favoritism.

A solid strike brought a weakened

contract. This was the fault of the bureaucrats. Experience is the great teacher and it has taught the teachers a lot. They have learned that they are strong when they have unity and that they must never trust the bureaucrats. An alternate slate of candidates is opposing the bureaucrats in current union elections

At that time Cabral was leader of the revolutionary party that finally liberated Guinea-Bissau from the colonial duthes of Portuguese fascists. Cabral was assassinated just a year or so before the final victory of his party (PAIGC)/African
Party for the Independence of Guinea
Bissau and Cape Verde Islands, completely liberated their country. The assassination was an attempt to stop that movement, but all it did was make the revolutionaries more determined to smash colonialism, and in-

on strike. They are fighting to keep some of the benefits they have won

over a period of years.

The Company is seeking to take away one week of their vacation and require workers to be employed three years in order to receive one week vacation. Also to be eliminated are two of the five sick days and three out of the ten holidays they now have. And most damaging is the discontinuation of the Health, Welfare, Pension plans and the institution of a plan that wouldn't benefit anyone for at least

This strike is of special interest to the workers, all over the country because in this crisis of capitalism workers are fighting back against the at-tempt of the capitalists to take back hard won benefits. This strike will set a precedent for the other workers in the book bindery industry as well as KAREN SILKWOOD AND ANTI-NUCLEAR ENVIRONMENTALISTS PROVEN RIGHT!

The recent malfunction at the nuclear power plant at Harrisburg, Pa., is just another example of the dangers into unsafe mines to get black lung and to be blown up or locking workers in a factory with fire violations to

In the nuclear industry at present, because of private capitalist ownership of it, workers are exposed to cancer-

Goverup uclear

in the nuclear industry because of capitalist control and the attempt of the government to coverup these dangers.

The dangers of the use of nuclear energy was exposed by the case of Karen Silkwood. Karen Silkwood was a worker at the Keep Machee plant, where she was constantly exposing the dangerous conditions there and sought to reveal the numerous nuclear accidents, coverups and plutonium spills throughout the entire industry. She was contaminated and her family has sued Keep Maghee for 11.5 million dollars

On March 6 the case went to court. This is significant because when Karen Silkwood's car was forced off the road, killing her and the documents she was carrying stolen, it was an attempt to stop the movement to tell the truth to the people. But, the brutal murder of Karen Silkwood has not covered up the fact that these plants are unsafe. In fact the case has further confirmed the fact that the truth about nuclear power is being covered

For the thousands in Pennsylvania around the 3-Mile Island plant, there is fear and anger over this accident. Nuclear power can be made to be safe but not under capitalism. It takes real consideration, money and time spent on safety regulations. There can be no speedups, cheap materials or shortcuts. Existing and future plants would have to be away from densely populated areas. However, capitalism's first consideration is given to the making of maximum profit. No matter what risks, hardships, or dangers the work ers and population are exposed to! Even if it means working children 18 hours a day or sending miners down

causing radiation, so is the surrounding environment. We cannot expect Carter to tell us that as a result of the accident at the 3-mile Island plant, the lives of thousands of people have been endangered, that food has been contaminated, as well as the water and the air. It wouldn't be prowater and the air. It wouldn't be pro-fitable!! Firstly, because the neces-sary safety and environmental con-trols would cut down on the capi-talists' maximum profit!! Property values would also go down; pro-ducts produced in that area such as milk, eggs, bread, etc. could not be sold. All of this would mean a lost pro-fit. And it is the nrafit motive that is fit. And it is the profit motive that is the concern of the few who control this society. The current billions tied into the nuclear industry would be lost, Although the capitalist owners use public funds, our tax money, for their research, then pocket the profits!

Therefore whatever the issue nuclear plant hazards, environmental regulation, control of radioactive waste and dumping systems, poisoning or other numerous health and safety hazards workers and the general population face everyday in relation to the nuclear industry, the masses of people must fight for public accountability, more stringent controls and safer conditions. But the fight must be finally to change this society, because under capitalism profit will always be placed above the lives of the people. Struggle gainst Male Chauvinism

Several couples, in or associated with Revolutionary Communist League, have been meeting informally to discuss marital problems with the aide of Marxism-Leninism.

Some of the broad areas we've discussed are: mental and physical abuse, feelings of male superiority and female inferiority, sexual rela-tions and problems, responsibility

for household work, etc.

In discussing all of these problems,
we concluded that based on living
under a capitalist society marital relations are built on a foundation of private property which supports and is perpetuated by male supremacy and female subservience and that this contradiction can be consciously struggled against and progress made. Though, on the final analysis, it would take socialist revolution to begin to provide the economic and structural foundations for the full emancipation of women.

Mental and physical abuse of wo-men is directly related to male chaumen is directly related to male chau-vinists' viewing women as their pro-perty to be treated however they please. Within our meetings this included examples of severe beatings based on finally imposing physical strength when the man's political line didn't win out. These acts negative

ly effected the comradeship, love and children in the family. It also included non-physical but equally oppressive mental abuse. This took the form of constantly belittling the woman's consciousness and ability. Dismissing, for instance, recuring problems one woman comrade had at her worksite as inability to cope as if male comrades didn't have problems at their worksites. Another example ocurred when one comrade didn't instantly win over his spouse to being actively involved in practi-cal work, he stopped trying and spent ong hours away from home organiz-ing the "community", "masses" etc. This belittled the woman's ability to understand the problems facing working people, and other oppressed sectors and make a decision to consciously struggle against it. It also reflects a great deal of idealism and subjectivism for the male comrade to expect instant victories. Like the struggle to overthrow capitalism, the struggle against male chauvinism and female collaboration is a protracted

Another major aspect of our discussions was the extreme amount of self-aggrandisement and infallability on the part of the men and the low

them. But if a law serves only to restrict, deny or limit the freedom or rights of one sex, such restrictions might not be extended to both sexes, instead the law could be declared unconstitutional. ERA will do nothing in itself, it must be followed by court and legal action; but ERA does set the stage for increasing class struggle. We learned from Comrade Lenin that 'Marxism, teaches the proletarian not to keep aloof from the bourgeois re volution, not to be indifferent to it, not to allow the leadership of the revolution to be assumed by the bourgeoisie, but, on the contrary, to take a most energetic part in it, to fight most resolutely for consistent proletarian democracy, for carrying the re-volution to its conclusion." (Lenin, Sel. Wks, V. III, p. 77)

The confusion between effect and interpretation of ERA is the error we made in the past and further concretized this error by not thoroughly in vestigating ERA from a practical standpoint. Our analysis must also reflect a clear understanding of reforms under the conditions of imperialism so that we do not become reformist. We have learned from Comrade Stalin that: 1) "under certain conditions reforms in general, and compromises and agreements in particular, are necessary and useful, it is not a matter of reform or of compromises and agree ments, but of the use people make of reforms and agreements;" 2) "to a revolutionary the main thing is revolu-tionary work and not reform, to him reforms are a by product of the re-volution . . . ," and 3) "the revolutionary will accept a reform in order to use it as an aid in combining legal work with illegal and to intensify, under its covers, the illegal work for the revolutionary preparation of the mass-es for the overthrow of the boug-eoisie." (Foundations of Leninism, p.97, 98) In summation we must be clear that communists use reforms as a revolutionary tactic, that is, supporting the reform increases our contact participation and integration with the masses we increases our allies and through this increase our influence and are open to more ways to point out the corruption and continuous exploitation in captialism because we know that the liberal bourgeoise will grant reforms with one hand and with the other hand take them back. It is this contradiction that we must use to educate the masses to the falsity of reformism, it is this contradiction that will heighten the class struggle and it is this contradiction that sets the conditions for communists to take the lead in organizing and educating the masses to the need for a commu-nist party based on M-L-M that will destroy capitalism and imperialism. It is this understanding that we must be clear on. WHAT IS ERA?

The ERA is three sentences that will be added to the U. S. constitu-tion. If ratified it would become the twenty seventh amendment. The text of the ERA reads as follows: Section 1. Equality under the law shall not be denied or

abridged because of

Section 2. The Congress shall have the power to enforce the provisions of the amendment.

Section 3. This amendment shall take effect two years after the ratification.

History of ERA
The ERA was first proposed in congress in 1923, after the victory of the women's suffrage movement, but for the next 50 years it was voted down by the democrats and the republicans each time it was raised. Finally, in

1972 Congress passed ERA and then the ERA entered the long run of state by state ratification. Before it becomes law, thirty-eight state legislatures must ratify the measure within seven years of its passage to Congress. Thirty-five states had ratified ERA by February 1977 and three more are needed. The deadline was March 22, 1979. This date has now been extended to 1981. This extension was the result of a hard won struggle by supporters of ERA to ensure more time to get the needed states (3) to ratify the ERA. If final approval doesn't come by then, the ERA dies. It then will have to be reintroduced to Congress and go thru the ratification by states again until 38 states pass it. When ERA is adopted, the first step in its implementation will be to examine all existing federal, state, and local laws to determine whether they contain classifications based on sex and if so, whether these classifications are constitutionally permissible. When a law is found to be in conflict with the ERA, the second step will be to decide whether this law should be expanded to include both sexes, be nullified entirely, or, when necessary, be replaced by different



FACTS REGARDING ERA AND PRACTICAL APPLICATION

The following information aided us in determining whether ERA will deprive women of any existing rights and the economic implications of ERA. These points of information are based on the report from the majority on ERA of the Senate Judiciary Committee (SJC):

1. ERA and the military - anti-ERA groups say that if ERA is passed, not only will women be drafted but they will be forced to fight. The response from the Senate Judiciary Committee Report on ERA states that "those women who are physically or mentally unqualified, or who are exempt be cause of their responsibilities (e.g., certain public officials; or those with dependents) will not have to serve, just as men who are unqualified or exempt do not have to serve today. Thus the fear that mothers will be conscripted from their children into military service if the ERA is ratified is totally and completely unfounded." Other information states that the U.S. army is voluntary and that we do not have a draft amymore and should the draft exist again ERA will not require all women to serve any more than all men are now required to serve.

RCL (MLM) ANALYSIS is that as communists we are opposed to the draft of men and women to fight imperialist wars for the redivision of the world. Bourgeois wars are unjust wars fought to exploit and plunder people and their countries for the benefit of the capitialist ruling class. The motive of these is maximum profit making, to ensure domination of the ruling class over the majority of the people But we are not opposed to every kind of war, there are also just wars. We refer

Step Up Struggle against Welfare Board!

Racism and sexism, in some of its most tragic manifestations was evident in the suit filed and fought by Norma Jean Serena, a Creek Shawnee Native American, against the Armstrong County, Pennsylvania Welfare Board, the Citizens General Hospital of New Kensington, Pa., and two physicians of that hospital. In 1970, Mrs. Serena was sterilized without her knowledge and consent, and her three children were taken away from her and placed in foster homes for three years. They were returned only after delay tactics by the Armstrong County Welfare De-partment and a subsequent court bat-

Ms. Serena, a 40 year old divorcee, was living with her two children in Apollo, Pa., an area whose Welfare De-partment has had numerous instances of overt racial prejudice. A public of-ficial complained to the Welfare De-partment that she was living with a black man who was not her husband. Apparently as a result of this com-plaint, a plan was designed by the Wel-fare Department to take Ms. Serena's two children away, put the expected child up for adoption after birth, and insure that she had no more children. A.D.P.A. worker began to talk to Mrs. Serena about sterilization. They also told her that her children were extremely ill and that they needed medical attention that she was unable to provide. The children were taken to Children's Hospital in Pittsburgh for a few days, after which they were taken to foster homes where she was told they would stay temporarily. Mean-while the foster parents were told to expect that they could adopt these

After Ms. Serena gave birth to her child on Aug. 16, 1970, this child was also taken to a foster home. They told her that she was too ill to care for it. On Aug. 18, the doctors performed a bilateral salpingectomy (sterilization). Ms. Serna had no knowledge of signing any consent forms. The forms were dated, in fact, the day after the oper-ation and Ms. Serena was under sedation when she apparently signed them. This act completed the racist plan by the Welfare Department to deprive Ms. Serena of her three children, and of any future children. Ms. Cerena filed suit on March 24, 1974 in U.S. District Court for \$3,000,000 against eight employees of the Armstrong County Wel-fare Board, the Citizens General Hospital, and two doctors (Drs. Carter and Houston) who were involved in her sterilization, on the basis that her ster-ilization violated her rights guaranteed by the 1st, 5th, 9th, 13th, and 14th Amendments to the Constitution. The case did not come to court, however, until January of this year.

The most blatant confirmation of the plan by the D.P.A. office came in court in a signed statement from Ms. Shott, a foster parent with whom one

of Ms. Serena's children had been placed. She stated that in a meeting with Ms. Serena's caseworker, she told her that she and the doctor were going to make sure that Ms. Serena had no more children, and that when Ms. Shott protested that Ms. Serena's consent would be needed for the operation the caseworker replied, "She ation, the caseworker replied, "She will sign the papers. She's too stupid to know what she's signing."

True to character, however, the state used such false issues as Ms. Serena's "morals", and the fact that she had been considering sterilization herself to deter the attention from the basic violation of her human rights.

While Ms. Serena was awarded \$17, 000 in damages for depriving her and her children of each other for three years, and "misrepresenting" (lying) about the health of her children in order to do this, she lost the suit con-cerning her sterilization, reconfirming the fact that Third World women (Black, Chicano, Puerto Rican, Native American, etc.) have been, and still are victims of genocide through sterilizations without consent, and other "birth control" measures rather than having the right to determine for themselves what should happen with their bodies. This is an integral part of the triple oppression that third world women face - from capitalism itself (as workers), from racism, and from

The oppression of women as a class and the triple oppression of Third World Women such as Ms. Serena has its base in the system of monopoly capitalism which maximizes the profit of the bourgeoisie by putting certain classes of workers on the bottom to be used as reserve labor (super-exploited labor) and then pushing the racist and sexual chauvinist ide which accompany these divisions thus producing welfare workers and doctors such as those involved in the Serena Case.

In addition, women fall into a vicious cycle often times, due to their economic status (lack of training, lowpaying jobs or lack of jobs, etc.) and the male chauvanism which leaves them many times as the sole parents of children. This leaves them with D.P.A. as their only resource and thus they become prey to whatever D.P.A. requires of them in order to continue receiving assistance.

In the final analysis, this oppression, in its many forms, will not be alleviated through the courts because they are only another instrument of the state, used by the ruling class to implement and justify exploitation. Women's oppression, as well as nation-al oppression, can only be eliminated by the destruction of the system of monopoly capitalism and the building of a socialist society capable of begin-ning to rectify the various ways in which oppression has been manifested.

STEEL HAULERS TAKE ON TRADE UNION BUREAUCRATS OF THE TEAMSTERS IN PITTSBURGH AND ACROSS THE NATION

Since November 1, 1978, independent steel haulers who own their own rigs have been on strike-fighting for collective bargaining rights independent from the International Brother-hood of Teamsters. The Fraternal Association of Steel Haulers (FASH) recognize that like other big indus-trial and trade unions, the Teamsters bosses do not represent the interests of workers, but rather, represent the interest of the steel company owners.

This is a unique strike in that the primary issue is not simply eco-nomic demands. More and more, the contradictions between the rank and file and the high paid union bureaucrats intensify to the point bureaucrats intensity to the point of forcing the workers to use one of their mightiest weapon—the Strike. In 1974 alone, according to the U. S. Bureau of Labor Statistics, there were 240 strikes against the corrupt trade union bureaucrats.

These steel haulers suffer from no illusion about non-violent struggle. They enforce their strike themselves and scab drivers had better beware. At least two dozen trucks have been shot at, Bricked, or tires slashed since the strike began. Several drivers have been shot also.

The FASH strike also points out more clearly the fact that the Trade Union structure and their bureaucrats have become riveted to the bour

geous state apparatus. The Steel Companies and the Teamsters have joined hand in a civil suit and have taken it to their cohort - the Federal Dis-

trict Court in Pittsburgh.


Undoubtedly the courts will rule in favor of the companies and the Teamsters. The courts always rule in favor of the company and in the interests of the bourgeoise, the owners of the industry. Even the labor laws in this bourgoisie "democracy" lean heavily in favor of the ruling class. These are all important lessons

for the working class struggle against the ruling class. That's why Lenin called strikes a "school for war." But he went on to add quickly that strikes should not be mistaken for war itself. The real war will be a class war, a civil war. We will not be just going for union representation higher salaries or better working conditions. The working class will be going for the whole banana—to overthrow the ruling class and seize ownership of the means of producing wealth so that the wealth can be more evenly distributed to meet the needs of the people, not the needs of maximum profit

Although strikes and other forms of struggle for reforms are important they can never deliver the ultimate solution to all our economic, social and political problems. The ownership of the wealth and means of producing wealth must change hands from the current owning class to the working class. There is no other,

male self-image and lack of self confidence on the part of the women. This, we analyzed, as being based on societies property relations, family upbringing and perpetuated through our current relationships. This inflated view of the renationships. This initiated view of the men's correctness led to nicknames such as "Mr. Not-Guilty" and "God" as well as the abuse mentioned earlier. This image was always perpetuated at the expense of the women. Through our group discussions, the men saw how their daily "attitudes" yielded the opposite results of their desires for more self-confidence on the part of women; the women saw that they were not alone in their respective situations or their analysis of them.

chauvinism

Our couples meetings came out of our concrete need to discuss the problems and seek solutions in our relationships, Individually and organi-zationally we questioned what me-chanisms could be developed to bring cadre and non-cadre together to dis-cuss male/female relations, finally several couples decided to take the initiative, serve dinner on a rotating basis and open the discussions.

The major benefits of these meetings have been the general honesty, criticism and self-criticism and some rectification that has resulted. The collective oftimes helped comrades deal with criticisms that had previous-ly been dismissed subjectively. We

also realized that we weren't going to solve each others problems in our discussions but many aspects of each problem were discussed with each member relating his or her specific experiences with it, so that couples left with enough information to conleft with enough information to con-tinue to work towards a solution.
Generally, we deepened our under-standing of the contradictions that aid in the development - or lack of it - of male/female relationships and sharpened our ability to use Marxism-Leninism in analysing and solving these contradictions. (To be continued next issue).

SELF-DETERMINATION FOR THE AFRO-AMERICAN NATION BLACK BELT SOUTH

Black Power, Self-Determination

The 1928 and 30 Comintern doc uments and the 1930 position of the CPUSA are eminently useful; because they set the correct Communist line the black National Question in the U.S.A., which, despite the normal changes created by the passage of time, which must be addressed are still clearly valid and revolutionary today. tional Question as a National Question and not a race question was revolutionary, because it raised the question of Power. Not a muted pica to polly anna humanitarism, etc. As the Reso lution of the Communist International on the Negro Question in the United States stated, "The Communist Party of the United States has always acted openly and energetically against Negro oppression and has thereby won in-creasing sympathy among the Negro population. In its, own ranks, too, the Party has relentlessly fought the slight-est evidences of white chauvinism, and has purged itself of the gross opportunism of the Louestonites Accounting to the assertions of these people, the 'Industrial Revolution' will sweep away the remnants of slavery in the agricultural South, and will prole-tarianize the Negro peasantry, so that the Negro question as a special national question would thereby be presumably solved, or could be put off until the time of socialist revolution in A-In the interest of the utmost clarity of ideas on this question, the Negro question in the United States must be viewed from the standpoint of its peculiarity: namely, as the question of an oppressed nation, question of an oppressed nation, which is in a peculiar and extraordinarily distressing situation of national oppression not only in view of the prominent racial distinctions (marked difference in the color of skin, etc.), but above all, because of considerable social antagonism (remnants of slav-ery) . . . The struggle of the Commu-nists for the equal rights of the Ne-groes applies to all Negroes, in the North as well as in the South. The struggle for this slogan embraces all or almost all of the important special interests of the Negroes in the North but not in the South, where the main Communist slogan must be: 'The Right fo Self-Determination of the Negroes in the Black Belt.' These two slogans, however, are closely connect-ed. The Negroes in the North are very much interested in winning the right of self-determination of the Negro population of the Black Belt and can, thereby, hope for strong support for the establishment of true equality of the Negroes in the North. In the South, the Negroes are suffering no less, but still more than in the North, less, but still more than in the North, from the glaring lack of all equality, for the most part the struggle for their most urgent partial demands in the Black Belt is nothing more than the struggle for their equal rights, and only the fulfillment of their main slogan, the right of self-determination in the Black Belt, can assure them of true equality ... The demand for equal rights, in our sense of the word, means not only demanding the same rights for the Negroes as the Whites have in the United States at the present time, the United States at the present time.

but also demanding that the Negroes should be granted all rights and other advantages which we demand for the corresponding oppressed classes of whites (workers and other toilers). Thus in our sense of the word, the demand for equal rights means a con-tinuous work of abolishment of all forms of economic and political oppression of the Negroes, as well as their social exclusion, the insults perpetrated against them and their segregation . . . It is the special duty of the revolutionary Negro workers to carry on tireless activity among the Negro working masses to free them of their of the White proletariat and draw them into the common front of the revolutionary class struggle against

There seems little doubt that increased presence and organizing in the south, particularly in the Black Belt nationa land, is called for. The line calling for self-determination for an Afro-American or Black Nation is a revolutionary call for democratic rights. Not only Lenin, C. P. and Stalin have made this call, including the CPUSA, before it degenerated; but all genuine communists must uphold his call. But various Black Nationalist and revolutionary organizations have this call, demonstrating the revolutionary thrust of oppressed nations and peoples fighting imperialism.

Self-Determination in Black Belt


The Black Belt is the geographical site of the Black Nation and the heartland of the oppressed black nationality throughout the United States. The depression of the ghettoes is linked di-rectly to the domination and depression in the Black Belt, the anchor of oppression. The view of national revo-lution in the Black Belt is is still valid and the cry, "Self-Determination, Liberation for the Black Nation," speaks not only to the Black Belt land and its related border areas, but to the national conciousness of black people throughout the United States. The struggle for equal rights or demo-cratic rights in the United States nation is linked to the national oppreson of the black belt, and as the . I. document states, the two struggles for democratic rights and self-determination must be linked together determination must be linked together as they are part of one struggle. It is exactly why the Black Liberation Movement takes on and has always taken on a distinct national character. There is no doubt the call for self-determination of the Black Belt weakens imperialism. The national character of the black people in the U.S.A. is still so tightly formed that Self-Determination and Liberation of the black nation speaks directly to them. And the largest movement of black people in the U.S.A. (Nation of Islam), until recently, made self-determination of the Black Belt their cry for 30 years.

been among the most active has of the multinational proletariat. And the C. I. document is clear when it says that "The struggle for equal rights and the propaganda for the slogan of self-determination must be linked up with the economic demands of the Negro masses.

The cry of self-determination, liberation of the black nation, upholds the revolutionary thrust of the black liberation movement. And the demands of the C. I. still seem relavent, no matter that now many of the black peasants have been transformed into a rural proletariat, as farm laborers and migrant laborers (In 1959, 7.7 of all farm operators were black; only 3.8% in 1969, as compared to 14% in 1920.

A demand of self-determination of the Black Belt in the 1928 Comintern Resolution, stated: "a. Confiscation of the landed property of the white landthe landed property of the white land-owners and capitalists for the benefit of the Negro farmers." Now, we are talking directly to capitalist farming industry; agribusiness, which has driven even small white farmers off their land. The land was never divided from the latifundist capitalist stage, for the most part when the transfer of ownership went North to the monopolists, they kept increasing their land holdings and the agribusiness monopolies were added to the others so that today, "one per cent of America's farms produce 25% of the nation's food. Eight per cent of the farms account for more then one-half of the agricultural sales. These farms are run by corporate farmers; big corporations such as Dow Chemical, Southern Pa-cific Railroad, Tenneco." (Foodprice (Foodprice Black Mail/United Front.) Of course, state-owned and cooperative large scale farming are methods of Socialism, but "dividing" the land is a thrust of democracy on the way to Socialism, of democracy of the way to Socialism, as democracy as such is a prerequisite to Socialism. In the same sense, Black Liberation cannot be seen as a bloodless "gift of socialism," though socialism obviously will be a condition for complete liberation. "The aim of socialism is not only to end the division of mankind into tiny states and the isolation of nations in any form; it is not only to bring the nations closer together, but to integrate them. And is precisely in order to achieve this aim that we must, on the one hand, explain to the masses the reactionary nature of Renner and Otto Bauer's idea of so-called 'Cultural and national autonomy' and, on the other, demand the liberation of oppressed nations in a clearly and precisely formulated political program that takes special account of the hypocrisy and cowardice of socialists in the oppressor nations, and not in empty declamations and not by way of 'relegating' the question

until socialism has been achieved.
"In the same way as mankind can arrive at the abolition of classes only through transition period of the dictatorship of the oppressed class, it can arrive at the inevitable integration of nations only through a transition per-

ATIONAL PPRESSION

The Anti-Bakke Decision Coalition which formed the East Coast Tour Committee for the "United League" of Mississippi, recently sponsored a week long tour (April 2-7) for the United League. Tour stops where Washington, D. C., Boston & New York. This focus of the tour was to give greater exposure to this rapidly developing grass-roots militant organization, fighting for democratic rights and the democratic struggle it has been waging in Northern Mississippi for land, freedom, jobs, open unions, black elected officials, end to local police backed klan, repression, and removal of klan members from the local judiciary and city governments.

United League Coordinator James Agnew, who spoke with oppressed nationalists (blacks, hispanic Americans, Native Americans and Asian Americans) working people, and students of Pedro Albizo Campos elem. school, C.C.N.Y. and the Williamsburg Coordinating Committee. ABDC seeing the need to link-up the democratic rights struggles of the United League with other critical mass issues called a press conference during the N. Y. tour that highlighted the Weber case. This case revolves around a suit brought by a white employee of Kaiser_Aluminum in Louisiana to end a "rolutionary Af-firmative Action skilled trades appren-ticeship program which would have opened the door slightly for a small percentage of oppressed nationalities in the U. S. (Blacks, Latins, Native Americans, Chicanos, Asian American, etc.) & women to become part of the skilled workforce at that plant.

The sears case, a suit brought by a Sears Roebuck Inc. against the Federal Government which seeks to end all affirmative Action Programs nationally. This would also have a devastating impact upon blacks, Latins, Native Americans, and women, allowing companies to resist hiring minorities.

In addition ABDC co-sponsored a "Mississippi Branch" legal services staff association and the national organization of legal service workers. Presentators at the branch addressed the increasing movement by the most reactionary segment of ht e right and its forces in the U.S. to suppress peoples advocates i.e. progressive political activists, progressive activists, lawyers, progressive legal workers, who struggle against the continued political suppression, deprivation of democratic rights, economic exploitation working people and oppressed nationalities by U.S. Imperialism.

AFFIRMATIVE ACTION:

WHAT IS THE WEBER CASE?

Information Supplied by: L.A. AD HOC COMMITTEE TO FORM A COALITION TO OVERTURN THE WEBER DECISION

The right wing trend in the U.S. has produced another big "reverse discrimination" case that threatens the rights of millions of oppressed nationalities and women. The case of Weber vs. Kaiser Aluminium is an attempt to extend the racist Bakke decision to the bread and butter issue of equal employment opportunity. It also attacks the flexibility of unions in the collective bargaining process.

WHAT DOES WEBER ARGUE?

Brian Weber, a white worker at Kaiser's Gramercy, La. plant, contends in his suit that he is a victim of 'reverse discrimination'. He claims that the affirmative action program in the 1974 labor agreement of Kaiser and the United Steelworkers (USWA) violates Title VII of the Civil Rights Act. The agreement set up an on-the-job training program designed to admit whites ing program designed to admit whites and blacks on a one-to-one basis. Candidates would be admitted from separate black and white seniority lists until the number of black skilled workers matched the black population of Commence. of Gramercy.

WHY ON THE JOB TRAINING BASED ON RACE?

The population around Gramercy is 40 per cent black. But in 1974 less than 2 per cent of the plant's skilled craft workers were black! There were no women! And only 15 per cent of the other workers were black. Kaiser's blatant discrimination resulted in a court order to pay \$500,000 to blacks in another Louisana plant. Kaiser fearant more suits.

Presidential order 11246 bans em ployment discrimination by those who do business with the government. An-

other discrimination judgement against Kaiser would have resulted in loss of millions of dollars in government contracts. Kaiser and the USWA implemented the quota based on-the-job training program to avoid these events. The number of black craft workers has doubled as a result.

WHO BENEFITED FROM AFFIR-MATIVE ACTION?

Blacks were not the only ones who benefited. Previously all skilled work-ers were hired from outside the plant. Without the affirmative action program, neither Brian Weber nor any other employee had a chance to upgrade themselves. Like most affirmative action programs, this one benefited all workers, not just minorities & women.

WHERE DOES THE CASE STAND NOW?

According to Title VII, quota programs like Kaiser's are legal if discrimination has been practiced. But neither Kaiser nor USWA presented the facts in their filmsy 'defense' of affirmative action. And the lower courts made the racist ruling that no discrimination had been practiced at Kaiser. Therefore they declared the program illegal. The case has been appealed to the U.S. Su-preme Court, which will probably make its decision by June.

WHAT WOULD THE IMPACT OF WEBER BE?

If upheld by the Court. Weber could gut Title VII and Executive Order 11246. All quota affirmative action programs not ordered by a courtboth for minorites and women—would no longer be legal.

This means that unions could not negotiate anti-discrimination programs with racist employers; public pressure could not force discriminatory institutions to remedy their injus

STOP Killer Cops!

Richard Hayes (a.k.a. Dickie Allen), a 29 year old black man, was shot through the top of the head and killed while handcuffed and shackled with a waist chain, and with almost certain indications of the use of ankle chains on Dec. 4, 1978. Two white federal marshals were escorting him from the Post Office Building back to the Allegheny County Jail when Eliza-beth Quick (draw), one of the Mar-shals, assassinated him in cold blood. Despite conflicting testimony, coverup, and perjury, on Dec. 16, an all white jury of the Allegheny County Coroner's Court ruled this murder "justifiable homicide."

Although this murder is just the latest in a continuous bloody trail of incidents in Pittsburgh, as well as throughout the U. S., it stands out particularly because of the totally cold-blooded way this man was slain (completely chained), because of the open collaboration of the City Police, the F. B. I., and the Federal Marshal's office to cover up the facts and manufacture an elaborate story. They had to quickly remove his leg-irons; they had to slap Elizabeth Quick out of panic stricken hysteria (screaming she didn't mean to pull the trigger of her 357 magnum),

and they had to manufacture a story about Hayes being a karate expert and attempting a karate style escape. The many discrepancies and unanswered questions regarding both the facts and the testimony of witnesses solled before the invertible that called before the inquest include the following: 1) Despite testimony to the contrary, there is some evidence that Richard Hayes had on leg irons (which is the usual procedure) and this would belie the whole story of an escape attempt and the karate kicks he was supposed to have been throwing;
2) County Police Officials confiscated the victim's hair from the family (who had it in a plastic bag and had obtained it from the hospital) under the guise of wanting to do a powder burn test to determine if he was shot from a close range. The test was never done because the hair was "lost;"
3) Elizabeth Quick testified that she by Lizabeth Color to shoot because he was "kicking Bill" but at another point she testified that she fired when he was standing upright, turning to his left starting to escape and that the bullet entered the side of his head. The coroner's report, however, shows the wound entering the top of his head, indicating that he was neither "kicking Bill" nor turning to run; 4) Her partner, William Oskin, a 6'4" 230 lb. young man testified that he


hit Hayes on three or four different occassions, knocking him backwards, and once into the Post Office wall. He said that he had a weapon but decided not to pull it because the situation didn't warrant it. Yet she, 20 feet away (according to her testimony) pulled her weapon, very nervously pointed it and "it went off" in her trembling hand.

These are just some of the more obvious contradictions already evident which clearly point out the collaboration and cover-up attempted by the as it continues in its patented trend towards fascism (rule by open force and terror). Fascism is being resorted to by the U. S. Bourgeoisie resorted to by the U. S. Bourgeoisie ruling class as their worldwide empire is being uprooted from its foundations. Just like Somoza in Nicaragua, the Shah of Iran, and the murderous Junta in Chile, they will stop at nothing in their last ditch efforts to stem the rising tide of the people's resisthe rising tide of the people's resis-tance. When they cannot maintain their cover — "democratic" rule—they quickly resort to military means. But rather than curbing the peo-

ple's resistance, these incidents arouse the people's resistance even more. The black community and progressive people within the multi-national working class are fired up over this incidence and have organized a coalition of organizations and individuals called The Richard Hayes Coalition to Stop Killer Cops in order to struggle against police repression, and to push for conviction of Elizabeth Quick. The coalition held a very successful "cas-ket-march" through downtown Pittsburgh in driving cold rain to the site of the murder. A militant closing rally included speakers from the Political Prisioners Solidarity Committee, the Revolutionary Communist League (M-L-M), the African Liberation Support Committee, and the NAACP. The coalition has held several meetings formed various committees, and held educational and moving memorial

an educational and moving memorial program for Richard Hayes and other victims of police repression.

Participation in marches, and coalitions such as the Richard Hayes Coalition to Stop Killer Cops is good because it is a good school of war for people. However, it is not the war itself. Only armed revolution, led by angulard communist party can defeat vanguard communist party, can defeat the forces of imperialism and smash its apparatus of suppression - the State (police, courts, legislation, etc.). Monopoly Capitalism and its worldwide network-imperialism—are what must ultimately be destroyed if Killer Cops will ever be stopped.

African youth, and the Black Consciousness movement, show the liberation movement is unstoppable no matter what repression the racists use. The victories of The Patriotic Front in Zimbabwe show the invincibility of the African people's struggle.

The death of Sibeko is a blow of tragic proportions against the liberation move in Southern Africa, but it will be avenged, just as the murder of Steven Biko by the same white racist agents of imperialism and colonialism will be paid back in blood!

All over the world imperialism is in trouble. Here in the U.S., the fortress of imperialism, the American bourgeoisie, the capitalists who own and control this exploitative system, are "sitting on a volcano" (as Mao Ze Dong said.) The international defeats suffered by the U. S. imperialism in the third world have sent them reeling in decline. The superprofits they use to cool out workers and oppressen nationalities are being burned away by revolution, which is the main trend in the world today!

To try to make their maximum profits, the watch word of capitalism, these capitalists are not treating the American workers like they were in Asia, Africa or Latin America. Cutbacks, layoffs, elimination of social programs, removal of art, music, physical education, recreation, from elementary schools . the phoney oil-shortage so they can make their 1970 superprofits even though the oil producing nations will no longer be bullied by the super crook in the red, white and blue!

In order to suppress the American people in this period of increasing imperialist crisis, the bourgeoisie moves the whole society toward the right. They try to make the people take the weight of their defeats, and because we refuse, the repression is intensified. Despite Jimmy Carter's crapeating grin, and babble about he is making the society better, it gets worse and more and more reactionary. He spearheads the elimination of all the gains made by the people in the rehelition—B0's The Baake decision.

Weber Case, Sears-Roebuck's attack on all affirmative action, the restoration of the death penalty, the reappearance of the Kean & Nazis fascist S-1 bill under another title . . all these things speak to the rightward push the rulers are making.

The recent attack on activist, writer, Amiri Baraka (Le Roi Jones) is another case in point. After beating Baraka and manhandling his wife, all in front of their children, the police then put out the slander that Baraka was arrested for beating his wife. An obvious lie, but a lie clearly aimed at character assanation of this long time black activist and socialist, and throwing mud on the Black Liberation Movement itself. But two of policemen who arrested Baraka and his wife have already been involved in police brutality cases including the shooting of a man in the Bronx. Though the bourgeois owned racist media has been intent on carrying these intentional distortions, despite the fact that Baraka's wife Amina called a press conference even before Baraka got out of jail to demonstrate to the public the police department's obvious lies and attempts at character assasination.

But this is the way the bourgeoisie always attacks. Either by character

assassination or outright violence and murder. The goal is always the same, blunt the spearhead of peoples liberation, to oppose the revolutionary aspirations and struggle of the people, prop up imperialism and its attendant sicknesses racism and the oppression of women. But imperialism is doomed! The most important development of the 60's in the BLM was the emergence of Malcolm X as spokesman for the black masses, winning the BLM away from its temporary leadership by the Black bourgeoisie and petty bour geoisie. When Malcolm first appeared the leadership of the movement had put forward slogans like We Shall Overcome, Turn the Other Cheek, Non-Violent Revolution bolstered by the revisions CPUSA, and Malcolm X Countered them with the political lines of the black masses, Self Deter-mination, Self Respect and Self Defnecs. And under Malcolm's influence the entire movement changed, and in a few years, revolutionary nationalism, self defense, attention to Africa began to dominate the BLM. For instance the student movement, when influenced by the pol line of the blk. bourgeoisie was called the student non-violent coordinating committee, with a pacificst as chairperson. In fluenced by Malcolm X's line they dropped the non-violence from the name, and succeeding chairpeople were Stokely Carmichael, whose slogan "Black Power," was a further popularization of Malcolm's call for Black Nationalism. And then Rap Brown who called for open rebellion, and said that the black rebellions were rehear sals for revolution!

Malcolm X was assasinated by the U. S. state because once he split from the nation of islam it was clear that his direction was no longer cultural and religious nationalism, but anti-imperialism and revolution! His death left the national movement in a shambles, principally because there was no Communist party in the U. S., no revolutionary party guided by scientific principles to turn the spontaneous workers movement into revolution, that is why the fire of the 60's sub-sided

Without a communist party, once Malcolm X was murdered, the black petty bourgeois gravitated to the leadership of the BLM by default, because usually the middle class attaches themselves either to the bourgeoisie or the working class! In the late 50's they had attached themselves to the black bourgeoisie, singing we shall overcome, in the 60's they attached themselves to the black masses because of Malcolm's leadership. But once he died, the BLM was dragged off into cultural nationalism on one hand, with its idealism and metaphysics,

trying to impose pre-capitalist African culture on the black proletariat as a prescription for liberation, or into the pop art gun cult Eldridge Cleaver transformed the Panthers into. Despite the rhetoric, both the gun cultism and cultural nationalism began to tie in more and more to reformism, because the petty bourgeois leadership of the BLM post MALCOLM began to attach itself more and more to the black bourgeoisie, and black power shortly camely to mean electoral politics only Not Malcolm's cry of Self Determina tion, which finally is the bottom line for black people in our struggle for democratic rights. Because the basic democratic demand in the U.S. for the Afro-American people is Self Determination for The Afro-American Nation in the black belt south, Liberation for the Black Nation! That is, political control over the lower south, the homeland of Afro-Americans in the U. S. where even now 52% of us live, 8 out of 10 of us were born there, and outside of the blk. belt we live in 26 urban centers, whose connection with that cry for Self Determination must be community control, the most developed application of democratic rights. Without self-determination for black people in the South, political control of the South the Afro-American Nation, democratic rights in the North, West & C. is meanless. It is impossible to be "equal" without political power. Equality without po-

litical power is a sham!

By the mid 70's the BLM had openly split around the question of nationalism or socialism, many of the national organizations prominent in the 60's and early 70's had become marxist organizations. But too often, the public acceptance of Marxism, was not accompanied with thorough understanding, and a great many of the positive developments of the 60's were abandoned because people felt they were not "marxist oriented." People who were able to organize 1000's of people in the 60's suddenly did not understand how to do it, based on book worship and dogmatism.

In the late 70's revolution is still the main trend, but we are in a bourgeous state actively seeking to move the entire society far to the right, despite the smiling capitalist lacky, Jimmy Carter, & his rhetoric about human rights. The Baake decision, the Weber case, Sears Roebuck's supreme court attack on all affirmative action programs, the re-intro-

duction of S-1 under code name "re-appearance of Klan and Nazis, the attack on all the gains of the 60's, all make it clear about the direction and goal of these attacks. The U.S. Imperialists are in an economic crisis, like imperialism all over the world. They are getting kicked out of everywhere. Since Viet-nam they have been in open decline, the new imperialists, the soviet social imperialists (socialism in words, imperialism in deeds) have actively and aggressively sought to run in the back door everytime the U.S. was being kicked out the front door. This will eventually lead to WW3. Meanwhile, 3rd world revalation means the continuing and ever sharper loss of the superprofits brought about by superexploitation of the 3rd world, and with this loss of profits the bourgeousie, the U.S. ruling class in order to insure maximum profit must drop the weight of its losses onto the backs of the multinational working class. The layoffs, cutback in social programs outlined by Carterhis state of the Union message, while simultaneously spending more on military hardware, are the results of U. S. imperialisms defeats all over

the world! In Nwk, black bureaucrats have cut out music, art, physical education out of the elementary school curriculum, saying it means "back to basics" But in reality, merely reflecting Massa Jimmy's speech which he made for his massas, the 6/10 of 1% that own this country.

Despite the move to the right, the struggles of the working people increase everyday in opposition to the growing reaction. The black united front of Crown heights rose up to fight against national oppression in Brooklyn, specifically the "killer cops" whose role it is to keep us "in our places" – submission or death. The United League of Tupelo rose up

in opposition to national oppression in the black belt, carried via the bloody klan. Peoples opposition to the legal lynching of Gary Tyler, Dessie Wood, Assata Shakur and Terrence Johnson, all show that even though the Bourgeoisie is trying to move to the right, the people will fight fi

more black people are coming to understand that black liberation will be a product of socialist revolution, and that the main democratic demand of the people must be self determination for the nation in the south, liberation for the black nation! The central task of all revolutionaries remain however, building a revolutionary m-1 party based on the most advanced members of the working class, that can draw together a massive united front of the exploited and oppressed majority and utilizing armed struggle smash capitalism and build socialism.

iod of the complete emancipation of all oppressed nations, i.e., their free-dom to secede." (C.W. Lenin, Social-ist Revolution and Self-Determination, Vol. 22, p. 146.) The motive of black struggle is Black Liberation, but we must relate it directly to Socialist Revolution, so that land division is the democratic thrust which is the first motion of voluntary socialist union. Failure to want to break up huge capitalist farms for peasants constitutes "Imperialist Economism" . . . and neglects the stage of democracy - The other demands of Self-Determination of the Black Belt in the 1928 document spoke to: "b. Establishment of the state unit of the Black Belt (which meant 'the bringing together into one governmental unit all districts of the South where the majority of the settled population consists of Negroes' as the unit of state power; c. Right of Self-Determination. This means com-plete and unlimited right of the Negro majority to exercise governmental authority in the entire territory of the Black Belt as well as to decide upon the relations between their territory and other nations particularly the United States."

Self-Determination has been roundly misinterpreted by a host of opportunists and chauvinists. But Self-Determination means just that, the right to decide. "This is the meaning of self-determination: that the Negro people, in full possession of their homeland, have the right to decide the political

SCARED STRAIGHT

AUTHOR COMMENTS ON PRISON

THE LIFER'S GROUP: THE BLIND LEADS THE LAME

The revolutionary impetus needed to bring about change in the prison system is in serious danger of evaporating into still more empty anger and facil posturing by men and women prisoners who, try as they might, cannot swallow what they have been condi-tioned to love and cannot love what they must swallow: bourgeois capitalist values. This is acutely pointed out when one views the thrust of the Lifer's Group at Rahway prison in

New Jersey.

By definition the Lifers are made up of some the most rebellious, if not revolutionary, men. But they have become imbued with a sense of helpless ness - - which has to be the worst feeling in the world when one has proclaimed, but more likely imagined, oneself to have the heart of a lion. Helplessness, combined with the special loneliness of a convicted felon, an and a heavy dose of false pride can distort any reality . . . Stronger than death. How else to account for so many prisoners dying for loneliness, for trying to feed false pride?

Thus I am disturbed by prisoner organizations like the Lifers - - not because their hearts aren't in the right places (I'm sure some few are) but be cause they don't seem to understand their technique for getting kids to conform is, at best, anachronistic, and, at worst bullshit. The kids who listen to the noisy prattle of empty threats know that the convicts are, in reality, just putting on a piece of egoistic show biz, a jive bluff backed by no authority save emotional bombast. It all ends at the front door in any case.

To ask kids to conform to a system ······

that they know rejects them is to deal in misconception in the extreme. It is an insult because the kids, like the average convict, are black and poor members of what is now being called the "Underclass" - and must have, first of all, a way of dealing with bare survival in old, decaying cities, rather than to inculcate the sterile values of and Joan Suburbanite. It is the Lifers who need straightening out; their tribute to and rehashing of middle class liberalism and reformism will never go far enough to correct any thing, muchless really change any-thing. Wearing their defeat on their sleeves, the Lifers forget that kids only really listen to winners who demonstrate ability to rise above America's social, economic and political bullshit. Who, in an oppressed situation, wants to hear a bunch of hot air which systematically negates real needs saying in effect: "The system is okay, it's

just me and you who are fucked up." Apologists for capitalist-racist America have come as readily from the slave-quarters as they have from every other nook and cranny in this society. I don't believe the majority of the mo-tives have been malicious; I do believe, though, that they have been willfully self-deceiving because their hope is, has been, so all-consuming . . . but hope has to have a reason to be, and it will not be satisfied - because it can't - - to live on itself. There is no redemption within a dead system, a system that is literally begging to be changed. Unreasoning hope, as displayed by the Lifers will not make life any better nor any more tolerable. Only the spirit of Attica will prevail because the sacrifice is, in the final analysis,

An exerpt from Nathan Heard's new unpublished prison novel

Breakfast had seemed particularly lousy this morning to Beans: a daub of blackstrap molasses between two slices of stale bread, soft only in the middle of the sandwich where the blackstrap had soaked through. There was a slice of fried bologna so thin that one could almost read a newspaper through it; a bowl of milk, which one could drink or ruin by letting the Lineman behind the steamtable plop a ladleful of mush (that was alledged to be farina but went down the gullet like lumps of gravelly grits) into it. A paper-thin pat of slightly rancid margerine was speared from a flat pan of cracked ice and unceremoneously, depending upon one's "Killer" reputation or the serv-er's mood, plunked onto the tray. Hot, unsweetened coffee completed the morning meal. The coffee was supposed to have sugar in it, but the kitchen detail had long years ago insti-tuted the practice of selling sugar for cigarettes or drugs or liquor or sex, so very little sugar was available for the very little sugar was available for the pandemically indigent bulk of the population. No kitchen officer in the history of the prison had ever succeeded in stopping the jail's sugar black market, or "swagging", as the enterprise is known. And this was largely true because the officers to a man were natt known. And this was largely true because the officers, to a man, were part
and parcel of the thievery; every 500pound bag they allowed out of the
storeroom meant two hundred and
fifty pounds in their homes.

Beans reflected upon this, among
other things, as he sat on the tripod in
his call cinning the still injunction to of-

his cell sipping the still piping-hot cof-fee from his tin cup, which acted as a kind of inferior thermos for hot coffee and cold drinks. Officer Jamison, The Petty, was working seven-wing today which was the reason Beans sat on the tripod instead of his bed. Jamison often wrote charges for unkempt-ness when he was unable to find something else to mete out his particular brand of justice upon. Beans sat waiting for the work-bell to scream.

In spite of all the reasons he had for brooding, including the ominous cloud of ambivalence hanging over his involvement with the inmate work strike, Beans felt, all, a con-spicuous elation. He had put in for a job-change to the kitchen-detail and the decision of the Classification Board was due back today. There was a grand excitment threading through him. Upward mobility in the making, like better food and better circumstances, more days off his sentence. Yes. He had good reason for wanting more time off

So needed that kitchen job; desired it with a passion, and the mere chance to eat good every day was not the greatest of his considerations. To eat good, however, was the main reason for most of the dudes on the detail, though they soon found how hard it was to get near the victuals with im-For the goods were controlled by only a few guys, with the hack's permission of course, and they had learned their lessons of control of many by few with thoroughness. But the true catalytic agent for Beans was the singular emotion of deep love that he still felt for Denice . . . it had not been altered by the long years of frus-tration and self-imposed separation. The job paid the most in "work-time" was the highest stipend proffered and was the highest stipend profitered (40 cents per day) seven days per week instead of the usual five-day work schedule of the vast majority of prison jobs. Working in the kitchen meant he could knock seven days per month off of his sentence, so that he only served twenty-three days of every thirty. The kitchen would get him to Denice sooner and that, for him, was raison d'etre enough to hurry home. Now it is certainly no longer a servet that there are many dudes to

cret that there are many dudes to whom the prison milieu is home. Afwhom the prison milled is nome. Af-ter having traversed, as so many of them have, the length and breadth of municipal, state and federal penal sys-tems from preteens to forever, they have become quite institutionalized they may not even know or like it, but

tices; and "pressure" from the governwould be to no avail either.

Thousands of corporations would dump existing programs which they never wanted in the first place. And the right to collective bargaining would be eroded.

WHY IS AFFIRMATIVE ACTION SO IMPORTANT?

Confronted by the powerful freedom movement of the 1960's, the government was forced to strike down overt racist laws and practices. This was a great victory, but millions still could not get a decent job or educa-tion because of "hidden" discrimination and biased testing for 'qualifica-

Dissatisfied, workers, women and students militantly demanded a com-plete end to racism and sexism. They fought for and won programs which forced biased employers to take af-firmative action by admitting, hiring, promoting or paying equal wages to qualified women and minorities. En-forced by a powerful people's movethese programs are part of the overall struggle of the American peo-ple for democratic rights. Because of the international crisis of capitalism the U.S. bourgeoisie is trying to force oppressed nationalities and women back "in their place" as part of the overall wave of cutbacks, layoffs, and rightward movement all designed to maintain maximum profit and eliminate the gains of the 60's. This is why affirmative action is a focal point of struggle between racists and antiracists today.

IS AFFIRMATIVE ACTION "RE-VERSE DISCRIMINATION"?

But have anti-discrimination pro grams gone too far-to the point of 'reverse discrimination' against white males as Weber claims? The facts say no. Minority income is still only 60 per cent of white income, unemployment is more than double. Another generation of third world youth is being condemned to the streets by joblessness. Women earn 57 per cent of male wages. Clearly programs which combat these inequalities need to be expanded, not eliminated.

DOES AFFIRMATIVE ACTION VIOLATE SENIORITY?

Affirmative action is perfectly consistent with the seniority principle.

Both promote equity among workers

and oppose arbitrary discrimination by employers against any worker. Unfortunately seniority has often been manipulated to reinforce the last hired, first fired status of minority and wo-men workers imposed by discriminating employers. The program at Kaiser, however, is a fine example of workers, however, is a fine example of workers voluntarily using seniority to promote democractic rights through the collective bargaining process. Brian Weber's suit is an attack on the collective baraning process. gaining process.

WHAT IS THE REAL ISSUE?

The issue in the Weber case is: Are programs which force employers to remedy racial and sexual discrimination by hiring or promoting qualified women and minorities legal? Or should racism and women's oppression go un-

Racism is the systematic separation of people on the basis of 'race' or color, for purposes of exploitation and oppression. People of color have had their land stolen and been forced to labor as slaves, contract laborers, braceros, and last hired-first fired indus-trial reserves. Minorities and women been made the shock absorbers of U.S. captialism, smoothing the way for others by doing the dirty work and

. But the question at the present time is not this. As long as capitalism

rules in the United States, the Communists cannot come out against gov-ernmental separation of the Negro

United States, communists cannot come out against separation; but at the same time, this does not mean that communists support reactionary bourgeois separatist schemes. What is clear is that it is the right of self-determination that is upheld at all costs, and it is an error as the document suggests to think that the right of self-determination is revolutionary only if it means separation. The right to exercise state power over the area by the black majority is truly revolution-ary. But in our current political work, must also stress that regional au tonomy has been a successful method of resolving the relationship of liberated nations within a multinational socialist state, but certainly voluntary union with the United States nation union with the United States nation under the dictatorship of the proletariat. In any view, the liberation of the Black Belt before the proletarian revolution of the United States nation would cause the liberation of the black nation. They play on the hardship faced by all workers and appeal to racism and chauvinism in order to prevent a united working class fightback.

back for all progressive people. Three great democratic movements-oppres-sed nationalities, women and labormust recognize their common interest in defeating the racist Weber case and combine with all democratic forces to

But the right of the Ne groes to governmental separation will be unconditionally realized by the Communist Party; it will unconditionally give the Negro population of the Black Belt freedom of choice even on this question. Only when the prole tariat has come into power in the United States, the Communists will carry on proganda among the working masses of the Negro population against separation, in order to convince them that it is much better and in the inter est of the Negro Nation for the Black Belt to be a free republic, where the Negro majority has complete right of self-determination but remains govern-mentally federated with the great pro-letarian republic of the United States.

nizing and struggling for Liberation of the black nation and relating that to the struggles for democratic rights, of the black oppressed nationality and the overall struggle for socialism. And it will be the active struggle for an end to their national oppression (and its super economic exploitation) which makes the black proletariat a leadingforce in the thrust for Socialist Revolution. And this national oppression leads directly to the struggle for the liberation of the Black Belt Nation.

It is the question of self-determination that plagues the black people. In the face of chauvinism form "friends", national oppression and racism from imperialism, and the cultural aggression suffered by some black petty bourgeois socialists. The Black Liberation Movement is not just a struggle against racism, it is a struggle for power! This is the validity of Black Power and why we go backwards if we think that black cries for Black Power were reactionary. What was reactionary is not seeing that it was only the defeat of imperialism that could bring Black Power! Haywood puts it like this: "Even with the elimination of legal discrimination and the abolition of exploitation, the historically-formed inequality - the economic and cultural disparity between Negro and White will not disappear with one blow; the age old rancor of the oppressed Negro age old rancor of the oppressed Negro people will not disappear; nor will the deeply ingrained white chauvinism among the white masses. The Negro masses in the Deep South must have guarantees in the concrete form of political power to protect their equality. It is impossible for the working class in the United States to organize an effective revolutionary movement and advance to Socialism without fighting for full freedom to the Negro Nation in the Deep South; that is to determine their own fate . . . They will have both the right and the means (the state apparatus) to determine their future relations with the United States nation." (Haywood, For A Revolutionary Position On The Negro Question.) We must show that the Black Liberation Movement, in all as pects, is part of the struggle to make proletarian revolution. The call for self-determination of the Afro-American nation is a part not only of the struggle of oppressed nations and peo-ples against imperilism, which is the motor of revolution around the world but is part of the international prole-tarian revolution. That is, in order to liberate the black nation and win dem ocratic rights for blacks anywhere in the United States, there must be a Socialist Revolution made by the multinational working class. We must not make Black Liberation an "automaton of socialism," that is, incorrectly imply there is no need to struggle for Black Liberation, as revisionists put out, because the only struggle is for socialist revolution. Genuine communists know that the struggle to liberate the black nation is a part of the struggle to destroy capitalism and build socialism, and to must not be liquidated. We are not asking, as narliquidated. We are not asking, as narrow nationalists accuse, "for black people to wait for everybody else" before black people make revolution. The fact is that the only revolution that can be made in the U.S. will be the result of the building of a multinational revolutionary Marxist-Leninist Party to guide the multinational proletariat and the working masses in socialist revolution.

To These:

1, The Afro American National Question must be seen in the context of our central task of this period, Party Building. It is a key question to be solved correctly in order that the black sector of the proletariat and advanced elements of the black nation and black oppressed nationality be drawn into the new Marx

- Black people are an oppressed Black Nation whose land base is the Black Belt South. Everywhere else in the U.S. they are an oppressed nationality. We struggle for Liberation for the Black Nation and Socialist Revolution. We are Marxist-Leninists whose ideology is Marxism-Leninism-Mao Tse Tung thought.
- The Black Nation has not been "as-similated" into the United States Nation and will not be under capitalism. Assimilation through the productive forces of imperialism is the program of the bourgeoisie black and white and the revision-
- 4. Both the black bourgeoisie and petty bourgeoisie have a dual char-acter. National oppression makes sectors of them both potential allies under certain conditions, though more and more the black bour geoisie is becoming comprador in character. We will unite with the progressive sector of the petty bourgeois, influence the middle sec-tor, and relentlessly expose and attack the reactionary sector which

serves the bourgeoisie.

We should also conduct a "carefully worked out" campaign against the petty bourgeois preacher-agents of imperialism as suggested by the Comintern 1928 statement.

- It is urgent that we also begin work in the Black Belt. We must work along a set of planned actions to promote the process of the building of a multinational vanguard party, waging unyielding struggle against opportunism, especially chauvinism and narrow nationalism around the Afro American National Question, polemicize against incorrect party building efforts of both the right, which is the main danger, like Revolutionary Community Party (RCP), October League, and the "left" such as the Dangerous Duo (PRRWO + RWL).
- 6. We recognize that black people in the USA have a special relationship to Africa, and we will continue to do much political and mass work, proganda and agitation around African Liberation. And continue to struggle to make ALSC viable again, struggling against the "Left" liquidationist sectarianism of the wing and the right danger inside the inside the ALSC as well.

We must also continue to reflect the fact that the struggle between imperialism and the Third World, is the principal contradiction in the world today, and the motor driving revolution around the world. And that the Afro American Nation in the USA is part of that struggle against imperialism, which adds another revolutionary dimension to the fact of the black proletariats key role in the struggle against U.S. capital, along with the rest of the multinational proletariat. We must make it clear that the Superpowers are the main enemy of African Liveration and that Soviet Social Imperialism at this time is the main danger to the independence of the Third World peoples and the peo-ples of the world, and represents ples of the world, and represents the main danger of war in the world today; but also point out the dangers of neo-colonialism as a growing form of imperialism in Africa. Our slogans must touch the thrust for equal rights and self-determination, but seek to join the Black

Mainly because a revisionist clique led by Kruschev (and later Bresnev) restored capitalism in the Soviet Union after the death of C. Stalin. This turned what was once the stronghold of socialism into a Social-Imperialist country (socialism in words, im-perialism in deeds). The restoration of capitalism serves as the material basis for social-imperialism. Revision-ism now centered in the S. U. where ism now centered in the S. U. where it exercises state power, is also pushed throughout the world by various revisionist parties, the main bansit in the U. S. being the CPUSA.

American Exceptionalism — revisionist theory put forward by leaders of the CPUSA in the late 1920's. This

theory says that American capitalism has particular features that make it different from other capitalism. That American capitalism is still in its young and vigorous "free enterprise" stage, and has not reached its monopoly stage. Therefore, there could be a peaceful transition to socialism by extending democracy throughout the country and raising the level of the productive forces.

States, in his State of the Union address, calmly explained to us that the government for the next fiscal year will be spending more on military spending and less on social services Social services includes Housing, Edu-cation and Welfare, all of which we here in Newark are nationally known

of have the worst of.

In reference to the Board of Education's "program modification" and the
laying off of teachers, security guards,
aides, and cafeteria workers we have to
understand just what is the root cause of our problems and then, like our parents used to say "we can get to the bottom of this".

The root cause is imperialism and here in the U.S., specifically U.S. imperialism and the fact that it no longer has hegemony in the international world market and is therefore not able to demand and receive large trade exchanges from weaker countries is coming home to working people all over the United States. This stems from the fact that the U.S. has continually stuck to its policy of aggression in other countries, propping up illegal governments such as Iran (before the revolution of the people) Israel, Rhodesia and South Africa and finally in its foot of the people is a constitution o frantic military arms race with the So-viet Union, the greatest menace to world peace and tranquility. So whenever a country struggles against and runs the U.S. out of its country such as Kampuchea (Cambodia), Vietnam, and Guinea Bessau, then that means the U.S. has less to steal from and less another country that it can drop its goods on and even worse, it has lost another source of resources that it can plunder under the guise of "aid". This has led to the military budget and

lopsided development of the national economy and increasing inflation which really means depression. The reason for this is because the rulers of this country see it more important to secure their financial interests in other parts of the world than to see that the people here in our society are guaran-teed proper food, clothing and shelter. Witness the U.S. sending billions of dollars of equipment to countries like Saudi Arabia, Israel, South Africa, and others that are "sympathetic" or "-allies" of the United States like the Philippines for example. And as this group of allies and friends gets smaller and smaller this means that Rocky (David is still alive and running Chase

Manhattan) have to make their maximum profit so cities like Newark must take the weight and make sure the capitalists continue to make maximum profit off of our labor which is why they plan to raise our living costs (such as gas, food, oil, and basic utilities).

Other problems such as overproduction in agriculture is also very important to us here in Newark. After having three (75, 76, and 77) good harvests and not

Meanwhile Gibson has managed to SAVE 29 million dollars as a surplus, by depriving the people of services. Gibson says Congress deprived Newark of "anti-recession" aid and so there is 11 million dollars less to work with. A bizarre situation, \$29 million surplus, but \$11 million deficit? If Carter and the state government are to blame why doesn't Gibson mobilize a march on Washington rather than put the weight on the people.

In Education the cutbacks are: 26 Home Ec teachers, 17 Industrial Arts teachers, 22 Physical Ed teachers, 22 Librarians, 43 Recreation teachers, 22 Recreation directors, 65 Cashiers, 36 Bus Attendants, 36 Attendance counselors, 65 Security guards, 582 Aides, 706 substitute teachers, 39 teachers termed "excess" and various other personnel which will result in the lowering of services.

height of bureaucratic double talk designed to hide the facts rather than reveal them. For instance, the cuts in Home Economics, Industrial Arts Home Economics, Industrial Arts (shop), Physical Education, Recreation, Art and Music teachers (included among recreation and "excess" teach-ers) removes those programs from elementary schools. These specialized sub-iects are now to be taught by the regular homeroom teachers. Supposed-ly, the basis of these cuts is philosophical rather than fiscal (financial). Sharif Kittrels and company say the removal of art, music, physical ed, shop and recreation will allow the students to go "Back to Basics". But actually teachers will have less time to teach basics if they must pretend to teach art, music, physical ed, etc. and these subjects are in reality lost to our children permanently!

The firing of Librarians at the same time one is babbling about improving reading? Only a jackass could believe such a lie. In truth 1 librarian will now have to travel to several schools (4 minimum) and while at one school the others' libraries are closed! *The state norm* is 1 librarian for 500 students, in Newark, where reading scores are already 2 and 3 years below the national norm Sharif and company are saying 1 librarian per 1,640 pupils. Reading scores will plummet even further.

People's Resistance to School Lay-offs in Newark

U.S. imperialism is in great disorder. U.S. imperialism is in great disorder. Its main source of super profits is being drained away with the main trend of revolution throughout the third world (Asia, Africa, and Latin America). The super profits are from the exploitation of labor and resources of the people and natural resources in the third world. The lay-offs and cut-backs in social services to working class people in the U.S. are a *direct* result of U.S. imperialism being put on the defensive. Education is one of the social services being hit the hardest in lay-offs and budget cuts. In Newark, a city made up largely of oppressed nationalities, the school budget cuts have hit us like a "slap in the face". The Newark Board of Education (members appointed by the Mayor) has stripped the ele-mentary schools of all its trained cul-tural and vocational personnel, along with its bus attendants, librarians, school aids, cafeteria workers, and 5 security guards. The people's resistance to these mass lay-offs has been the 5

Gibson, Sharif, Elected School Board 'Thorough & Efficient'

selling the goods at prices that the American people could afford they are then forced to cut prices for the goods coming from the farmers because they have an overabundance of produce. Then this means that the farmers must take the brunt of this and cannot afford to produce for the next year unless they are given more money. WHICH IS WHY THE FARMERS WERE IN WASHINGTON, D.C. RECENTLY RAISING SO MUCH HELL. But what the capitalists will do instead of solving their problems they will boost up our prices of produce and make even more money and at the same time starve the farmers.

Inflation and high unemployment are two of the most important problems here in the Newark/New York area and nationally. In the first half of 1977, food prices rose at an annual rate of 13.6%, heating rose 19.2%, medical fees rose 10.1%, gas and electricity rose 11.4% and overall consumer prices for the whole year went up 6.5% as against 4.8% in 1976. These two problems coupled with the U.S. working people struggling more and more against monopoly capitalism in the forms of strikes and job actions makes our work here in the U.S. more serious and needs more work in terms of explaining the root cause of our oppression and therefore paying the way for resolving our problems.

forming of a broad coalition of students, parents, teachers, cafeteria workers, and community activists.

The coalition grew out of the community's opposition to the Board's lay-offs and restructuring of the ele-mentary school curriculum. The "Pro-gram Modification" is a blatant attempt by the Board to deprive our children in the elementary schools of cultural and vocational education (art, music, home economics, industrial arts and physical education). The Board claims, that these skills are "frills" and our children do not need them taught by trained personnel at this early age. They say that the classroom teacher is qualified to teach these courses. The community says that the classroom teacher is not as qualified to teach specialized courses such as music, art, physical education, and industrial arts as a teacher who has been trained and certified in these areas. Also in the high schools, the program modification calls for substitute teachers to "monithe classes and not follow any lesson plans or teach the children, just keep them quiet until the period is

The Community Coalition is strongly

opposed to this attitude and "Program Modification" that deprives our children of their democratic right to quality education. The coalition has drawn up demands:

- 1) Rehire all laid-off school personnel;
- 2) Restoration of cultural, vocational and recreational programs;
- 3) Elected school board;
- 4) Recall Gibson.

The coalition has organized and participated in boycotts at various schools to protest the lay-offs and "Program Modification". Some of the most successful school boycotts have been lead by the students at their schools and through their city wide organization, the Student Coalition. Students have lead boycotts, demonstrations, and walk-outs at Arts High, Barringer, and Broadway.

At other schools throughout the city, parents and community workers have shown strong support for mass resistance in boycotts at Roberto Clemente, Clinton Place, Madison, Barringer High School, and other schools.

The coalition is beginning to grow throughout the city. A new and broader unity between the community and teachers can be seen in the coalition meetings. This new unity has matured through the understanding that quality education is the goal of all concerned, the community and the teachers. Only with the combined efforts of both groups can we get the lay-offs rescinded. Parents are understanding that supporting the teachers and other laid-off school workers in getting their jobs back is an important part of the battle that has to be fought for "thorough and efficient" education in Newark. At the same time, teachers are learning that the parents will support them in their fight for their jobs back once they understand that the lay-offs are taking away badly needed educational skills which these teachers can provide.

The lay-offs are forcing a unity in Newark that we never had before. More and more people are coming to gether, uniting on struggling against a common enemy, the Board of Education and the Gibson clan, the tools of the bourgeoisie. The oppressed are resisting the oppressors and the people will surely win!

him over the corrupt and racist Hugh Addonizio. In education, for instance, the convention platform which Gibson promised the people to uphold said:

but now he represents the essence of opposition to this correct line. Obviously, the real dangerousness of the man is that he was elected out of a militant peoples struggle, but now he is used by the bourgeoisie to attack the people. The so called "program modifications" in Newark's education system are racist to the bone in keeping up the bourgeois super exploitations of the oppressed nationalities which is part of the basic social organization of capitalism. To have these modifications carried out by a negro gives them more creditability in the largely Black and Puerto Rican city of Newark, and allows the rulers to sidestep the obvious charge of racism.

And of course even stooges have their stooges. Witness Carl Dawson/Sharif the man with the grey flannel suit, the old organization man of the 50's who could only join the Muslims now post Malcolm and post Elijah when the emphasis is on business and religion rather than resistance to Black National Oppression! Dawson had a reputation around Newark for most of his life as a "stuck up" "white boy" who despised Blacks, now under the cover of his brand new "Islam" he can carry out, as President of Gibson's hand-picked Board of Education, outrages

against blacks (and all the people of Newark) that no white bureaucrat could get away with!

What is nastier still, is despite Dawson-/Sharif's lies to the contrary, he fought openly against the people in the late 60's and 70's, when he worked for Hugh Addonizio against Gibson, as a henchman of Larrie Stalks! This shows as well how completely Gibson has turned into his opposite since he has united with most of the old Addonizio negroes and raised them to high up patronage posts such as the one Sharif holds which pays \$21,000 as a Gibson "aide".

It also further points out how severe is the need to get rid of the Gibson hand-picked Board of cronies and patronage appointees and have an elected Board of Education. 600 Boards of Education in New

Jersey only 24 are appointed!)

Gibson, Sharif, and the Third Blind Mouse, Kittrels, the Superintendent of Schools, have conspired to completely destroy education in Newark with this sham "Back to Basics" which is a catch phrase to initiate a legally inferior school system, separate and unequal exactly like the apartheid system of racist South Africa. And Newark is to become their model Banstustan, where art, music, physical education, recreation and library service are called "peripheral" and "frills", in opposition to 2,000 years of Western Civilization.

And Gibson's hand-picked Board of MisEducation grimly goes along with a decision that will plunge us actually into a pre-human state since there were drawings even in the walls of caves!

What is obvious is that the Gibson-Sharif-Kittrels attack on Newark's children cannot possibly meet the criteria for "Thorough and Efficient" education that the State constitution calls for. A group of parents are already initiating a suit against Sharif and the Board since the apartheid "program modifications" clearly are in violation of the T&E laws. Kittrels' own guidelines dated August 1977 say that a T&E education must enable a student "to learn to express oneself in the fine and practical arts as well as enjoyment of leisure time". Can the firing of all art, music, physical education and recreation teachers do this?

Can the closing of playgrounds and abandonment of youth to juvenile delinquency do this?

To remove formal training in the arts, music and physical education from ghetto schools is racist to the bone. If Gibson and Sharif had brought such proposals to any middle class district in New Jersey they would be laughed out of town, possibly tarred and feathered (not a bad idea)! But many of the youth in ghettoes like Newark only survive because of Music, the Arts, Recreation and Physical Education. The list of nationally known athletes, musicians, etc. coming out of Newark schools is impressive. Most Newark parents cannot afford private lessons for their children.

The firing of bus attendants saying they are "non-essential" and that "it is the responsibility of each student to behave properly" is ruthless. Last year fights broke out in one district that spread to the streets because of conflicts set up by a busing situation. The children didn't create the busing programs, nor did they create the dangers and violence inherent in the oppressive and exploitative system of capitalism and its attendent evil racism. The firing of security guards will leave many schools with small children with no

security guards at all! This means the doors of the schools are locked, possibly creating another danger in case of fire. This also stops parents from coming in the schools to observe during the school day.

The Newark Board of MisEducation has also illegally cut the lunch period to 30 minutes. The state constitution says lunch periods must equal instruction time or 45 minutes. Now children must eat in less than 25 minutes. There is no time left for recreation and relaxation which actually makes the students less receptive for their afternoon classes and rushed in eating!

At no time were parents, teachers or students asked for input in this program modification, which is also supposedly illegal. The goal of Gibson and company is to create a completely separate and unequal school system in Newark. A legally inferior school system such as in the Banstustans of a partheid South Africa.

The Board can run its education program in Newark for 38 million dollars. They have \$53 million (where does the \$15 million go) the problem here is not at this time principally fiscal but this so called philosophy of "Back to Basics" is really a racist attack on the children of Newark's working people, such a program would only be tried in a city where there are a large percentage of Blacks, Hispanics or other oppressed nationalities!

No, Gibson and company are telling us "to hell with your children", but we must answer with unceasing struggle against these mindless messenger boys. Our message to Gibson, Carter and the rest is "We're fired up — won't take it no more!"

It is clear to the majority of parents, teachers, students, school workers and concerned people in Newark that the skin game is exposed. The color of Gibson's skin does not change his upholding of the bourgeoisie's attacks on the People of Newark. A few "black faces in high places" has not changed the oppressive and exploitative capitalist system. Our fight in education is part of the struggle of the majority of people for democratic rights which is the animating drive that eventually will topple capitalism itself!

BROAD ATTACK ON EDUCATION

Education is under attack nationwide. In New Jersey the blows are coming thick and fast.

The Basic Skills Tests (BST's) are an example. BST's were given statewide in New Jersey for the first time last year. Students flunked 43% of the tests. 74% of the students entering county

colleges flunked elementary algebra. It is the school systems which have flunked the BST's! They are an educational disaster area! There must be a major overhaul of the schools in order to bring them up to a reasonable level of effectiveness.

DEMUESTRA EL FALLO DEL CAPITALISMO

Menos Dinero Para Viviendas—

Educacion Y Servizias

Sociales-Pero Mas Dinero Para Las Preparaciones de Guerra de las Grandes Patencias

Hace poco, en su discurso ante el Congreso Nacional, El Presidente Car-ter explicó tranquilamente que el gobi-erno estadounidense gastará más en armas militares en el ano que viene y menos en servicios sociales. Esos, que incluyen aydua financiera para la construcción de domicilios, educación y welfare, siempre han sido peores aquí en Newark qe en cualquier otra parte.

En cuanto al "programa de modivicación" de la Junta Escolar y del despido de maestros y de los guardas, ayudan-tes, y trabajadores de la cafetería, es necesario entender la raíz del problema para poder bregar con la situación.

La causa fundamental es el imperialismo, especificamente el de Estados Unidos porque ya no disfruţa de la supremacia en el mercado internacional, y por lo tanto no puede exigir y recibir las ventajas de negocios de paises menos fuertes. Esta pérdida del poder se hace centir en los trabajadores poder se hace sentir en los trabajadores norteamericanos. La presente cirisis resultó del pólice nacional de agresión imperialista, y del apoyo de gobiernos ilegales como el de Irán (antes de la revolución popular) Israel, Rodesia, y Sudáfica, y finalmente en su contienda frenética de armas con la Unión Soviética la mayor amenza a la transmillidad ica, la mayor amenza a la tranquilidad mundial. Cuando una nación vence a EE.UU. en la lucha libertadora, este pierde una fuente de recursos naturales y también un mercado donde echar sus

productos industriales. O sea, ya no puede aprovecharse del otro país (por ejemplo Kampuchea (Cambodia), Vietnam, Guinea Bisau) mientras la explotación se disfraza de ayuda

Todo esto ha conducido a que la presupuesta militar sea desproporcion-adamente alta, y a que suframos bajo la presente inflación, que es otro térmi-no para la depresión económica. Los gastos militares provienen de la necesi-dad de la burguesia de asegurar sus intereses financieros en otras partes del mundo. A los que mandan no los importa asegurar que los trabajadores de nuestra sociedad tengan una vida de-

cente. Pienses en las armas que cuestan Unidos a países simpatizantes o aliados coma Arbia Saudi, Israel, Sudáfrica, y las Filipinas. Mi entras el número de "aliados" se reduce cada vez más, Rocky (Davis todavia vive y domina el Chase Manhattan) tiene que ganar lo más posible de ciudades como Newark y que aprovecharse cada vez más de nuestro trabajo mientras hace subir el costo de sobrevivir (por ejemplo los precios de gasolina, comida, electricidad y califacción.)

Otros problemas, como el de la sobreproducción de productos agrícolos, tambien nos afectan aquí en Newark. Después de 3 años de buenas cosechas

la mercancia a precios que el pueblo no puede pagar, la administración federal se ve obligado a bajar los precios para bregar con la sobreproducción. Esto quiere decir que los mismos labradores agrícolos tienen que sufrir las consecuencias, y que no pueden producir más mercancia a menos que reciban más dinero. POR ESO HAN ESTADO QUEJANDOSE TANTO EN WASHINGTON RECIENTEMENTE. Pero, la solución de los capitalistas será subir el precio del pan y otros productos agrícolos, subiendo también sus ganacias, y a la misma vez les quitarán aun más a los trabajadores de la tierra.

subió en una proporción anual de 13.6%, la califacción subió 19.2%, servicios medicós subieron 10.1%, el gas y la electricidad subieron 11.4%, y en general el costo de la vida subió 6.5% en contraste con el 4.8% de 1976. La Junta planea evaluar la eficación de los maestros a base de los conocimientos del estudiantado. Pero, ya se sabe que los muchachos están poco desarrollados escolásticamente, gracias a las condiciones del sistema educativo: un alto nivel de desempleo, el racismo, el sexismo, y más que nada el sistema raccionario del capitalismo. Una sociedad caótica tiene que producir un sistema educativo caótico.

FUERTE **ATAQUE** CONTRA LA EDUCACION

El ataque contral la educación opera a nacional. En Nueva Jersey los golpes son frecuentes y fuertes.

Los exámenes de destrezas básicas (basic skills) son un buen ejemplo, puesto que 43% de los estudiantes fra-

casaron al tomarlos. El porcentaje aumenta a 74% en cuanto al examen de algebra para los que ingresan en los colegios del conado (county colleges).

!Lo que ha fracasado es el mismo sistema educativo! Tiene que haber una

reorganización fundamental de las escuelas para que alcancen un nivel aceptable de instrucción.

En vez de los cambios necesarios tenemos los legisladores y "educadores", y otros que hasta proponen dar "certificados de asistencia" a los estudiantes que resultan poco preparados para hegar con los exemples estandor. para bregar con los exómenes estandar-dizados. Fuerte Ataque Contra la Educacion

El contenido verdadero del "plan de evaluar a los maestros" se manifiesta en la intención del gobernador de Nueva Jersey, Brendan Byrne, servidor leal del capitalismo, de cortar 30 millones de dólares este año de la ayuda financiera estatal a los distritos escolares locales. La burguesía quiere que nosotros paguemos por los dispidos futuros de maestros y por eso grita, "Los maestros no ensenan". Byrne quiere ahorrarle a la burguesía dinero y manda al demonio la educación la educación de nuestros hijos.

Lo que tenemos que contestar es, "Al demonia con los cortes de los capitalistas." y asegurar que el lema tenga resultados. Las cortes, las juntas escolares y las legislaturas son, en este país, armas de la burguesía para arre-batarle los derechos al pueblo. Sin embargo, esas instituciones pueden convertirse en vehículos de la voz popular, si sabemos utilizarlas, por ejemplo a través de exigir que los miembros de las juntas escolares sean elegidos y no nombrados. La coalición ha organizado y participado en boycotes en varias escuelas para protestar los despidos y "El Programa de Modificicación". Unos de los más exitosos boycotes han sido dirigidos por los estudiantes en sus propias escuelas y en su organización de la Coalición Estudiantil a nivel minicipal.

Los estudiantes han dirigido boycotes. manifestaciones, y huelgas en Arts High, Barringer, y Broadway.

En otras escuelas por la ciudad entera padres y trabajordores de la comunidad han mostrado un fuerte apoyo a la resistencia masiva en los boycotes en Roberto Clemente, Clinton Place, Madison, y más escuelas aun.

La coalición empieza a cmmcer por toda la ciudad. Una unidad ancha v nueva se manifiesta en las reuniones de la coalición. Esta unidad nueva ha madurado a través de una comprension que la educación dencente y de alta calidad es nuestro objeto común, el de la comunidad y el de los maestros. Sin embargo, el imperialismo estadounidense todavia busca sus super-ganancias, si no puede conseguirlas a través de la explotacion de los obreros del tercer mundo, las ganara de la explotación de su propia clase obrcalde) ha quitado a las escuelas elementales todo el personal con entre-namiento personal y vocacional, junto con los asistentes do autobuses, bibliotecarios, asistentes escolares, trabaja-dores de la cafetería, y guardas de la seguridad. La resistencia popular a estos despidos masivos ha tomado la forma de una ancha coalición de estudiantes, padres, maestros, trabaja-dores de la cafetería y de activistas de la comunidad.

Los despidos y los cortes en los servicios sociales para los trabajadores en los Estados Unidos son resultados directos del imperialismo norteamericano que se ha visto obligado a tomar una posición defensiva.

La educación es el servicio social que más sufre a causa de los despidos y los cortes. En Newark, ciudad compuesta mayormente do nacionalidades oprimidas, los cortes en las presupuestas escolares nos han golpeado como una "bofetada." SUBJECTIVISM



From the same people who gave us "A Nation of a new type" as a new cover for the same old white chauvinism that ends up denying the existence of the Afro-American Nation; the same people that also brought us "The main danger in the Anti-Revisionist Communist movement is Narrow Nationalism"; so it was very plain, even several years ago that the then Revolutionary Union not only suffered from extreme subjectivism but white chauvinism as well.

Then when Chairman Hua, and the Central Committee of the Chinese Communist Party leaped on the Gang of Four, crushing them quickly and dramatically, RCP, which had never bothered to teach its cadres Marxism-Leninism, trembled with uncertainty, and after a typical petty bourgeois and after a typical petty bourgeois philistine performance split in half because Chairman Avakian and the folks around him upheld the Gang of Four. Instead of this there are legislators, "educators", and others who actually propose to give "attendance certificates" rather than high school diplomas to students who end up unable to pass BST's! The real content of the "teacher evaluation" plan is shown by the intention of NJ Governor Brendan Byrne, loyal servant of capitalism, to cut state aid to local school districts by \$30 million this year. The bourgeoisie want some-one else to take the weight for the teacher layoffs they have planned so they yell, "The teachers aren't teachthey yell, "The teachers aren't teaching!" Byrne is out to save money, and to hell with educational needs!

What the people need is to say, "To hell with the capitalists' cutbacks," and to find ways to make it stick. Courts, school boards, and legislatures are usu-ally bourgeois tools for the denial of the people's needs. However they can be used to raise issues and to rally the people, such as the demand for an elected school board rather than an ap-pointed one. Militant teachers' strikes, school boycotts, mass activity among parents, student-teacher-parent unity: these are the means of the people to fight for their educational needs.
