## MURDER IN THE MI KKK Threatens Bessie

On March 9th at 12 pm the Blue Diamond Coal Company murdered 15 miners at its Letcher County, Kentucky, Scotia Mine. Knowing full well that the mine contained large amounts of deadly methane gas, the profit-hungry capitalists sent 150 miners to work anyway. The miners were sent in just hours after the Scotia mine owners had received warnings from federal inspectors that the mine was too gassy to be worked in. (Any mine with 1% methane level is considered too dangerous to be worked. This mine had an 8% methane level and yet the miners were forced to work anyway).

Surviving miners said that their brothers were sent to weld under these conditions, and that a spark from the welder had set off the series of explosions which ripped up steel tracks miles from the site of the explosion. 9 men died instantly. 6

suffocated behind a barrier thrown up to protect them from the smoke from the blast.

Knowing full well that the blood of the miners was on their greedy hands, the capitalists had the Kentucky State Police confiscate the film of newspaper photographers. News film was released only after Blue Diamond ok'd it.

But if this wasn't enoughon Thursday, a second explosion killed 8 more miners and Continued on Page 6

GENERAL STRIKE! Not since 1934 has there been a general the capitalists to keep strike. But every worker knows why this call is being made today. There is hardly a person who is not feeling the effects of sharp attacks on our standard of living.

The situation in San Francisco, as well as the whole country is becoming deplorable for the working class. There is 11% unemployment in this city. As the unemployment benefit funds go dry, the welfare department is making tremendous cut-backs. Childcare through Title 20 is also being cut. Rents in the city are skyrocketing. A four room apartment in the Mission District rents anywhere from \$185-\$250!

Workers in Hunters Point are being thrown out of public housing with no place to go, while homeowners are threatened with increased property taxes (and it was just raised 69¢ per \$100 assesed value).

And yet we are told by tightening our belts! WE are blamed for the crisis of the cities. And, right now they are blaming the city workers.

Since March 31, the 1900 "crafts" workers (a majority are semi-skilled and unskilled workers) employed by the city of San Francisco have been on strike. Salary negotiations with City Hall had broken down over the issues of pay-cuts, a "no strike" agreement, and a daily layoff option. "Muni" (the municipal transit system) has been shut down by the strike after bus drivers voted unanimously to honor the picket lines. Meanwhile thousands of other city workers are still on the job because their unions have settled for meagre wage increases. And now, the executive committee of the San Francisco Labor Council has called for a general strike.

## FATE OF BUSING: PASADENA

Workers and progressives of Pasadena have fought for years for the implementation and defense of the Pasadena School Integration Program. In the last few years, the bourgeoisie has launched a massive campaign to destroy this busing program, and wipe out the hard-won gains of the Negro and Mexican national minority. The pro-busing forces are on the defensive. Despite a valiant try, they barely lost a recent campaign to recall the reactionary Pasadena Board of Education, and the forces of reaction like the Nazi Party and the John Birch Society are gaining momentum.

When the Supreme Court begins hearings on the "Pasadena Integration Plan" on April 24, they will be deciding the fate, not only of Pasadena's plan, but of busing programs throughout the whole country.

Many people have been confused about the busing issue by propaganda which has said "Busing doesn't work" or "Busing causes violence" or "It is better to spend more money on segregated neighborhood schools". In every case Pasadena has proved the opposite. Continued on Page 9

# OFF CUBA!

In the last issue of the Western Worker, Kissinger's trip to Latin America and the building of an anti-Cuba alliance was reported. Since that time it has become apparent that the US is intent on punishing Cuba for its support of the MPLA in Angola and the national liberation movements in Africa. The imperialists' drive toward war is exemplified on the international scene by Ford "scrapping" the word detente in favor of "peace through strength," and his trip to China, which signified the further development of the anti-Soviet alliance.

Kissinger in a speech in Dallas on March 22, has threatened Cuba with retaliation if it continues to support the struggles in Africa against apartheid and colonialism. The Washington Star also reported that the Pentagon has laid plans to invade Cuba if it continues on this path.

Our government and the big banks of this country are determined to stop the advance of the revolutions in Africa and Latin America. With the coup d'etat in Argentina, the Argentinian people face undisguised terror, violence and oppression. There is no doubt that the US government, through its many arms, was instrumental in the overthrow of Mrs. Peron, and the establishment of the military junta. The two continents, Africa and Latin America are huge reserves of political, economic and military strength for the ruling

Latin America in particular, has always been the "backyard" of the imperialist strength. From their stepping stone in the Negro Nation and Puerto Rico, the US imperialists conquered Latin America almost one hundred years ago. Cuba's solidarity and aid to the African peoples, is for the imperialists, a harbinger of the future of the role that Cuba will continue to play in Latin America. Although the revisonist Kruschev promised Kennedy that the Cubans would no longer aid the Latin American revolution, the Cubans have always dedicated themselves to proletarian internationalism and have come to the aid of the colonial peoples everywhere.

The interests of the working people of this country demand that they support the struggle against imperialism in these continents. Cuba's role in Arica should be praised and not condemned. It is the duty of all progressive people in this country to demand that Ford and Kissinger keep their hands off Cuba, Latin America and Africa and that our government recognize the legitimate governments in Angola and Cuba.

Our party has as a keystone in our program the call for hemispheric unity. The revolution in the Americas will be a hemispheric one. The US working class must support the heroic struggles of the colonial workers in Latin America. Certainly the imperialists understand the importance of Latin America and have tried successfully to divide the Americas from each other. Cuba has always been the beacon of light for the toiling masses of Latin America. The action by the imperialsits against Cuba must be condemned. The US workers must raise the call of hemispheric unity and applaud the courageous internationalist actions of the Cuban people against imperialism and for national liberation and socialism.

In the past month, we have en a vicious intensification of the attacks against the Mexican national worker on the part of the Immigration and Naturalization Service (INS) and outright fascist gangs.

The INS has carried out deportation raids at NAASCO and many of the factories in San Diego. The number of INS agents here has doubled. The result has been that thousands of workers have been deported.

Terrorist Gangs In the last 2 weeks terrorist gangs, both Anglo-American and Mexican national minority have attacked the vulnerable Mexican national workers as they cross the border. The gangs have robbed, insulted, kidnapped, and then raped the women.

## RANK-AND-FILE ON MOVE

On February 21, longshoremen from ports up and down the west coast held a workshop in Wilmington, Calif. The basis of the workshop, called by the International Longshoremen's & Warehousemen's Union (ILWU) Local 13, was the fact that the employers association, the Pacific Maritime Assoc., and the international union leadership colluded to change last year's contract in mid stream.

ILWU Int'l. President Harry Bridges and the PMA changed an important section of the contract without consulting the rank and file nor the local leadership. The Pay Guarantee Plan (PGP) is similar to the autoworkers Supplemental Unemployment Benefits (SUB) Fund where the longshoremen are guaranteed work or an income if laid off. By changing the hours test which determined the amount of the PGP the workers could get, hundreds if not thousands of longshoremen would be eliminated from their right to collect their guarantee.

Even worst, within 9 months, longshore division (not a many injured, sick and older longshoremen could lose a year's eligibility towards their pensions. They could lose their vacations and health and welfare benefits. While Bridges and the companies were forced to temporarily suspend this new hours test, over 50% of San Francisco's Local 10 longshoremen are reported to have already lost their vacations for this year.

voters' resentment against the strikers and so, during the November election, secured easy passage of a City Charter amendment outlawing future strikes by these workers. The Board of Supervisors has learned its lessons well.

This June a Charter amendment will be on the ballot

The PGP, which the longshoremen fought for in last vear's contract struggle, is being used against them, in the form of wage cuts, losing control over their hiring hall, etc.

The workshop was a response to the growing attack by the company and the international leadership on the daily conditions of the longshoremen. It was attended by officers and rank and filers from Seattle, San Francisco, Stockton, Sacramento and Los Angeles. San Francisco, Seattle and Los Angeles represent 60% of the membership of the longshore division on the west coast.

The main topics of discussion were around the inequalities of the PGP, the need to develop a program in the interests of the longshoremen and the fight for jobs. The following is the proposal which came out of the workshop:

WORKSHOP PROPOSAL FOR A COASTWIDE CONFERENCE

The overall resolution of the workshop was to call for a coastvide conference of the caucus) to discuss and propose action around the direction of the union and the contract. The conference would be a rank and file conference open to all members on the coast.

The main aspect of the conference should be to key in on the question of jobs. Various examples were given at the workshop that should be used as a guide line-a) Equalization of earnings or work op-Continued on Page 13

## SOCIALISM: FOR THOSE WHO LOVE THEIR COUNTRY

In the United States of North America (USNA) there are many misconceptions about socialism. The capitalist class of this country does everything in its power to paint socialist countries as "evil" places where there is misery, where the people are powerless and hungry, where there is no progress for the people.

Yet these anti-communists are the same ones that ordered the murder of millions in Viet Nam; that are openly planning to invade Cuba today; that support the expansion of a military budget that maintains over 2,000 military bases abroad; that oppose programs for the unemployed and poverty stricken worker at home; that fully support the fascist murderers ruling Brazil, Argentina, Chile, South Africa, South Korea, etc.

So let us compare, using facts, how people live in a socialist country and how they live in a colony of U.S. imperialism. We'll use Cuba and Mexico as our examples. The facts quoted are the World Book Encyclopedia (1976 Edition).

### MEXICO

Mexico is a neo-colony of the USNA. The US imperialists dominate and control Mexico's economy. US imperialism indirectly controls the government through Mexican rulers who are 30-50% unemployment existed: in the economic and political pay of US imperialism.

Mexico is an extremely rich country in natural resources. It is 17 times larger than Cuba and has 6 times as many people (60.2 to 9.5 million). In Mexico, many valuable minerals are found in abundance and are presently being exploited; large deposits of petroleum are present; one fifth of the land is covered by forest rich in timber; it has excellent fishing waters; and it has abundant farmland. Yet Mexico's riches and peoples are exploited by US imperialism. Mexico's wealth is extracted for the benefit of a handful of imperialists leaving Mexico's people poverty stricken. Cont. on page 10

Prior to 1959: Cuba was a colony of the USNA. Its economy and government were fully controlled by the US imperialists. As a result, each year one million children went without school (2/3 of the children had no primary school to attend); five million of the six million Cubans did not own homes and lived in 'bohios' (huts) without light, water or sewage; 43% of adults were illiterate; some beaches and hotels were off limits to Cubans so they could be used only by wealthy Anglo-Americans and Europeans; corruption in government was rampant; etc., etc.

# SUPPORT THE MOLDERS' STRIKE

STRIKE. Three thousand foundry workers in Northern California, Oregon and Washington went out on an important strike last week, after rejecting company offers for a new contract. The multinational foundry workers. represented by the Molders and Allied Workers Union, face a potentially long and bitter strike. They deserve the unflinching support of all workers.

The San Francisco-Oakland Bay Area foundry workers have been leading the drive for the three-state strike and for democracy within the union. The foundries within the East Bay are at least 60% national minority workers who are among the lowest paid industrial workers in the country. Wages range from helpers at \$4.11 per hour to crane operators at \$4.72 per hour and molders (skilled workers) at \$5.86 per hour.

Foundry workers are important to capitalism. They are part of the backbone of this country. By producing the means of production, they enable factories, mines and mills to operate and produce.

The capitalist class has made it clear that they plan to pin workers against the wall in this year of major contract disputes. The Molders and other contracts were negotiated during Nixon's wage freeze. Now the capitalists are united in their drive for more productivity off the backs of the working class.

More productivity out of us means more profits for the capitalist class. For workers more productivity means longer hours, longer weeks and murderous speedup. This means more injuries. For foundry workers third degree burns, crushed limbs and amputations are common. Currently one out of every three full-time foundry workers will be injured every vear and one in a thousand

But the foundry workers are fighting back against the capitalist class. The striking foundry workers have been struggling hard for the past few months to unite their ranks and make their International union leadership toe the line and follow their militant lead. One of the first ground rules for negotiations set by the International was the mail-inballot. This is directly

contrary to the Union Constitution that requires votes to be held at meetings.

Local 164, which represents 1,000 workers in 28 Bay Area foundries, voted 139-4 to reject the mail-in ballot. The workers organized and threatened an injunction. The International manuevered and ended up forcing this rule on the rank-and-file.

At a strike meeting held earlier in the Oakland Labor Temple workers packed the hall and booed down the proposals by the capitalists, represented by California Metal Trades Association. The union leadership could only offer a few weak proposals and the workers were temporarily disoriented because they would have to work without a contract.

Despite the manuevers by the CMTA and certain union officials, the workers voted to strike through the mailin-ballot. The negotiating committee did not make a recomendation, but rank-andfile members of the committee urged workers to vote no if they were prepared to strike.

Along with wage, cost of living and health and dental plan demands, foundry work-

ers are fighting for plantwide seniority and against speedups and for better health and safety.

The acceleration of the fascist drive against our class requires the unity of all workers - Anglo-American and national minority, young and old, urban and rural, men and women, employed and unemployed, union and unorganized.

Especially important is the unity among the rankand-file of the different unions. This can provide a big push for the whole working class movement against

capital.

The bourgeoisie's assault absolutely demands that all workers support the foundry workers strike. Millions of their fellow workers have contracts coming up soon and millions of other workers face speed-up, unemployment, and harassment. The capitalists are discussing eliminating the minimum wage law for many workers.

Workers must recognize that the foundry workers struggle is no different from that of the farmworkers of California and Texas, the cane cutters of Louisiana, the

The Board of Supervisors of Monterey County has long wanted to close down the coun- health care of the working ty hospital or transform it into a private facility, since the private interests the Board represents aren't making enough profits there. The workers' fight to keep Natividad a fully operating public hospital has exposed the relationship between the county government and the bourgeoisie that seeks private ownership of the hospital. One of the members of the Board of Supervisors, Mr. Ed Norris, is administrator and part owner of one of the private hospitals in town, which will gain if the public hospital is closed.

This struggle has exposed the county government -- they reserve democracy for the rich only provided translation at and systematically crush the rights of workers and progressives to participate in public affairs. Especially, they have tried to keep the Mexican national minority and Mexican national workers from being heard, and have attempted to divide workers of different nationalities by language.

MECHA, the Chicano Concern Patrol, the United Farmworkers, the Communist Labor Party and other organizations and individuals forced them to change the hearing to an auditorium, but the Board still refused to publicize it.

> At the hearing itself, they the back of the room. # FITZSIMMONS **SELLS OUT TEAMSTERS**

After just 3 days of the first nationwide Teamster strike, a "tentative agreement" was reached between International Brotherhood of Teamsters President Frank Fitzsimmons and owners of the trucking industry. Most of the 450,000 truck drivers, whose contract expired

The Teamsters are going back to basically the same kind of conditions that existed before the strike except for a few cents more in take-home pay. Almost every teamster can smell the rottenness of another sellout! This contract struggle from beginning to end, was



April 1st, are back to work. As of this writing, however, a number of Teamsters in 11 Western states are still honoring the picket lines of 1200 members of the International Association of Machinists (IAM) who are striking 21 trucking lines. Also not back to work, in addition to the countless number of illegally fired strikers, are those in jail for their defense of their strike and the union members killed on their own strike lines.

No sooner had the strike began when Fitzsimmons gave the green light to local IBT leaders that the International would encourage interim agreements or a "me-too" situation, where selected freight carriers who would agree to the union's last offer would be allowed to operate while the other companies were on strike.

# WHAT MAKES REAGAN RUN?

WHO IS RONALD REAGAN?

Ronald Reagan on TV again. But this time he's not on the late show, not on GE Theatre or Death Valley Days host. Now, as winner of the North Carolina presidential primary. Californians know him as the Goldwater supporter who spent eight years as governor of that state, serving the bankers, industrialists and oil companies well and earning the hatred of the majority of workers and progressives. How did the star of "Bedtime for Bonzo" rise to such prominence, even to the threshold of the presidency?

Beginning as an "F.D.R. Democrat" Reagan used his acting career as a launch pad to the presidency of the Screen Actor's Guild. During the height of the McCarthy anti-communist pogrom, Reagan assisted the House UnAmerican Activities Committee in ruthlessly purging the Screen Actors Guild of all left-leaning progressives. There is a distinct ring of McCarthyism in Reagan's present attacks on Kissinger an arch reactionary in his own right.

In 1954, Reagan began his career as "corporate ambassador" for General Electric Co., a cornerstone of the Morgan financial grouping. Ousted from the leadership of Wall Street by the Rockefeller interests, Morgan moved steadily toward the National Association of Manufacturers (NAM), where their giant industrials were welcomed with open arms.

In the eight years from 1954-1962, Peagan toured 135 G.E. plants and spoke to over 250,000 workers. Reagan wan't only selling lightbulbs - he was selling the National Association of Manufacturers.

During this period Peagan characterized himself as a "Democrat for Eisenhower" and later, for Nixon. He openly

emerged as a Pepublican in 1964. "I didn't leave the Democratic Party," Reagan explained, "The Democratic Party left me."

During the 1964 presidential election, Reagan campaigned as a "Goldwater conservative." When they failed to put Goldwater in the White House, G.E. and the NAM groomed Reagan to succeed where Goldwater had failed.

The original "Pepublicans for Peagan" committee was headed up by a cabal of rightwing reactionaries closely connected with the John Birch Society and the NAM. This committee included officers of Union Oil, Rockwell International (major defense and arms producers), Litton Industries and the Bank of America. The same interests who backed Goldwater in '64 threw all their weight behind Reagan in the 1966 California Governor's

It was common knowledge dur ing that election that Reagan was supported by the Birch Society and that he refused to openly repudiate them. Rep. John Rousselot, a well-known Bircher and member of the California House of Representatives, recieved wide public attention for his famous question to Reagan - "Do you want us to support you or stone you which will do the most good?"

In his campaign Reagan opposed Social Security, the progressive income tax, Medicare, the Civil Rights and Voting Rights Act of 1964, public housing and federal aid to education and favored declaring war on Vietnam so that anti-war demonstrations could be treated as treasonable offenses.

He saw the "Communist threat" as the # 1 problem facing the US and stated "[the Communist leaders] have not retreated one inch from world revolution... The split in the Communist camp doesn't give me much comfort. The

# SENATOR FROM BOEING

Meet Henry Jackson - the Senator from Boeing. Four years ago, voters across the country had asked, " . . . who?" during the 1972 contest for a Democratic Presidential candidate, Henry Jackson had the advantage of the best-financed campaign. Yet he met humiliating defeat in primary after primary, and finally bowed out before the Democratic Party Convention in August of that year. Jackson has spent the 4 years since making himself known to the public. With his victory in the Massachusettes primary, he proclaimed himself the candidate of the people. In reality he is a powerful politician and master demagogue who would serve his master well - and in doing so usher in fascism. Who are his masters? These are the questions we will answer.

Jackson hails from Washington state. He served in the House of Representatives from 1940 to 1952, and has been a Senator since then. Jackson has rewarded Washington state - the capitalists, that is - for their unlimited campaign funds by pouring billions of government dollars into the industries and

banks of the northwest.

A look at the 1972 contributions to Jackson's campaign will show just how much a "man of the people" he really is: Gulf Oil, \$10,000 illegal contribution; Amerada Hess (oil), \$250,000; Dwane Andreas (agribusiness), \$25,000; Rapid American (garment and beverage mfg.), \$100,000; not to mention the secret money never reported from Victor Carter (L.A. "philanthropist", director of the United California Bank, and sits on the board of the Southern California Rapid Transit District), and the Boeing Co.; and fundraising efforts by Simpson Reed Timber and Weyhauser Lumber which in one night alone netted Jackson \$200,000. Jackson was the only Democratic Party candidate for president who refused to disclose who his contributors were before the 1971 campaign disclosure law went into effect. So in reality these known contributions represent the tip of the iceberg. This year, Jackson has again entered the presidential race with the richest war chest.

These are Jackson's masters - a consortium of petroleum and energy industries, aerospace, timber and agriculture — the four main component parts of the northwest economy. But through interlocking directorships and common stock these "northwest industries" are in fact rigidly integrated into the entire national economy. Jackson's politics are intimately connected to the interest of those capitalists whose investments are mostly concentrated in industry inside the USNA. He built his political career serving the men who make their living by the rape of our land, the sweat off our backs, and plunder of the world's people.

How does Jackson serve? After 36 years in Congress he is one of the most powerful senators in the USNA, and in the best position to steer more profits into the coffers of the bourgeoisie. He is a member of the Armed Services Committee in the Senate. He is chairman of the sub-committee on SALT. He is top advisor on military applications of nuclear power to the joint committee on Atomic Energy. He is the ranking majority

member of the Senate Government Opera-

tions Committee. He sits on the Permanent

Investigations Committee (he joined during the infamous McCarthy era) and the National Security Committee, and is chairman of International Operations. He is also chairman of the senate committee on Interior and Insular Affairs. Jackson holds power - he knows how to get it and how to use it.

### Generalissimo Jackson

Because Jackson has been such a vocal spokesman against detente, we should examine his record on and ties to the military. Then we may understand why cars in Washington sport the bumper sticker: "Henry Jackson has a Military Industrial Complex."

Most rats will flee a sinking ship. Not "Scoop." In the final days of the Vietnam War, Jackson was one of the few who advocated continued aggression, long after most "hawks" hypocritically argued that continued support of the Thieu regime was worthless. He was among the few diehards who were still voting to bomb Cambodia after the last POW had returned. He urged on the imperialist plunder using every lie and distortion possible. If the USNA was to be the savior of democracy, "We must pay the price," he argued. Hundreds of thousands of Vietnamese and US men dead are the price tag Scoop Jackson delivered history.

Fascist Admiral Rickover and retired Air Force General Schriever both regard Jackson as a prime architect of USNA strategic power. From 1961 when he voted against Kennedy's proposal for an Arms Control and Disarmament agency to 1972, when he opposed the SALT talks with Moscow, Jackson has sided with the most reactionary anti-Soviet bourgeois and military leaders, who serve as the backbone of anti-detente agitation in this country at this time. Jackson has served his masters, especially Boeing and other military contractors more dependent on war for profits, extremely well. His power in the Senate, through the various committees, is such that he can make or break military commanders and forced at least one admiral into early retirement.

Much of Jackson's power in the Senate is a direct result of his personal and political friendship with Nixon. During the 1972 presidential elections, the campaign contributors of both read as identical lists. When Nixon gained office he tried twice to take Jackson into his cabinet, once as Secretary of Defense and once as Secretary of State. Shrewd Jackson turned these offers down in favor of one which increased his senate power: (unofficial) floor manager for Nixon's defense budget requests in Congress. This brought about the largest "peacetime" military budgets in the USNA history. Nixon appointed James Schlesinger as Secretary of Defense on the advice of Jackson. The point is, while a Wallace or Reagan can rant and rave about this country's "second rate" military power, Jackson has done more to militarize this country than almost any man in government today

### Pentagon Populist

How does Jackson hope to capture the presidency with such an offensive history of war mongering and wasteful defense spending? He has tried to emphasize his "liberal" domestic policies.

## S.F. WORKERS FIGHT **EVICTIONS**

The struggle of the tenants in the Hunters Point Housing Project in Hunters Point, San Francisco has taken a rugged turn. The capitalists and their tools - the city and federal government - desperately want the hill where these projects are located.

In February, over 200 Negro national minority tenants met at George Washington Carver School demanding guarantees that they would not be displaced. Walter Scott, representative of the City's Housing Authority, made empty promises of temporary housing adjacent to the projects. A speaker from Mayor Moscone's office hypocritically promised that "This is a new day. at City Hall and your voice is going to be heard" - then urged the workers to drop their "impossible" demands!

## LA YOUTH "shot down like a dog"

It is late at night - you are 16-year old Barry Evans, a young Negro national minority worker from the Pacoima ghetto in Los Angeles. You are well-known as a community leader. Only recently you wrote a high school paper criticizing the police and other government agencies for their lack of concern for the rights of poor people in the United States. It is late at night as you walk through the housing projects and are met by two L.A. policemen. And as witnesses watch horrified, you are clubbed to the ground, and as one witness put it - "Shot down like a dog." Barry Evans - another victim of Los Angeles police violence.

The sun is setting as you, Jimmy Blando, a young Mexican national minority worker from L.A.'s Pico Union District, step into a supermarket to make an urgent call. In fact, you are calling the L.A. Police Department because you are concerned for your safety. As you wait for the police to arrive, you purchase a small pocketknife

for protection.

But when the police arrive, you panic, you run down the street and the cops shoot you in the leg. You limp forward and finally stop under a street light at Pico & Hoover streets. But when the cops catch up to you, the officer empties six bullets into your body. The officer then reloads his revolver and pumps another six rounds into your already lifeless flesh. As witnesses watch on in horror, the cops handcuff you, step on your face and tell you not to move. Jimmy Blando - a troubled young worker who sought protection from the police - only to have them gun him down in the street.

These stories are terrible - but true. They happen every day in Los Angeles. In the last year and a half over 75 civilians were killed by the infamous LAPD. Chief Edward Davis, a member of the John Birch Society, has declared the 7,000 man Los Angeles police force to be judge, jury and executioner for the working class youth of Los Angeles and especially for the Negro and Mexican national minority youth.

The two cold-blooded murders described above were only two among a dozen such killings which brought together over 150 people at a mass meeting against police brutality at the L.A. Inner City Cultural Center on March 19. In a real show of class solidarity workers and youth from all over L.A. County, of all nationalities came together to discuss what could be done to end these killings and bring the cops to justice. - No More Deportations!

At the end of the meeting at least a dozen different defense committees joined together to form C.A.P.A. - the and to demand:

1) Suspension without pay and indictment of all officers involved in cases of abuse and brutality.

2) A federal investigation of the L.A. District Attorney's office for lack of indictments of officers involved

3) Elimination of the L.A. "special tactics" squads, such as SWAT & Criminal Conspiracy Squad.

4) Elimination of the Internal Affairs Division, the investigative body of the LAPD, and the establishment of an impartial, "community controlled" agency to investigate charges of police

5) An end to the illegal use of police in deportations

# **DEATHROW LOUISIANA** FREE GARY TYLER!

In Louisiana a young Negro man named Gary Tyler sits on Death Row. Not even 17 years old, he has spent the last 18 months of his life in Angola State Penitentiary, 13 of them in total isolation. A few weeks ago he watched as an electric chair was moved past his cell and into the prison. That electric chair is intended for him. Gary Tyler has been framed! Unless we stop it, his death will be another legal lynching in the Negro Nation!



The Frame-lip In October, 1974, a fight broke out between Negro and Anglo-American minority students at Destrehan High School. real killer is. They have ad-The Negro students were put on mitted seeing an Anglo-Ameria bus to take them off the Coalition Against Police Abuse campus. Gary Tyler sought refuge on that bus. Anglo-American minority students and parents, throwing rocks and bottles, attacked this bus of Negro students. A shot rang out and Timothy Weber, an Anglo-American student fell

After this, all the students in cases of abuse & brutality. were taken off the bus and searched. No gun was found. Not on any student and not on the bus. It wasn't until the bus was driven back to a police substation that a .45 was "found" by police. This gun belonged to the police firing range, and had not been reported stolen or missing until it was "found" on the bus.

On the day of the shooting, David Duke, leader of the Ku Klux Klan, flew all the way from Boston to Louisiana because of this case. (In Bos-

ton, he had been leading antibusing demonstrations). He was determined that this young Negro worker, innocent of any crime, was going to be convicted and executed. The Klan, eager for bloody publicity. staged a "memorial" for the slain youth, held several press conferences, and tried to whip up a lynch mob fever in Destrehan.

At the trial, the State presented one witness who claimed she saw Gary fire the shot. Three witnesses on the bus disputed this, including the bus driver who swore that the shot was not fired from the bus at all. (This man had spent 20 years in the Army). In spite of this, it took an all Anglo-American minority jury less than 3 hours to convict Gary Tyler of first-degree murder. Today, he is the youngest person in the USNA on death row.

The key state witness has revealed that she lied in Court because the District Gary Tyler. Attorney threatened to charge her as an accessory, and get her 99 years in prison if she didn't testify against Gary. The lives of the families of these witnesses have been threatened, and their parents refuse to let their daughters

> Gary will be granted a hearing on his motion for a new trial on April 8th, but his execution date still stands.

Recently, a supporter of the Gary Tyler defense was murdered by a shot gun blast to his stomach as he left a fundraiser for Gary at Southern University. Richard Dunn's only "crime" was that he supported justice for Gary Tyler. Gary Tyler's only "crime" was that he is a Negro in the Negro Nation!

Indian people have come under attack in the Santa Clara Valley.

Recently, a vicious attack against a Negro national

minority family living in a predominantly Anglo-American neighborhood in San Jose occurred. Three thugs yelling that they "want the niggers out of here" kicked in the door to the home. After the scum had been run off the family's property, one of them net: returned and fired a shotgun blast through an upstairs bedroom window. The police arrested the three attackers and cited (like a traffic ticket) two of them for "disturbing the peace" and "unlawful entry'. The third got off scot free, and no felony charges have been pressed against any of them.

The brutal murder of Danny Trevino was met with an immediate angry and militant response by the workers and other progressive elements of San Jose.

The evening after the killing 400 people demanded immediate action against the police officers. A Committee on Public Safety (COPS) was formed to put pressure on the city government to see that the following demands were

3 federal inspectors bringing the total death toll to 26. The Scotia coal operators were so eager to make their millions and get the mine back in operation, that these men were sent in to repair the collapsed mine roof -even though the methane gas remained!!

The site of this mine disaster is a few short miles from Harlan County, Kentucky. Harlan is the site of the notorious scab, anti-labor union, the Southern Labor Union. Most of the miners who died, lived in Harlan County.

Some of the fiercest union battles of the 1930's were fought in Harlan which earned its nickname "Bloody Harlan". In the 1970's Harlan has become a center for the terrorism of the Ku Klux Klan. The KKK has engaged in cross burnings, the burning of workers' homes, threatening phone calls, and warning letters in this community. Recently, the Klan threatened the life of Bessie Lou Cornett. Bessie, an Anglo-American roman, is an outspoken fighter for the workers of Harlan of all nationalities. She is on the staff of the Harlan Labor News. Bessie has been fighting all her life for better working and living conditions in the coal mines of Appalachia, for better housing and for equality for Negroes. The Klan has threatened to "tar and feather" her the first chance they

the threats against Bessie Lou Cornett may seem remote. But remember the horrible day in Ludlow, Colorado in 1914 when the Colorado National Guard, under John D. Rockefeller's orders, burned down the tents of strikers, massacring scores of women and children. Or think about the disaster at Sunshine Silver Mine in Kellog, Idaho in May, 1972. There the mine operators killed 91 miners, poisoned by carbon monoxide gas from a spreading fire deep in the mine which the capitalists did not tell the miners about.

The owners of the Scotia Mine are members of the capitalist class, just like the owners of Sunshine who left 75 widows and 184 fatherless

## LA FIREMEN FIGHT DISCRIMINATION

the are reprinting this appeal of Firekialiters For Independent Rights & Equality (FFIRE). We urge our readers to support this important struggle.

Los Angeles is a City heavily populated by Minorities. 42% of our City's population is either Spanish-Surnamed, Black, Asian or Native American. The present cause for concern is that we are grossly under-represented in a very important City wide institution. Of the Los Angeles City Fire Department's 3,009 firefighters, over 90% are Anglo.

In a Consent Decree issued by the United States District Court in 1973 the L.A.F.D. was ordered to put all its effort into significantly raising the level of Minority input until it is brought up to parity with the local population. An Affirmative Action Program was instituted to help accomplish this goal. Beginning in 1975, Training Centers held twice yearly (January and April) were to become solely concerned with fulfilling the directives of the Decree.

All applicants for Firerecruit positions are thoroughly pretested before entrance into a Drill Tower where training takes place. 161 out of every 1.000 applicants are admitted to either one of two Drill Towers. There exists an overall average Elimination rate of 23%. The January and April training sessions of 1975 graduated 3. Because of the discriminaa consistent amount of Minorities. The number eliminated reflected the average. However, in the January training session of this year the circumstances have drastically changed.

The January group of 1976 originally consisted of 161 trainees. 104 of these recruits were representative of the Minority community. The remaining 57 were Anglo. From the original group only a total of 61 recruits graduated. Of the 100 recruits eliminated, 75 were from the Minority group of 104. While the Anglo elimination figure of 39% is itself off the average 23%, it is not comparable to the astounding Minority elimination figure of 73%. The washout toll for this group is the highest in Departmental history.

Our organization, Fire Fighters for Independent Rights and Equality (FFIRE), consists of ex-recruits who were unjustly eliminated during the January session. There are 50 of us and we are a Minority group. We all know we were Racially Discriminated against by prejudiced Captains and Drill Instructors who ran the Towers with the sole purpose of eliminating us. The above statistics speak for themselves.

We ask for you to show your support. Listed below are our basic demands:

# **DEFEND** RAMON CHACON

(We are reprinting this press release, made available to us by the Ramon Chacon Defense Committee. We urge all our readers to actively support Ramon Chacon in his struggle for freedom.)

Supporters of South Texas Chicano activist Ramon Chacon, who is imprisoned in Mexico, have announced the start February 2, of a national campaign for his freedom. The campaign will include benefit performances throughout the US by Mexican movement singers and actors.

Charged with subversion of the Mexican government and illegal transportation of guns, Ramon Raul Chacon maintains that he is the innocent victim of a set-up. Held incommunicado for three days after his arrest, on October 2, 1975, Chacon was beaten and tortured until he signed a confession which he did not understand and has since repudiated in court. He had simply accepted a ride into Mexico with a Mexican acquaintaince and had no knowledge of the guns allegedly found hidden in the vehicle they were driving at the time of the arrest. The owner of the car escaped after the arrests.

Chacon has told family members that in spite of the charges ultimately brought against him, his interrogators limited their questioning to his activities in the U.S. An unidenitfied American was present and presiding at his torture. Chacon supporters feel that this is evidence of the US and Mexican governments' interest in destroying the increasing solidarity between Mexican and Chicano activists.

Chacon is now at the state prison in Monterrey, where he shares a crowded barracks with other prisoners and eats only if he has money to purchase food. His trial has tentatively been set for March. "It has been diricult to find Mexican lawyers who will help Chacon," said a Texas lawyer who is assisting Chacon's family, "and he is still uncertain whether he will have adequate representation at trial."

The Ramon Chacon Defense Committee hopes through the tours of Jesus Molina, Xavier Martinez and other Mexican artists to draw national attention to Chacon's case, to encourage people in the US to join in demanding that the Mexican and US government arrange for his release, and

to raise money for Chacon's care as well as for the defense effort.

Molina, who will appear in Texas and Midwest cities, is a noted progressive folk singer and poet. Martinez will travel throughout the West with members of CLETA, a people's theater group from Mexico City.

Ramon Raul Chacon is from Mercedes, Texas, where he has been active in several community groups. He has long supported efforts to improve conditions for the many impoverished farmworkers in the Lower Rio Grande Valley. He was also an original organizer of and student at Universidad Jacinto Trevino, the nation's first Chicano college. Among defense committee coordinators are Chacon's brother, Ernesto, a leader of the Raza Unida Party in Wisconsin, and Chacon's wife Concha, who is working and caring for the couple's two babies in Texas.

This strike is only one of the many ways that City Hall is dividing the workers of San Francisco. School teachers are being told to fight among themselves and choose either layoffs for recently hired national minorities or an end to the seniority system. For City workers (including capitalism - an overproducteachers) it's layoffs and speedups or paycuts. San Francisco's national minorities are being made to choose between busing and bilingual education. To all the workers, the politicians offer the choice of either increases in the property tax (the City's largest source of income) or cuts in City services. And the same thing is happening in cities across the country, with New York City standing out as the most notorious example. What we need to understand is whos to blame for the financial crisis of our cities, and what can be done to get us out of this situation.

The San Francisco Chamber of Commerce (in close connection with the National Association of Manufacturers) is callously putting the blame for the crisis on the working class.

The Chamber works through politicians like Supervisor Kopp (who broke into politics as an outspoken opponent of busing and integration) and Supervisor Barbagelata (the local chairman for the 1968 Wallace-for- President campaign).

The goals of these representatives of the capitalist class are to: 1) build a mass base for fascism among the petty bourgeoisie and the upper strata of the working class around the issue of the rising property tax, 2) keep the Anglo-American and national minority workers fighting each other over who gets or keeps jobs in the face of growing unemployment and layoffs, 3)isolate the unemployed workers on welfare, particularly the national minorities, by blaming them (along with public employees whose wages haven't even kept up with the cost of living) for San Francisco's financial problems.

At the same time we are being attacked economically, the political attacks follow right along with it. Basic rights that we have fought bitterly for are being taken away.

Proposition E, designed by the Board of Supervisors for the June ballot, would outlaw strikes by city workers. Any city worker who went on strike would be fired! The basic right to strike is one of the main defenses of the working class against the constant drive of the capitalist class to sink us ever deeper into poverty. This amendment must not pass! If strikes can be outlawed for city workers, how long will it be before all of us will lose this basic right of labor? This is a fascist law! Only fascists outlaw strikes and protests. And this is exactly what is happening. Because of the economic crisis, the bourgeoisie is preparing for war -\$113 billion for war - war against the socialist countries. We can be sure Kissinger isn't

and 4) divide the national minorities by pitting their needs against one another, especially around the question of quality, integrated and bi-lingual education.

We will not accept the blame for this so-called crisis of the cities and we cannot blame the city workers either. This is a crisis of tion crisis. This means that we don't work because there's too much produced. It means we have to suffer lavoffs. paycuts and increased taxes to make up for the capitalists loss of profits. At the same time we are told there is no money for the cities and we see a \$113 billion military budget!

Every worker has a right to work, to a decent life, but the capitalists cannot provide us with that right. Their system is obsolete. Capitalism does not work! The crisis of San Francisco is only one of the examples of the moribund nature of the capitalist system. There is only one system which can provide jobs, housing and a decent life for the workers, and that is socialism! It is only when workers run the society that they can plan the economy and provide the necessaries of life for all workers!

making idle threats against Cuba. Ford's "Peace with Strength" spells war! And this will mean fascism for us!

This attack is hitting first at the national minorities, in particular the Negro national minority. It is no coincidence that San Francisco, with a 60% minority population and a militant labor history is feeling these attacks. And it is also no surprise that city workers, with a high percentage of Negro workers, are being hit first! And hit from all sides. Busing is also under attack with the same excuse, "no money." They want us to fight over whether busing or bilingual education when \$113 billion - can you imagine -\$113 billion is set aside for war and destruction!

Look at Boston! Where fascist hoodlums ruthlessly beat up a Negro while the police did nothing. And what have we seen in San Francisco - Nazis marching down Market St. beating up people and the police protecting them. In this crucial year of labor, with numerous major contracts ending we cannot afford to let the capitalists further divide us. A defeat on busing will also mean a defeat in the factories because the more we fight each other the weaker becomes our fight against the capitalist class!

In light of the city workers' strike and the imminent General Strike, what is needed for victory is the unity of the working class.

The capitalists are offering war and fascism as a solution to the economic crisis - putting the burden on the working class. We must shift this burden onto their shoulders!

The Communist Labor Party, understanding that socialism is the only answer to the situation in San Francisco, to the increased fascist violence against the working class, puts forward the following program to rally all those who want to fight against this capitalist system and impending fascist onslaught by the imperialists, for the San Francisco area: 1. No lay-offs of City Workers (including teachers) or elimination of unfilled city jobs. End the hiring freeze. No cuts in city services.

2. Support the "craft" workers. Vote NO on Prop. E. Defend the right to strike. Full collective bargaining.

3. Defend and protect the national minorites. Support busing and bi-lingual education. Outlaw the Nazi Party and all fascist gangs.

4. Free quality 24 hour childcare for working families. 5. Roll back property taxes. Guarantee low-income housing for all workers.

6. Full employment at the expense of the military budget; Jobs with Peace! City officials must go to Washington and demand funds for city services. These funds should come out of the \$113 billion military

Take this program to your factory, community, church, union and mass organization. Have them take a stand in support of the City Strike and the General Strike. Let Mayor Moscone and the Board of Supervisors know that the working class in San Francisco will fight for our basic rights. We will not let them destroy the labor movement in this town!

Pasadena makes it clear that what is at stake here is not just a question of philosophies, of priorities or "what works" in education. No! The real question is: will the Negro workers be driven back into semi-slavery? Will the workers of other nationalities allow themselves to be used as pawns against the Negro national minority? Will the working class of our country stand divided and defenseless in the face of economic crisis and the growth of a fascist police state?

Fascist forces have been preparing the ground work for some time in their assault against Pasadena's busing program.

John Birch Society in LA Area

Continued from Page 3 Fitzsimmons was saying "yes" to the militant activity of the rank and file while sabotaging it at every turn. He prevented any real preparations and organization for the strike, which were essential if the Teamsters were to succeed.

This tactic resulted in 2/3rds of the drivers and warehousemen working prior to Saturday's announcement of an interim agreement.

Why else would Fitzsimmons and company have a mail. order referendum which would take two to three weeks? Because he and his handpicked henchmen had to avoid the militant rank and file who promised to show up at the usual ratification meetings.

Why else were there no strike funds in many locals to bail out union brothers arrested and beaten by police?

Why else didn't the "leadership" demand that their locals stay out until all illegally fired workers were reinstated?

Why didn't the International with its millions of dollars collected in union dues rally support from other unions and forces? Why no ads in the press, calls for support on TV and radio?

The only answer can be that Fitzsimmons and the capitalists he serves - that same class of parasites which pays him well for his services - knew that this would be a short strike that could only end in defeat for the workers.

That's why the companies didn't bother putting ads in the newspaper - want ads asking for scabs to break the strike. They didn't have to.

That's why the government which works in the interest of the capitalist class, didn't have to institute the fascist anti-labor Taft-Hartley law to try and break the strike.


And that's why the capitalist news media -NBC- had a week long "special" which tried to label every one of the millions of Teamsters as part of the "mafia".

Organized crime is well entrenched in the Teamsters union at the very top. They

use the trucking industry to transport illegal and stolen goods. And the effect of these millionaire gangsters and their henchmen is disastorous for the rank and file Teamsters. These gangsters have conducted union busting drives as well as allowed wholesale violations of the Master Freight Agreement.

public" as they are seeking rate increases from the government.

Secretary of Labor Usery just made the statement that the settlement was "in the best interests of the nation". But how can this be in the "best interests" of both workers and capitalists? The tiny class of capitalists - no more than 500 interlocking boards of directors of the giant banks and corporations - own



80% of the contracts in the New York-New Jersey area are below the Master Freight Agreement.

Despite the fact that Fitzsimmons' promises were phoney from the beginning, the rank and file fought bravely for a decent contract. Despite treachery, thousands of Teamsters stood firm against all kinds of odds - from attacks by police and railroad agents to the sell-out of their leadership and many misguided fellow workers.

The bourgeois news was full of stories about thousands of auto workers and others getting laid off because of the strike. But it was the capitalists who own the factories that laid them off, not the Teamsters. The millionaires of General Motors, American Motors, etc. wouldn't risk losing a penny of their stolen profits so they lay off workers and blame those on strike who are fighting for a little more of the enormous wealth that the working class alone produces.

At the same time, the trucking monopolies were assuring us that the wage increases and benefits that the Teamsters received "must be passed along to the

everything worthwhile and know only one thing - their ruthless, unbridled striving for maximum profits. The working class - the proletariat - is the majority vet owns virtually nothing. The labor of the Teamsters, the auto workers, the miners and farmworkers - of our whole class both here and in the colonial world - is what has created all of the wealth, yet every gain, from the right to unionize, equal rights, decent housing, to decent health care has only been achieved at the sacrifice of millions - up against the capitalist class and their police, courts and fascist gangs.

When "Labor" Secretary Usery opens his mouth, he speaks for the imperialists and their traitors in the labor movement. When Fitzsimmons makes deals with the Bank of America - the backers of California's huge agri-business to destroy the farmworkers union he does so to guarantee the profits of capital and therefore harms both Teamster and farmworker.

The Lessons of the Teamsters strike must not be forgotten. Presently, nothing can be done within the union leadership. Pro-

gressive Teamsters must begin anew the efforts started by the rank and file in Los Angeles, St. Louis and other cities. Fighting in such a way as to expose those in their ranks who seek to divide them, they must build caucuses of progressive members with the goal of seizing control of the shopstewardships and creating a network independent of the companies and their stooges.

The bitter lessons are becoming clearer. Fitzsimmons and company didn't say a word about the thousands of Teamsters laid off - thrown out in the streets to join the growing ranks of the unemployed. He didn't say a word about the speed-up, the forced overtime or any of the other thousands of attacks by the capitalists in their frenzied drive toward war and fascism.

Nearly 2 million other Teamsters - cannery workers, office workers and helpers have never been included in the Master Freight Agreement and earn far lower wages. The Teamsters union has been further weakened by this. Those covered by the MFA must fight for the continuation of the MFA and for better representation not only for the truckers, but for all Teamsters.

The Teamsters must unite against the growing war danger, in the fight for jobs with peace! They must support their fellow workers in the fields to choose a union and win the best possible representation. Only by the organized efforts of the rank and file can the policies of Fitzsimmons and his cohorts be defeated.

This strike marks a new stage of development that must be analyzed and organized into a mass campaign for the control of the Teamsters union. With the convention only months off in July, the next stage of the struggle is set. The objective basis is there to rally the progressive forces of the Teamsters to organize and fight to dump Fitzsimmons and all of his kind.

#### EDUCATION

One out of every four adults does not read or write. One out of every three children does not attend school because of the lack of schools and teachers; and less than 10% of the children go beyond the 4th grade.

### HOUSING & FOOD

Only 12% of the land that could be under cultivation to produce food is in use. Most of the people are presently living with inadequate food and housing. Food is plentiful for the capitalist and inadequate for the workers and disabled.

### EMPLOYMENT

Because of imperialism, 40% of the people of Mexico are unemployed or underemployed. The <u>average</u> salary for a rural worker is \$175 per year. Many are forced to beg and do the most menial jobs just to survive. Child labor is common.

### ECCNOMY

Mexico has an imperialist dominated economy. The economy is organized to produce the maximum profits for the imperialists and their henchmen in Mexico. Mexico owes the USNA over \$12 billion. And 80% of all foreign investments in Mexico comes from the USNA. All the major mines, factories, farms, etc., are directly or indirectly controlled by the USNA imperialists through the banks.

### DEMOCRACY

The imperialists and their puppets control the government and the major political party (PRI). Talk of democracy for the masses and of social and economic equality are plentiful, but empty promises. The capitalists daily become richer off the sweat of the workers. The Mexican government daily terrorizes the people: farmers are shot down by the army; labor leaders and students are jailed and shot. The dictatorship of the bourgeoisie that exists in Mexico means fascist terror for the workers and toilers, and democracy and wealth for the imperialists.

### CRIME & DRUGS

USNA interests are presently using Mexico as one of the principal producers of illegal drugs in the world; the poverty and misery of this capitalist society maintain a high crime rate.

### HEALTH

Health services are very limited, and rarely exist in the rural areas. Preventive medicine is non-existent for the workers. Hosptials and doctors are often hundreds of miles away.

### EDUCATION

Ninety-nine percent of the adults read and write; every child attends school at least until sixth grade. All education is free and workers are encouraged to continue their education through classes set up at the workplaces.

### HOUSING & FOOD

Since 1959, over 350 dams have been built for irrigation and electrical power. Today, electricity and running water is available to every family. At least one hot meal, and more often two, are given free to every worker and child at his work place or school. All young children are guaranteed plenty of milk daily: the government assures that all food stuffs are distributed equitably among the population; no one dies of hunger or suffers malnutrition any

### EMPLOYMENT

In Cuba there is a shortage of workers. Workers can freely change jobs. The minimum salary is over \$1000 per year. Cuba has the highest standard of living of any country in Latin America. No one needs to beg or sell trinkets in the streets to survive.

### ECONOMY

Cuba has a socialist economy. The working class, through its state, controls the economy. The factories, mines, fields, banks, etc., are owned and controlled by the Cuban workers and peasants. The wealth of society is organized to bring about the maximum economic growth and political and social equality.

### DEMOCRACY

The dictatorship of the prever proletariat that exists in prope Cuba means that the working the distance and determine their malar own future. The Communist eases Party of Cuba helps to guide the development of the country.

This is but a brief overview of the differences between socialist Cuba and capitalist Mexico. These examples should give us some understanding as to why, in just the last 60 years, almost half of mankind lives under socialism. It begins to explain why tens of millions more are daily fighting valiantly to throw out U.S. imperialism and their own capitalist rulers. It explains why the heroic people of Mexico, with the aid of the working class of the U.S.N.A. and throughout the world, will overthrow imperialism.

Cuba has shown that the only way oppressed peoples and nations can liberate themselves is by breaking with imperialism, with all capital, by destroying the control that the capitalist class has over the government and the means of production in the country and establishing socialism where the working class and the toiling masses control and benefit from the wealth produced by their labor.

It is no wonder that the U.S. bourgeoisie hates Cuba. Since 1960, the U.S. government has maintained an economic blockade against that country. The capitalists are so afraid of this small country because Cuba is living proof that socialism is the only answer to the misery, the hunger, the unemployment, the discrimination, and all the other social and economic problems of capitalism.

Fellow workers, socialism is for those who love their country and its people, because only socialism can save it!

Cont. from Page 3 this official slogan of the Save Natividad Committee was the universal rallying cry. Highlights included a skit by the Teatro del Valle, which dramatically exposed the role of private interests in closing the hospital and called for the nationalization of health care.

In the face of this massive outcry the Board of Supervisors backed down from its original plans to close the hospital and is instead moving to transform it into a private facility. Already in the last three years, 16 of California's 49 public hospitals have been closed down or turned over to private ownership. Possible plans that the Supervisors have for Natividad include:

1) contracting out; under this

All the laws and reforms have to be approved by committees of Poder Popular (Popular Power), to which all Cubans actively belong, Judges are elected by the people they serve. All elected officials are subject to immediate recall. Managers of factories can be dismissed by the workers. No one can be fired without the approval of the workers at the plant. The dictatorship of the proletariat means democracy for the workers and peasants and dictatorship for the capitalists who seek to re-establish their reign of terror.

### CRIME AND DRUGS

Although Cuba was famous for its gambling, prostitution and drugs before the socialist revolution, now drugs and prostitution are unheard of, and crime is very rare. Rapists, child molesters and other degenerate antisocial elements are severely punished.

### HEALTH

The finest health care is free and available to all. Much emphasis is placed on preventive medicine and proper nutrition. Many of the diseases prevalent under capitalism (tuberculosis, malaria, many parasitic diseases, etc.) have been eliminated or brought under control.

system private hospitals and doctors are hired to care for County patients which results in higher costs, and frequently their refusal to provide services to these patients:

2) consolidate the County hospital with the local private hospital; and 3) to form a "non-profit" medical corporation. This plan is favored by the Natividad administrator, Mr. Skouras, and the leadership of the Monterey County Employees Association.

In San Jose County when workers organized successfully to keep open Valley Medical Center, the Center was replaced by a private medical corporation with its first aim to benefit the capitalists' profits not provide service for the working class. We must prevent the same thing from happening in Salinas. Under the medical corporation plan the County would not provide services for anyone who doesn't qualify for Medi-Cal. This means thousands of workers who now receive medical care from Natividad would be denied essential health services to the working class.

To start off this most fascist attack against the working class, the Board of Supervisors is closing the Extended Care Ward where sixty poor and homeless old people receive shelter and medical

The capitalists' spokesmen complain that they are losing money on these old people and plan to transfer them to private nursing homes which are certain to refuse them. Capitalism is just as willing to discard these workers who have produced the wealth of this country as they are to throw out an old machine.

We must be clear. The cries of "financial crisis" by the County are phoney. Monterev is a vastly wealthy county where the giant agricultural firms make billions of dollars of profit from the hard labor of the workers. The moves against Natividad Medical Center are nothing less than the attempt of the capitalist class to make the working class, in particular the national minority workers, bear the burden of the overproduction crisis.

The Communist Labor Party raises the demand, KEEP NATI-VIDAD OPEN, PUBLIC AND INTACT! and calls for free and universal health care, organized through out the country on following principles:

 Nationalization of all hospitals, clinics, and health facilities with employ-

ees including physicians and dentists becoming federal employees paid at equal rates in all parts of the country.

2. Special attention to the health needs of the Negro Nation, Puerto Rico, the Philippines, the Southwest and all Indian territories to eliminate the present crushing inequalities in care.

3. Financing provided by the federal government.

4. The construction of a system of neighborhood health clinics with money taken from the military budget to create new jobs in health care.
