# **Afghanistan: Soviet Union's Vietnam**

Right before Christmas, the Soviet Union started a massive, around the clock airlift into Afghanistan. Amin, the Soviet puppet, was toppled and replaced by an even more trusted dog, Karmal. 100,000 Russian troops poured into the capital of Kabul, fanning out to all the important installations and roads.

Soviet tanks lumbering down the streets were a reminder of Czechoslovakia in 1968 when Soviet troops put Prague under siege to crush the Dubcek government. The Soviet newpaper *Pravda's* report on the invasion was a paraphrase of Lyndon Johnson's order on the Gulf of Tonkin in 1965 to "win" the war in Vietnam.

But this time more than ever before, the Soviet bear has lumbered into quicksand that it won't get out of. The Islamic movement is on the rise against all foreign intervention, and Afghanistan will swallow this invading force until the Soviet Union sinks to its knees as Viet Nam did to the U.S. pulled from the borders of China and Eastern Europe. No longer able to rely

A Desperate Soviet Move Amin was the third Afghan presi-

dent to be toppled in the last 20 months. All three were executed after a coup pulled from the borders of China and Eastern Europe. No longer able to rely on their henchmen, Cuba and Viet Nam like they did in Eritrea and Kampuchea, the Soviet Union must do the dirty work themselves.

d'etat. Amin took over three months ago after his predecessor, Taraki, failed to stop the rising liberation movement. But Amin's brutal fascist rule only increased desertions from the army and strengthened the rebel forces. The Afghan army's strength was cut in half, from 100,000 to 50,000. With Amin's government on the verge of collapse, the Soviet Union had to either swallow defeat or pour Soviet troops in to take direct control.

#### Afghanistan: Strategic to the Soviet Union


The Soviet Union needs Afghanistan to contend with the U.S. as well as to contain China. It is reported that the Soviets contracted to build three air bases in Afghanistan. These airfields would offset the fighters and bombers of the two U.S. aircraft carriers in the Indian Ocean. It provides the Soviet Union with a closer route through the Arabian Sea to the Persian Gulf and the Strait of Hormuz, where most of the oil shipments to Western Europe and the U.S. must pass through. Soviet forces in Afghanistan put them on Iran's eastern doorstep, pressuring the Khomeini government. It also threatens Pakistan to the south and China to the west. With so much at stake, Russia launched a full-scale invasion to wipe out the Moslem forces. Over 265 tanks and 300 armored personnel carriers armed with missiles were sent in with the invading troops. Five more divisions are massed at Afghanistan's border,

#### U.S. Can't Intervene

The U.S. can't go into Afghanistan despite all its sabre-rattling. Afghanistan has little strategic importance to the U.S. Trade with them is only one tenth what the U.S. pumps into Micronesia. Iran, in comparison, is rich in oil and is militarily crucial for the U.S. to spy on and surround the Soviets. If the U.S. couldn't intervene in Iran, it definitely can't go into Afghanistan.



# MOTHER BURNS BABY IN EXORCISM Fascist Culture Bears Bitter Fruit

N.Y., Jan. 2, 1980--His baby son had just been burned alive in an oven. Racked with waves of sorrow and disbelief, all Leroy Justin could do was break down in the street crying. Patricia Abraham scalded their own 20-month old son with hot water and then roasted him in the oven.

Spiritual advisor Miss Rose, had told Patricia that God said she must exorcise the devil out of her son by fire. Spiritual advisors, palm readers and others of that kind have been showing up on every street corner. The Harlem community was shocked and out-



raged after the incident. Leroy Justin cried out, "I'm going to get a gun and kill that bitch."

While little Leon was put into the oven, Miss Abraham told people to "come in and see the devil burn." A neighbor made four calls to the housing cops. And he even walked over to the police precinct to report that someone was burning a baby. But no housing or city cop showed up until 50 minutes after the first call.

Movies like the *Exorcist* and *Damien*, full of irrationality, the devil and mysticism, set people like Patricia up to accept the irrational as answers to their disoriented, oppressed lives. Fascist movie trends like horror flicks are consciously initiated or approved by big corporations who own the stocks of these movie companies. People get numbed as these irrational movies become a part of every-day life. This is a sinister aspect of the process of bringing in fascism. People can turn inward and get so indifferent to what's going on to others around them that neighbors can watch as Patricia Abraham put her son into the oven and not stop her. People are paying dearly for this. And with 95% of his body burned, a 20-month old baby has paid with his life.





### League of Revolutionary Struggle **Ten Years Behind**

#### Dear WVO,

Just wanted to share with you some of the developments in the California statewide Mecha. For people who don't know, Mecha is a Chicano student organization with a long history of struggle. Many of the best fighters in the communist movement today came out of Mecha.

Over the last few years, the revisionist LRS (formerly ATM) has tried to take over the Mecha network by holding the statewide conferences under their thumb. Without offering a single shred leadership, these self-proclaimed of "leaders of the Chicano National Movement", have tried to reverse all of the correct verdicts of the last ten years and turn the clock backwards and turn Mecha into a narrow social democratic clique, longing for the good old days of the 60's.

This was clear at the last statewide conference held in East Los Angeles, over the summer, where many students became crystal clear on the real nature

In the High School/Youth Workshop no lessons were summed up, no positive fighting program was proposed, no issue was discussed, not one concrete suggestion, except ... to plan another conference. Picture that, youth travel hundreds of miles to a conference, . . . only to plan another conference. And when a concrete proposal was made around fighting for the rights of immigrant students, the chairperson responded, "... that's not what we're talking about. We're planning a conference."

The only concrete proposal that LRS made during the entire conference was for Mecha to endorse the coalition (they themselves had instigated) to commemorate the Chicano moratorium. But what was the content of this commemoration? To sum-up the victories of this day, draw out the lessons and mistakes of the spontaneous movements of the 60's and point the direction forward for the road ahead? No way. They're content to believe that the Chicano moratorium has significance for just Chicanos. As their presentation and literature pointed out, "Things haven't changed much since the 60's". This is a lie. It completely negates the change in the objective conditions and the lessons and development of our movement that were paid in blood by our people. No. it is the LRS that is ten years too late, because they haven't been able to grasp where our movement is at and what tasks lie ahead to push it forward, particularly the role of propaganda and training. And because of their complete inability to consolidate political line and assume leadership, they have to rely on tactics like bureaucratism and manipulation to control Mecha.

But it's clear from the last few conferences that students are not about to be taken by these tricks. Entire campuses have walked-out in disgust and recently a number of schools have come together to form a seperate Southern California region and break ties with LRS.

To break with the revisionist LRS means breaking with reformist, narrownationalist line they hold, and engaging in sharp political discussion to really propagate the lessons of the history of Mecha and the entire movement.

# L.A. Chinatown Protests – No Traffic Without Traffic Lights!


"I'm late for work," shouted one woman driver as she attempted to drive her station wagon through the growing crowd of men, women and children blocking the intersection near the Castelar Elementary School.

"We have to do this because we don't want to have another little boy killed around here," explained one of the protesters. Just two weeks before a tenth grader was run down by a car and killed right near the school. Six months ago an elderly couple was knocked down by a car at the same intersection. One of them died.

The residents of Los Angeles' Chinatown have

response is just one indicator of their lack of regard for the lives of the Chinatown community. The recent death was the 12th major accident at that intersection in five years. The City has invested millions of dollars on roads, garages, etc. to turn Chinatown into a commercial center. They refuse to put traffic light because blocked traffic affects growing business.

On Nov. 1, 7:30 a.m. over 300 people, led by the Communist Workers Party and Asian Americans for Equality, took matters into their own hands. # Chrysler Loan Guarantees Strangle Workers

Just before the holidays, Congress passed \$1.5 billion in loan guarantees for the Chryşler Corporation. The government loan guarantees give the big banks security that any money they lend to Chrysler will be repaid, repaying with people's tax dollars if the company goes bankrupt.

The money to Chrysler will be supplied by: state and local governments-\$250 million, dealers and suppliers-\$180 million, foreign banks-\$150 million, selling assets - \$300 million, selling stock - \$50 million, domestic bankers-\$500 million, and workers' "contribution"-\$400 million.

#### At Least 40% Drop In Chrysler Workers' Standard of Living

While all the other money comes in the form of loans, autoworkers are


asked to "give" \$400 million through wage cuts to a company which has only given them hell. In return for this sacrifice, autoworkers will be given \$175 million in sick Chrysler stock (Senator Long said this would give the workers "incentive to produce"). This \$400 million loss means a 40% drop in the standard of living for each worker over the next three years *if* the present inflation rate stays the same.

As Congressmen debated how much the workers would be asked to sacrifice for Chrysler's loan guarantees, many Chrysler workers waited in unemployment offices wondering where the mortgage money will come from.




The Senate originally wanted up to \$900 million from autoworkers and a mandatory wage freeze for three years. Pushed by Senator Lugar of Indiana, this plan was opposed by the United Auto Workers (UAW) and dropped. Chrysler workers were already hit with a \$200 million cut in their original contract, approved by 69%. Now they are asked to reopen their contract to give up \$260 million more. A revote is scheduled for January 20.

UAW bureaucrats have already sold out the rank and file, especially Chrysler workers, by agreeing to a worse contract for workers at Chrysler compared to *Continued on Page 7* 



Although the proposal to put UAW president Fraser on the board of Chrysler is still not definite, the experience of the worker/director arrangement (codetermination) in West Germany raises interesting questions. Hitler, who hated and abolished the unions, encouraged codetermination to suppress strikes and •undermine the workers' struggles. Workers first got on corporate boards during 1952 when they threatened a general strike. Since 1952 while the West German economy has been relatively stable, 1/3 of the mining jobs have been chipped away and 50,000 to 250,000 of iron and steel workers' jobs were melted down without any strikes to resist these massive cuts.



# U.S. Steel Blackmail Breaks National Contract

U.S. Steel is blackmailing steelworkers with their jobs. In late November Ambridge, Pa. workers at U.S. Steel's American Bridge Division plant rejected the company threat to close the plant and voted down a 3-year wage freeze. Then U.S. Steel announced the permanent plant closing. They dangled a "second chance" on the wage freeze in front of the stunned workers. Confused, unable to fight any longer without clear leadership, the workers revoted and accepted the 3-year wage freeze and separation from the United Steel Workers Basic Steel Agreement.

The wage freeze was originally rejected 650-432 and freeze was accepted) would now be kept open. They switched the closing to the American Bridge plant in Gary, Indiana where workers are still rejecting the freeze. Playing off one plant against another, U.S. Steel's blackmail has nothing to do with keeping the plants open. It is an attempt to break up the Basic Steel Agreement (national contract), weakening the union's position for the 1980 contract and setting a precedent for a more massive wage freeze.


Even U.S. Steel admits wage increases are not the real reason for the plant closings. Their "new strategy for the future" says they are expanding only in non-steel industries, for more quick and high profit. Their plan for steel is a massive efficiency drive by shutting down older, less profitable plants and cracking down on labor. So as planned they cracked down on the American Bridge workers with the wage freeze. Ambridge workers hope this setback will stop the plant closing. But U.S. Steel will keep shutting plants as planned, very likely including the Ambridge and Schiffler plants, because they have no other solution for the stagnating capitalist steel industry.  $\Box$ 

# Chrysler Fires Comrade Fighting Klan

HAMTRAMCK, MI – On Wednesday, November 7, three days after the attack on the Party in Greensboro, Communist Workers Party member, Clarence Dowdy passed out leaflets at Dodge Main (Chrysler Hamtramck Assembly Plant). The leaflet announced the burial march for the Communist Workers Party 5 murdered by the KKK and the government. After the shift began, general foreman, Jimmy Mays threw the Party leaflets on the floor and told Clarence, "Sweep that bullshit up". He refused. Then the general foreman told him, "I'll kick your ass and the union won't do anything about it". Mays took out twenty dollars and s packing. Fifty stitches were needed to crose the cut.

Clarence Dowdy was fired along with the general foreman. Chrysler has made it clear that it is willing to sacrifice a general foreman just to keep out one Party member. Like he did after three previous firings in over 11 years working at Dodge Main, Clarence will fight for his job back.

The hysteria over communists, Iranians and undocumented workers cannot erase the exploitation and oppression facing the workers here today. So when the guards try to stop the paper sales at the gate, the Party and the workers step up their efforts to distribute the propaganda in the plant right under their noses.  $\Box$ 





# Post Office Speed up Delivers Mike McDermott's Death

### 80's Bring Health & Safety Nightmare

JERSEY CITY, N.J.-Mike McDermott never had a chance. On Dec. 15, 1979, while he worked alone loading Christmas packages into a postal truck, he was crushed to death when a conveyor belt sucked him into its gears. He tried to push the emergency stop button, but it was located too far from where he worked. The jam relay, which cuts power to the motor when something jams the belt, had been disconnected.

After learning about McDermott's brutal and senseless death, workers at the facility stopped work and wore black arm bands the following day. They were outraged because postal management had ignored repeated warnings about the unsafe conditions at the center. According to a management safety check of the other 55 belts in that area, done the day after the accident, each had an average of more than six serious defects.

Mike McDermott was one of 4,000 postal workers employed at the highly mechanized N.Y. Bulk and Foreign Mail Center in Jersey City, New Jersey which handles 350,000 to 400,000 parcels a day. During the Christmas rush, he and the other mail handlers had been forced to work 11hour days, six days a week of mandatory overtime.

A week and a half after McDermott's murder, two women workers from the center were sent to Christ Hospital, Jersey City for on-the-job injuries.

Two days later, another mail handler, Frank McGee, narrowly escaped serious injury when his apron became entangled in a moving conveyor belt. He lived to tell the staff members at the hospital that his face was pulled within inches of the conveyor belt before he was able to press one of the few working emergency switches that stopped it. While he went home in a neck brace, the Postal Service called it a "minor incident, not an accident." Dr. Jones, Director of the hospital's Emergency Service Department, stated that the mail center accounts for more injuries than any of the other industries in Hudson County, N.J.

These postal workers' accidents were not the result of "freak" mishaps or carelessness as the management claims. A mechanic at the Jersey City facility said, "We've been told to take a lot of them (safety shut-off switches) out or change their settings, so that they aren't so sensitive to strain and won't cut off as easily. When a oelt stops, it causes a lot of down-time and slows up production." So the safety devices were allowed to die out for the sake of productivity.

#### Bourgeoisie's 80's Strategy: Health and Safety Nightmare The recent rise in industrial acci-

dents is a forecast of a health and

safety nightmare to come in the 80's. The bourgeoisie's "four-point plan" guarantees this. (See WV, Nov. 5, 1979, "30's Depression Haunts Bourgeoisie, But Fear of 80's Freaks Them Out!") It calls for cutting social services, hiking military spending, stepping up "productivity" and most important, "reindustrializing America."

Stepping up productivity, a catchword which generally means work output per manhour, means how to get more production squeezed out of less workers. It is the justification for deliberately making the conveyor belts hard to cut off because it causes too much down-time. This bourgeois strategy murdered Mike McDermott and it's only the beginning.

Calling for "reindustrializing America" while they have no unity on now to do this means more workers will continue to be hit with speedup on old, dangerous machinery where even patchwork maintenance is scarce. The parasi-

### Indiana **Steel Mill-**Deathtrap for 6

E. CHICAGO, IND. December 28-As a big ball of gas and steam engulfed them, steelworkers and foremen rushed to close a leaky valve in the No. 3 blast furnace at the Jones & Laughlin Steel Co. Plant. One by one they fell, trying to help each other get out, until six were killed and twelve injured by the carbon monoxide fumes. Those killed included Ben Harris, 46, keeper on the No. 4 furnace and Fred DeHoyas, 22, helper on the No. 3 furnace.

As OSHA investigators and J&L public relations flew to the scene, steelworkers throughout the Chicago-Gary steel belt condemned the J&L plant (formerly Youngstown Sheet and Tube Co. until the big merger of Lykes Corp. and LTV Corp. in December 1978) as the worst deathtrap in the area. There have been at least a dozen on-the-job deaths at the mill in the past five years. Equipment dirty, greasy and crumbling with age set up the deaths. The leak was triggered by the exhaust fan motor burning out, no alarm to signal this, no gas-monitoring devices in the area to warn of high levels of gas, a valve that wouldn't close manually and had no electric crank.

The call to "reindustrialize America" while the U.S. bourgeoisie has no confidence to make big investments in basic industries like steel, means pushing for productivity in antiquated turn-of-the-centruy mills and it is paid for in workers' lives.

to ATT's longstanding practice of harassing operators. One of the workers, because of job pressures, developed severe emotional problems. His supervisor held a few counseling sessions with him. This wasn't designed to help him. It was just standard company policy meant to document ATT's good faith in helping a worker cope with his problem; and if his problem continued to affect work performance, then ATT had cause for firing. It was after a counseling session that he died.

The second operator had 36 years with ATT and a perfect record. Her friends attributed her death to ATT harassforgot one day and for the first time in 36 years she was suspended. Extremely upset over the suspension, she suffered her fatal heart attack a short time later.

Overseas operators at 32 Avenue of the Americas, a major overseas switchboard facility, have been traditionally the most exploited and the most militant of the many CWA (Communications Workers of America) locals. Years ago, it was not uncommon for the operators to strike and shut down "32." Other sympathetic locals would walk out and ATT never dared punish any striker. After the long and bitter 1971 strike which resulted in sepa-

on strike. A two day strike would mean six days without pay. ATT almost succeeded in taking away the only weapon workers have, the one ATT fears most. the right to strike.

The overseas operators struck Friday, Dec. 21, 1979, right before Christmas, the second busiest season of the year for ATT after Mother's Day. They walked out to protest the deaths of their co-workers caused by ATT's severe job pressures and harassments. ATT immediately suspended the striking workers. Warnings were issued to all workers in Operations and Clerical departments threaten-

overseas telephone traffic over the Christmas weekend.

ATT was forced to drop the two day suspension policy for the 300 operators, as a settlement was reached the day after Christmas. Amnesty for the striking operators is a major victory for every telephone worker. Only by exercising the right to strike can workers fight ATT on issues of job harassment, speed-ups, safety hazards, etc. The strongest CWA local in N.Y.C. has put a dent in ATT's strikebreaking tactics, a feat that CWA lawyers and bureaucrats haven't accomplished for the past decade.

"Welcome home comrades. babwe." The masses cheered, sang, and waved signs.

As many as 100,000 blacks crowded through the airport gates, trampling down 12-foot high steel fences and pushing forward again and again against police lines backed by dogs. They came to greet the first delegation of the Patriotic Front.

Standing 10-deep along the road out of the airport, they danced and sang for hours, interrupted by a joyous surge toward the buses that carried the Patriotic Front delegations into the city. The Rhodesian police helplessly suspended a 6 p.m. airport curfew.

The scene at the Salisbury airport went beyond anything experienced there before. It was granite proof of the Zimbabwean people's support for the Patriotic Front.

But, these imperialist racist dogs won't take their defeat sitting down. They will try every trick to destroy the Patriotic Front and not implement the cease-fire agreements.

On Dec. 27, before the deadline of the cease-fire, General Tongogara; the Commander of the Zimbabwe African National Liberation Army (ZANU's military wing) was reported killed in a car crash. He was traveling from Maputo to his headquarters at Chimoio in Mozambique, a town 50 miles east of the Zimbabwean border. His car was hit by a truck.

No one believed this was an accident, but more likely a premeditated murder. His car crash came right after Robert Mugabe (head of ZANU) warned Britain that ZANU would not gather at the assembly points agreed on unless the British account for South African troops still in Zimbabwe. Mr. Mugabe fiercely criticized the British for not implementing their part of the cease-fire agreement and told his men to hold on to their arms and ignore any orders that might be given by peacemonitoring troops.

The situation is excellent for the Zimbabwean people, and the Patriotic Front has to be even more vigilant for backstabbing by the British and U.S. imperialists. The transitional period will be full of struggles.

# **OPEC LIFTS CAP ON OIL PRICES U.S. Oil Monopoly Grip Slips**

After a week of intensive talks in Caracas, Venezuela, in December, the OPEC countries for the first time in a decade did not set a ceiling on the price of their oil. Each country is free to set prices as they want until the next OPEC meeting.

Four days before the meeting, Saudi Arabia, the largest OPEC oil producer, announced a 33% increase in prices to \$24 per barrel. This was the largest single increase since the oil embargo in 1973. The Saudi oil minister lashed out against the Western monopoly oil companies for making over 100% profit while Saudi Arabia was keeping prices low. The increase was needed to keep up with inflation and return part of the profit back to Saudi Arabia.

Spurred by the rising anti-

meeting, many countries, led by Iran, had taken political initiative to cancel their long term contracts with the international oil companies, encouraging direct trade agreements with European countries instead. These agreegments make OPEC as well as the Western European countries and Japan, more politically and economically independent from the U.S. Western European countries are relying less and less on the oil monopolies to keep them supplied with oil. The role of the oil giants like Exxon, Shell and Texaco as middlemen have been cut back. Before the Iranian revolution, these companies controlled over 80% of the oil worldwide. This has dipped to less than 60%.

This sharpens the contradiction between W. Europe and Japan with the U.S. When the U.S. cancelled their order for Iranian oil, Japan immediately stepped in to sign an agreement for more oil from Iran. Western European countries are reluctant to support U.S. calls for an economic boycott of Iran, and condemned the U.S. freezing of Iranian assets. By not setting a ceiling price and encouraging direct trade agreements, the OPEC countries strengthen their political initiative and flexibility in their fight for economic independence from the U.S.

through grants, research and technology, low taxes, fat government contracts and so on. But the bourgeoisie can't agree on who will get government help and who will lose out. GM or Ford workers. Now a precedent is being set for the auto companies and the government to reopen the contract everytime they want to squeeze workers more. Fraser, UAW president, said he would reopen the contract if "the survival of the company" was at stake, and has yet to put a limit on what he would ask the rank and file to give up.

#### Fight for Jobs Just Beginning

The \$1.5 billion is the largest government bailout in a private corporation in U.S. history. (In 1971 the federal government approved only a \$250 million loan guarantee for the near-bankrupt Lockheed Aircraft Corp.) House Speaker O'Neill pleaded for the bill: "Laying off 700,000 people, which is what you easily could do, believe me,

PITTSBURGH, Pa., Nov. 19-Ted Kennedy took one look at the red Communist Workers Party banner and friends of the CWP shouting, "Speak on the murder of the Greensboro 5," and jumped like a jack rabbit into the small Catholic hospital.

He had come to this white working class community to try and publicize his health program. Doctors and nurses and at tops, 30 community people were standing around. The Catholic schools were let out early to get more people to see Teddy. When asked, "What do you think of Kennedy?" the students just said they were glad to be out of school.

Leaving Kennedy no peace, Communist Workers Party friends sold the Workers Viewpoint newspaper outside. An FBI agent and three cops came up and told them to leave. The FBI agent grabbed the banner and asked, "Is there a gun in here?" When the CWP supporters refused to move, the cops threw the comrade holding the banner down to the ground. When two others came to his aid, they were arrested, too. Kennedy left the hospital within 15 minutes, hardly enough time to shake a few hands or kiss any babies. The cause of the CWP 5 is keeping him on the run!

## GREENSBORO Weapons Suspena

Weapons charges against 9 of the 26 people arrested on November 11 under the state of emergency law were dropped. During the trial held on January 3, the judge refused to hear defense arguments on the right to bear arms and the unconstitutionality of the state of emergency law. The 16 other defendants were given 12-month suspended sentences and ordered to pay court costs (about \$27.00). The year sentence would become active if the defendants are convicted of the same or similar charge within the next five years. On February 4, CWP member Nelson Johnson, and Party friends Willena Cannon and Rand Manzella go to trial on charges of inciting to riot and weapons charges. Police arrested the three after the Greensboro massacre on November 3 while the KKK/Nazi and government assassins were allowed to escape.

# **City Blocks Fe**

The city of Greensboro has just refused to issue a permit for the February 2 anti-Klan demonstration. Organizers for the demonstration couldn't get the Coliseum as the endpoint for the march, and the city used this as an excuse to deny the permit, trying to block the February 2 protest.

This follows the Greensboro City Council's decision on January 3 to postpone voting on changes in the city Parade and Demonstration Ordinance. The proposed amendments, pushed by



# GREENSBORO NEWSFLASH Weapons Charges Dropped for 10, Suspend Sentences for Others

Weapons charges against 9 of the 26 people arrested on November 11 under the state of emergency law were dropped. During the trial held on January 3, the judge refused to hear defense arguments on the right to bear arms and the unconstitutionality of the state of emergency law. The 16 other defendants were given 12-month suspended sentences and ordered to pay court costs (about \$27.00). The year sentence would become active if the defendants are convicted of the same or similar charge within the next five years. On February 4, CWP member Nelson Johnson, and Party friends Willena Cannon and Rand Manzella go to trial on charges of inciting to riot and weapons charges. Police arrested the three after the Greensboro massacre on November 3 while the KKK/Nazi and government assassins were allowed to escape.

# **City Blocks Feb. 2 Demonstration**

The city of Greensboro has just refused to issue a permit for the February 2 anti-Klan demonstration. Organizers for the demonstration couldn't get the Coliseum as the endpoint for the march, and the city used this as an excuse to deny the permit, trying to block the February 2 protest.

This follows the Greensboro City Council's decision on January 3 to postpone voting on changes in the city Parade and Demonstration Ordinance. The proposed amendments, pushed by Mayor Jim Melvin and other council members, would:

1. Force parade or demonstration organizers to post bond or pay a fee for additional security forces over 45 that the City Manager feels necessary before the city would grant a march or rally permit. Organizers would have to pay 2/3 of the final additional costs (The city estimates that the November 11 CWP 5 burial march cost them \$85,000).

2. Declare most of Greensboro off-limits to parades or demonstrations,

particularly residential areas.

3. Prohibit arms at or within a certain distance from a demonstration. Signs that could be used as weapons would also be banned. (Present North Carolina law allows weapons to be carried as long as they aren't concealed).

The city council vote was postponed to January 17 since many council members had not seen the amendments before and some had heard about it less than 24 hours before the meeting.

# **Shocking Press Reaction To KKK Killings**


If the slaughter of five demonstrators by the Ku Klux Klan in Greensboro, North Carolina, last weekend was appalling, the newspaper coverage of the atrocity was at least equally so. Virtually every account that moved across the national wire services and showed up in the nation's metropolitan daily newspapers carried the outrageous' suggestion, either implied or stated outright, that the victims of the massacre somehow deserved what they got when carloads of admitted Klansmen drove up to a demonstration in a mostly Black housing project and opened fire with shotguns and automatic rifles.

Where were the expressions of outrage from the reporters who covered this bloody atrocity? Where were the soul-searching questions about what is happening to a society when such cold blooded mass murder can occur in broad daylight? Where was the condemnation of the Klan and the historical notes linking this latest rash of killings to a heritage of cowardly bloodshed that started more than a centruy ago with white robed citizens dragging helpless Black families out of their homes at midnight, torching their dwellings and lynching them?

None of that was in evidence in the press accounts. Instead, we were treated to the utterly calm and complacent speculation that the demonstrators had, after all, said nasty things about the Klan, printed derogatory things about them in their brochures and even, imagine this! hurled verbal abuse at the hoodlums when they drove up with guns on their laps and murder in their hearts.

What hope is there for a free society in America if the press not only accepts such murderous behavior but actually looks for reasons to excuse it?



# DEATH TO THE KLAN!

### Klan's Bloody History — Buying Time for the Bourgeoisie (Part 2)

This is the second part of a two part series on the Ku Klux Klan (see Part I, WV, Dec. 10, 1979, p. 5).


In the 30's, the Klan shifted its target again to better serve the capitalists. "The Klan will subordinate racial and religious matters to oppose communism and the CIO," said Imperial Wizard Hiram Evans.

The great depression-15 million workers on the streets, millions of farmers ruined, and wage cuts in all industries averaged 45%. In the midst of this suffering, the Communist Party, USA (CPUSA), had established itself as the leadership of the U.S. people. In 1930, they organized more than 1 million unemployed workers in nationwide demonstrations. In 1931, they took up the fight of the Scottsboro Boys, nine Afro-American youths who were framed up for rape. In the basic industries, coal, steel, auto, the CPUSA was decisive in building up the unions that were to become the Congress of Industrial Organization (CIO).

The Klan attacked the CPUSA and built up Franklin D. Roosevelt, the most advanced representative of the bourgeoisie at that time. In Detroit and Flint, Michigan, they killed and kidnapped dozens of workers to stop the formation of the United Auto Workers. In Florida, they murdered communist organizers in the orange groves. They attacked the Textile and Steel Workers Organizing Committees and the Southern Tenant Farmers Union for being multinational and communist-led. At the same time they organized Roosevelt Southern Clubs, with Paul Etheridge, the Klan's top lawyer heading them up. FDR returned the favor by appointing Hugo Black, a known Klanner to the Supreme Court in 1937. All of this was to give the monopoly capitalists time to build a coalition of different monopoly groups around the New Deal. The New Deal, strengthening state monopoly capitalism in the U.S. was the way out of crisis for the bourgeoisie.

#### 1950's-State Spearheads Scapegoat Politics Directly

During WWII, the KKK lost ground because of their support for Hitler. And after WWII, the bourgeoisie did not use the KKK to spearhead their vicious redbaiting campaign. Instead the President, courts, and Congress spearheaded it them-



selves. The aftermath of WWII brought 13 socialist countries, while one revolutionary storm after another swept Western Europe, and strikes were at an all time high in the U.S. Desperate, the capitalists launched a red-baiting campaign to get the CPUSA and further oppress the U.S. people. The national leadership of the CP was arrested and jailed. Thousands of communists and progressives like Paul Robeson, the great Afro-American actor, were dragged before Joe McCarthy's House Un-American Activities Committee.

The CPUSA, weakened by an allaround right line, could not use this excellent situation to organize the U.S. people to go forward to break the bourgeoisie. The CPUSA punked out-voting for anti-communist clauses in the trade unions they themselves led, and expelled themselves from leadership. The betrayal of the CP left the U.S. people without leadership. 822,000 rank and file members were run out of the CIO. Many Chinese-Americans including some of the best physicists in the world were arrested, and deported harassed. for being "communist conspirators". Through this the capitalists were able to implement the Marshall Plan to effect a temporary stabilization of capitalist rule.

The Klan grew somewhat as part of this offensive against the U.S. people but not much. When the Klan aid come out in the 50's, their attacks against the people were beaten back. The Deacons for Defense, a black, armed self-defense group, blasted the KKK out of Monroe, North Carolina in 1956; and just a few weeks later, hundreds of Lumbee Indians, in warpaint and headfeathers, drove the KKK out of Robeson County, N.C. for good.

More important, the capitalists could not openly back and promote the KKK in the 50's because the U.S. was trying to pass itself off as the "defender of democracy" to the rising third world countries. So, under cover of "investigation and surveillance" of the KKK, the FBI penetrated the Klan in a big way, to use as one tool to attack the rising Black Liberation Movement. Although the main force of violence against the movement of the 60's was the state itself, undercover FBI agents in the KKK had full go ahead to attack freedom fighters. Undercover FBI agents murdered Viola Liuzzo and 3 other civil rights activists in Alabama in 1963. The FBI even boasted in the New York Times (11/22/77) that they "had enough agents in the KKK to elect the imperial wizard."

#### Death to the Klan!

Caught by the deepest economic crisis ever, the bourgeoisie is pushing out the KKK again. For ten years the bourgeoisie has worked to divide the working class, black against white. In the early 70's, the demands of the 60's were twisted to divide people. In the Boston Forced Busing Plan, the demand for quality education was turned into "school desegregation" and used to pit whites against blacks. In the late 70's, the Bakke case and the Weber case, aimed at skilled white workers, are used to spread the chauvinist lie of "reverse discrimination"that blacks are taking jobs from white workers.

The Klan is promoted in the media to spread racist poison. White youth hard hit by unemployment are particularly susceptible. Without communist propaganda to focus their energy to fight the capitalists, they can be drawn into the KKK.

The entire history of the Klan shows they are dripping with the blood of the U.S. people. The history of the fight against the Klan in Vineland, N. J. in the 1920's, to Monroe and Robeson County, N.C. shows that anyone who is serious about fighting the KKK/Nazis effectively must be prepared to meet the KKK's and the government's reactionary violence head on. □

Soviets is no smooth sailing. The imperialists fear that Canada, Australia and Argentina's agreement not to sell grain to the Soviet Union will wear thin as time passes, and they haven't even gotten France to agree to stop selling grain to the U.S.S.R. The U.S. is also afraid that arms shipments to Pakistan (to counter Soviet influence in the subcontinent) will further antagonize India and push her further towards the Soviets, besides the fact that General Zia has openly stated that "Pakistan has always been suspicious of U.S. imperialism". The U.S. worry has been especially strengthened after Indira Gandhi's landslide victory in the recent Indian elections. Gandhi has historically leaned towards the Soviet Union. Carter's economic "punishment" of the U.S.S.R. has triggered an entire dislocation of the commodity exchange in the Midwest. Stopping grain deliveries to the Soviet Union means the U.S. has to purchase \$2.5 billion worth of grain from farmers to compensate their loss.

Farmers and Midwest banks that speculate on the grain market as well as finance farm machinery protested. The recent Republican debate in Iowa strongly registered this protest, with "hawks" like Howard Baker coming out against Carter and the grain boycott line. Similar fears have been raised by banks such as Morgan Guaranty Trust that the Soviets' might retaliate by stopping loan payments to U.S. and European banks. This, they argue, will lock the U.S. into countering by freezing Soviet assets in the U.S. in the same manner that the U.S. acted against Iran. This, they fear, will further weaken the position of the U.S. dollar in the world, already falling fast since the U.S. action against Iran and the stampede to dump the dollar in exchange for gold sparked off by the Soviet occupation of Afghanistan.

the 19th century are still fresh in their minds when the British were routed in their attempt to dominate Afghanistan. As one of the Afghan exiles said, "You'll see, this isn't the end of the story. It may not be easy or quick, but we'll drive them out just the way our ancestors drove out all the others."

The Moslem forces already control over half of the countryside and the main highways in the country. They have been launching attacks close to Kabul and the other major cities since last summer. They are waiting for the Russian troops to leave the big cities and enter the provinces. It is a rugged mountainous country that the Moslem forces know like the back of their hand. Fighting a guerrilla war, they will tie down the Soviet troops who are only trained to fight a conventional war in Europe or China. Without major highways to resupply their troops, the Soviet Union will be stuck fast. Entering the country with airborne troops is easy. Getting out is another story.

the world. Khomeini's government is providing food and shelter to Afghan refugees. On January 1st, thousands of Afghan demonstrators stormed the Soviet Embassy in Teheran, scaling the walls and tearing down and burning the Soviet flag. They then moved on to the U.S. Embassy, to show their fight is against *both* superpowers. Sixty Afghan students seized the Afghanistan Embassy in New Delhi, India, condemning the new Afghan regime as a Soviet puppet. Politically, the Soviet Union has already suffered a strategic defeat.  $\Box$
