From \$200,000 to \$200 **Clumsy Judge Backs Off Nelson's Bail**

GREENSBORO, N.C.—The attempt by the capitalists to gag Communist Workers Party spokesman, Nelson Johnson, ended in victory for the CWP. The government was forced to back down on their attempt to detain Nelson and throw him in jail on \$115,000 bail. At issue here is "preventative detention" —a fascist attempt to put away someone for merely speaking the truth and showing contempt for the capitalists and their crooked politicians. The battle against "preventative detention" brought out to the ultimate for everyone to see why this

show up at Governor Hunt's press conference, walk up to his face and accuse him of conspiring to murder the CWP 5. He had the nerve to disrupt the Greensboro City Council meeting. When Mayor Melvin told NJ to sit down, NJ said, "Shut up Melvin." According to the government, these are the actions that make NJ a danger to the Greensboro community. These were the actions that were brought out by the government that day in the courtroom. Summing up his case to the judge, Assistant District Attorney Knight said, "I know this is an

attack on the CWP by the government came from a position of their weakness.

On July 23, five days before the Klan/Nazi trial began, Nelson Johnson was busted for telling the people of Greensboro to rise up and beat back the fascist attacks and overthrow the criminal rule of the capitalists. The government arrested him and slapped a \$15,000 bail bond. After Nelson was freed, the DA twied to have the bail revoked and upped it to \$115,000.

On Wednesday, Aug. 6, Assistant District Attorney Lee Knight presented ·his case to Judge McLellan, that NJ's bail on his charge of "inciting to riot" on Nov. 3 be upped by \$100,000. The prosecution said it wanted the court to raise bail so high that it would "effectively detain Nelson Johnson until his trial on charges of inciting to riot." Knight, who used to be a Baptist minister, made the most of the occasion. Shouting hell, fire and brimstone, he turned the courtroom into an emotional attack on NJ and the CWP. Pointing his finger at NJ, he shouted, "This man's conduct poses a danger to people in the community, including himself. What he has been doing is agitation-conspiring and encouraging others to the point where people get killed." He said that NJ had a history of starting violence and "backing out," leaving others to be hurt. Speaking of Nov. 3, he pointed at NJ and shouted that NJ is "morally responsible" for the Nov. 3 killings. His tirade brought shouts of outrage from spectators in the courtroom.

NJ tried to speak at least four times, each time being interrupted by the judge.

unusual motion I presented to the court, one without precedent. But these are unusual times calling for unusual measures." Shouts of "that's right" and "sure is" came from the spectators.

NJ was taken to jail and held on \$100,000 bond for assaulting an officer. This is in addition to the \$115,000 bail being sought by the prosecution on his charge of "inciting to riot." These pigs showed what was really behind his detention. They tried to make a deal with NJ. They offered to drop the \$100,000 bail and let him out if he would sign an agreement not to associate with any member of the CWP, go to a CWP residence or CWP headquarters, or go near the Governmental Plaza until his Sept. 1 court date.

NJ told them where they could go. Public opinion was explosive on this issue. Throughout the community, everyone was clear. "They're trying to put NJ away." Thursday morning at a hearing on his assault charge, the court was forced to lower his bond to \$200. That afternoon the prosecution called Mayor Melvin to testify against NJ. Melvin walked into the courtroom with his bodyguards. He testified that "he was frightened to death" by the disruption of the City Council by NJ, Dale Sampson and Signe Waller. (Both these widows were arrested at the City Council meeting for disrupting a public meeting.) For once Mayor Jim Melvin is telling the truth. But even more, NJ dared to walk into their sacred chambers and show by his actions he had contempt for their lies and contempt for their authority. To them, this is the biggest threat of all. For the only way they can control all of us is by fear, by forcing the people to have respect for their power. This is why they freak out when we go against their authority. When we refuse to go by their rules, we are forcing them to play the game on our terms. They realize how vulnerable and weak their hold over us really is. They realize that the only thing between the people and freedom is the realization that the capitalists have no power over us. This realization gives us the courage to stand up. This attack was a testing of the waters. The capitalists used it to test public opinion, to see how quickly they can move to outright fascism. And when they came out of it weaker, they got their answer. Their attacks will be resisted by Continued on Page 4

Statement of Tom Clark In Response to Being Subpoenaed to Klan/Nazi Trial

My name is Tom Clark. I have been a long time CWP supporter. I was wounded by the government agent Klan/Nazi assassins on Nov. 3. Since then I have filed charges on my own initiative against the scum murderers. Not only have the police taken no action on my charges, but they have arrested me for trying to protect Paul Bermanzohn on June 16, when he attempted to attend the Klan/Nazi trial. I have been called as a witness in the Klan/Nazi trial today. In my opinion this trial is a coverup to be used to put the CWP on trial. I refuse to cooperate with your upside-down capitalist court system. The jury was chosen after a careful process of political screening. The jury was chosen. Selection exludes all blacks and picked people who are clear pro-Klan Nazi supporters including the Greensboro cops. Their prejudice is clear. The McDuffie case in Miami and the Klan case in Chattanooga shows very clearly how the court system works to protect terrorists who work for the capitalist class. Millions saw the murderers of the CWP 5 on TV. The videotapes can be seen in court. There is ample evidence to convict these murderers without my testifying. The people of Miami and Chattanooga have shown how the American people feel about the capitalist courts. They are rejecting this kind of justice. They are rejecting a system that forces people to starve because there are no jobs. They are rejecting a system that is leading the American people right to the chopping block by instituting Hitler-type fascism and leading us into World War III. Miami is only a beginning of the American people's resistance. You can be sure of that. The CWP is being repressed precisely because it speaks for the interest of the U.S. people and offers the only real alternative-workers' rule. You know what I mean when I say that the ruling class fears the CWP and will do everything it can to shut it up. When the widows. Marty Nathan and Floris Cauce, are give 30 days each. When Nelson Johnson's bail is being raised to \$115,000 while Klan/Nazi murderers walk around the courthouse, you can see what kind of justice is being dealt out there. The U.S. government, the FBI, BATF (Bureau of Alcohol, Tobacco and Firearms), the Greensboro police and the Klan/Nazis are the ones really on trial before the American people. This trial is a sham. They will acquit the Klan/Nazi murderers. I will not cooperate with this coverup.

Prosecution Orchestrates Defense at Klan/Nazi Trial

Nov. 3 Film **Suppressed As Direct Evidence**

GREENSBORO, N.C.-With the Klan/ Nazi trial only a week old, the courtroom has already taken on a humdrum atmosphere. The truth is being covered up in all the BS legal arguments and maneuvering. In fact, many of the facts drawn out by the prosecution are laying the basis for the defense of the Klan. Should the TV videotape of the murders, seen by millions on TV, be allowed as direct evidence in the courtroom? Or can they only be used to "illustrate" facts that are brought out by testimony of witnesses? This is the main question facing the court this week. Both the defense and prosecution stated that the videotapes were key to the whole trial.

Judge Long Sides With Klan/Nazi Murderers

Judge Long, fascist sympathizer, decided in favor of the Klan/Nazi murderers. The TV videotapes will not be used as direct evidence. Of course he had some fine sounding legal explanation for his decision. He said he made the decision "in the interest of justice," to avoid the whole trial being overturned if the murderers are found guilty and they appeal. But this is a lot of doubletalk. The fact is that he is handing the jury legal loopholes to use to let the murderers off. How will this decision affect the trial? The jury will see the TV tapes, but

they will be instructed by the judge to ignore anything they see that has not been mentioned in testimony. What will this mean?

Take the case of murderer Jerry Culp Smith who killed our comrade Cesar Cauce. More than any of the other six murderers on trial, the TV tapes are damaging to him. Millions watched with scorn and outrage as Cesar, hit over the head with a stick fell on his knees. They saw Jerry Culp Smith run up to Cesar, get into a policeman's crouch, take careful aim and shoot. The TV videotapes showed clearly there is no doubt in anyone's mind that this man, who claims he cannot remember a thing from that day, killed Cesar in cold blood. This was done to protect the other assassins who in the meantime were picking off our comrades one by one. He is now claiming that he was unconscious at the time, had no. control over what he was doing, and has. since been suffering from amnesia, remembering nothing from Nov. 3. A TV cameraman, George Vaughn, who filmed much of the assassination, took the stand as a witness on Thursday. He testified that he saw a man in a rust colored jacket (TV tapes show that this was Cesar.) hit over the head, while a man was running towards him wearing a jean jacket and pants carrying a .22 caliber long barreled pistol. (TV tapes show that this

man was Jerry Culp Smith.) But he was unable to testify that he actually saw Smith pull the pistol trigger. Vaughn fell down before the shot was fired. So it would make little difference what the tapes showed. The prosecution must still find a witness to testify that they saw Smith's gun smoking. The videotapes also show that the Klansmen/Nazis coolly stopped their cars, calmly took out and loaded their weapons, and methodically picked off the five CWP leaders out of a crowd of 100, with shots to the head and upper body. But the prosecution will find no one to testify to that, so the videotapes may not be used as evidence at all. Because those tapes show the undeniable truth, the truth that the "prosecution" is so desperately trying to hide.

After the judge made the ruling on the TV tapes, the District Attorney said that the decision will have little affect on the trial. According to him, the jury will see the tapes and be influenced by them no matter what they are told to ignore by the judge. District Attorney Schlosser helped the defense handpick an all-white jury of Klan/Nazi sympathizers. This batch of jurors will be looking for technicalities to let the murderers off. Judge Long and the prosecution has already handed them one on a silver platter. This all white batch of fascist jurors will let the terrorists go free just like they did in Miami and Chattanooga.

Prosecution Does the Job of Klan/Nazi Defense

In another development in the trial, Judge Long accepted the defense motion to subpoena federal agent Butkovich, who infiltrated the Winston-Salem Nazi unit to help plan the assassination. The defense also asked for a copy of the report written by Butkovich to his supervisor after the Nov. 3 assassination. Judge Long ordered District Attorney Schlosser to give the defense any information from the report that could help prove the Nazi murderers innocent. In an opening statement to the court last Monday, the defense stated that it would prove that the six Klan/Nazi defendants were set up by federal agent Butkovich. This is their story. The murderers claim that they thought they would be led to Burke St. Shopping Center where they

Page 3 thought the march was to end. There they intended to counterdemonstrate. Nothing more. They expected hundreds of National Guardsmen to be there between them and the anti-Klan demonstrators. They claim that a police agent who had spent years in the Klan led the caravan to Morningside where the anti-Klan march was just getting under way. That as they drove up they were attacked from all sides by CWP, they were scared for their lives, and shot back. This is their defense in a nutshell. Testimony this past week by Greensboro police officers only backs up the Klan's defense. The police claim that according to all the information through informants, the Klan/ Nazi caravan would confront the demonstrators at the end of the march at the Burke Street Shopping Center. They claim they were surprised that the Klan/ Nazi caravan started out earlier than planned. They claimed they were even more surprised when the caravan headed towards Morningside. They claimed they were shocked when the shots broke out. The confusion over the course destination of the caravan was one cause for the lack of protection. All this was brought out in the prosecution witness testimony this week. This Monday, the courts called on Coner, the first uniformed cop to arrive at the murder scene, to testify as a prosecution witness. To further lay the basis for the defense, he claimed that he found a cosmetic case containing a Derringer near Cesar Cauce's dead body. He also said there were other weapons in front of the entrances to the Morningside project. He said these were not among the weapons seized from the Nazi/Klan caravan. According to a press report, the court is going to prove that these weapons belong to the CWP. This is another classic example of the prosecution laying all the groundwork for the Klan/Nazi defense-that it was a shootout between two groups, so the Klan/Nazis are not responsible for the deaths of the CWP 5. This is despite the fact that the demonstrators were armed with nothing but picket signs and one pistol, against a barrage of automatic and semi-automatic weapons-from a gang that was "shocked" when the shooting started. The coverup continues to be played out each day in court.

NP 5 Widows

Marty Nathan, widow of Mike Nathan, and Floris Cauce, widow of Cesar Cauce, were thrown in jail by the same court that is supposed to try their husbands' assassins. On Nov. 3, 1979, five members of the Communist Workers Party, Jim Waller, Cesar Cauce, Mike Nathan, Bill Sampson, Sandy Smith were murdered by the KKK/Nazis/FBI in Greensboro, N.C. At the time of his death, Mike Nathan left behind his wife and a six month-old baby.


On Monday, Aug. 4, at the trial of the Klan/Nazi murderers, Marty Nathan stood up to the jury of secret Klan supporters, "This court is a sham, the real criminals are not being brought to trial here. It is the government that killed my husband and the CWP 5. The government is using this trial to bring in fascism." For speaking out, Judge Long, the presiding judge, had four men pin her arms to the side, gagged her mouth with tape and threw her in jail for 30 days. First the U.S. government murdered her husband and now her baby is left with no mother.

But a gag around Marty's mouth couldn't silence the truth. Floris Cauce faced the court squarely, "There is no justice in this courtroom. All jurors have been convinced that murdering the CWP 5 was no crime." She too, was sentenced to 30 days in jail. The bravery of the widows, who continue to hold high the banner of their martyred husbands has unnerved the whole court.

TWO months after the Communist Workers Party victory against the Klan and government .in Kokomo, Ind., Kokomo Police Chief Roger Fain has been traveling around the country bragging about the great job his boys did protecting the Klan. This flunky for the ruling class is so proud of the Kokomo Police Department's (KPD) protection of the murdering, racist Klan that he blabbed it across the front page of the June 26 Kokomo Tribune. Straight from the horse's mouth, Fain confirms the CWP's analysis of the role of the government in defending and promoting the Klan.

Fain Admits He's Best in Defending Klan

"We didn't find the idea of bringing them in from another location included in any other city's plan. KPD's plan was to bus the Klan into town from a secret location, start the march in an alley away from the publicized area and surround the marchers with a ring of police." This is the truth behind all the Kokomo City Government's lies about "protecting constitutional rights" that was exposed by the CWP long ago.

While the government and capitalist class lie about "neutrality" towards the Klan, they all reveal themselves as staunch Klan supporters. See what the Kokomo Tribune said, "The police chief said his investigation into other areas, including Ill., Calif., and N.C., had revealed that the anti-Klan protestors had provoked the violence." What a beautiful defense for the Klan murderers whose history is built n countless lives and blood of Afro-Americans, working class leaders and progressive civil rights activists, as well as communists, most recently the CWP 5.

Fain went on to boast about his part in the ruling class' nation-wide, coordinated attack on the CWP and other anti-Klan activists. "Other cities like Columbus and Cincinnati helped us prepare for our march giving us a better idea what to expect. We are just returning the favor (and) helping law enforcement in general by keeping everyone abreast as to the different techniques that can be used to avoid trouble."

"Who's making trouble?" Comrade Clarence Dowdy asked a rally in the black community the night before the march. "It's the mayor and the city council who are supporting the Klan by letting them march, by giving them the green light to carry on their campaign to split us up. We've got to fight the Klan and U.S. ruling class who is backing them up under the cover of "constitutional rights."

Party's Sharp Leadership **Throws Cops into Sweat**

The May 12 Workers Viewpoint summed up the April 26 demonstration this way: "This small Indiana town, long a stronghold of Klan terror, had never seen anything like it. With ranks tight, over 200 people marched the streets of downtown Kokomo, and the demonstrators led by the Communist Workers Party came into view down Sycamore Street near the court house . . . As anti-Klan marchers hit the street, the police gave the signal and the Klan scrambled down a back alley into a waiting police van." This is just as Fain describes it. "At the first sign of trouble, the march was to be cut short of its planned two revolutions around the courthouse and Klansmen escorted into the same alley where they emerged.'

It's clear that to the police the "trouble" was the CWP, not the Klan. As soon as the Party-led caravan unloaded in the black community, the police radioed "Here they come!" and the cops hustled the Klan down a back alley. This is precisely because what the capitalist class fears most is the Party's higher level political propaganda and higher level organization inspiring the black and white people of Kokomo and across the country. They know the Party's sharp communist analysis of why socialist revolution is the only solution for the American people, coupled with the Party's sharp military tactics, are the real danger to their rule in the 80's.


Fain himself admits that the CWP helmeted defensive forces and tight ranks threw the cops into a sweat. He said they made three major mistakes. First, all of one squad scrambled to put their gas masks on at the same time. "The way it's supposed to be done is every other officer in line puts on a mask so only half our force is occupied doing that at one time. They (CWP) might have charged and broken our lines at that time." Another mistake was letting the Klansmen straggle out along the march leaving some unprotected. Third, "we opened up the downtown to traffic too early." But Fain, relieved that no Klan scum were hurt and that his troops managed to stay in one piece, sums it up this way, "The interest other cities have shown in the way we handled the situation shows how good a job we did."


Kokomo Defines Class Struggle of the 80's

But the truth is the boycott of downtown called for by the Mayor was a complete failure. Setting Up False Target U.S. Gov't. Attacks Iranians Celebrating Butcher Shah's Death

WASHINGTON, D.C., Aug. 1–On July 22 a man dressed as a mailman knocked on the door of the Bethesda, Maryland home of Ali Tabatabai. Saying he had registered mail the Iranian had to sign for, he quickly pumped several shots into his stomach from a gun hidden in a handful of letters. The gunman escaped leaving the mail truck two blocks away.

Immediately the Washington Post gave half of its front page to the story saying Tabatabai was an anti-Khomeini Iranian living in exile and fighting for a democratic Iran. He had organized the Iran Freedom Foundation and in the last six months he alone had been on more TV and radio shows than all of the pro-Khomeini Iranians combined. places the government didn't want publicized. He was fired from this job for stealing money from the department he worked in and he returned to the U.S. in 1973.

Saying that SAVAK had made him leave Iran, he began publishing an anti-Shah newspaper. Iranians in D.C. suspected that he still was working for the Embassy and that the paper was put out by the embassy to confuse the anti-Shah Iranians. By 1975 he was back at the Embassy as a close aid to Zahedi, the hated ambassador who was as close to the CIA as he was to the Shah. Ali was the embassy's liason to Capitol Hill from 1976-1978, where he bribed and partied the politicians with wild orgies at the embassy and even at his own home which Zahedi helped to buy. These parties were even photographed by the embassy for future blackmailing schemes. He remained at the embassy even under Bakhtiar's (Prime Minister appointed by the Shah before he left the country) regime and was kicked out when the embassy was taken over by Khomeini's supporters. He returned a short time later with a gang of Iranian soldiers that were being trained in the U.S. and got into the embassy and destroyed many of the secret files they had on student activists as well as the politicians they had bribed. He received political asylum from the U.S. government as a reward for his work.

D.C. Cops Provoke Pro-Khomeini Demonstrators

The U.S. ruling class has been desperately trying to build up its sagging anti-Khomeini campaign. With the Shah's death and the hostage situation unchanged, with the economic crisis deepening every day, the national chauvinism that they hoped to fuel would cover these other crises. Tabatabai had been organizing a small anti-Khomeini demonstration by reactionary Iranians for July 27. With his death on July 22 ing for revenge after being overrun by the anti-Shah demonstrators three years ago during the Shah's visit to the White House. They tried to provoke the pro-Khomeini supporters all afternoon, while snapping at bystanders. In one incident they threatened an American who wanted to join the students that his four-year old child with him would get hurt if he didn't stay away from police lines.

When the march reached 15th and G Street near the White House, the police attempted to pinch off the pro-Khomeini students from continuing on along side the Shah's supporters. The students locked arms in defiance and the police swooped in swinging their riot sticks. Eight to 10 students were taken to the hospital for treatment. When the day had ended 191 Khomeini supporters were jailed. The 150 Iranian reactionaries in their designer jeans and gold jewelry boarded chartered buses as they left and applauded the police for their dirty work.

Typical Opportunist Used by U.S. and the Shah's Regime

Iranians who knew Ali for the last twenty years described him as a complete opportunist who would do anything to be sure he had a new car, fine clothes, and a luxury apartment. As a student at Howard University he worked part-time for *Voice of America*, a radio program which preaches U.S. imperialist propaganda to the world's peoples. He then got his first job with the Iranian government in the U.S. Embassy where he began to inform on Iranian students who were active against the Shah.

He returned to Iran in 1972 and got a high paying job as a government guide to the foreign press in Iran. His job was to be sure these guests had a good time and to keep them away from people and

When news of his death spread, people who knew him clapped happily saying it couldn't have happened to a nicer guy. Tabatabai had become one of and the Shah's death on July 26, three other Iranian groups planned marches on the same day to support the Khomeini government.

The pro-Shah-Bakhtiar Iran Freedom Foundation, the phony organization funded by the Shah headed by Tabatabai, got full police protection on a march route that began on the steps of the Capitol and ended at Lafayette Park across from the White House. Along the march route bands of U.S. servicemen in street clothes and young Klan sympathizers heckled and picked fights with the pro-Khomeini Iranians who jeered at the marchers. Smash Sell-Out **Arbitration** In Local 2 Strike

SAN FRANCISCO, Ca., Aug. 2 - Defying picket injunctions, massive arrests and harassment from hotel guests who throw shit at the picketers, the Local 2 Hotel and Restaurant Workers' strike is needling the hotel bosses where it really hurts. Management scabs are complaining about backaches and columnist Herb Caen is humoring on jammed-up toilets at the Fairmount. With rumors of a taxi drivers' strike next week, tourists are checking out ' of San Francisco en masse. Negotiations resumed for the second time, with Charles Lamb, President of Local 2, Sirabella and Mayor Feinstein busting their asses to channel the contract issues into binding arbitration. A Hilton worker hit it right on the nose: "If that's what we're fighting for, why the hell did we go out?'

"Lamb was forced to go out on strike because of rank and file pressure, especially from the United Hotel and Restaurant Workers [a rank and file caucus with Communist Workers Party leadership]," said Richard Leung. Leung is a former business agent who posed so much threat that Lamb fired him. "Now he is rigging up the sell-out arbitration by dangling a few pennies that don't even catch up with inflation. The fact is people are hurting, with only a promise of \$50 a week strike benefits. Lamb and Sirabella were forced to fake militancy by staging a bust; actually they are working double time to sabotage the strike by letting scab trucks in and signing interim "me too" contracts with the smaller hotels

Sirabella had to admit that 'the arbitrator is less likely to agree to many of the tradition-shattering proposals demanded by Local 2.

"This is how hotel bosses, union hacks and government politicians are using legalistic channels like arbitration to diffuse and divert people's anger under this economic crisis. It's a false choice they are presenting. The only choice is between capitalism and socialism, with the strike as a weapon, and in the course of fighting for higher wages and better working conditions learn how to smash the capitalist class. Only under communist leadership will the workers learn their power as a class and the organization needed to finish the bloodsuckers off once and for all. That's why it is stabbing workers in the back by banking everything on the strike and then offer binding arbitration as the only alternative.'

On the picket lines, the initial euphoria is over. With eight-hour picket duties and strike benefits only a promise, people are asking questions. "Some people are feel-ing demoralized," said Kathy Bibby, a leader of UHRW. "It's like what McDonald (former president of Local 2) said before the strike. 'You're damned if you do (go on strike) and you're damned if you don't (go on strike)'. But it's the best time to do propaganda because people are sobering up. Just the other night when six police cars, with their sirens screaming, charged at our picket line because of a phone call, one of the first things they did was to arrest a picketer. 

CWP Busts Up Feinstein's Press Conference

SAN FRANCISCO, Ca., Aug. 7-The banner was quickly unfolded across the balcony of Mayor Feinstein's office while inside Communist Workers Party members and supporters busted up her conference on Local 2 and the Democratic convention. The banner read: "Feinstein, Carter, Kennedy, Reagan = Crime, Corruption, Murder. Serve Notice to the Politicians in the N.Y. Democratic Convention. Prepare for Workers' Rule." Seven CWP members and supporters had just gotten away while Secret Servicemen fumed over our successful and quick maneuver that made them look like fools.

Two squads of riot police lined up next to the militant picket at the top of the stairs of City Hall. The commander told one of his officers, "Henry move back." Henry was so disoriented that he attacked prematurely and stepped away from his post. Then in broad daylight in front of TV cameras, the riot police started swinging clubs at the demonstrators.

However, if the government thinks that the cop's clumsy reaction could intimidate us, they are highly mistaken. This time, City Hall wasn't dealing with a spontaneous riot of unorganized individuals that could be dispersed easily. Instead, they are dealing with the advanced detachment, the vanguard of the working class, the Communist Workers Party, U.S.A. For the first time since the 50's the struggles of the working class is turned from one of scattered and spontaneous one into an organized resistance—whether it is serving notice to corrupt politicians or striking in their shipyards where war ships are made. Party Fends Off Police Attack

In the face of this police attack, we stood our ground. Two workers jumped to the front line using their bodies as shields for others and pickets became sticks. Swastika Burnt to Honor Fed Bureau Chief Assassin



Dickerson's house is in the superexclusive suburb of McLean, Va. Late Saturday night a Klan effigy hung from a tree in front of his house, and on Monday morning, CWP set up a picket. The cops were waiting out front, with more sitting hidden in the house. They attempted to disrupt our picket and provoke violence by stopping a car in the middle of the picket. We stood our ground, stepped up our exposure of the police and pointed out their role in the November 3, 1979 murder of our comrades. The pig was forced to move his car.

When one neighbor asked why we were

there, we told him that Dickerson is a fascist murderer who carried out the government's attack on the CWP.

The picket moved to the Bureau's headquarters in Washington, D.C. where the police had already blocked the entrances and lined up to protect assassin Dickerson. The CWP talked to government workers, tourists, and unemployed hanging out downtown, hitting the government for planning the assassination and linking the murders to the growing revolutionary anger of the American people.

The militant picket and strong propaganda from the bullhorn grabbed their attention and crowds gathered to listen. Many bought newspapers. While the response was mixed, most knew of the murders and immediately supported the picket, placing the blame squarely on the U.S. government.



MIAMI, Fl.—On August 8, the CWP gave the Democrats a taste of its own medicine, compliments of the people of Miami. At 2:30 p.m., the CWP teargassed the Democratic Party Headquarters. The gas, expropriated by the people during the May 17 rebellion and given to the CWP to use. There was enough to saturate a whole city block—almost the amount used against the residents of Liberty City by the police and National Guard during the uprising. I had someone I could talk to about it even though it was only every year or so that we could get together. I live in Florida and he in Pennsylvania. But there are a lot of people who do not understand the paper, as myself when I started to read it. People get turned off right away when they read communist. Now I believe it is a little strong for people who are not educated on the paper. As you all know, we all had these lessons in school, so the word is very mis² understood. If you did away with the word and used something like The Peoples Party many more would leave their minds open. And there's some articles that are too strong. I can't get people to listen and understand because they read things like I killed a pig and I'm proud of it. Your average person can't comprehend this. I believe now is the prime time to talk to people and try to get people to unite. They are ready to listen, and I have talked to all ages. But I find it tiring to try to explain the paper after they have picked out some strong articles to read. The main ages are 16-20 and late 50's, they totally misunderstand the paper. We are all in total agreement about changes and how to do it and to work on it. But if the paper could print some beginner articles, for those trying to understand, like myself. I now understand better but would like to learn more and people need to trust someone. I have a little more trust because of the person I am able to talk to. And it is the majority you are after and the way the paper now reads, when someone close picks it up wherever it may be they are gonna lay it back down or throw it away. The little I know, about the people and the Workers Viewpoint paper, I like. I am trying to talk to more people and they're eager to listen. I wish somehow we could get a group together in this area. Thank you for your time.

Your letter raises several crucial points that our Party must deal with if we are to successfully meet the challenges of the 80's. First of all, we would like to unite with your criticisms and thank you for taking the time to let us know about them.

The majority of American people today are waking up to political life, many people for the first time. The working class' indifference to politics and most social questions that was characteristic of the 50's, 60's and 70's has given way to strong positions and opinions in the 80's. Ordinary people, average people are being drawn into politics whether they want to be or not. Iran, the Olympics boycott, Miami, etc. - people today take sides on all these events and very rarely do you hear someone say "I don't care." Values, morals, the family, the American Dream all these and more are being torn apart and shredded up right before our eyes. For the first time in 30 years, the majority of people are beginning to question their whole lives and wonder what it is all worth.

The essence of the matter is that the majority of people are questioning capitalism and are open to alternatives, including communism. This is what the situation boils down to.

But in practice, in life itself, things are not so neat and orderly. The disorder in people's lives - like going from the assembly line to the welfare line, with all the negative ideas that welfare has - and the disorientation that people are feeling doesn't mean that they will automatically turn to communism. Many people snap altogether and turn to drugs, alcohol and even suicide. Others turn to TV preachers like Jerry Falwell and the PTL Club in order to get grounded and make sense of the world.

People will turn to communism if we can reach the majority of people and explain what is happening to them, to their families and friends and to society as a whole. And we must learn to explain it in a way Many people have asked us that people understand. We cannot give a pat answer such

have to convince them of the correctness of our analysis with lots of facts and figures. Some of the articles still do not use enough facts, so are not authoritative enough. Then when people read it, they have no choice but to take it or leave it; then it is not controversial and thought-provoking and does not inspire debate.

You said that some of our articles are too strong and you object to some of our language. In certain articles we take a stand with certain responses to oppression (I killed a pig and I'm proud of it). In order to be authoritative, we must not only have facts and figures but must also be a militant voice of the working class. That article draws out the deep hatred of brothers and sisters who have direct experience with police brutality and would like to kill some cops themselves. But we should also be concerned about people's attitude towards death, like "I may not like the police, but I'm sorry for his widow and children." In that sense, we should also explain what cops represent, why this brother killed a cop and why we stand with him. Then the article will be more convincing even to those who don't hate cops as much. Once that's done, readers will take a stand based on our meaning, not on language alone.

We must learn to educate our brothers and sisters in the Party's line through everyday experiences and through life itself. In addition, we run a regular column on the basics of Marxism and publish a theoretical journal, The 80's.to give more comprehensive analysis of different issues. We would appreciate your comments on these too.



in protest of their arrests.

The other prisoners saw the double standard of treatment being given out. The guards complained that they couldn't use the force they were accustomed to using on the prisoners. The jail officials covered themselves saying that they feared for the safety of the American hostages if these Iranians were handled in the usual way American prisoners were handled.

The capitalist ruling class through Carter had to use the Immigration Service to rescue the D.C. government from the humiliating position the students had put them into, and to salvage their attempts to fuel national chauvinism. It took three cops for each student to get them on to buses where they were taken to Andrews Air Froce Base and flown to New York to face deportation hearings in several weeks. The only way they could skirt around the police riot charges, and defuse the situation at the D.C. jail, was to make an international case out of the arrests. Yet the students will continue to show their support for the Iranian revolution in the jails in New York or in front of the White House where even more students are holding another hunger strike.

U.S. Imperialism's Bloody History In Latin America

kicked out the U.S.-backed Somoza regime in Nicaragua, Latin America is engulfed in the flames of revolution.

*Revolutionary groups in El Salvador have formed a united front to liberate their country from the clutches of the fascist Christian Democrat government and U.S. corporations. The government has already murdered over 3,000 people this year, and the country is on the brink of civil war.

*In neighboring Guatemala, liberation groups hold the northwestern part of the country, and the military regime, barely clinging to power, has desperately set up assassination teams to terrorize the people.

*Last week in Bolivia, tin miners called a general strike, seized the mines, armed themselves and barricaded the roads after the military staged a coup against the results of the presidential elections.

What seems like chaos is actually the birth pangs of a new order and the death cries of the old. Why is the U.S. government and multi-national corporations so hated by the people of Latin America? Why is the U.S. so involved in this area of the world anyway? And most important, why should we, the U.S. people, support these struggles against U.S. imperialism?

Newly-Independent U.S. Turns **To Colonialism**


Just like the U.S. fought the War of Independence to shake loose from British colonialism, Latin America fought tooth and nail to kick out Spanish and Portuguese colonialism. Starting with the successful revolution in Haiti of black slaves in 1804, for the next twenty or thirty years the great part of Latin America was liberated under the leadership of men like Simon Bolivar. During the War of Independence the American workers, farmers and small shopkeepers had broken the stranglehold of the British, only to put into power the

Only one year after the Sandinistas American capitalist and big landowning class Once in power, this class began to turn the country from a friend of the world's people to one of their oppressors. In 1830, the Monroe Doctrine was announced, declaring Latin America the U.S.' backyard and warning the European powers to stay out.

> The U.S. grabbed the British, French, Spanish and Portuguese colonies for itself. Through the Mexican-American War, the U.S. seized one-half of Mexico's territory. The Spanish-American War of 1898 turned the newly-independent Puerto Rico into a colony of the U.S. The Marines were sent into Panama, killing thousands and dividing the country in half so the U.S. government could annex the territory needed to build the Panama Canal

Rockefeller Seizes Chance

By the 1930's, the U.S. was one of the top imperialist powers in the world. Under Roosevelt's administration, John D. Rockefeller became the Coordinator of the Office of Interamerican Affairs. Taking advantage of the worldwide Great Depression and the Second World War, Rockefeller drove out the smaller capitalists; dismantled the German, Italian and British interests in Latin America and turned it into the exclusive domain of the biggest U.S. monopoly corporations. Consolidated Mining had free reign to exploit the gold, silver and tin throughout the continent. United Fruit reaped all the fruits, sugar cane and coffee, Gulf and Exxon sewed up the oil and fertifizer markets while Alcoa and Anaconda seized the bauxite and copper mines. And Chase Manhattan and Citibank loaned the countries money at ridiculously high interest rates. Heads of corporations became the real rulers of the land and the military regimes they established were to guarantee their superprofits by force of arms. In Honduras and the Dominican Republic, United Fruit not only owns the farms, but also the roads, the electricity, railroad, shipping, telephone and tele-



graph. No wonder that throughout Central America, the nickname for United Fruit is "El Pulpo"-the Octopus.

U.S. Uses Monopoly Position to Strangle Latin America

The U.S. imperialists squeezed the people of Latin America dry and raped their land. Surplus goods from the U.S. were dumped onto Latin America whether they wanted them or not. By the 1970's, 80 per cent of all U.S. exports were headed towards Latin America. And the return on their investments, the superprofits gained, were tremendous. Citibank received 20 per cent of its total profit from Brazil alone.

Latin America was turned into a gigantic plantation producing coffee, banana and sugar for export by these corporations. Once self-sufficient in food, the countries in Latin America are now forced to depend on imports from the U.S. At the same time, with the monopoly capitalists controlling the worldwide market for produce, Latin American countries are forced to accept whatever price the monopoly capitalists are willing to pay. 70 per cent of the world's banana trade is controlled by three companies-Castle and Cooke (which markets Dole), United Brands (formerly United Fruit and markets Chiquita) and Del Monte. One-fourth of the sugar market is controlled by Amstar, formerly known-as the American Sugar Refining Co. and onesixth of the coffee market is controlled by General Foods.

The U.S. government helps these corporations maintain their monopoly. In 1969, the U.S. refused to renew the International Coffee Agreement until Brazil agreed to impose a tax on exports of Brazilian instant coffee. In this way, General Foods maintained their worldwide control of the instant coffee market. The old Sugar Act only allowed Latin America to export raw, not refined sugar, again protecting these corporations. Unable to develop or market their own products, Latin American countries were at the mercy of the corporations. Besides unequal trade agreements, they were forced to swallow the inflation dumped on them from the U.S. While it cost Latin America the equivalent of 160 bags of coffee to purchase one tractor in 1960, the same tractor cost the equivalent of 400 bags in 1977. Out of every dollar's worth of bananas, only 11 cents stays in the country to go back into the economy.


Even when prices go up for produce, the countries do not see any of the profits. Everyone remembers the coffee and sugar shortages in 1974 when prices rose sky high. The foreign exchange of the Latin American countries rose by a small percentage point. But Amstar, which refines and markets the sugar, had a 420% jump in profit. The next year, worldwide market prices fell and countries like the Dominican Republic suffered a loss of \$350 million in trade. But prices remained the same on the supermarket shelves and the corporations still made a bundle. This pattern of U.S. imperialist domination applies to other sectors of the Latin American economy. Gulf, Exxon and Texaco pumped the oil out of Venezuela like mad. Since they controlled the worldwide oil market, they were able to set the price. When Venezuela tried to build an oil refinery to process their own crude, Big Oil slammed the door and bovcotted Venezuelan oil. Without tankers to market the oil and with the refinery not finished yet, the Venezuelan economy almost collapsed.

Peasants Crushed While Imperialists Profit From Green Revolution

The imperialists even use so-called economic aid to further their plunder of third world countries. To set up large scale agri-businesses, U.S. imperialism forcibly drove tens of thousands of peasants from the land. Because of the large scale production through mechanized farm machinery, fertilizers etc., the large plantations were able to sell their products cheaper than the peasant could and drove them out of business. Many peasants also lost their land when they rented it to these plantations. At the end of the contract, the plantations demanded the peasants pay for improvements made on the land. Unable to afford the outrageous charges, many peasants were forced to hand over their land. Other peasants had their crops destroyed by chemical sprays and their irrigation waters purposely polluted.

The Green Revolution is an example of how imperialism, in the name of progress and "aid." fattened their wallets and exploited the people. Backed by the Rockefeller Foundation, hybrid seeds were developed in the late 1940's that signalled the beginning of what they called the "Green Revolution." These seeds were supposed to increase crop yield and solve the food needs for the world. But the hybrid seeds could only be planted on irrigated land and required tremendous amounts of fertilizers and pesticides. The small peasants, trying to plant these seeds on their tiny plots of less than five hectares of land, got into debt and lost their land. Only the large plantations lording over tens of thousands of hectares, with their capital could afford these seeds and benefited from it. The peasants were forced to become agricultural workers in these plantations, getting work on a seasonal basis. Each year that these seeds were used, the need for fertilizer and pesticide increased, of course, supplied by U.S. corporations. To continue raising the crop yields, pesticides were applied up to 50 times a year as compared to seven times before. Corporations like Exxon supplied the pesticides, dumping pesficides that were obsolete or proven dangerous. DDT, banned in the U.S. since 1972, continues to be sold and used throughout Latin America.

In the ever thirsty drive for profits, crop dusting planes are used without regard to the people's health. Toxic chemicals are sprayed while workers are in the field and the fumes also descend on their homes. A recent UN study showed that in Guatemala and Nicaragua, the average DDT content in human blood is 520 parts per billion as compared with 46 in Dade County, Florida, one of the highest levels in the U.S. These pesticides have caused



hundreds to die from poisoning, uncounted number of aborted pregnancies, sterility. All that the "Green Revolution" did was increase the greenbacks stuffed into the pockets of the Rockefellers.

People Forced to Eat Junk, **Imperialist-Style**

The dislocation of the peasants from their land and increasing mechanization have caused 60, 70% unemployment. Those that have work in the plantations or the mines, risk their lives for starvation wages. Peasants and workers stay in the same position at work from sunup to sundown, causing them muscular disorders and circulatory diseases. The chemicals and dust from the mines cause lung and neurological diseases. On the average, Continued on page 14

U.S. Military — Colossus With Feet of Clay

SINCE the end of World War II, the U.S. government has amassed one of the largest arsenals in history. It has spent over \$2 trillion in the people's taxes. But on any given day, only 13% of all U.S. combat fighter planes are in a state of readiness as a recent Pentagon study showed.

* The XM-1 tank, the first new American tank in 20 years, rolled off the assembly line in February. But when the tank was shifted into reverse, it got stuck in that gear.

* May 1980, the U.S. launched its military commando raid against Iran. Two of the RH-53D helicopters malfunctioned, another one crashed and, abandoning all the helicopters and leaving eight dead men, the commandos beat a hasty retreat.

* In Germany, the front line of Europe in the event of war with the Soviet Union, many GI's don't even have bullets in their guns. The reason? The officers are afraid of being shot by their own men.

How ready is U.S. imperialism to wage a world war with the Soviet Union?

Scenario for a World War

With the recent establishment of the Rapid Deployment Force, the Pentagon strategy is to be ready to fight one and a half wars — a major war in Europe and another smaller war, probably in the Middle East — at the same time. Under this plan, the 4,000-man Division Ready Brigade of the 82nd Airborne Division stationed in Fort Bragg, N.C. will be the first unit sent out to the Middle East in the event of war. Within this unit, a 1,000man battalion, ferried by C-5 and C-141 transport planes, will be in position and ready to fight in 18 hours. The other 3,000 will be ready in another six hours. In two more days, the entire 16,000-man division will be in place.

But the 82nd Airborne lacks tanks, artillery and armored personnel carriers to dig in for a long war. Even if the U.S. Army had these heavy support weapons to spare (which it doesn't), lack of transport planes would prevent them from reaching the 82nd Airborne. The largest transport plane available now can fit only two of the new XM-1 tanks. The closest supplies are in Europe but any shipment of arms from Europe would drain stocks to dangerously low levels. And if Europe is embroiled in a major war, supplies from there would be out of the question. The only alternative would be to mobilize the 12,000-man 3rd Marine Division and the 1st Marine Air Wing, based in Okinawa and the Philippines. Even if these forces were mobilized immediately along with the 7th Fleet, it would still be two months before the arrival of reinforcements. By that time, the 82nd Airborne would be completely routed - their supplies would have run

fire one anti-tank missile practice round a year. Costing \$3,000 apiece, there simply aren't enough to be spared for practice. The Pentagon not only wants more helicopters, tanks, missiles, ships, submarines and planes to throw away in a war to redivide the world with the Soviet Union, but they also need to stockpile ammunition and spare parts for all their weapons. The U.S. economy, stagnating and dying because of the inherent contradictions of capitalism, simply cannot rearm quickly.

The economy has been irreversibly poisoned by militarization. To get itself out of the Great Depression, U.S. imperialism went to war. During World War II, auto plants were converted to make tanks and planes. Steel mills churned out the specialty steel needed for armorplating and other military needs. Shipyards worked overtime to build battleships and aircraft carriers for the Navy. The lead time for the development of a new weapon, from drawing board to mass production, was about 90 days.

After the war, this bailout of the economy not only continued, but was stepped up. More than 20% of the labor force now depends on armament orders from the Defense Department. Fully twothirds of the total U.S. scientific and technical manpower is related to armament and space research. To finance all this, the U.S. has gone on deficit spending - buy now and pay later. As the deficit grows, the economic crisis deepens.

Instead of money pumped into building better cars, to make steel for construction, to develop better health care, etc., money goes to make tanks and other weapons. Half these weapons are obsolete by the time they are produced as another generation of weapons is already in production. Billions of dollars are wasted, literally like pouring cars and steel into the ocean while the people get more impoverished.

The companies, with guaranteed profits from military contracts, lose the intiative to invest in new plants, new machinery, etc. Cost overruns in the millions are accepted by the government. Chrysler, which makes the new XM-1 tank, got millions from cost overruns. And still it was on the verge of bankruptcy. The government steps in once again to give it a loan and bail it out. This results in even more stagnation of the economy to the point where technology for new weapons outstrips the capability of the industries to produce them.

The same plants that were making planes in the 1940s are supposed to produce the weapons today. Most of them are half a century to a century old. Even if they could handle the new requirements of this generation of weapons, production will still not step up: most of these plants are

the plane, only two U.S. companies have presses big enough to make the extrusions of the wing plank and they are already working at full capacity.

The titanium armor for the A-10 must be ordered two years in advance because of a titanium shortage. The bearings, fasteners and electrical connections must be ordered from 30 to 90 weeks ahead of time. And the engines for the plane, made by General Electric, need the same titanium, hightemperature alloys and forgings that are in short supply. In fact, some planes are being built without engines because of a strike by GE workers. Even without the strike, it takes two years for GE to order and get the materials they need and at least another year before it is developed for the A-10. If a new plane is designed and production starts up right away, it will take another two years just to build the machine tools necessary for production. These same shortages plague all the weapon systems that the U.S. military wants. The new XM-1 tank uses an airplane engine. With these problems, it will be no surprise if the Air Force has a fleet a planes that don't fly and the Army has a division of tanks that don't run because they don't have engines.

Third World Struggles Lessen Danger of World War

A big reason for these shortages is the need for raw materials like titanium, chromium and cobalt. Most cobalt comes from Zaire and most chromium from Zimbabwe and South Africa. As third world countries kick U.S. imperialism out and become independent, it is harder for the U.S. to exploit them and get the raw materials it needs to wage a war. Zaire stopped shipping cobalt to the U.S. in 1978 and the same may happen with Zimbabwean chromium. Also, OPEC countries threaten to cut back production if

XM-1 Battle Tank Cost: 12.1 Billion the U.S. or any other imperialist country tries to use oil as a strategic stockpile. Unable to build an oil reserve, U.S. as well as Soviet tanks will quickly run out of gas in a war.

Besides cutting off raw materials, third world countries are kicking the superpowers and their military bases out. The U.S. has already lost its bases in Viet Nam and Iran. The Soviet Union is finding it hard to keep military bases as the Eritrean people and Afghanistan people are fighting hard. Without military bases and a stockpile of different weapons around the world, both superpowers are unable to gear up quickly for war. The more the third world countries rise up in struggle, the fewer areas are left for the superpowers to contend over and the harder it is for them to start a new world war.

U.S. People Won't Stand for Another World War

Even if the Pentagon had all the weapons they need to throw away in a war, they would still need manpower to operate the weapons, manpower willing to sacrifice their lives for U.S. imperialism. The Pentagon doesn't have that either right now.

After the Vietnam War, the U.S. military began its Volunteer Army program. Boosting pay scales and promising skilled training and college education, the military tried to lure prople into the armed forces. But the pay raises in 1972 have been eaten up by inflation. The \$448 a month basic pay is less than the federal minimum wage. Close to 20% of the Air Force qualifies for food stamps. The lack of jobs due to economic crisis makes many youth join the army as a last-ditch alternative. They still hope to receive some of the Continued on Page 13


And what would happen in Europe? The Pentagon in 1978 conducted a world-wide military-readiness exercise, code named Nifty Nugget, to find out the answer. The exercise found that 600,000 men will die in a European battle. Thousands more wounded will die because of inadequate supplies. Soldiers will run out of bullets. Communications systems will be in total disarray. The draft mobilization center computers will break down, snarling the draft program. Uniforms will run out for the new recruits, and even if they get miraculously equipped, there will be no way to rush them to the battlefield quickly.

Stagnating Economy Makes It Impossible to Rearm Fast U.S. tank crews are lucky if they get to


already closed because of the economic crisis. Lead time for development of a new weapon is at least five years.

The new A-10 attack plane for the Air Force is a perfect example of the quandary that U.S. imperialism faces. The A-10, equipped with 30-mm rapid-fire anti-tank gun and an arsenal of bombs and missiles, will be the mainstay of the Air Force in providing air support for ground combat troops. benefits that are promised. Once in the army, they find that to be eligible, they have to sign up for another tour of duty. GI's are bounced from base to base, making family life ridiculous.

Youth respond by leaving the army in droves. Fully one-third of the enlistees leave before their first three-year term is up. Of those who remain, morale is low and sabotage of equipment is rampant. The army cops out by saying the enlistees are "mentally incompetent", that they are not intelligent enough to work all the sophisticated weaponry. But the truth is that enlisted men refuse to follow the orders of their commanding officers. They pretend they can't understand the orders to get out of the work and if the situation is intolerable enough, they'll frag their commanding officers. Beetle Bailey is more ready to fight a war than the army is right now

Besides the problems of keeping the enlisted men in line, the military has a problem in maintaining its officer corps. The army needs a strong, lean and stable officer corps so that in case of war, these officers can train thousands of new recruits. But even the officers, some with ten and more years in the army, have decided to call it quits. The Air Force estimates that it needs to retain 60% of its pilots and 54% of its navigators with 12 years of service to maintain its strength. Right now, only 27 pilots and 40 navigators out of 100 are re-enlisting. The Navy is 35% short of pilots and it estimates it will be short by half in two years. The Navy, short of 21,000 petty officers, can't even maintain its ships at sea because of the lack of personnel. The traditional drill sergeant in the army is being replaced by a drill corporal, who has just completed basic training himself, because there aren't enough sergeants re-enlisting. In other words, the military won't have a crew to fly their engineless planes. But the main reason the U.S. can't go to war now is the U.S. people won't allow it. The Vietnam War, Watergate and the phony energy crisis have exposed U.S. imperialism. Before Carter could even get the draft legislation passed, thousands of people rose up in protest, vowing they will not register and fight Exxon's war. Weeks before the registration began, the draft registration center in New York City's Times Square was firebombed, signalling actions to come. On the first day of registration, picket lines and demonstrations filled post offices around the country. Thousands stayed home and didn't bother to register. The message of the U.S. people is clear — we will not be sacrificed to maintain U.S., imperialism.

U.S. Must Institute Fascism to Go to War

With no bottom in sight for the downward plunge of the economy, U.S. imperialism has no alternative but war to conquer new markets and redivide the world. To this end, the government is pumping even more money into the military. After a short drop in defense spending after the Vietnam War, the defense budget has skyrocketed again. In 1972, the defense budget was \$78.3 billion dollars. This year, Carter submitted a defense budget of \$250 billion. But even this won't be enough. A Business Week report this this year estimated to prepare for war with the Soviet Union, the U.S. needs to spend \$1 trillion by 1985 — fully half of all the money spent from the end of World War II to the present.

To finance this scheme, more money will be printed, driving inflation out of sight. Money will not be invested in anything else except the military, furthering the economic stagnation. The U.S. economy could start looking like the Soviet Union — a military giant but an economic dwarf. Because of the militarization of the Soviet economy, the whole Soviet agriculture was destroyed. With no money left to reinvest in seeds, fertilizers and new tractors, the land was left to rot. In the Soviet Union, agricultural production between 1962 and 1972 dropped six times.

This means the U.S. people, just like the Soviet people, will be left to starve. There will be no cars and no gasoline. Schools and hospitals will be closed as social services are cut. Plants will shut down right and left as the economy grinds to a dead stop. Forget about social security, unemployment benefits, welfare and food stamps - there won't be any. For those who still have jobs, there will be overtime to churn out war goods and no time to see their families. Speedups and cutting corners will cause more industrial accidents. Without regard for anybody or anything, U.S. imperialism will concentrate on the single purpose of war. To get the U.S. people ready for war, the government must and will impose fascism. The ruling class can't afford any resistance at home. They will set up a police state just like the Soviet Union. Strikes by workers will be illegal. Curfews will be common. Shoot to kill will be the orders as the imperialists try to quell the inevitable upsurge. To carry this out, U.S. imperialism will try to whip up patriotism and use scapegoat politics to fan chauvinism. Calls to defend the country will be made. Anti-communism will be whipped up to wipe out the genuine leader-

next move the pigs would make. It took the pigs about 30 minutes to move the strikers up about two blocks, each time marching up a few feet-the strikers inching back slowly. The sentiment was not to run, not to leave, but to go back to the main gate and picket. Everytime the pigs retreated back a block, thinking the masses of workers would break up, workers came back down the street-all the time calling them all the scum names they deserve.


Not clear how to resolve the situation of just going back and forth without being able to break through the police lines, strike leaders suggested the demonstration move down to hit the mayor's office. The response was mixed, while the sentiment was to stick it out with the pigs. One worker said, "we pay taxes, we have a right to be here, let's do it here! "

leave. They waited to see what was the Everytime the pigs got closer, a rash of spontaneous agitation came down on the pigs. One white worker yelled: "You Nazi pigs! This is Nazi Germany all over again! All they want is war, so they can redivide the world. They're going to declare war on us before they can go to war in the world. You can't strike under fascism! Hitler's army! " Another Chicano worker shouted: "Yankee go home!" The white worker said," "Yeah, Yankee go home," knowing the Chicano worker wasn't talking about him.

After about an hour of this back and forth, each time the workers getting up closer to the pigs to curse them out, the pigs finally decided to clear everybody out. They started charging into the people with their billy clubs used as butts to shove people out. Breaking up the demonstration into three sections, people marched out of the area. The pigs were so

scared, they had blocked off the freeway exit to NASSCO. They followed groups of dispersed workers, checking out to. see where they were going. Many were taken into the homes of supportive neighbors. Even though some people broke off, about 200 people regrouped back at Chicano Park to develop sharper plans for the strike.

The negotiations with NASSCO have resulted in them exposing even more what their aims are. The two main demands of the strike are 1) Rehire all the 17 people fired and 2) Total amnesty for the strikers. The Company wants to split up the two demands-saying they would give partial amnesty to the strikers, but they won't rehire the 17 fired. Trying to split up the workers, setting the body of workers against its fighting leadership-they have to try and cut off the head in order to control the body.

The strike continues-the yard is still shut down.

The situation is forcing NASSCO workers to deal with what's at the bottom of this whole situation. They know that if the union gets busted, there's no talk of getting a decent contract in '81. They got a taste of worker's rule when they took over the ship launching and put the Navy and NASSCO in their place. They've got 300 pigs to contend with, just to maintain their picket lines. And they know through their own sweat and blood that it's workers who build the ships and make the yards move. They got a good taste of what fascism will mean in this country, but the alternative has to be clear. Workers' rule is the only thing that can beat back this inflation, war preparations, fascism, and cut off the money-grubbing hands of the monopoly capitalist class. One worker had part of the answer, as he chanted, "We are the working class" to the pigs. The more crucial part of the answer is "the working class has to fight for workers' rule."

As of Aug. 10, two negotiators of the strike, Miguel Salas and Renaldo Inchaurregui, both ironworkers and business agents of Local 627, were fired by NASSCO. A total of 20 workers were arrested who if convicted would be fired. Pressured by the court injunction and the lack of support from the International which sent a letter urging everyone to go back to work, and the San Diego Building Trades Council which refused to endorse the strike, workers voted on Thursday to go back to work on Monday. The spirit of going back is to "take the war back inside." The situation is still so hot that the workers could go back out anytime.

The company seized the opportunity to lay out two conditions in exchange for the demand for amnesty for all workers on strike. One, the company does not want the scabs to be prosecuted and two, the union can only meet with its members on a one to one basis, thus prohibiting the union from holding lunch time meetings in the parking lots and in the yards. This is the clearest example of union busting. Both conditions were rejected by the union. Furthermore, the Local is seeking the International's promise to sanction all future strikes. Meanwhile, a lot of spontaneous activities of sabotage are being conducted by the workers inside the yard to show NASSCO where the workers are at. NASSCO responded by beefing up security in the yard.

Olympic Boycott: U.S. Athletes Learn Hard Facts of Capitalist Politics

WHILE the Summer Olympics, weakened by super imperialist rivalry, limped along in Moscow, Olympic-bound American athletes were wined and dined by President Carter, attempting to use them to win support for his hypocritical boycott. Many went for the Olympic Medals Ceremony out of some feelings of being honored by a Presidential Reception. But nobody clapped during Carter's speech.

In fact, many of the athletes openly defied the President's boycott. Some wore T-shirts reading, "Jimmy Carter's Threat of National Security," under the 5-ring Olympic logo. Others wore badges reading, "I'm Here to Make Sure This Never Happens Again." Many, including 27 of the 30 women rowers, refused the "honor" of standing in the reception line to shake the President's hand. Expressing the feeling of many athletes, one woman rower said they were used by the President as part of his election campaign. "All the remarks he made today were directed to voters," she said. "If he had any compassion for us, he wouldn't have made political statements."

The President pulled out all stops, amassing a range of entertainers (billed as "frustrated athletes"), including Andy Gibb of the Bee Gees, Leonard "Spock" Nimoy, and Patti Labelle.

Yet, the trip to the White House for gold-plated medals by "act of Congress" was little consolation for athletes who trained long and hard for years with many sacrifices for the usually one-time chance to compete with the world's best athletes.

As one athlete pointed out, "If we had gone to the Olympics, we would have been here anyway. This trip is just two weeks earlier."

Communist Propaganda Exposes Superpower Rivalry

Reasons for opposing the boycott among the athletes varied. Some saw it as an election ploy. Many more saw it as just a continuation of the government's unsupportive attitude towards amateur sports.

Few, if any, saw the boycott as a tool to whip up national chauvinism against Russia as part of the superpower rivalry.

Sharp communist propaganda is needed to take the spontaneous opposition to the boycott to the larger political significance and danger for the American people. The bourgeoisie, the capitalist class, through the U.S. government, is whipping up chauvinism, trying to swing the American people into supporting a world war against Russia to temporarily stabilize the economy under the wellworn guise of "fighting communist danger to the Free World."

The government is playing on the American people's genuine sense of national identity and honest hatred of the Soviet government's bullying and aggression. They try to twist this into support for an imperialist war.

^{*}Yes, Russia is an imperialist power hiding behind socialist cover. But, war between the United States and Russia will be a war between two world thieves. For both American and Russian people, it will mean tremendous suffering.

U.S. Boycott: Maneuver to Prepare For War

The boycott is an empty, hypocritical maneuver to influence the people ideologically behind war.

Why didn't the U.S. boycott the

Olympics in 1976 when African nations refused to participate with the illegal, colonialist South Africa? Why were John Carlos, Tommie Smith and Larry James sent home from the 1968 Olympics after they raised their black-gloved fists in protest against racism and national oppression in the U.S? Why didn't the U.S. boycott the 1936 games held in Nazi Germany, when both fascist Hitler and so-called liberal President Roosevelt refused to greet black gold-medalist Jesse Owen?


Why did the U.S. slander the Palestine Liberation Organization (PLO) as terrorist for seizing the Israeli athletes' campsite in the 1972 Munich games? The PLO was demanding the release of political prisoners in illegal, Zionist Israel.

Until now, the U.S. claimed sports must be kept "free from politics." But, now that it is to their advantage to whip up war hysteria against Russia, sports no longer are separate from politics, and the American people and this time especially the athletes have to sacrifice.

Internationally, the U.S. is trying to paint an image as defender of human rights, and capitalize on Russia's growing exposure as an aggressive superpower. But, both the U.S. and Russia are imperialist superpowers, competing to control the world's natural resources and markets to feed their own capitalist economies. This competition is played out politically in smear campaigns against each other and with military preparations. As Russia smarts under third world condemnation of the Afghanistan invasion, the U.S. hopes to squeeze out political mileage by boycotting the Olympics in 'protest.'

While the two superpowers fight to sway world opinion with their imperialist games, the people of Afghanistan are fighting to kick out the Soviet aggressors.

And, at home, the American people are once again witnessing the hypocrisy of the American government, controlled by the interests of the small capitalist class. The process of polarization, amplified by the Communist Workers Party's sharp propaganda and strong leadership, is continuing.



Levi Strauss donated more than \$500,000 of merchandise to dress the athletes in "American Western Wear" for the carefully orchestrated four-day Olympic Honors Program. In spite of the widespread anger and frustration, none of the rumored open protests took place. Yet, the athletes took a stand in spite of pressure from the Olympic Committee and the intimidating "respectability" of the White House.

"I was feeling a bit just a little bitter," said Linda Dragan, one of the two Washingtonians among the Olympians, "when all of a sudden the President appears in his blue suit. You see him and hear him. Then, I felt more bitterness. Even though I'll like to show some respect for him."

This shows the questioning and breaking down of the conditioned response of respect and awe for the President, though for some it is still there. This is the necessary process of politici-





Nassco Wildcat Shuts Down Shipyard "Defend Our Leaders!"





"Strike Now or Starve in '81" is the call from Ironworkers Local 627. The wildcat strike against NASSCO is to keep the union from getting busted for the '81 contract struggle.

SAN DIEGO, Ca.-The wildcat strike is on at National Steel and Shipbuilding Company (NASSCO). No work is being done in this San Diego shipyard. The U.S. military war machine is suffering another delay in the capitalists' war preparations. With a huge allocation of San Diego police and SWATs, growing in numbers from 100 the first day of the strike, to 200 the second-close to 7,000 NASSCO workers are out and ready to take on all odds to protect their unions against NASSCO, the government and the pigs. Included in the strikers are pensioners who are still working, taking a strong stand with the younger workers against the company's attack of union leadership.

Strike Now or Starve In '81!

The kettle boiled over Monday afternoon. Seventeen active union stewards and workers were fired for "disrupting the ship launching." A majority of the 17 are union stewards of Ironworkers 627 (the strongest union in the yard with Communist Workers Party sympathizers in union leadership positions) and a local of the International Association of Machinists, including the Chief and Assistant Chief Stewards of Ironworkers, and the Chief Steward of IAM. NASSCO's target was clear-get rid of the fighting leadership of the strongest unions in the yard to prepare for the worsening conditions NASSCO has planned for the workers in the 80's. Bust the union so NASSCO can compete for Navy contracts at lower costs than shipyards up the coast. Using the disruption of the ship launching as an excuse to fire 17 of the

most outstanding fighters in the yard, NASSCO didn't know they dropped a match into a powder keg. Tuesday morning after the firings, a picket was set up and the yard was shut down. As foreman and salaried employees reached the picket lines, the workers' favorites got what was coming to them before they were kept posted near the gates, even though there was no legal injunction against the strike. An "unfair labor practices" strike, NASSCO has been unable to get a court injunction against

So-Called "American Patriotism" A Flop

The wildcat was sparked off by a quick series of events taking place since last week. Wednesday, July 30, union steward Steve Crain, of International Association of Bridge, Structural and Ornamental Iron Workers, Local 627, was suspended indefinitely for cussing out a foreman. That weekend followed up with a demonstration at the "christening" of a newly finished Navy ship-

"We make the ships!", the Navy and NASSCO brass tried to continue as if nothing was happening.

The demonstrators decided there would be no business as usual at this ship launching and were determined to be heard. Marching down the center aisle, straight up to the podium, the brass on center stage scattered like a bunch of loose marbles for fear of getting too close to "workers." The podium was deserted and NASSCO workers took over the program. They let everybody know that the ship behind the stage was made under downright slavery conditionsworking down in the bottom of ships where it gets as hot as 120 degrees, and nothing to breathe but hot air and paint the strikers

Tuesday, the situation heated up between the workers and the pigs-as the pigs carried out their job like paid thugs for NASSCO. As 7 A.M. neared, when the workday begins, and as small droves of scabs tried worming their way past the pickets, the pigs moved in to disperse the main gate picket. Close to about 400 or 500 workers from the main gate area were cleared out as pigs called the picket "an illegal assembly." Mad as hell, but not prepared to beat back the army units of pigs, workers slowly moved up across the street, where throngs of strikers cursed them out. The workers would not
