# **Carter Proposes Secret Court** to OK Spying on Americans

"Carter to Propose Using Secret ening restrictions on U.S. intelligence Court to OK Spying," rang a headline in the February 4th edition of the Baltimore Sun newspaper. The article (based on a report from the Washington bureau of the Associated Press wire service) leaked that President Carter is planning to propose that a secret court have the power to let government agents break into homes and offices, open mail and wiretap Americans.

The secret court plan follows Carter's State of the Union address where he used increased contention with the Soviet Union to justify loosagencies and stepping up attacks against the U.S. people, and when the Senate is considering a new CIA charter that gives that agency a freer hand (see WV, Jan. 28, 1980).

Carter wants a comprehensive charter to cover agencies such as the FBI, CIA, and National Security Agency. "The charter would make some spying on Americans legal if the president ruled the investigation was "essential to the national security " said Senator Walter D. Huddleston. He's chairman of the Senate Intelligence Committee's subcommittee which is consulting with the Carter administration. "The very intrusive types of spying like opening mail and break-ins known as 'black bag jobs' would require a court order."

The court he's talking about is a secret. Federal court that was set up two years ago to okay wiretapping and other electronic surveillance against foreign spies in the U.S.

"It's no big deal," claims a defender of the charter (who's not named in the article), "ever since World War II the agencies have been doing these things under a claim that the president has inherent power to order them." This is no surprise to anyone who remembers the government repression against the Black Panther Party, how the FBI bugged and blackmailed Martin Luther King Jr., or the state harassment against anti-war activists in the 60s.

#### Green Light to Step Up **Repression Against CWP** And Others

But Carter's proposal will legalize spy operations that the FBI and other agencies now carry out illegally. Agents wouldn't have to get regular court warrants to tap phones (like they're supposed to now) where the court record later becomes public information Agents wouldn't have to get a warrant to open mail-now they're supposed to show probable cause that a crime has been or will be committed and notify the victim that this is going on.



## **Anti-Draft Movement** Shifting into High Gear WORKERS PARTY Northeast Conference a Great Success! STANDS FOR:

day, February 10, the Northeast Conference Against the Draft organized and hosted by students at Wesleyan University, signals the rise of a new, young anti-draft movement. With only a couple day's notice, over 100 draft age students, men and women, came out for the conference with over 25 campuses and organizations represented. "A lot of my friends are getting-into this anti-draft stuff back home who couldn't make it this time, but are already planning for the April conference" was the comment of one Harvard sophomore. A cafeteria worker, an older woman in her 50's, said "I'm fed up with Jimmy Carter's lies and I'm against the draft!"

Running two days, the conference began with workshops covering a whole range of issues related to the draft: the anti-draft movement, militarization, nuclear proliferation, U.S. foreign policy and women and the draft. The second day wrapped up the conference with a plenary session. Lively debate broke out when Communist Workers Party supporters struggled for the conference's principles of unity to link up the draft with the growing threat of a third world war, rather than narrowly "just opposing the draft." The struggle has just begun with a date set for the next conference-April 5-and resolving to push out and mobilize even more broadly.

WESLEYAN UNIV., Conn.-Sun- announced plans for draft registration, and already, demonstrations and rallies have mushroomed at Stanford, Columbia, Wisconsin State, and many other campuses across the country. Many of these people are only 18 and 19 years old and didn't live through the experiences of the anti-war movement of the 60's. At this point, many do not yet see the draft as the cornerstone of the U.S. ruling class' preparations for a third world war and part and parcel of the growing fascist trend. When cheap political speculators like Kennedy and Brown speak out against the draft chasing after the student vote, they also support the vicious war preparations of U.S. imperialism. Therefore, while the spontaneous mass hatred for the draft is wide-spread, in the absence of clear direction, it can easily get coopted and diverted.

With the recent Soviet invasion of Afghanistan, the re-instatement of the draft has upped the ante in the superpowers war game. As the anti-draft movement gathers steam, the struggle for clear political direction must inevitably sharpen up. The narrow view that isolates the re-instatement of the draft away from the growing danger of World War III and fascism and attempts of politicians to pimp off this issue during an election year must be exposed and defeated. Only with this correct orientation in the lead can the anti-draft movement serve as an effective force against It hasn't been a month since Carter the danger of world war and fascism.  $\Box$

The Communist Workers Party, U.S.A. (CWP) is the political party of the U.S. multinational working class. The CWP, formerly the Workers Viewpoint Organization, is a fighting, nationwide organization. # **CWP & Parents Fire Up L.A. School, Racist Principal Fired**

LOS ANGELES, Ca.-After months of consistent struggle, the Community Group for Better Education (CGBE) along with the Communist Workers Party (CWP) won an important victory! The racist principal Anthony Ventresca was fired from John Muir Jr. High School. John Muir, in Los Angeles' black south-central community holds 1800 students with 93% Afro-American. Two off-campus murders of students had already taken place in the last two months. This is what the CGBE and the CWP have been fighting for the past two years; to make Jonn Muir a better school for the community's kids.

John Muir is like a penal institution with crowded and filthy classrooms. "You know how they handle criminals? That's how they're handling the students here." Last fall, when school began, there were only 2 bathrooms for these 1800 students. The racist principal Ventresca, instead of confronting the school's problems, would cover them up. When 3 teachers spoke out against the miserable conditions, he transferred them

to other schools. And to split the unity of the students and teachers, he'd promote white, inexperienced teachers over black, experienced teachers. Students

On that day, there was a shootout between the security guard and a group of youths, some of whom were injured. ### FROM THE MASSES TO THE MASSES **Our Readers Speak Out!**

### **Open Your Eyes and Start Struggling!**

This letter (translated from Spanish) came from a striker on the picket line of the 9-week Monfort meatpacker strike in Greeley, Colorado (see article on page 5).

#### Dear CWP,

I have come to you with an aim, that through your newspaper, a newspaper which has never feared to print working class sentiment, I can reach the workers. Your newspaper, through the Communist Workers Party (WVO), has given concrete leadership to thousands and thousands of workers who have been in need and who were tired of hearing promises from bureaucrats and sellouts, as we better call them.

Right now we hear Carter talking to the country and the rest of the world about his doctrines pertaining to human rights. Fellow workers, do you think he is saying the truth? Especially when it is him and the companies who increase the prices of goods which are produced by millions of workers who consume these same goods but can barely afford them with our low salaries; this is why we demand higher wages for our work. Monfort says they have lost \$7 million and that is the reason they offered us a 3 year contract with low salaries and wage freeze. Mr. Monfort says he is going bankrupt, but I do not believe these lies. Do you? Internally, in the Monfort meat packing plant when someone gets hurt or has an accident, they would either bandage your whole leg or if possible your whole body, we look like mummies. After this they would tell you that you still had 4 hours before finishing, so go back to work and later you go to the doctor. Once the doctors remove the

bandages as if you were an animal, never considering your pain; he looks at you up and down and hands you over a slip of paper so you can get some aspirin, and another one stating that you will be ready to go to work the next day. You are never treated as a human. I feel this is injust and that it is time we take the bandages off our eyes and start struggling for a better way of life.

At the Longmont Turkey Plant all the workers stopped working and demanded better working conditions and higher salaries. One union representative tried to brainwash the workers but he was unable to convince anyone. This was due to the fact that there was true courage and political consciousness among the workers. Neither the union representatives nor the the police could scare the workers. The owner of the plant, knowing that the majority of the workers were Mexicans, tried to scare them by telling that he has called immigration and would have them deported. But the workers boldly replied: "we don't care, we won't move from here no matter what." Finally they won part of their demands. We should learn from the 150 workers of the Longmont Turkey Plant, who went on strike and won, not worrying if it was legal or not. Carter has called upon the working class to accept lower wages, saying that this will help end the inflation. Why doesn't he call upon the rich to lower the prices of goods so that those of us who produce these goods can live on our actual wages. Or why doesn't he take money from the monopoly capitalists to cover the deficits due to spending on nuclear weapons and war preparations? A war which will serve us no pur-

pose except that of our own destruction. It is Carter who backstabs us with inflation and under the worst conditions the government and monopoly capitalists try to divide the working class.

We workers must analyse our present and future lives. The only way to remove the monopoly capitalist is by organizing a revolutionary party, where we would find our freedom and true liberation.

We must struggle and fight and die fighting before we die crushed under its dominance and slavery. What will be our future? What are we going to leave to our children? I am simply a worker, without much education. But I hope my words are engraved in your minds like a calling, like a last resort.

Anyhow, this system is crumbling; right now they don't know what to do and they want us to carry all the burden for the problems they have created. Although we are not organized as we should be -- it doesn't matter if you are white, black, brown or yellow, we must unite with the struggle and hit them hard, and finally they are scared to death.

Ventresca and the L.A. school board tried to cover it up and pretend that nothing significant happened. They fired more teachers and hired more armed guards to keep students in line. That's how they see solving rotten education.

#### "We've Called the CWP in"

All across the country, schools are being turned into armed camps; more guards are being hired to keep the youth disciplined and to isolate the "disorderly", outspoken students. What they want is the youths to be faithful robots. obeying all their rules and regulations without a single question. But the youth are angry at the lack of education they're getting. That's why they sometimes end up in gangs or on drugs because they think it's better than facing a life with no future. Ventresca and the school board would be content if all the youths did that.


But CGBE and CWP have shown the parents and students another alternative-to stand up and fight. On the Wednesday following the shootout, the students organized a walk-out in the school. Ventresca and his security guards came out to force students back in school. When that didn't work, he thought he'd make an example out of Debra Greenwood (a CGBE leader and CWP supporter) by arresting her for trespassing. Then he went further and suspended over a dozen students for participating in the walk-out. Defying these actions, Debra Greenwood went back with a parent whose child was suspended. She was arrested again on a trumped up charge of battery against Ventresca. Bail was set at \$5,000. Her crime? They accused her of spitting on him!

Nothing was going to stop the militancy and unity of the parents and students. Dec. 17, everyone in the community marched right into the school board meeting to demand an end to school violence, to expose the cover up and demand that Ventresca be fired. Ventresca and his lackeys, the school board, tried to turn the issue around saying that CGBE and the CWP were "outside agitators" and that they were the ones who were disrupting the educational process. But they exposed themselves when they wouldn't let the parents speak. They were so scared of the community that they hightailed out of the board room with security guards as escorts.

#### Ventresca Kicked Out

Ventresca's final words were to say that he wasn't going to allow "black communists" to get rid of him. His lackeys have been continuing his dirty work and redbaiting parents working with the CWP and CGBE. But despite these futile attacks, the CGBE and CWP triumphed! Because of the mass pressure and media coverage organized by the CWP and the CGBE, Ventresca was kicked out of John Muir. After the board meeting, one parent explained how she had gone from one group to the next for support, but no one responded. When she came to the CWP, we took up the fight and because of our leadership, were were able to win. She said "if this is what it means to be a communist, then I want to be a communist too!". The struggle at John Muir is far from over, but with this victory and the leadership of the CWP, the parents and students are more determined to continue the fight for quality education.

YOUNGSTOWN, Ohio-And once again the politicians came and talked . . . and talked and talked ... From the mayor's office, to the governor's, to U.S. Senator Metzenbaum. They vied for the spotlight at the January 28 rally at Youngstown's United Steel Workers Local 1330 union hall, called to battle the closings of U.S. Steel's Ohio and McDonald Works. They mouthed the words "We support you, we're with you all the way."

But the 1,500 steelworkers and their families had come for more than talk. "Let's go down that hill!" "Jobs Now! We're sick of the politicians' talk."

president at U.S. Steel's Briar Hill Works in Youngstown (also being closed down) called for the charge. He quoted black abolitionist, Frederick Douglass: "If there is no struggle, there is no progress. Those who profess to freedom and yet deprecate agitation are men who want crops without plowing. They want rain without thunder and lightning.

## **U.S. Steel Takeover** We Built It—It's Ours!

They want the ocean without the awful roar of its mighty waters. This struggle may be a moral one, or it may be physical, but it must be a struggle. Power concedes nothing without a demand. It never did and it never will!"

"So we're going down that hill!"

At 11:20 a.m. Salt Springs Road filled with 1,000 enraged steelworkers storming down the short half block to U.S. Steel Corp. offices. At the bottom of the hill, U.S. Steel's lone guard saw the steelworkers streaming out of the union hall and ran to lock the heavy glass entrance doors. But the workers shattered the glass and smashed in the doors. The

guard raised his can of Maceand reconsidered. The wave of hundreds of steelworkers swept him against the wall.

"Everybody in, everybody in," yelled Ed Mann. "This is your building, you built it, it belongs to you!" From the windows on all four floors banners flew and the occupiers hung out their signs. Inside, the steelworkers discovered the exec's' plush rec room, and overran the pool table and exercise bikes. They ate the food too. Younger steelworkers covered the roof and with a loudspeaker led the picket line already formed in front of the building in chants, "We Want Jobs! We Want Jobs!"

Local 1330 President Vas-

quez and other area union officials are calling for government aid so the steelworkers themselves can buy and run the phased-out plants. Most steelworkers see this as "pressuring the government." They don't believe the worker-ownership scheme will work but see no other alternative. While a few "we want Kennedy" signs float around, most signs say simply, "Jobs Now."

At 5:25 p.m. President Vasquez came to the 700-800 workers to ask them to trade militancy for patience. U.S. Steel had agreed to meet with the union if the building were surrendered. He was met with boos and catcalls by the occupiers who threatened to take matters into their own hands. But in a gut-wrenching move they followed the leadership and evacuated, some demanding to know, "why did we take it if we're only giving it back?"

The workers' next step is to get onto buses to Washington, D.C. for local union testimony before Senator Rawlings on U.S. Steel Responsibility for the Workers on Feb. 5.

Across the tracks, down the valley next door, is the Jones & Laughlin works (formerly Youngstown Sheet and Tube) that was shut down two weeks ago. It is a ghost haunting these men. Who is going to stand up and fight for themthe politicians got exposed by holding back when the occupation began and later joining the picket outside. The international union rep refused to join the rally or the occupation, just as he refused to join the Nov. 30 march on U.S. Steel's Pittsburgh headquarters. (See WV, Dec. 10, 1979) The workers have found they have to rely on themselves. "I might be too old to get hired, but I ain't too old to fight."

# **AT&T** Strips Workers' Right to Armed Self-defense


WASHINGTON, D.C .-- "If they can fire you for defending yourself, they can fire us for anything." On Jan. 25 AT&T (American Telephone & Telegraph), the largest private employer in the U.S., fired Jody Ansell, a supporter of the Communist Workers Party and member of the Revolutionary Youth League. According to the AT&T bosses, Jody was fired because she was "convicted of a felony" for having a gun for self-defense on her way to the Nov. 11 funeral march for the Communist Workers Party 5 in Greensboro.

When Jody asked the bosses where they got the information about her convictions, they said it was a "matter of public record," that she was convicted of a felony. To fire Jody, the company is forced to lie through their teeth. It is a matter of public record that Jody and 13 others going to the funeral were convicted of misdemeanors and given a year suspended sentence for practicing their right to armed selfdefense. AT&T has to openly lie, trying to make Jody look like a "hardened criminal." to try and get rid of this young class fighter. Jody, a member of Communications Workers of America (CWA) Local 2350, is a respected fighter for the workers at AT&T Long Lines. Recently, she led a successful petition drive to remove a donothing shop steward and fight for more democracy in the union. Several workers have stated Jody should be their steward. The reason she isn't is because the union bureaucrats

appoint stewards, denying workers the right to choose their own.

The workers realize that an attack on one is an attack on all and nearly all have stated their support for Jody. One worker told her, "AT&T wants you out because you are taking a stand. Other people have been convicted and they are still here. It's not fair!" Another stood unshakably with the masses' right to armed selfdefense: "After what happened to the Communist Workers Party 5, it would have been foolish to go down there without a gun." And another warned, "If they ever try to come and get my stuff (his weapons), there is going to be a lot of trouble!"

AT&T has said that it plans to have fewer employees at the end of 1980 than they had at the end of '79. They are refusing to replace workers who retire, and they are using every excuse they can to fire others. The company is using new computer systems to replace skilled workers, and pay ing those who are left less money because they "don't see why they should pay workers when the computers make the jobs easier." The cutback in workers means speed-ups and forced overtime. Like workers all across the U.S., AT&T workers' anger and resistance is rising. In December, AT&T workers were ready to walk the picket lines beside workers of Chesapeake and Potomac Phone Co. (a subsidiary of AT&T) before their strike was sold out by the union misleaders. ### **Outcry Against Steel Imports** Feeble Echo of '77 Crisis

PITTSBURGH, Pa.-Negotiations for the 1980 steel contract affecting 450,000 workers opened Feb. 5 amidst the industry's cries it is in deep distress. What is its remedy for this ailment?

Now there's a renewed cry against steel imports, as a remedy for sick American steel. In an American Iron and Steel Institute document, the companies call for "stricter enforcement of trade laws".

State Vance going over to Europe and telling them that they can't export any more steel to the United States because U.S. Steel is getting mad, and then telling them that they shouldn't export to Russia either? He'd be thrown off the Continent".

While the U.S. superpower bully sharpens up its chauvinist daggers, preparing for world war and fascism, why are they hesitating on escalating another trade war in steel like 1977? The world situation is different from three years ago. With U.S. imperialism on the strategic decline and the danger of world war and fascism much sharper in the last few months, with the stepped-up contention between the two superpowers and intensifying contradictions between the U.S. and the second world countries (Europe and Japan), the U.S. bourgeoisie has a lot fewer options to save themselves in the 80's.  $\square$

# Meat Packers Challenge Slaughterhouse Union-busting

GREELEY, Colorado-On January 11th, Monfort of Colorado meat packers returned to work and began grinding beef. Due to Monfort's unionbusting tactics, the workers of United Food and Commercial Workers Local 641 returned without a contract. However, they don't intend to be led to the slaughter. Not after two and a half months of battling Monfort's unionbusting tactics. Not after the lessons they gained from their bitter strike!

Meat packing is a rough and dangerous job. After a full shift, you go home with bloodsoaked aprons and the stench of cowhides. There is the everpresent danger of being cut with knives and saw blades. But the greatest danger is the bloodthirsty bosses who desperately try to carve away workers' livelihood. Local 641 meat packers got a bad taste of Monfort's unionbusting tactics when their contract expired last November 1st. Even though their Greeley plant cut the work force by 20%, Monfort offered a 3 year wage freeze and cuts in health benefits, breaks and vacations. In addition, Monfort wants to give plant sanitation work to outside, non-union contractors and smash the grievance procedure. One worker said, "They will give the foremen the complete right to do what he wants."

Outraged by this slap in the face, Monfort meat packing workers overwhelmingly voted "Strike." The whole county geared up for the strike as 24 hour picket lines were set up. Al Frente de Lucha (a community organization the Commu-

re-

nist Workers Party works in) and the Colorado Migrant Council planned a fundraiser. The broad support from the predominantly Chicano community helped the workers stand firm and militant. On December 23rd, nearly 1,400 people marched through Greeley to support the Monfort workers. They were organized by unions throughout the state of Colorado. \$50,000 in cash, food and children's toys were raised.

Monfort is the third largest manufacturer in Colorado and the king of the meat industry in the area. The strikers angrily saw through Monfort's pleas of bankruptcy. "Monfort says they have lost \$7 million, but I do not believe these lies. Do you? Mr. Monfort spent \$1 million and a half on a new plane, bought two more meat packers and remodeled the Greeley plant, expanding it and taking advantage to the last hair and wasting not even a drop of saliva. Does this sound like bankruptcy?" In fact, Ken Monfort is living high off the hog with his meat packing business. In the past three years, Monfort bought several new plants costing more than \$50 million. He bought another plant after the strike began to maintain his production and profits.

#### Strikebreaking and Union-Busting-Dangerous Precedent in Colorado

Monfort stepped up its strikebreaking. Using courts, they ordered the pickets from blocking the plant gates so their scabs could crawl in. The police, whom Monfort gave \$12,500 to buy special equipment such as night sticks and gas masks, provoked fights with workers and even arrested one for felonious assault on an automobile. (He kicked a scab's car). These attacks led to 28 arrests on the picket line.

Lacking firm support from

gain her job. On the day she was fired, she and some friends met workers on their way out of the building, leafletted and talked about what happened. Workers are circulating a petition, calling for her rehiring with full back pay and her record cleared. Sensing that the workers are angry about this unjust firing, the union leadership is taking up the case (although with less than a year on the job she has little official union protection). As Robert Williams, a staunch advocate of the people's right to bear arms and a fighter against the Klan, said in the 60's, "Self-defense prevented bloodshed." And as thousands of workers across the U.S. know from fighting for their basic right to a union, no union was built without a gun. In the militant fighting tradition of U.S. workers, UPHOLD THE RIGHT TO ARMED SELF-DEFENSE! □

the union's leadership, these 28 arrested workers found it very hard to defend themselves. Many stood alone when they went to court, like lambs being thrown to the wolves. Monfort completed the butchering by refusing to consider rehiring these 28 workers.

In a desperate attempt to break the strike, Monfort announced that he would reopen the plant on January 14th. He would replace the strikers with new workers. This meant that the strikers would be replaced and they would lose their jobs to scabs. This set a dangerous unionbusting precedent. You can bet Monfort will eventually try to get these new workers to vote to decertify the union. Several years ago, the Coors Brewery was able to bust a long strike by using this tactic. In Colorado, three other meat packing plants presently face meat cutters' strikes. They now plan to use the same tactics as Monfort-threatening to reopen the plant with scabs in order to force the strikers back

to work without a contract.

Nine weeks of determination, of struggle and sacrifice will not disappear. It was true that the workers were hurting with mortgages due and behind on car payments. However, they had gained great unity and were more committed to a strong union. Many strikers were fighting mad about being railroaded back to work and are ready to deal with any scab rather than go deeper into poverty with a lousy three year  $\Box$ contract.

## Another Blow Against Redbaiting G.E. Workers: Re-elect Cathy!

OAKLAND, Ca.-On February 3, as a resounding rejection of the redbaiting campaign, Cathy Scolieri was nominated for re-election as union president of Local 853, International Union of Electrical, Radio and Machine workers (IUE). She, along with several other fighters nominated for other offices, are all committed to thoroughly defeating the company, the sell-out international, and the local union puppets and building the strongest union General Electric has ever seen.



Scab redbaiters tried to steal ner post as president due to a clause in the constitution forbidding communists to hold office. But because of her reputation as a fighter, the Committee to Defend Cathy (made up of GE workers), has been able to make headway against redbaiting attacks trying to ride on the years of prejudice and misconception many of the workers have against communism.

In a court case won by lawyers Dan Siegel and Alan Yee on January 23, Cathy got an injunction against the union for carrying on illegal persecution of her for her views as a communist. "They (the international hacks and local union puppets) should be charged with felony redbaiting and assault with a deadly ideology, but alas, we must remember whose court we're in.," wrote an ex-law student who observed the case. The legal victory was won because of the strong rank and file support at GE and throughout the Bay Area. Fighting the attacks in every possible arena including the courts is one step at chipping away at the fear that redbaiting breeds in some of the workers.

Since the bourgeoisie is casting a shadow over the workers movement with the recent firings and political assassinations of friends and members of the Communist Workers Party nationally, Cathy's victory is significant. Every step forward, no matter how small, in busting up the redbaiting attacks is important, because we are not fighting by surrendering our principles in a stampede of fear. Every step is a real blow which stands firm with the working class interests and furthers the fight against the bourgeoisie's preparations for world war and fascism. The Committee to Defend Cathy circulated a petition demanding all charges be dropped. They talked to other workers defending her good work uniting the union and fighting the company over the pas. two years. As one worker said, "she's one of the best fighters we've had here at GE. She has taken a stand against the company for their discrimination policies and fought for us. If that's what communism is, then I'm all for it." The work of the Committee is a good basis to build the reelection campaign.


A political firing by AT&T three years ago highlighted the company's total disregard for the right of workers to hold political beliefs or engage in

political activities hostile to AT&T. A management telephone employee attended the 1976 May Day demonstration sponsored by the Communist Workers Party (then Workers Viewpoint Organization). AT&T suspended him based on the traditional capitalist concept that a private employer has an absolute right to fire a worker for reason or no reason, just or unjust.

#### **KOREA STARTS REUNIFICATION TALKS**

The Democratic People's Republic of Korea (DPRK-North Korea) Prime Minister Li Jong Ok proposed to South Korea on Jan. 12 that reunification talks be resumed. On Feb. 6, a 3-man delegation from both sides met at Panmunjom. DPRK proposed that the meetings alternate between DPRK's capital of Pyongyang and South Korea's capital of Seoul.

Ten million Koreans are separated from their family and reunification is the hope of all the Korean people. Although the U.S. wants reunification under capitalism the South Korean government is racked by internal power struggles and there's a growing mass movement demanding democratization and reunification. Whether genuine reunification under the socialist system of DPRK will prevail over capitalist South Korea remains to be seen.

#### SOVIET BEAR MEETS FIERCE AFGHAN RESISTANCE

Soviet troops are suffering an

Phnom Chat (towns along the Thai-Kampuchea border). But the Kampuchean people, led by the Communist Party of Kampuchea and its chairman, Pol Pot, are fighting back and are drowning the invaders in a raging sea of protracted people's war. The invaders predicament in Kampuchea is a sign of what awaits the Soviet imperialists in Afghanistan.

On December 15-17, 1979, a Congress of the Standing Committee of the Assembly of the Kampuchean People's Representatives was held. The Congress summed up the present situation in the country. It mapped out a new strategic policy that "the major and sacred task" of the Kampuchean people is to defeat the Vietnamese aggressors. Finally, the Congress improved the composition of the government to best implement the new policy, such as choosing Khieu Samphan as Prime Minister, Ieng Sary as Deputy Prime Minister in charge of Foreign Affairs, and setting up a Supreme Commission of the National Army with Pol Pot as Chairman and Commander-in-Chief. These were unanimous decisions of the Congress.

The following are excerpts from the statement issued by the Congress which we are reprinting in a 3-part series -editor.

Statement of The Congress Of The Assembly of the Kampuchean People's Representatives. . .



#### Democratic Kampuchea, Dec. 18, 1979

I. General situation of the country-1979

... Through the experience of the repeated failures of its strategy of aggression and land-grabbing in Kampuchea the Le Duan (revisionist head of Vietnam-ed.) clique then started applying its strategy to attack and seize at once Phnom Penh and the whole of Kampuchea through its "lightning-attack, lightning-victory" strategy which in its minds would annihilate the forces of Democratic Kampuchea at one go, thus preventing all resistance both from Kampuchean forces and from international opinion. # British Governor in Zimbabwe: "Half the Country Infiltrated by ZANU"

Over 250,000 Zimbabweans wel- bus carrying 16 black civilians were (leader of the Zimbabwe African National Union) to his homeland on January 27th. The British colonial governor Soames had blocked his return to the country for two weeks. The reason was clear as the masses poured out in the largest turnout for any political leader in Zimbabwe.

#### Soames Scapegoats ZANU, Threatens to Ban Them **From Elections**

As the election date draws near-Feb. 27 to 29-the British and puppet Muzorewa are desperate. There were two assassination attempts against Mugabe in the last week. A grenade was thrown at Mugabe's home and later, 80 lbs. of explosives blew up right behind his car as he was heading to the airport after a political rally. Soames said nothing about political violence and intimidation at these assassination attempts. Yet when a

comed the return of Robert Mugabe ambushed, Soames blamed ZANU, announcing that he has the power to ban campaigning by political parties and candidates that "encourage or condone intimidation of voters." According to the New York Times, both Mugabe and Nkomo (head of the Zimbabwe African People's Union) have said that the drunken, rag-tag mercenary army of Muzorewa was responsible. But instead of taking any action against Muzorewa, Soames banned Enos Nkala, one of ZANU's senior representatives, from campaigning because Nkala exposed how Britain is rigging the elections. ZANU has threatened to resume the armed struggle if Britain continued with her dirty tricks.

Muzorewa stated that "no sane person could expect his group to accept a Mugabe victory at the polls if political violence in the tribal areas continue," and threatened to pull out of the ceasefire agreement. "He's afraid. He now sees how the elections are going. He is



going to lose." responded ZANU. The morale of Muzorewa's troops are at an all time low-there are even reports that his soldiers have shot themselves while drinking in bars.

No matter how afraid the British and Muzorewa are of a Mugabe victory, it would be almost impossible for them to hold off the elections now. There would be massive protest from the Zimbabwean people and other countries. On February 2, the African countries pushed a resolution through the U.N. Security Council calling on Britain to stop discriminating against the Patriotic Front (ZANU and ZAPU) and favoring Muzorewa.

#### The Real Provokers and Intimidators are Britain and Muzorewa

The resolution called for: the removal of all remaining South African troops, the return of exiles, the release of political prisoners, keeping Rhodesian Army forces and mercenaries restricted to their base, equal treatment for all parties, and the end of the emergency rules (press censorship and curfews) obstructing a free election. The condemnation of these acts committed by Britain and Muzorewa shows who is really provoking violence and intimidating voters.

The resolution passed 14 to 0, with Britain refusing to participate even though they have veto power. No doubt-Britain swallowed the vote under pressure from the U.S. who fear the Soviet

estimated 500 losses a week, with between 2,000 to 10,000 casualties in Afghanistan. Soldiers risk their life crossing the street in downtown Kabul as several have been killed by snipers. In the countryside, the Afghan guerrillas control most of the provinces of Nangarhar, Badakhshan and Paktia.

The Soviet Army is now snowbound by the Afghan winter. Their sophisticated tanks and armored personnel carriers guard snowplows, desperately needed to keep supply lines open. Afghan fighters cut off Soviet supply lines by blowing up bridges and triggering massive avalanches that buried Soviet troops alive.

imperialists will step in if the armed struggle in Zimbabwe continues.

#### Independence and Initiative is Key

The cease-fire agreement has worked to the advantage of the liberation forces and back-fired on Britain and Muzorewa. Soames has complained that ZANU has already infiltrated half of the country. The key is the independence and initiative of the liberation forces. ZANU still has 9,000 troops outside the assembly points, and Kangai, ZANU's representative in the U.N. has made it clear, "if corrective measures aren't taken soon (referring to the British violations), we shall have not any alternatives besides that of continuing armed liberation struggle." 0

# New Mexico Prison Burns Amidst Liberal Silence

SANTA FE, New Mexico-It was the biggest prison uprising in the last 10 years. More than 500 inmates seized the New Mexico State Penitentiary on February 2. Taking 15 guards hostage, they held the prison for more than 36 hours, demanding better food, less harassment by prison officials, decent living conditions and the immediate firing of the Deputy Warden. The takeover ended when the state stormed the prison. The press has played up that "neither the State Police nor the guardsmen in riot gear and armed with tear gas and M-16 rifles fired a single shot". So far there are 35 known deaths.

#### Remember Attica? State Must Account For New Mexico Prison Deaths

All of the deaths have been pinned on the inmates. The papers played up stories of prisoners torturing the trustees, with blowtorches, meat cleavers and chopping axes. The New York Times quoted a fireman who said, "it was worse than anything that I ever saw in my combat years in Vietnam. Arms, heads, legs chopped off." While it may be true that some of those killed were snitches who deserved to die, the Attica uprising proved that when the state storms a prison, they will kill off the leaders and any witnesses who may have seen them do it. The state has to be held accountable for the truth about how all the prisoners died in the New Mexico uprising.

The inmates were not the drugcrazed manics that the papers made them out to be. They are the most downtrodden, oppressed and exploited of our class brothers. In New Mexico, it is no accident most of the inmates were Chicano and Mexicano. Capitalist hell is what drove them to crime in the first place. Once they are locked up in prison, they are at the mercy of the state. The prison system exercises complete control over every aspect of their lives. Most of the improvements in prison conditions that were won in the 60's have been or are being taken away. For these reasons, prisons nation-wide are tinderboxes just waiting to explode. New Mexico was the first of many waiting to happen. Just the day before New Mexico exploded, Attica State Prison in New York was locked down to cool off a potential rebellion. And in the last two months small rebellions have rocked Soledad State prison in California and the Washington State Penitentiary.

Silent "Liberals" Herald **Coming Fascism** But the real significance of the New Mexico uprising lies mainly in the response of the American people. The Attica uprising, ten years earlier, held the undivided attention of the entire nation. Broad sections of Americans denounced the vicious tactics of Nelson Rockefeller (then governor of New York), who gave the command to storm the prison and murder the men. The petty bourgeois press was full of exposures of the brutality of the prison system. And big political campaigns were organized to take up the cases of the men who were framed up as a result of it.

the role of the state in 35 deaths in New Mexico: Throughout the 70's, the capitalists have pushed irrationality and mindless murder through horror movies like the *Exorcist* and *Dawn of the Dead* and have played up mass murderers like the Son of Sam, Juan Corona, and "Stinky" the rapist. This creates an attitude of indifference among the people to the point that something like New Mexico is treated like everyday life in this "crazy world."

Who will stand up for the men in New Mexico. The American people's response will say a lot about how ready the bourgeoisie is to unleash fascism in this country. Already, the state prosecutors are calling for the death penalty for inmates who took part in the uprising. This clearly shows how the state will deal with future prisons uprisings as well as uprisings among other strata of American people, like another Levittown. If something like New Mexico can happen and people have nothing to say, how much longer will it be before the state come down on others and their next-door neighbor won't make a sound.

# FBI "Abscam" Sweeps Congress For the Bourgeoisie

No one's surprised by the recent FBI exposures of Congressmen-catching them with their pants down, knee-deep in taking bribes in exchange for setting up casinos in New Jersey, snagging military contracts in return for money, or altering immigration laws to fit wealthy foreigners fleeing revolution in their countries. Everyone knows that's the way Congress, dirty politicians and the U.S. government works.

#### Bourgeois Democracy: Ruling Class Rule Indirectly

Bourgeois democracy, the appearance of so-called checks and balances between the executive, legislative and judicial branches of government, is the best shell of capitalism. The bourgeoisie rule all the more surely because they rule indirectly. Rarely do you see a Rockefeller or Morgan directly in public office. Behind the appearance of democracy and elections, the ruling class keeps its hold tight through their hold on the media, backroom deals, bribery, through key appointments, think tanks, "charitable" institutions like the Ford for tax money to be pumped into energy research and technology. This research and technology would then go to big oil companies like Exxon (owned by Rockefeller). The bill has been deadlocked for two years now because other monopoly capitalists want a share of the loot too, and until they get it, their representatives in Congress are blocking the bill.

The FBI "Abscam" is aimed at cleaning house for the bourgeoisie so that bills like these can get through Congress. It is part of the objective process of streamlining and centralizing the government preparing for world war and fascism.

#### Cover to Crackdown on CWP and Other Anti-Fascist, Anti-War Forces

The "Abscam" is part of the FBI's new direction which they claim will crack down on political corruption, organized crime and white-collar crime. And under the cover of cleaning up "corruption", the state legitimizes setups, wiretapping, mail-tampering and so on. Applying these same dirty tricks to murder and harass the Communist Workers Party, friends and other progressive fighters against fascism and World War III, the FBI will claim this is just "even-handed justice."



Now, with the New Mexico uprising, the so-called liberals are silent. How did it come about that no one even questions Foundation, commissions, and so on. The Röckefellers and Morgans all know this and so does the repressive arms of the state like the FBI, so why all the fuss now?

Congress Blocked Up With Monopoly Capitalist Squabbling In the past few years, Congress has been dragged down by the squabbling between representatives of this or that monopoly group or interest. # AS THEY SEE IT

### The Greensboro Record...

The following are excerpts from an article, "Impact of March Is Undetermined," in the Greensboro Record, February 4, 1980, p. A-1.

Numerically it was a success. The long line of marchers snaking through the downtown and out Lee Street Saturday was an impressive sight.

But whether the highly publicized march and rally signal the start of a major new left-wing movement in America remains to be proven.

The tone of the event was definitely radical, not merely leftist or liberal. The same revolutionary chants heard at the November funeral procession sponsored by the Communist Workers Party were sung again Saturday along the parade route and inside the Coliseum.

Banners and many speakers denounced not just the Ku Klux Klan and racism—the targets of the march and rally--but capitalism as well. Literature and newspapers being sold in the crowd were heavily laden with fiery revolutionary rhetoric.

The CWP was by far the noisiest group in the demonstration, despite supposedly being expelled from the event for refusing to pledge to leave its guns at home.

The widows of the five CWP members killed in the Nov. 3 incident with the Ku Klux Klan and American Nazis here were paraded across the stage. They stood at attention beside a CWP member from New York who was allowed to address the rally.

The CWP even got a plug from Wilmington 10 leader Ben Chavis, who received the loudest ovation of the more than 20 speakers appearing Saturday. Chavis, wearing his clerical collar and flanked by two body guards, said there is one man he will come to Greensboro anytime to help-Nelson Johnson, the leader of the local CWP organization.

Chavis also made his own political philosophy perfectly clear, declaring, "We must blot out capitalism and imperialism once and for all." Many in the audience jumped to their feet and roared approval.

Chavis and other speakers made oldtime liberals such as Joseph Lowery of the Southern Christian Leadership Conference and Dick Greenwood of the United Machinist Union sound like conservatives.

Lowery, who marched with Martin Luther King through the South in the 1960s, was battered by boos for making a negative comment about the Ayatollah Khomeini, Greenwood was hooted for denouncing violence as a way to achieve the Coliseum. A National Guard helicopter hovered over the march, and police and highway patrolmen lined the streets. The National Guard was in waiting several blocks from the route, but was not called in. A state of emergency, declared by Mayor Melvin, was in effect...

Saturday's political march was the second within three months in the city, the first being the CWP funeral procession in November. Will there be more? Only the Feb. 2 committee and the CWP know for sure. Some observers at Saturday's rally think future efforts by the mobilization committee probably will be in other cities....

The trials of Nelson Johnson, Willena Cannon and Rand Manzella have been postponed from Feb. 4th to Feb. 20th by the court, which did it to avoid the high sentiment of support from the successful Feb. 2 anti-Klan demonstration. The bourgeoisie calls it "justice" and "due process" when victims of KKK/Nazi assassins are put on trial because they are fighters of the working class and fighters against the Klan. Nelson Johnson faces charges of inciting to riot and resisting arrest. This is consistent with the Klan's defense that the Communist Workers Party provoked the killings and got what they deserved. That's also why conspiracy to commit





thing against it. That is why it did its utmost to mobilize huge forces composed of crack troops assisted by a host of Soviet tanks and artillery to launch a far more violent offensive against Democratic Kampuchea on December 25, 1978. The balance of forces at that time in every battle-field throughout the country was 6 to 7 Vietnamese aggressors' soldiers to one fighter of Democratic Kampuchea...

But they have failed to achieve their "lightning-attack, lightningvictory" strategy. The war keeps going on and the Vietnamese are compelled to use their own troops. Consequently, the Le Duan clique is rather driven into the protracted war strategy of the Kampuchean army and people...

In the last rainy season, after drawing experiences from our struggle over the last dry season, we carried out the guerrilla war line and the guerrilla attacks as a fundamental form of fighting while using commando attacks and annihilating attacks as secondary forms of fighting. In this way, we were able to preserve our own forces...

From January to- the end of September 1979 we inflicted 70,000 casualties on the Vietnamese enemy... in the course of the dry season we inflicted 40,000 casualties on it and in the course of the last rainy season we inflicted 30,000 more casualties. In addition, the enemy forces suffered great losses due to various diseases, especially malaria. Besides, the fighting spirit of the Le Duan clique's soldiers was getting down very fast. Up to ten thousand of them defected, either fleeing back to their own country or abroad or deliberately getting themselves incarcerated by categorically refusing to go to fight.

In short, throughout the dry season 1979, the Vietnamese "lightning-attack, lightning victory" strategy met with complete failure. And their rainy season 1979 plan to destroy and wipe out our army and our guerillas suffered a crushing defeat too.

Now, we have come to the new dry season 1979-1980 for nearly 3 months already. How is the military situation between the Vietnamese enemy and us?...

In the first phase of their dry season offensive in October and November, the Vietnamese aggressors met with fundamental failure as they did not achieve their goal to wipe out our forces and take over the North Eastern region and the Central region and to withdraw their forces to the Western part of Kampuchea. On the contrary, the enemy's forces are now getting more and more bogged down in every battle-field throughout the country.

At present, our battle-fields in which we are fiercely fighting the Vietnamese enemy are stretching out all in one block from Koh Kong, Kampong Som, the Cardamones, Samlaut, Pailin, Malay, Thmar Puok, the Northern region, the Central region up to the North Eastern region.

Besides, we are carrying out guerrilla activities everywhere throughout the country...

Moreover... Vietnam economy is in a shambles. Officially, the Le Duan clique has declared that they are suffering more than four million and a half tons of food shortage this year... They



No longer "restricted" by the pressure of keeping up a legal image, it would give the state more freedom to step up selective repression against the Communist Workers Party and others who challenge the government. In fact, the state is already tampering with the Communist Workers Party's mail. For years, they've opened our mail and prevented subscriptions to Workers Viewpoint from reaching us and newspapers from getting to our subscribers. The government has continued this in spite of our repeated, written complaints. U.S. hostages. The U.S. today is more like Germany in the 30's. At that time the Weimar Republic, the German form of bourgeois democracy, collapsed under solution of Communists-socialist revolution.

The 80's gives us a rare opportunity to unite and influence the broadest sections of American society against fascism and world war. It gives us a chance to lead the whole American people to beat back these attacks, take state power and build a bright, socialist future.  $\Box$
