Did "Free and Peaceful" Elections Free Zimbabwe?

After Mugabe and ZANU's sweeping rout of imperialist-backed Muzorewa regime (Muzorewa won only three seats), the U.S. had to recognize the new government. Hostage's Family Demands U.S. Apologize To Iran


Fed up with the State Department's handling of the hostage situation in Iran, the family of John Earl Graves, one of the hostages, appeared on Washington D.C. television on March 4. Lizette, Mr. Graves' 28-year old daughter, said, "We're going to have to apologize. We're going to have to admit to what past administrations did in Iran and say we're sorry and we won't do it again." Mr. Graves' wife, Bonnie, added, "We have to stop meddling in other people's affairs. We are now urging people to pressure their Congressmen for a total re-examination of our foreign policy. We can't continue in our neocolonialist approach. This is our position, and we have every reason to believe it is Mr. Graves' position, too."

Before he was seized as a hostage, the 52 year-old Graves had worked for the U.S. Information Agency beginning in 1962, serving in Saigon and five other places in Africa. In 1974, he became an information officer with the State Department.

The Graves family feels that the Carter Administration is more interested in protecting the Shah than in the return of the 50 hostages. They had with them a copy of a cable sent by Bruce Laingen, U.S. Charges d'Affaires in Teheran to the State Department, warning of possible Iranian action if the Shah was allowed to come into the U.S. The State Department ignored this warning and admitted the Shah anyway.

The Graves family made their views known at the last meeting of the hostages' families in Washington in February. But they had seen no changes on the part of the government yet. This prompted them to go in front of TV cameras and make their views public. No longer relying on the government to get her husband back, Mrs. Graves sent a letter written in French to the Iranian President Bani-Sadr requesting a meeting. The letter was given to the Iranian Embassy in Washington and promptly telexed to Teheran.

Commenting on their news conference, Mrs. Graves said, "I hope it has a good effect. I hope our Government has the guts to examine its foreign policy. This is bigger than just my husband."

Two Whirlpool Co. maintenance workers in Marion, Ohio had lost 6 hours pay and were reprimanded in their files for refusing to walk out onto a wire mesh net, 20 feet above the floor, on which one man was killed and others injured a few months earlier. The Supreme Court ruled against Whirlpool Feb. 26 that workers have the right, under certain circumstances, to refuse to perform tasks they believe pose a danger of death or serious injury. This upheld part of the Occupational Safety and Health Act of 1970 forbidding employer reprisals against such work-


BUDD CONTRACT PACES FORD/GM

Auto Workers United members at Budd Co. auto parts plants won their first

strike in 22 years. Budd tried to push through a Chryslerstyle substandard contract. The workers struck for 26 days and got basically the same wages and benefits as Ford and GM workers' contracts, which have less takebacks.

RETAIL CLERKS RING UP **HIGHER PAY**

A six-week strike in the Bay Area by the Retail Clerks union ended March 4 when they ratified a new contract. The San Francisco chain stores Safeway, Lucky's, Ralph's, Alpha Beta, Albertson's and Raley's agreed to pay \$1.81 over a 38-month period in addition to about \$1 in cost-ofliving adjustments. Before the strike, their wage was \$8.78/hr. Management had to drop demands for flexibility on work rules and seniority.



MORE OIL WORKERS **ON STRIKE**

The ranks of the 60,000 Oil, Chemical and Atomic Workers Union, out on strike for 2 months, grew last week as 1,200 workers at Mobil's Paulsboro, New Jersey refinery walked out over wages, benefits and vacation. Another 1,000 workers from Sun Oil Co. in Marcus Hook, Pennsylvania also went out March 1.

WHY PAKISTAN **REJECTED \$400 MILLION IN U.S. AID**

Pakistan recently turned down \$400 million in military aid from the U.S. and said they would base their foreign policy on close ties with Islamic and non-aligned countries.

"We have officially conveyed to the United States that we are not interested in the aid package as proposed and had specifically disassociated ourselves from any U.S. initiatives to introduce the relevant legislation in the Congress," said Pakistan Foreign Minister Agha Shahi on March 5th. He said that accepting the American aid package would weaken rather than strengthen Pakistan's security. Taking U.S. aid would threaten Pakistan's non-aligned status and its link with the Islamic countries, particularly Iran.

Head of Pakistan, General Zia, had warned the U.S. before that \$400 million in military aid was "peanuts" and that Pakistan would need a lot more to really build up its defenses. The fact that the U.S. refused to give the amount of aid needed shows how much the U.S. aid package was really meant to provoke the Soviet Union into invading Pakistan. This would tie Soviet troops down and make the Pakistanis fight the Soviets for the U.S.

The Pakistani government saw through this imperialist trick and rejected the U.S. offer. They said that Pakistan will seek the closest possible friendship and cooperation with Islamic countries and would play a positive role among non-aligned countries.

By mainly relying on the Pakistani people and the people of other third world countries, rather than U.S. help, Pakistan will be able to fight the Soviet imperialist threat.

This ignores the fact that it took seven years of armed struggle, countless sacrifices by the liberation fighters and the Zimbabwean people to even bring the British and the puppet Muzorewa regime to the bargaining table. And only after the Patriotic Front had already liberated most of the country.

Nor was the election process "peaceful and free." ZANU had to wage a fierce fight to maintain its independence and initiative while the imperialists tried every trick to prevent the election from representing the will of the people. Britain and Muzorewa first tried to disarm ZANU and the Zimbabwe African People's Union (both members of the Patriotic Front) by insisting that they report to assembly points guarded by Commonwealth forces. Meanwhile, British colonial governor Soames (in charge of the election process) let Muzorewa's mercenary forces and South African troops roam free, intimidating the masses-a violation of the cease-fire agreement. ZANU kept most of its soldiers in the countryside and concentrated its troops only in the assembly centers where the mercenaries and South Africans were relatively weak. Mugabe ordered his men not to give up their arms, and repeatedly warned the imperialists that if Muzorewa and South African soldiers weren't leashed ZANU would resume the armed struggle.

During the election process there were at least two attempts to assassinate Mugabe. In addition, Soames threatened to block the election in areas where ZANU had the strongest mass support. Despite all this, ZANU took on their enemy on the parliamentary front (a stronghold of the imperialists and a front where ZANU had little experience), maintained their independence and initiative and won. The resounding success in the elections was a fruit of ZANU's sharp and flexible tactics and seven years of sacrifice during the armed struggle.

ZANU Can Use State Power to Meet New Challenges

for ZANU. Even if ZANU were to be forced out of power by a right-wing coup backed by the imperialists, the Zimbabwean people have demonstrated to the people of the world that ZANU is their true representative.

With state power, ZANU can now mobilize a lot more resources for its cause such as the right to organize and control the army, the police, the courts, and prisons, the power to tax and issue currency, access to TV, radio and transportation, control over natural resources like chrome, and so on. This can now be utilized to fight for the political and economic independence of Zimbabwe and the liberation of the black majority instead of oppressing the black masses as the racist Smith regime used it.

With state power, ZANU can now use the diplomatic front fully to fight the British imperialists, the South African regime, as well as the two superpowers-the U.S. and the Soviet Union. ZANU can now provide more active leadership in the Organization of African Unity, the movement of nonaligned countries and the United Nations.

ZANU and the Zimbabwean people will need all these resources to carry out the more complicated and challenging tasks ahead. ZANU has to fight not mainly on the military front as it did in the past, but on all fronts-parliamentary, economic, military, diplomatic, as well as the cultural front. Only victory, step by step, on all these fronts can insure a politically and economically independent Zimbabwe and bring final liberation for the people.

Building Independent Economy Difficult for Third World Countries

One of the most difficult fights will be to build an independent Zimbabwean economy. Zimbabwe is a poor, underdeveloped third world country. For Zimbabwe, because of years of imperialist robbery and domination, it will be a big fight just to be able to feed her people, not to mention building roads, factories and so on. Seven years of armed struggle against the racist regime and the imperial-

ists has brought tremendous destruction and hardship. And the biggest loss has been the lives of the best sons and daughters of the Zimbabwean people in the fight against their oppres-


Frontline states like Zambia, Tanzania and Mozambique have not solved the problem of building an independent economy and are susceptible to imperialist domination again through new forms of colonialism (neo-colonialism-where the imperialists don't rule directly like the British once ruled the American colonies, but instead rule indirectly by controlling a country's economy). Neither Cuba nor Vietnam were able to solve this problem. It is possible for third world countries to become economically independent. For example, China, under Mao's leadership, was on the right path and achieved self-sufficiency in food, then failed to accomplish it. (That's a factor why there was a restoration of capitalism in China after Mao died and the revisionists those who distort Marxism-stole state power.)

The British and U.S. imperialists are hitting this front, pressuring for an "open economy" (The Economist, March 8, 1980, meaning complete freedom for the imperialists to invest in Zimbabwe and once again dominate the country).

Sharp Tactics to Disintegrate Enemies' Ranks

Mugabe has made sharp tactical decisions to help consolidate Zimbabwe's independence. For example, he has asked General Wells, the present head of the Rhodesian army, to be head of the new Zimbabwean army and integrate his and ZANU's troops together. Right now there are 25,000 soldiers in Muzorewa's private army, 4,000 South African troops, the Rhodesian army, as well as 18,000 ZANU and 9,000 ZAPU (Zimbabwea African People's Union) forces in the country. If the Rhodesian army is not integrated into the official forces, they would be a potential pool of troops for a coup backed by South Africa and the imperialists. The chances of winning

SUPPORT MIDWESTERN FARMWORKERS' STRIKE!

TOLEDO, Ohio—During the 1978 and 1979 harvest seasons, migrant farmworkers called strikes in the tomato fields, demanding decent wages, living conditions and hospitalization. The Toledo-based Farm Labor Organizing Committee (FLOC), leaders of the strike, report 50% of the tomato crop was left to rot in the fields last year. One cannery in the area, Libby-McNeil-Libby, was forced to go outside the region to fill its quota of tomatoes for the year.

Farmworkers in Ohio have called for three-way negotiations between tomato processors, growers and pickers. The main processors in northwestern Ohio, Campbell's and Libby, have refused to negotiate, claiming they have no responsibility to those who pick the tomatoes that the companies can. FLOC is calling for a national boycott of Campbells and Libby to support the strike, which continues into the 1980 season.

Ala. Textile Workers Strike 8 Months

HUNTSVILLE, Ala.—Local 997 of the International Chemical Workers Union goes into its 8th month striking against Huntsville Manufacturing Corporation.

Thousands of yards of defective fabric have been rolling back to Huntsville Manufacturing Corp. by dissatisfied buyers, and six mysterious fires have been set inside the plant within two weeks. This has made textile czars Lowenstein and Sons come back to the bargaining table with the militant workers of Local 997, who have been on strike since June.

The textile workers are demanding that the company recognize the union as the workers' representative, dues check-off (union dues automatically taken from workers' checks), and improved health and safety conditions in the plant, which has been cited for over 200 Occupational Safety and Health Administration (OSHA) violations in the past year.

WILDCAT! 6,000 W.VA. MINERS BUST OUT

MORGANTOWN, W.Va.—For 11 days the coal in West Virginia stayed deep in the ground. From Feb. 21—Mar. 3 6,000 northern West Virginia coal miners refused to work. They were on a wildcat strike protesting the suspension of a United Mine Workers local president and two mine safety committeemen. The wildcat, the biggest coalfield walkout in two years (since the 111-day contract strike in 1978), shut down seven of the state's ten largest underground mines.

Local president Michael Zemonick was fired and safety committeemen Willard Blair, Jr. and Gary Riggs were suspended for "acting irresponsibly, inciting a strike, and insubordination." This followed a one-day wildcat a few days earlier over a job assignment at the same mine, Consolidation Coal Co.'s Four States mine in Marion County. After this strike was ended by court order and the men suspended, the miners walked out and spread the strike by roving pickets wearing ski masks to other mines in UMW District 31.

"Everyone's mystified over this," said a company spokesman. A UMW official in Washington said the union deplored the strike because the miners "didn't use the grievance procedure." But, he added, Consolidation Coal 'provoked the wildcat. It looks like we're in for a fight with them." Both company and union officials are troubled, their dream of labor stability in the coalfields shattered by the strike. Since the 1978 confrontation, there has been an all-sided attack on miners' right to strike. This affects all workers, who look to the miners as fighting examples for the whole working class. This strike shows that, despite attacks by the company, the union bureaucrats, courts, government and media, the workers are seeing through the tricks and are determined to use the strike weapon against the

Strike Shatters Coordinated Attacks On Miners

Back in May, 1979, Consolidation Coal, the second-largest coal producer, left the BCOA (Bituminous Coal Operators Association—the unionized coal companies' coalition). Then new UMW president Sam Church led the delegates at the December UMW convention to approve a selective strike fund, the UMW's first. This fund (which would have working miners pay striking miners' benefits) weakens the union by putting a crack in the miners' "one out, all out", "no contract, no work" tradition. In the name of "strike fund" they want the miners to scab on each other.

Then the 40 BCOA board members changed the structure of the BCOA to give major coal companies, and Consol in particular, greater control in the 1981 contract talks. With the union weakened and with more control in the BCOA, now Consol Coal is, of course, moving to return to the group.

20,000 miners are thrown out of the mines and onto the streets by layoffs, this disorganization making it harder to fight. The hated union president Arnold Miller was forced out of office, replaced by vice president Sam Church. With Miller gone, the target for fighting the union bureaucrats was temporarily lost. Church used this at the December UMW convention to weaken the hand of the rank and file members. The selective strike approval along with dues increases, having appointed rather than elected officials, and other decisions serve the capitalist plan for labor stability in the coalfields—make the workers pay for a constant source of domestic coal and capitalist profits.

In January some UMW bureaucrats called on the FBI to investigate communists in the coalfields. By openly inviting government intervention into the union, these attempts to cut

down leading organizers in the mines divide and intimidate the rank and file.

Despite this orchestrated and concentrated assault on the coal miners, they are refusing to bow down to the intimidation, which the recent wildcat shows.

The miners began returning to work March 4 after losing an arbitration decision which upheld the firing of Zemonick and the two committeemen's suspensions. Judge Robert Maxwell of U.S. District Court ruled the union would be fined \$3,000 for each shift missed.

The strike's impact is great. "It's going to be a long time before we restore productivity and good labor relations with Consolidation

Coal Co.," said a UMW district official. "We're very concerned that this disruption may signal a return to the uncontrolled wildcat strikes "that plagued the coal industry before the 1978 settlement," an industry official said. And in UMW president Church's debut in trying to control wildcatting rank and filers, all he did was send telegrams ordering the miners back to work. This only provoked grumbling from miners about what side their president was on.

This means the bourgeoisie will have to use more direct force, and the attacks will become much heavier. Tensions are brewing on both sides as the 1981 contract confrontation nears.

HAWAII HOTEL WORKERS DUMP TRUSTEESHIP

HONOLULU, Hi.—"Where are you going?", asked the big goon, one of Art Rutledge's strongarms outside the polling place. "To vote," replied the worker. "I don't think that's such a good idea," the goon threatened. Last month, Hawaii's hotelworkers answered Rutledge's intimidation with a big 2,548 to 1,933 "NO." They voted in the Team for Democracy slate for a second time in 1½ years.

One and a half years ago, the rank and file of Hotel, Restaurant and Bartenders Union Local 5 voted out old-line bureaucrat Rutledge as president. He got smashed with a vote of Richard Tam and the Team for Democracy, (a broad coalition of people with various views). To maintain their hold on the workers, the International immediately slapped a trusteeship (removal of local union officials and suspension of local's constitution, replacing it with people from the International), on Local 5 and maneuvered to keep Rutledge in power. However, the second vote shows that the International's maneuvers will be shortlived.

Just a week before the second election, Rutledge and the hotel bosses—which include IT&T, owner of the Sheraton-Waikiki—were so desperate they started redbaiting the Communist Workers Party. Rutledge's goons told workers if they voted for Tam, (who's no communist, but a bureaucrat riding in on the opposition slate) they wanted communists in their union. Long active in the Team for Democracy, the Party stood firm and exposed this redbaiting for what it really is—an attack on the entire rank and file.


In Nana O Na Pa'ahana, the Workers Viewpoint supplement in Hawaii, the Party summed up the rank and file's feelings towards this attack on them. "The International has made a habit of disrupting the operation of our local. They slapped us with a trusteeship to keep the Rutledges in and the workers out. They openly distort the real issues in the local by attacking communists. These crooks steal \$11,000 every month and all we get back for our dues is trouble. They take our dues and then tell us who we can elect and cannot elect and how to run our union! These two bit hacks must be kept out of Local 5."

So after 40 years of living under the Rutledge family's tyranny, the rank and file voted them out not just once, but a second

Thus the Local 5 workers scored a victory for the thousands of workers across the country battling the growing trend of trusteeships. The Hotel, Restaurant and Bartenders Union alone has over 20 locals under trusteeship (including Local 2 in San Francisco). The Amalgamated Clothing and Textile Workers Union has all five of its Cone textile mills locals under "administratorship" (trusteeship). CWP comrades led two of these locals before they were assassinated in Greensboro on Nov. 3. This trend shows how the rank and file are becoming more disgusted with the old bureaucrats and kicking them out. The weakening bureaucrats can only keep control by taking things over directly.

It was not an easy struggle for the Local 5 rank and file. The International tried to use the 1½ years of trusteeship to confuse the workers and whip them back into line. But they couldn't kill the spirit of resistance. And the workers said again: INTERNATIONAL HANDS OFF! TRADE UNION DEMOCRACY FOR A FIGHTING UNION!

CWP Rallies Heart of Indiana Harbor



Dear CWP,

Up until last September 16, the people in Indiana Harbor hadn't seen real communists in action before or heard of the Communist Workers Party. But that morning things began to happen. Some CWP comrades and friends were on a corner speaking to the crowd that was gathering for the Mexican Independence Day parade with its beauty queens, politicians and Mexican chariots. The people were in a festive mood and most of them had forgotten what the Mexican Revolution was all about. We began to remind them of the revolution in Mexico and the oppression of the rich class of landlords on the peasants. The spirit of the Mexican Revolution is more than celebrating it with beauty queens and politicians. The best way of commemorating the heroic struggle of the Mexican people is to continue that struggle against the daily oppression of the capitalist class here in this country.

After a while, the police came on the scene and told us to keep quiet or get out. We argued, refused to leave or stop speaking. Before you knew it, they started arresting us. Both Mario Diaz and Jim Hashiguchi ended up in jail and were booked on a number of charges from assault and battery of a police officer to disorderly conduct and with a \$8500 bond on each. But the fight did not end there. After they spent the night in jail, 15 people came to the arraignment and the charges were reduced to disorderly conduct and resisting arrest and a \$100 bond on each.

To arrest us, the police used East Chicago city ordinances and Indiana state laws which had not been used in 30 years. The laws were then used against communists organizing in the steel mills. East Chicago is the site of Jones and Laughlins' giant Inland Steel Mill. The fact that now they must use this law against us is a testimony to the Communist Workers Party's impact.

We wrote a leaflet and got it on the streets to the people and rallied the heart of the Harbor. This was not just an attack on communists, but on anyone who dares to speak up against any injustice or oppression. The prosecutor came up with 5 additional witnesses just before trial, and we were forced to delay it. The police continued to stop us from using a bullhorn and even leafletting, but this just gave us a better case against the city and police for the civil suit we filed in federal court for violation of our rights to speak and


The Chief of Police was indicted for voter fraud at the same time the police were trying to deny us a permit to march. We marched not only against the attack here but also against the murder of the five comrades in Greensboro by the Klan, Nazis and FBI. They were forced to give us the permit because of our political and legal offensive.


Initially, most of the people in East Chicago were afraid to speak out for communists. However, during our campaign we were able to point out the larger meaning of these arrests-that if the state can do this to communists, then they can do it to any worker on strike or anyone who speaks up. At Jim's plant, one backward worker threatened to file a grievance against him for being a communist. However, his efforts were unsuccessful because the other workers knew that this would only further divide them.

The trial just ended in February with a Not Guilty verdict by a jury of six. But the victory is not just in the courts but in the hearts and minds of the people of East Chicago, In East Chicago, Inland Steel's backyard, everyone knows that the victory against redbaiting here is also a blow against Inland Steel.

We showed the people of the Harbor that the Communist Workers Party has the organization and leadership to take on the state, and that the ultimate solution to this capitalist hell is socialist revolution!

At that time we became clear that it wasn't just the foreman, it was the whole company.

A couple of weeks later I started working at Cone Mills, White Oak plant. I remember telling the lady who interviewed me how lousy Guilford Mills was. She said Cone was different. What a joke.

I started working in late summer of 1977 at White Oak in the dye house, third shift. Most of the workers were black. Just before I got there the workers, both black and white, won a victory. They stopped a Cone supervisor from coming a half hour before the shift ended and forcing them to speed up so that when the supervisor's boss came in he would be very impressed by the supervisor. So when I came the company was working full force trying to break this unity among the workers. They tried everything. First they told the black workers not to trust the leader of the unity, Bill Sampson, a white worker who told workers they must stick together to fight for safer working conditions, higher pay, etc. When this failed, they offered Bill a supervisor's job. They told him he was too smart to work as a worker in the dye house. Meaning with all these black workers.

I talked to Bill, told him about my past history at Guilford Mills. He told me the only way we workers are going to get any rights, a voice in working conditions, is to organize together to build unions. He said that the system (the government) is run by the rich people who own the mills. A handful of rich people rule this government in their own interests, not

and a leading union fighter at Cone Mills, White Oak plant in Greensboro, N.C. Since the murder of his close friend, Bill Sampson, one of the Communist Workers Party comrades assassinated in a government-instigated Klan/Nazi attack, he has been fired from his job. He is being framed up for protecting the masses from the killers on that day. The government is charging him with being "armed to the terror of the people".

His statement for the N.C. Advisory Committee to the U.S. Commission on Civil Rights (see article on page 8) on his experiences in the textile mills follows:

I started working in 1976 at Guilford whole day at the plant and so did the rest their rights. of the workers in the packing department. It was driving me crazy, no social life. It got to the point where we had to take a stand-the whole packing department. We got together and decided not to work over our shift without a notice in advance to give us enough time to change our other plans. The boss said we had to work over whether we wanted to or not. All of us, black and white, stood together and said NO!, that's not right. He said if we don't stay, don't come back.

We figured that if all of us left he couldn't fire all of us. When we came to work the next day, Saturday, we weren't let in the plant. We figured we'd get this

Rand Manzella is a textile worker the majority. That's why Guilford Mills could get away with firing us like that. Then he told me about Cone Mills and how they have been for years trying to bust the workers from organizing. He said there was a difference from Guilford Mills, however-the difference is Cone has a union. But the reason our pay and benefits are so low and the working conditions are so unsafe was because the union was weak. He said that's because of misleaders in the union and because Cone really harasses people who organize and fight for better conditions. They fired some of them and they usually got away with this. He encouraged us to stick together and join the union. He said if we organize together to build a strong union Mills on Market Street. The workers united in after awhile I got tired of spending my the dye house and started fighting for

Cone fired our shop steward, Thomas Anderson, on trumped-up charges. They went around telling the black workers it was Bill's fault Thomas Anderson got fired. Just before they fired him the supervisor offered me a supervisor's job saying I had good management potential. That was just another attempt to split up the workers because if I would have tried for a supervisor's job I would have played right into their shoes. They use this as an example of how we can't stick together, both black and white. And the supervisor couldn't have known whether I had management potential or not. I was there

over the bulk of the black soldiers in the Rhodesian army is good since their morale is low. In addition, Mugabe has appointed a ZANU officer to serve as General Wells' deputy.

Is Mugabe Waffling on Support for S. African Liberation :

Mugabe has also tried to tactically neutralize South Africa. "South Africa is a geographical reality for us; it's also a historical reality. We cannot get them away even if we wanted to. The reality is that we have to co-exist with them and co-exist on the basis of mutual recognition of the differences that exist between us. In other words, we should pledge ourselves, if South Africa does so on its part, to non-interference in South African affairs and they to non-interference in our affairs," he said.

Is Mugabe wavering on his support of the Azanian (South

African) people's struggle against the racist regime? Shouldn't he let Zimbabwe be used for guerrilla bases for the Azanian peo-

ple's armed struggle? Right now, there is a real threat of a right-wing military coup by the white minority still in Zimbabwe, backed by South Unable to Atrica. stomacn ZANU's victory, right after the election the South African regime threatened, "Any neighbor which allows its territory to be used for attacks on or the undermining of South Africa and its security will have to face the full force of the Republic's strength." Mugabe made a tactical decision to demand noninterference on both sides to buy time to build up his country. He knows that a strong, independent Zimbabwe is itself a great threat on the continued rule of the white minority regime in South Africa.

The principle of peaceful co-existence does not apply to

illegal settler states like South Africa or Israel. This means that other countries can provide military aid to the Azanian people in S. Africa and the Palestinian Liberation Organization, and it is correct for them not to have diplomatic relations with countries like S. Africa and Israel. This was China's policy under under Mao. However, tactically ZANU can't fight in all directions recklessly. Mugabe is correct to mainly concentrate on the domestic front to consolidate Zimbabwe's independence and not give South Africa an excuse to militarily intervene right now (although South Africa will definitely use political and economic means to topple the ZANU government). This is the same tactical principle Mao applied in China after the communist victory in 1949, (although he was talking about internal policies toward different class forces) when he said, "It is undesirable to hit out in all directions and cause nation-wide tension. We must definitely not make too many enemies, we must make concessions and relax the tension a little in some quarters and concentrate our attack in one direction." (Selected Works, Vol. 5)

Trotskyite RCP Attacks ZANU's Victory

On the one hand, the imperialists are hoping that Mugabe and ZANU will trip up and give them an opening to get back in the country. They are speculating on the so-called "two Mugabes"-the "Marxist terrorist" and the "new pragmatic prime minister". They can't understand how Mugabe could be firm on Marxist principles while being flexible in tactics. On the other hand, the Trotskyites like the "Revolutionary Communist" Party (RCP) said the cease-fire agreement was a "sellout" (see WV, Feb. 16, 1980). Now the RCP is calling the election victory an "illusion." They pit armed struggle against parliamentary/diplomatic struggle, as well as the fight to build

an independent Zimbabwean economy. This poverty of tactics comes from the fact that the RCP sees liberation as a pure and straight road without twists and turns. To them seizing state power means the end of class struggle. They would have ZANU stay in the jungle instead of move on to more difficult challenges. By attacking Mugabe and ZANU, they are giving the imperialists a helping hand.

Victory to ZANU and Zimbabwean People

Whether one supports the ZANU-led national front government of Zimbabwe or attacks it is the watershed between genuine communists and the imperialists, revisionists and Trotskyites. We have confidence that Mugabe and ZANU will be able to overcome this problem. Mugabe is a Marxist-Leninist and ZANU has been trained through years of struggle and building base areas. Zimbabwe is also the second most populated country and richest in resources in

Black Agenda Conference Fails To Meet Challenge Of 80's

RICHMOND, Va. - Between Feb. 28 and March 3, 1,000 people attended the Conference on a Black Agenda for the 80's held here. More than a year of preparation and a series of miniconferences preceded the Richmond meeting. The conference's purpose was to develop a black agenda and present this to the presidential candidates on the last day of the conference. The meeting was convened by Gary, Ind., Mayor Richard Hatcher and included old-line civil rights leadership such as Joseph Lowery of the Southern Christian Leadership Conference (SCLC), Jesse Jackson of Operation PUSH (People United to Save Humanity). Benjamin Hooks of the NAACP, Vernon Jordan of the National Urban League, and ex-Ambassador Andrew Young. Also in attendance were black elected officials from every level of government, black educators and black professionals of every political persuasion. This was the third such major black leadership conference since the first in 1972 in Gary. One of the most striking differences between this and the Gary meeting was the lack of grass-roots activists rooted in the day-to-day struggles of the Afro-American people.

Presidential Candidates Didn't Show Up

On the day before the conference began, three presidential candidates (Ted Kennedy, Jerry Brown, and Republican John B. Anderson) canceled their scheduled visit. In fact, none of the candidates even bothered to send a representative in his place. Many of the conference organizers were visibly upset after this announcement was made, although the conference proceeded as planned. It was a rude awakening to some at the conference, especially to those who wanted to use the black vote as a lever to squeeze some concessions from the candidates. The candidates' cancellations highlight the political impotency of old-guard black leadership. On the one hand, they have staked their whole political careers on electoral politics, alienating themselves from the Afro-American masses - these careerists and political speculators can't deliver any voters because they have no following. On the other hand, no presidential candidate has anything to offer blacks even if he wanted to.

Conference Shows Need For New Moral Authority

Several positive resolutions were passed at the conference, including condemning the murders of the Communist Workers Party 5, (see page 9) opposing registration and the draft, and demanding that the U.S. break all ties with South Africa. But the conference was dominated by electoral politics and lobbying for different individuals' selfinterest. The failure to develop a clear program that speaks to the needs of the Afro-American people in the 80's shows the inadequacy of the old leadership to meet the challenges of the

Electoral politics and reformist tactics are being swept aside by the Afro-American people. Their own experience has taught them that electoral politics is a sham. Idabel, Okla., where 200 blacks fought state and local police after the murder of an Afro-American youth, shows that the spontaneous tendency among blacks is to meet the attacks of the 80's with armed resistance. At the conference, an SCLC proposal that 'non-violence be adopted as the strategy for black people in the 80's" was defeated.

Since 1972 the number of black politicians has almost doubled from 2,300 to 4,500. Despite this increase, the plight of black people has worsened. The Supreme Court passed the Bakke and Weber decisions legalizing the racist lie of "reverse discrimination." The KKK is being built up all over the U.S. Joblessness among black youth is 70% and rising. Last year a black youth was lynched in Chester, S.C. and another was murdered for "fun" in Chico, Calif. A black executive was beaten to death by cops in Miami. All this, and especially the murders of the Communist Workers Party 5 by the KKK/ Nazis and the fact that half the killers are still free walking the streets, indicate the tremendous repression that the 80's will bring.

The 70's proved that reformism is a failure. New leadership is the demand of the Afro-American people. And this is exactly what the CWP 5 died for. They represented the finest working class fighters in the interest of the Afro-American people and the U.S. people as a whole. Their heroic tradition shines as a beacon for the revolutionary struggles of the 80's.

NOBEL PRIZE WINNER FOLLOWS IN HITLER'S **FOOTSTEPS**

Last week William Shockley announced plans to create a generation of "superbabies" by impregnating women who have high IQ's with the sperm of Nobel Prize winners. The purpose of this program, Nobel Prize winner Shockley says, is "to increase the percentage of people at the top of the population." This announcement got a lot of publicity in papers like the New York Times and Shockley got time on CBS' Stanley Seigel show to explain his project. Who is William Shockley and what will his generation of "superbabies" lead to?

Shockley is one the main advocates of eugenics in the U.S. Eugenics is the science of selective breeding. Shockley is a racist who has spent the last 20 years trying to prove that blacks get lower scores than whites on IQ tests because they are "genetically inferior." Now Shockley is shifting his emphasis to this new program, the first step towards the creation of a master race.

No Such Thing As **Born Genius**

Shockley's "master race" is based on the idea that some people are born smart because of "superior genes" and other people are born dumb because of "inferior genes." But the fact is, there is no such thing as a born genius. Intelligence is determined by a child's environment. How well can a child's mind function and grow if he can't get enough decent food to eat? Or he may not have a roof over his head because his parents can't find a job or because food is just too damn expensive. With the quality of schools under capitalism, there's no way to get a decent education! If you can afford special schools, a room full of encyclopedias, a home computer to stimulate your child's mind, he might be all right. But how many parents can afford these? Most kids in the U.S. will never have access to any of these. The IQ tests which are supposed to determine who is smart and who is dumb are set up to force the capitalists' standards of intel ligence on the U.S people. If a child doesn't think like a capitalist or isn't white, top administrators and some co-called scientists will say the kid is dumb.

The master race idea isn't new. It was one of the main pillars of Hitler's rule in Nazi Germany. And Hitler wasn't the only one who supported this fascist theory during World War II. Many U.S. capitalists supported Hitler's program. Henry Ford was in complete agreement with Hitler's idea of "Aryan superiority" and was one of the biggest backers of the Nazi party. Ford gave hundreds of thousands of dollars to Hitler's cause.

A program of supporting a "superior race" goes hand in hand with a program of repression to keep the "inferior races" down. In Germany, Hitler's "Aryan superiority" meant tremendous repression, especially for Jews, and the eventual murder of more than six million Jewish people in Nazi gas chambers. Will this ever happen in the U.S.? While some may think something that horrible is impossible, day-to-day decisions are already being made as to whose life is valuable and whose is worthless, decisions that will increase the hardship and suffering of the U.S. people in the

Life Decided by Dollars and Cents

Last week, Hilmar G. More, Chairman of the Dept. of Human Resources, and the mayor of Richmond, Texas called for mandatory sterilization of all women on welfare. This means if you are poor, you don't deserve to have children. This would legalize the existing policy of secretly sterilizing black, Native American, and Latin women, and make every poor American family a future target for sterilization. As more factories close down and workers get thrown out on the streets, more will have to turn to welfare just to survive. Thousands of white workers will have to give up their right to a family to be able

In a report just leaked to the press, the State of New York has put into ruthless dollar and cents terms whose life is valuable and whose is worthless. The report said a stockbroker in a white suburb of New York City is worth \$1,000,000 while an old woman from an older section of Brooklyn is worth \$60,000. The report determined how valuable a person is by how much money he makes and how important his job is. The state plans to use this report to decide which community gets state funds to purify the water supply in case the water is contaminated by cancer-causing agents. As more cases pop up of whole towns being poisoned with cancer-causing chemicals, who gets money will decide who lives and who dies. If a person's worth is determined by how much he makes, how much will be spent to clean the water in a black community where the youth will never have a chance to get a job?

Programs to sterilize poor women and let "worthless" communitles die from chemical waste are what the 80's will mean for the U.S. people. And the capitalists will use fascists masquerading as respected scientists to justify their attacks.

YOUNGBLOOD, RISE UP!

ANTI-DRAFT FORUM AT BROOKLYN COLLEGE DRAWS NEW FIGHTERS

BROOKLYN, N.Y.-On March 3 and 5, over 250 students attended an anti-draft rally and forum at Brooklyn College. Sponsored by Brooklyn Against Nuclear Power (BAN), the event covered the political situation in Iran and Afghanistan on the first day, and Carter's registration plan and the threat of a new draft on the second. Most of the people there were 18, 19, and 20 years old-draft age-and came with a lot of urgent questions about the draft and the danger of war. One student said, "I don't want to kill or be killed...how can I avoid getting drafted?" Another asked, "Why shouldn't the U.S. just send troops to help Afghanistan kick out the Russian invaders?" Instead of glossing over the ugly role of the Soviet social-imperialists (socialist in words, imperialist in deeds) like some speakers at the rally and forum did, a Communist Workers Party member and Revolutionary Youth League organizer stood up and condemned both the U.S. and the Soviet Union. When he said that the Afghan people must liberate themselves and not rely on one superpower to kick out another, he was instantly applauded by the students.

Like a thermometer, the Brooklyn College event gives a good reading of the temperature of this budding movement. For many of those who came out, the draft is their first time getting involved in politics-it's an issue which affects them directly. People with no previous interest in politics are marching in the demonstrations, attending meetings and passing out leaflets against

The activists of today's anti-draft movement nunger for answers and clear political direction. They want to know why their futures are being threatened by the draft and the danger of a war between the U.S. and the Soviet Union, but most important of all, they want to know what they can do about it. This generation didn't directly experience the mass movements of the 60's, but their political attitudes have been shaped by the anti-Vietnam war movement and Watergate. Most young people today are anti-"big business" and automatically distrust the government. In spite of the anti-Iran scapegoating and "get tough" war hysteria whipped up by Carter and the press, few people will willingly fight another war for U.S. imperialism.

For every youth and student taking a stand against the draft today, there will be hundreds of thousands in the near future. Out of their ranks will come many new fighters, revolutionaries to take up the challenges of the 80's.



The judge agreed with Schlosser that it is totally within the discretion of the District Attorney to decide if he will accept the help of a private prosecutor. The Judge also claimed that it is traditional to consider only the motion of the District Attorney, unless

the District Attorney is considered disqualified. The Judge refused to allow Signe Waller (widow of Jim Waller, one of the CWP 5) to speak. In effect, the Judge allowed the District Attorney to decide his own competency by not allowing Signe to show why he should be disqualified. Judge Long further stated that allowing indiscriminate private prosecutors would diminish Schlosser's efficiency. The state and District Attorney's office have only been efficient in defending the Klan/Nazi murderers. First of all, Schlosser approved of a mere \$4,000 bail on five counts of first-degree murder. Then to ensure a "fair trial," the Judge granted the Klan/Nazi motion for the state to use the taxpayers' money to pay for private investigation for the murderers-1,300 hours of work worth \$32,500. The state is also paying all the Klan/Nazi attorneys, including four lawyers who specifically consented to take up those cases. The CWP will continue to fight court attempts to cover for FBI and Klan/Nazi and police involvement in the Nov. 3 murders. As we can clearly see, they are setting the stage to allow the criminals to go free-opening the floodgates to Klan/Nazi violence with a license from the state.





* CWP members and supporters have talked to the police and identified some attackers by photograph and even by name, as well as filed charges against certain police. What have the police and District Attorney done about these? Edward Dawson (the Klansman to whom the police gave a copy of the Nov. 3 anti-Klan march permit) and George Dorsett (a known FBI informer) have not been arrested.

The dropping of conspiracy charges against the Klan and the pending trial of the three comrades shows the treachery of the state and its true nature of being a Klan/Nazi supporters. It shows the need to continue to broaden the support to drop all charges against the three comrades and to prosecute the KKK/Nazi killers.

Mayor Pushes "Shootout" View -KKK Defense

Greensboro Mayor Melvin was right in line with the Klan and Nazi defense when he claimed that race relations in the city were: "swell" and that if it weren't for "outsiders" there wouldn't have been a "shoot-out" on Nov. 3. The KKK/Nazi murderers are claiming that the CWP fired first and they just defended themselves. For Melvin to call the massacre a "shootout" is to deny that the attack was a planned assassination aimed at the leadership of the CWP.

In contrast to Melvin, John Erwin testified, "November 3 brought to life what has been long apparent-we (Afro-Americans) are being shortchanged. November 3 could have been prevented if information about the march route hadn't been given to known Klansmen by the Greensboro police." Speaker after speaker from the community spoke of discrimination against Afro-Americans, such as segregated public facilities like swimming pools where it's "understood" to be for whites only.

Pull the Sheets Off Government Coverup

Nelson Johnson asked the Commission, "Who had an interest in seeing that five organizers, three of whom were extremely successful in organizing at Cone Mills, were murdered? Who has an interest in seeing that our Party is crushed and its growing influence among the masses destroyed?" He went on to point out that while the KKK/Nazis are unquestionably guilty, they don't have the means or motive to organize a military assassination and a political and legal coverup.

The CWP demanded that the Commission uncover the truth about the Greensboro massacre. Specifically, they should uncover:

*The entire FBI file, including its investigation of the CWP before and after the Nov. 3 assassination. *The entire file and record of the Community



September 9, 1971-Attica, the maximum security state prison in Western New York. D-yard has been seized by prison inmates. Their message: "We are men. We are not beasts and do not intend to be beaten or driven as such... What has happened here is but the sound before the fury of those who are oppressed." Their demands:1) Amnesty for all the inmates in the rebellion 2) The firing of the head of prisons 3) Eleven other demands for prison reforms.

March 2, 1980 ABC Television presents Attica, a two hour special based on the book A Time to Die, journalist Tom Wicker's first-hand account of the rebellion. Nine years after the prison uprising, ABC is still trying to cut out its revolutionary heart.

"A Change Has Come Over The Brothers In Attica"

ABC proceeds to show the inmates as a motley crew, with the vast majority not knowing what they're doing but just going with the tide. The character who plays Tom Wicker talks to one black inmate who says he's got kids and a wife and all he wants is to serve his time and get it over with. But in the actual rebellion of 1971, the Black Panther Party and the Young Lords Party played a large role educating inmates about the nature of the capitalist system-the system which creates hell-holes like Attica.

The Attica rebellion was a conscious act of defiance by Black, Puerto Rican and white prisoners united. "I can't tell you what a change has come over the brothers in Attica," wrote inmate Sam Melville in August, 1971, "so much more consciousness of themselves as potential revolutionaries, reading, questioning, rapping all the time. There is still bigotry and racism...but one can feel it beginning to crumble in the knowledge so many are gaining that we must build solidarity against our common oppressor-the system of exploitation...'

The inmates were fed up with being treated as dogs; kicked around, abused, stripped of any rights of being human beings. They were fired up against the harassment that went on every second they sat in those hell-holes. ABC presented none of this background which explains why the uprising was justified.

ABC tries to make people forget the dirty work of Nelson Rockefeller who was Governor of New York at the time. It was Rockefeller who, from his billiondollar Pocantico Estate, ordered state troopers to flood D-yard with tear gas and shoot down 29 heroic Attica brothers and 10 guard hostages on the morning of September 13. A mother, whose inmate son was killed, said the bullet "had Rockeller's name on it." ABC executives edited out from the film the scene of Rockefeller refusing to negotiate with the prisoners. "We believe that seeing Rockefeller, who everyone knows is dead, would be distracting to viewers, "explained an ABC spokesman.

only three weeks and I hadn't talked to him much at all.

Since then some of the other workers quit because of harassment. The rest of us still tried to organize. The company time and time again attacked us. They had Bill arrested for representing the card tender in a work overload grievance. They fired me twice. Plus they had their supervisors go around saying bad things about us, telling people we're violent and dangerous. Cone had historically tried to split black and white, young and old, men and women, just by the way they set things up for us to compete against each other. The reason Cone did this is if workers are fighting each other, they won't be able to fight the real oppressor, Cone, who speeds up their jobs, cuts their pay, and fires them when they disagree with the oppression. The black or white guy next to us is not the one responsible.



ABC Executives Reverse Scenes To Blame Inmates

In the final scene of the show, ABC shows the inmates threatening hostages right before the vicious assault on the prison by the state. But the facts in 1971 were the exact opposite. Inmates took no action on the hostages until after the state opened fire with riot shotguns, randomly shooting down anyone in the way. "ABC insisted that the scenes be reversed so that viewers would believe there was greater justification for the attack by the state," said the filmmaker himself, "I fought with ABC for several weeks, but lost".

Nine years ago, after the state had massacred the leaders of the Attica rebellion and witnesses, ABC News and the other networks put the blame on the prisoners-they had provoked the slaughter by mutilating and slitting the throats of their hostages. Autopsy reports later proved different, and the nation was outraged. Now ABC is again pushing the

same sick lie that the unarmed prisoners in D-yard asked for their own deaths.

This logic of making the victim to blame is the same argument used to justify the KKK/Nazi and FBI assassination of the CWP 5 on November 3, chauvinism against the Iranians, and the recent deaths of inmates at the New Mexico prison-all to numb and confuse the American people's resistance to oppression.

Attica portrays the state as all-powerful while the prisoners are weak. But it is the bourgeoisie and their state apparatus who are really weak, losing legitimacy in the eyes of the people. It was out of desperation and mortal terror that the Attica rebellion would spread to every prison in the U.S., that drove Governor Nelson Rockefeller to order the bloodbath in 1971. And it is out of fear that the government refuses to show ABC's Attica in some prisons, especially at
