 - (c) Misc. Chris and Dee opened up prospects for a small local in Conn. At present we have 4 such prospects: N.Orleans; Seattle; Columbus, Ohio; and Conn. Letter from Malcolm Bruce, states he has resigned from the LSA and asked us to announce this. Exchange of letters with Charlie S. reported; REB endorsed Al's letter to Charlie. Ron has been cleared of all charges in Nebraska. Cuban Trotskyists have been released from jail. Meeting with Marcus, SWP oppositionist, has been arranged. Disintegration of Balto. local has not only been arrested but reversed; all worthwhile members have returned and are functioning; local needs organization.

5. New York City Elections:

Motion: to endorse the motions passed by the Exec.

- (1) We call upon the labor and civil rights movements to put forward independent candidates in the forthcoming City elections.
- (2) We give critical support to those working-class candidates, Clifton De Berry of the SWP for mayor and Bill Epton of Progressive Labor for State Senator from the 21st Senatorial District, in the event that the labor and civil rights movements do not put forward independent candidates for these offices.
- (3) We oppose Major Owens and Jesse Gray because they are running as candidates of capitalist parties and thereby furthering illusions of the black working-class in these parties.

Amendment: In (3) to oppose the candidacies rather than the individuals. Amendment accepted.

M2M- Planning meeting for summer will be on Sunday.

Free University- (PL front, but open) 2 should be assigned.

Lynn Henderson of SWP teaching class on 'Permanent Revolution'.
