2. Women's Liberation

Lubrano reported on red-baiting that has taken place against some SWP members who belong to the National Organization for Women since the NOW national conference in April. These attacks have taken place in Boston, New York state, Seattle, Los Angeles, and Brooklyn. The New Jersey state NOW newsletter printed an editorial condemning the red-baiting at the national conference. Lubrano also reported on the YSA's participation in the upcoming state and regional NOW conferences and the International Women's Year conferences that will take place this summer. Also reported was that August 26 actions have been called in New York City and Seattle.

A coordinating committee was set up and will mail out a report on the meeting. Hart also reported on June 16 actions being planned in several cities. Also reported on was an anti-deportations meeting held in Los Angeles, which discussed the possibility of a national conference in California.
