# YANKEE GO HOME

The recent American attack on the Libyan capital of Tripoli, must surely rank as one of the most outrageous acts of aggression by a country not actually at war, in living memory. On the feeble excuse that they had evidence (still as yet unseen) of "Libyan involvement" in an attack on a US army base in Berlin, the US government felt justified in sending their bombers over a crowded capital city, killing and maiming dozens, perhaps hundreds, of innocent civilians,

Even in a world fast becoming accustomed to US aggression against Small states, a wave of shock and outrage was felt at this act.

This was also the reaction of many people in this country, but for many of them however the greatest shock came when they learnt that the British government had allowed the US to use this country as the base for the attack.

Outrage at the government for allowing the US to use this country as if it were some kind of stationary aircraft carrier, and outrage because by doing this, they have greatly increased the of revenge attacks attacks against British targets both at home and abroad.

### REVENGE

This may not be of to concern to Thatcher and her cronies, who are after all, always surrounded by the tightest security where-ever they go. But it is certainly of concern to all the rest of us who are not quite so well protected.

And if there are revenge attacks can we be in any

way suprised. Imagine if the position was reversed and a Middle Eastern country had just sent it's planes over one night and bombed London. Imagine the cry for revenge that would go up here.

### DOMINANCE

The fact is there was no justification for this raid whatsoever, and certainly no justification for this countries involvement. Even if you leave aside the moral issue, there was no military reason for British involvement. The US could just as easily have carried out the raid from sea or even from the States itself.

Why did they involve this country then ? Simple. They knew full well that this act would meet with great opposition around the world, and they were anxious that another country should be seen to be involved, to spread the blame as it were. That country they decided, would be this one. It is this factor perhaps,

### EXCUSE

In fact, the Berlin bomb was no more than a convenient excuse for the US to carry out action that they had obviously been planning for some time.

Two weeks beforehand, the US sixth fleet had sailed into the bay of Sirtar which goes right into the heart of Libya, and had started to carry out military manoeuveres. Such a move was bound to be seen as a threat by the Libyans and can only have been designed to spark off a confrontation which would no doubt have formed the excuse for US military action.

### MANOEUVERES

This incident gives us yet another example of the staggering hypocrisy of the US government, When the Libyans complained about the US presence in the bay the pious reply from Washington was that as long as they were at least three miles off of the coast, it

Just imagine if you can, what the response would be in the US, if a Libyan fleet was to set off to carry out military manoeuveres 3 miles off of the coast of Florida. Christ almighty. They'd have every plane ship and missile that they had blasting them to bits before they were within a thousand miles of the place.

3 miles like hell. Nicaragua is a bit more than three miles from the US, over a thousand in fact. But that doesn't stop the US government claiming the right to interfere in Nicaraguan affairs on the basis that it is "in our back yard".

The fact is that whilst claiming to represent the forces of "law and order" against terrorism, the Americans are quite prepared when it suits them to use methods that can only br described as terroristic themselves. It is this hypocrysy that makes their terrorism all the more sickening.

A recent report in "The Guardian" from the annual conference of the "Federation of Conservative Students" gave light to some very interesting facts about what is happening in this Tory Party nursery. It described the sweeping victory enjoyed by a group called the Libertarian Faction, who captured every seat in the elections for the executive committee.

The Libertarians are a relatively new grouping. They represent a very strange mixture of extreme right wing politics and lefty sounding jargon - they refer to each other as comrade, and describe their officers as commissars.

### "FREEDOM FIGHTERS"

They declare their support extreme right wing movements such as the Contras who are fighting the Sandinista government in Nicaragua. One of them recently went over there and visited a Contra camp. They have also sent representatives out to South Africa, and they are talking about forming an International Brigade to assist right wing "freedom fighters" around the world.

For many of this faction, Ulster Loyalism is the bedrock of their political commitment. They sent representatives over to the recent bye election campaigns, and during the conference, their parties were held in a Glasgow Ranger's supporters club decorated with recruitment posters for the UDA.

### RADICAL

Weil it's hardly traditional Conservatism is it, but the question is of course does it have any significance?

Some will be quick to point out that there is actually nothing new about extremism in student politics. It wasn't that many years ago that it seemed that the universities and polytechnics were packed out with left wing radicals, who were just as uncompromising with their politics. This loss was due in no small part to the activities of the full time officials in the men's own union, the Union of Contruction Ailied Trades and Technicians.


The dispute began some six months ago when the men were sacked from a John Laings site in London, basically because some of them were known as trade union activists in the building industry. The men refused to accept this and began picketing Laing's sites in the London area assisted by other activists.

The success of this action forced Laings to negotiate and eventually an agreement was reached and the men re-instated on a Laings site. Within just a few weeks however, Laings had reneged on the agreement, and the men found themselves locked out again, and straight away resumed picketing. In response to this Laings went to the High court and under the terms of the 1983 Employment Act, they able to get Court injunctions against imposing stringent conditions on the men. Not only were they not allowed to icket any Laings site, they were also not even allowed to address any meeting of people about the dispute,

This was the first time that the employment act had ever been used against named individuals in this way. Courageously, the men decided to defy these injunctions and continue the dispute. It was then that the full time union officials played their dirty role. Not content with not giving the men any effective support they also took it upon themselves to send circulars to delivery firms who'se drivers had been honouring the picket line, telling them that their drivers should cross the line. They also spread blatant lies about the men around the building industry. This blatant treachery, effectively undermined the pickets and it became clear that the lads were not going to win this time Eventually on the 19th of April they decided to call it a day. We salute them for their courage and their principles.

# **BULLY FOR YOU**

Pick up a newspaper any day of the week, and you can bet your life that you will find in it at least one case of a violent attack on someone somewhere. Violence, whether it be another child murdered, another pensioner battered and mugged, or another battle on the terraces, is rarely out of the news these days.

### DOMESTIC

There is however, one area of our society in which dozen and perhaps hundreds of violent assaults are taking place every day, and yet you will rarely read about them in the news. Several people die every year from these attacks, and there are numerous cases of broken bones, yet even though in many cases the assailants identity is known to many people they usually go completely unpunished. These attacks that we are taking about are those that occour behind the doors of family homes all over the country. Attacks that are usually reffered to as being cases of domestic violence.

### TYRANTS

In almost every case, these attacks are carried out by the husband/father on his girlfriend/wife. To get a complete picture of what causes these attacks, you would probably need the services of a psychiatrist, but it seems pretty obvious that social factors are involved. There are noticably more cases of domestic violence in families on low incomes

Some men turn into tyrants inside the house because they are meek and insignificant outside of it. For some it's a case of frustration. He may work all week in a job he can't stand having to be subserviant to a boss he hates. His wife/girlfriend just happens to be the nearest person to lash out at, Drink of course also plays a part. There will be many women anxiously watching the clock approach closing time this Friday and Saturday, wondering what sort of mood he is goning to be in when he gets home.

The question that you may ask is Why do women put up with it? Well of course not all of them do, but of those that do there must again be many reasons. Some stay and stick it out for the sake of the kids, reasoning that any home is better than a broken home. Some may be scared of just upping and walking out on the only life that they know, however bad it may be. Some are in such mortal fear of the man that they are afraid to do anything that they think might provoke him. It is not unknown for men to track their wives down to women's refuges and attack them there.

### OSTRACISED

One of the worst things of all about the whole syndrome is that people who know about it - neighbours friends etc don't say or do anything about it because they think that it's none of their business. This is absolutely terrible. It isn't something that you can just ignore. Any man who is known to be systematically battering his wife, should at the very least be ostracised by the whole community. Personally I think that he should be dragged out and given a good kicking. If someone was known to be involved in racial attacks, that is what the response of most people would be. I don't see why it should be any different. Cowards like that deserve a dose of their own medicine.

### COMMUNITY

Even though as we have seen, there are social factors that contribute to these attacks lets get one thing straight. They in no way form any excuse for them whatsoever. Any man who uses his physical advantage over a woman to systematically assault her is the lowest of the low and deserves to be treated as such.

As socialists we stand for the community caring for all who are weak and vulnerable. Women in this position are certainly that and it is up to socialists in the community to take up the issue and make it a community one.

# ORDERING THE LAW

"I think from a police point of view that my task in the future, in the ten to fifteen years from now the period during which I shall continue to serve, that basic crime as such - theft, burglary, even violent crime will not be the predominant police feature. What will be the matter of greatest concern to me will be the covert and ultimately overt attempts to overthrow democracy, to subvert the authority of the state and in fact involve themselves in acts of sedition designed to destroy our parliamentary system, and the democratic government of this country".

James Anderton, Chief Constable of Greater Manchester police, on BBC's question time in 1979.

Most people in this country support the existence of the police force. Even some who are quite critical of them, still often qualify this criticism with a statement like "Yes but you have to have them though.

It is a quite understandreaction really. When you think of some of the things that go on today, young children being abducted and murdered, old age pensioners being battered senseless for a few pounds, then it is not suprising that people see a need for some sort of organisation to protect the weak and vulnerable in society from those who would harm them. No one would argue with that,

### VULNERABLE

But does that necessarily mean that we have to have the sort of police force that have today? It is the belief of militant socialists that we do not. In fact it is our belief that protecting the weak and vulnerable is not even the real reason is our belief that the protection of the weak and vulnerable and prevention of crime are not even the real reasons for the existence of the police force in this

Their true role is spelt out very eloquently, and from appropriate source quotation at the beginning of this article. The primary task of the police force is not the protection of old ladies or young children, or the apprehension of thieves and murderers. It is the defence and maintainance of the political system.

This is something that has become more and more apparent in recent years. As the worsening ecomomic sit-

this was the miner's strike, Thousands of police always available, sometimes just for the sake of getting one or two scabs into work. Even at pits where there was no scabs and no danger of any trouble, there were still masses of police.

### BOOMING CRIME

They weren't there because the rule of law was under threat. They were there because the upper classes wanted to see the strike broken, and used their control over the force, to try and intimidate the miners.

Meanwhile back in the areas from which these police had been withcrime was booming due to the fact that there no coppers. But this was of no concern to them. Anderton said "basic is not their main concern


police force founded by the bosses in the nineteenth century, to protect them and their riches from the anger of the work-When you strip away all of the bullshit that's all that they really are today. company police. Of course they have at times served parts of the working class community, when it has suited them, but when it comes to the crunch, their primary task is the one that they were set up for, the protection of the rich, and that task will always take predominance over all others

As the economic and social system deteriorates even further and the police are pulled more and more into playing that role instead of traditional policing one, working class people are going to have to more and more be responsible for the protection and policing of their own communities. Now thats a thought for you.

The law so we are always being told is a neutral institution that treats all in society the same. In fact there are numerous examples to prove that the law like everything else in our society is biased in favour of the rich and powerful. Let's take the fiddling of public money as an example If a working class person fiddles even one weeks dole he or she invariably ends up in prison. When the rich are collared for non payment of tens and even hundreds of thousands of pounds income tax, they are invited in for a chat and to make an offer of how much they are willing to pay.

There are plenty of other examples in the work-place. If a working class person should ever hit a governor or foreman they are invariably knicked for assault, which can be a very serious charge, but when workers are injured and sometimes even killed because a firm ignores safety regulations, the usual result is a fine somewhere between fifty and two hundred pounds.

How can we really expect it to be any different. Judges are the ones who direct how the law should be interpreted, and they are all unelected members of the upper class. Then the various Chief Constables are the ones who give the police in each area their instructions on how the law is to be interpreted in that area. They are also unelected members of the upper class. What chance have you got.



One of the more interesting developments of the last couple of years, has been the dramatic increase in the number of policemen finding themselves in the dock facing criminal charges. As well as the well publicised cases - The Merseyside copper who got seven years for kicking a drunk to death, the five in Holloway nicked for assault - hardly a week goes by, without news of some copper somewhere getting done.

According to the recently formed "Police Complaints Authority" there are at this one time 27 policemen facing criminal charges, as well as nearly 200 facing internal proceedings. These sort of figures represent a massive increase on what you would have found not so very long ago. So what has brought this about?

Some would perhaps say that it proves that the police are committing far more offences than they used to. Maybe that is true, but even if it is, it doesn't in actual fact explain the increased figures. If you look at the statistics, you will see that in nearly every case, the charge is some sort of assault against someone in custody.

### "RESPECTABLE CITIZENS"

As anyone with first hand experience of the police would be able to testify, this has always been fairly common practice, and has certainly not increased that much in the last couple of years. What has changed, is that until recently, unless you had a coachload of vic ars magistrates and other "respectable citizens such as eye witnesses to the incident, it was impossible to bring any charges against a copper. But now a few at least are being nicked. Why

### CLEAN UP

It is obvious that someone high up has taken a decision that more policemen are to be prosecuted but what is the motive behind this ?

The police themselves and their supporters, would no doubt claim that this is proof of the integrity of the force. Evidence of the willingness and ability of those in authority to pursue and punish those that step out of line.

But if that were really the case, if the aim of this operation was really some sort of clean up of the police force, then we are entitled to wonder why some

### **ORGREAVE**

The miner's strike for instance, where there was overwhelming evidence numerous cases of police malpractice - who could forget the occasion when a copper outside Orgreave, was clearly filmed repeatedly battering a fallen picket over the head with his truncheon. Then what about the attack on the peace convoy at Stonehenge last year, Dozens of police were openly attacking the convoyers and smashing up their equip-

If your aim is to clean the police force then surely it is even more importent to clamp down on such incidents of mass violence than it is on individual cases. Even if you were to nick only some of those involved, it would be a clear indiction to all other copp-

of police violence in recent times have seen absolutely no action taken by the auth-

### SACRIFICE

off of their own bat it is different though, Violence is by character disruptive and if it began to get out

Alive, John Mikelson the only black Hells Angel in Britain, and sixty seven year old Henry Foley a retired pension who carried a bus pass wouldn't appear to have a lot in common. They do now Both died while in police custody.

In the case of Mikelson it wasn't just a case of whether he was hit only once as police claimed, or beaten repeatedly as claimed by witnesses but the undeniable fact that he was allowed to lay for over an hour and a half in an unconscious state without any officer summoning medical attention. He never regained consciousness and died from his injuries. Seven police officers have been suspended pending

The police officer who kicked Henry Foley to death de-nied any knowledge of how he got his injuries. He was found guilty of manslaughter and got seven years,

It is high time an enquiry was launched to investigate the callous indifference displayed towards the fate of these "unconvicted" detainees, rather than just writing it off as the excesses of one or two officers. Excesses that are all too often explained away by defending barristers, or by inquest verdicts influenced by a less than partial judge or

When the case does result in a guilty verdict, opportunist politicians are often quick to jump in to deflect criticism by looking suitably solemn and quoting the old "Bad Apple in a barrel" theory, which means that each case is treated as an independent and isolated incident.

It should be remebered that between nineteen seventy and nineteen eighty three, there have been FOUR HUNDRED AND EIGHTY FOUR isolated incidents just like John and

that such behaviour will not be tolerated.

Yet in all of these incidents and many others like them, not one copper has been arrested. So what we to have is a strange sutuation whereby on one hand the authorities seem to be trying to stamp out police violence, and on the other hand actively encouraging it. So what is in fact going on ?

The answer is quite simple really. The real target of this "purge" is not so much police violence but indiscipline. The real crime that those coppers who have been arrested have committed is not so much that they were violent but that they did it at the wrong time when it was un-authorised.

It is not that the authoridon't want policeman who are violent because they do. But they want them to be violent when they tell them to be: On those occasions each and every copper knows that he can act as knows that he/she can act as violently as they want to with total impunity. There is no way that the authorities will take any action, because having given them because it is they who have told them to do it.

When coppers start doing of hand it could actually

And so it is actually in authorities interests to sacrifice a few coppers. It enables them to get rid of their most undisciplined elements and at the same time cracks a whip over the heads of the rest. It also helps fool the public that they are doing their best to stamp out police violence,

The unfortunate reality is that all that is really happening is that they are establishing greater control over it. Perhaps the present wave of police arrests might make it a bit less likely that you will get a truncheon over your head for sweet F.A. one saturday night. Unfortunately if isn't going to make the slightest bit of difference when the riot shields and plastic bullets come out

In a cruel distortion of the advertising slogan for coal, gra-ffitti on a wall in Loyalist East Belfast now reads, accord-ing to the Observer \*Join the RUC and come home to a real fire". Impish humour I'd call it,

It seems that National Front organiser Joe Pearce can still offer a decent amount of bullshit when required. Interviewed in a London listings magazine recently, he described himself as a "political soldier" who could not be scared by a bunch of "Marxist street thugs" (who they are we could not think). Anyway the man who knows no fear (his words not ours) is currrently in the custody of her Majesty in Eastchurch Kent, where he has landed himself a job as the cleaner on the punishment block, an obvious step up from his previous position as editor of the young NF paper "Bulldog". In 1976, a scare story about an Asian family being housed in a hotel caused headlines such as "Scandal of £600 a week immigrants" (The Sun) and helped to create an atmosphere of racial tension that was exploited by fascist groups. Ten years on, in Leicester recently, a similar scare story has been created by Tory councillors, in an attempt to divert attention away from the Tories disasterous housing policies.

"Home on rates - at £118 a night" was the headline in the local paper the "Lei-cester Mercury". The story about a local family being tel, even reached some natinewspapers, prompted by the fuss kicked up by Tory councillors and a Tory MP. The family just happened to be Asian. The result was a flood of letters from a number of white residents claiming that they were being unfairly treated, or listing their own housing problems, and claiming that the Labour controlled City Council were responsible.

### DISCRIMINATE

For the Tories, it was an easy way to divert attention from Leicester's REAL housing crisis - 10,500 people council house waiting on lists, and some 33,000 homes in need of repair (I live in one of them) The family concerned were just another victim of the city's housing problem, but they were presented almost as though they were the cause. The fact that at any one time around 30 people have to be put up in hotels in Leicester, and that the City Council were doing no more than carrying out the duties imposed on them by the Housing and Homeless Persons Act 1977 was completely ignored.

It is not the case (as some appear to believe) that local authorities discriminate in favour of black people, That is illegal under the race Relations Act, yet an amazing number of people in Leicester and other places believe that it's the case.

All that local councils have said, is that they have equal opportunity policies which operate REGARDLESS of a person's race or colour, Certain daily papers would have you believe otherwise.



For me and thousands of others in Liecester, the housing problems are caused not by homeless Asians, but by cuts in government support to the local authority. Some £20 million worth, which will now end up as tax cuts for the rich instead.

The housing problem in Britain is not caused by immigrants or any ethnic group. There is no shortage of houses in the UK. You can go all round the country and find houses for sale everywhere. The simple fact is that homes are too expensive for working class people to buy. But rather than point this out, the establishment and it's media prefer to try and set working class people against each other or against councils that are even slightly progressive.

### ILLOGICAL

No one should be conned by stories of homeless immigrants being the cause of the housing crisis, Nobody ever talks of immigrants taking cars or stereos or whatever from white people. It's just as illogical to say that they are taking homes.

The workers build the houses and they are taken by the bosses and sold off for profit, Decent housing should be a right for everyone and the only way to get it, is to replace the profit based system with a housing policy based on people's needs. Only by returning homes to the class that builds them will our needs and rights be served.

FREEDOM AND EQUALITY: All of those that contribute to a socialist society will receive equal FREEDOM AND EQUALITY: All of those that contribute to a socialist society will receive equal reward and eajoy equal rights, irrespective of colour, race, set or creed. All of society's facilities—between, education, medical, etc.—will be equally available to all. All questions of personal morality—bosonorausility, abortion, divorce, etc.—will be left to individual choice and free from state inserference. There will be freedom of worship for all religions, but no church will be allowed to interfere in sinic matters.

CLASS STRUGGLE. Real Socialists cannot be achieved through parliament. The Labour Party does not try to end capitalism, merely to give workers a better deal within it. If they did attempt to take real power from the ruling class and give it to the workers, they would suffer the name fate as other parliamentary moreonents that have tried to do this. The ruling class would use its control over the forces of the state to crush them. To achieve Socialism, a Socialism movement has to be ready to overthrow capitalism by force.
