THAT 'DEMONSTRATION' OUTSIDE TRANSPORT HOUSE by Chris Arthur

In the demonstration by Young Socialists outside Transport House on June 24th, The Times reports, Mrs. Braddock was lifted off her feet, Miss Alice Bacon hit, Mr. Greenwood pushed into a line of scooters, falling to the ground, and many members of the NEC arrived "white and shaken". No doubt it made young demonstrators feel good to rough up NEC members, but this is serious because what is at stake is the whole future of Socialist youth. The Young Socialists could not have done anything more likely to get the whole movement closed down. No one om the left has any sympathy for (ex-Communist) Mrs. Braddock but to mete out such treatment to Greenwood, one of the few friends the youth movement has on the NEC is disgusting.

Such behaviour should be reserved for the class enemy. By engaging in it a certain group have reached a new low in what can only be described as the pre-war Stalinist 'social-fascist' tactic. That is, they consider anyone in the Labour movement not in their own camp, as bad as the Tories. The right-wing has always held that followers of Keep Left were out to smash the Young Socialists and the Labour Party so that they could pick up some of the pieces. The left has always rejected this as a smear, but need certain Young Socialists continue to act so as to confirm the right wing's claims?

Of course the Young Socialists have suffered from the attacks of Transport House which expelled two of its leaders on the day of the demonstration. Again there was no need to close down the Streatham branch for publishing their leaflet (admittedly stupid and opportunistic) about mods and rockers. Nevertheless, if one demonstrates it is not for the good of one's soul but to get something done. This latest episode will merely isolate the Y.S. further from the Labour movement and therefore cut if off from the only allies it can have. In other words by such ultra-left tactics the people concerned play right into the hands of Transport House.

A great reservoir of revolutionary energy is at present frittered away in useless battles in the Young Socialists. Only a very small proportion of Young Socialists take part in the Labour Party, and when they do they are mostly like fish out of water. If this reservoir of left wing enthusiasm could be brought into the Labour Party an organic link with the Labour left it could change drastically the whole situation in the constituencies. Your Transport House official knows this very well and he is pleased to keep such a lot of lefts tied up in the Young Socialists where they can run riot without harming anyone but themselves. The Keep Left simpletons fall for this strategy by responding to the needling of the bureaucracy by further isolating themselves.

However, now it has come to a public scandal for the Labour Party and Mr. Williams is hinting that the situation will have to be reviewed after election.

We must not let Transport House and Keep Left pull the youth movement to pieces. The adult left must insist that the NEC stop expelling Young Socialists, and appeal to the ultra-lefts to give up their sterils sectarianism and work together with the left as a whole.

A DEMAND FOR MEAL TIME PAYMENT

from Platform (July, 1964)

The following letter was published from Conductor Dougal of Sidcup:
Some three months ago, one of our women conductors came off a bus at
the proper relief point for her meal-break, and, during the three-minute
walk to the garage canteen, she tripped over a rough payment, injuring her
leg and hand. First-aid in the garage was followed by a trip to the local
hospital where she was promptly certified unfit for work. The certificate
was duly handed, with a claim under the Industrial Injuries Act, to the
London Transport Board, who passed it down the official pipe-line resulting
in the applicant receiving a letter rejecting the claim and explaining that
the accident did not occur whilst she was at work and being paid. She was
informed that she could appeal to the local tribunal if she was not satisfied.

In due course the appeals court was held consisting of six, including the National Health Officer, who appeared for the Crown against the appeal. The result of all this was that the Tribunal unhesitantly and unanimously agreed that the claim should be met on the following grounds:

- 1. That at all times during her duty she has the responsibility of the safety of the Gibson machine, box, money and lost property, as there are no lockers provided for conductors.
 - 2. She has to write down ticket numbers during her mealbreak.
 - 3. Reading notices in the garage has to be done in staff's time.
- 4. Washing and toilets are provided only in the garage.
 They also expressed surprise that the trade union allows conductors to do this work and carry this responsibility in their meal times.

This report, when submitted to Sidcup 1/339 branch resulted in complete approval for a claim to be lodged through our union for payment for all meal times, irrespective of length, for <u>Conductors only</u>. Even the drivers present agreed that the conductors have a strong officially backed, which, if successful would go some way towards lessening the pay differential between back and front.....

COMMENT: an interesting point is raised here, we wonder if any other section of workers face a similar situation?

ROW OVER COMPREHENSIVE EDUCATION

A major rumpus has been caused in Bristol by the disclosure by a Gitizen (Tory) member of the council of what is alleged to be part of the Labour Group's plans for extending comprehensive education. This is that the local authority should not take any free places in the city's seven direct grant grammar schools after this year. The result would be that these fee paying schools would feel the pinch, and some of them might even be forced to close after a time.

Bristol has a good record on comprehensive education and when Labour regained control two years ago the Education Committee was given the job of drawing up plans for the extension of comprehensive education to cover practically the whole of secondary education in Bristol. These plans were due to be made public in September, but following the present disclosures the remaining stages of discussion are bound to take place in the full glare of publicity, and the Labour Group will be subjected to strong pressure from a number of directions. The local Evening Post, following its self-styled policy of impartiality, has already come out strongly on the side of the Tories. One can only hope that the forces of the Left will rally to meet this challenge. One big mistake of Labour Councillors in all this seems to be that they regarded their Citizen opponents as gentlemen to be trusted.

IT CAN NEVER HAPPEN - OR CAN IT?

A few months ago a rash of denials broke out on conscription. Suddenly all the politicians were saying that we should not have it. It was never quite clear who was saying we should.

The Youth Campaign and C.N.D. issued statements and these were dicussed by supporters and finally endorsed, expressing our opposition.

More recently, with the air of those who study these things, Campaigners have been assuring me that the issue is dead and that there will be no conscription, and that no one will raise it 'at least until after the election'.

'We in this House should accept the responsibility, and the courage to say so. This is more important than the question of votes in an election. More important than winning an election at any time, is governing the nation.'

I understand that our Youth Campaign in Huyton have one or two interesting questions that they want to ask their M.P. about this statement, which appears to have sneaked through without arousing much comment.

YOUNG GUARD ISSUES STATEMENT ON NATIONAL COMMITTEE

The Young Guard E.B. has sent the following statement for publication: RECONVENE THE NATIONAL COMMITTEE!

FIGHT ON THE POLITICAL ISSUES!!

On June 6 the National Committee of the Young Socialists was adjourned by Reg. Underhill before it was due to close: Streatham Y.S. had been suspended by Streatham CLP for issuing a leaflet calling on mods and rockers to unite against police violence, conscription, etc., In the National Committee Sheila Torrance moved an emergency resolution calling for the reconstitution of Streatham Y.S. This was carried 9-3. She then demanded that a member of the Committee should report to some 40 people lobbying outside. Anthony Wedgwood Benn asked the Chairman to rule whether this was consitutional. Chairman Ashby ruled that it was unconstitutional and a vote was forced, resulting in a 6-6 tie. Ashby then voted against his own ruling in favour of going outside. Reg Underhill ruled the decision unconstitutional and closed the meeting.

This is the issue in all its triviality; the Young Socialists silenced nationally because of 180 minutes - the time it would have taken before the decision became known. We deplore the suspension of Streatham Y.S. and all other branches closed in the last four years - East Islington, Eltham, Glasgow Federation, etc. The futile actions of these comrades in the National Committee only helped the right wing and alienated those in broad agreement with them.

We believe the real fight facing the Young Socialists is on the following issues:

1) Overthrow of the Tory Government and return of a Labour Government;

2) Opposition to the betrayal of socialist principles and the shabby manoeuvrings of the Labour leadership in supporting imperialism in Malaysia, Aden and Cyprus.

We demand a Labour Farty conference to determine policy on these issues. We condemn those sections of the Y.S. and Labour Farty who fight on

procedure and organisation instead of policy.

Bans and proscriptions are inimical to the growth of a democratic socialist party and are singularly reserved for use against the left.

70% OF POPULATION OPPOSE FOREIGN NUCLEAR BASES IN BRITAIN

During the last few months CND Groups in the North West have been polling public opinion about aspects of CND policy. The main conclusions drawn are that 34% of the population are in favour of unilateral nuclear disagrament by Britain; and that 70% are opposed to foreign nuclear bases in this country.

The poll was carefully conducted using accepted polling techniques, the aim being to obtain accurate information for our own use. The report has been shown to Professor W.J.M. Mackenzie, Professor of Government at Manchester University, whose comments were: (1) The sampling technique was as good as possible in the circumstances. (2) The phrasing of the questions should have been pre-tested more carefully to ensure that they were not accidentally loaded.

It is evident that the issues rasied by the poll are of considerable public concern, but they are issues which are not being discussed by the major political parties, and which may not be raised by them at the General Election.

HIRE PURCHASE DEBT OVER £1,000,000,000 from Stan Mills

The Railway Review of 19/6/64 carried the following item:

Car business was mainly responsible for a further jump of £18 million in the hire purchase debt in April to a total of £1,003 million at the end of the month. This was £122 million (14%) more than a year ago. After allowing for seasonal influences, new hire purchase and other instalment credit business of both household goods shops and finance houses remained at much the same level in April as in earlier months this year. Compared with a year ago new credit extended in April was about one-third higher. In March the rise was about one-quarter but differing dates for Easter may have affected the figures.

Credit for new cars was around 30% higher in April than a year earlier. Credit for commercial vehicles showed a similar rise, while for used cars the rise was about 40%. Direct debt owed to finance houses increased by a further £20 million in April to a total of £668 million at the end of the month. Compared with a year ago, sales by household goods shops as a whole were up by about one-tenth in April against rather larger rises in January and February, when the comparisons were with periods affected by the severe weather in the early part of 1963, and an increase of only about 5% in March.

The increase in sales in April, compared with a year earlier was rather higher for hardware, radio and electrical, etc, group of shops, at just over 10% than for furniture and furnishing group, where the rise was about 7%. Hire purchase and other instalment credit sales in the household goods departments of stores were about 5% higher in April than a year earlier. Debt outstanding to household goods shops as a whole decreased slightly in April to a total of £335 million at the end of the month.

DEVELOPMENTS IN BRITAIN'S ARAB WARS by Pat Jordan

Whilst the struggle in Southern Yemen (Aden and the 'Protectorates') has received most publicity in recent months, the other field of operations - Oman - should not be forgotten. The scale of operations there is indicated by a statement issued in Cairo by the Omani Liberation Movement. This states that "the British colonial authorities in Oman burned down more than 10,000 houses in different parts of Oman in May in a terror campaign to subdue the independence movement..." The statement concludes with an appeal to all progressives to oppose this terror campaign. The latest issue of the P.S.P. Bulletin reports trouble in the Lower Aulaqi State, where the sheiks of the Al-Shammah tribes are on hunger strike, in protest against various repressive measures; mass arrests in the Lahej State; widespread unrest in Hadhramout, etc. It is clear that the struggle is going to be a protracted one of very wide scope. The Wilson concept of 'police action' is way off the mark. Middle East News (Sana) reported on June 22nd that fighting continued in the Radfan region; British camps had been attacked in the Fim Valley -3 officers and 12 soldiers being killed. The Labour movement should act fast to end this senseless slaughter.

WHY TOGLIATTI PUBLISHED GRAMSCI'S LETTER



K.S. Karol's article in a recent issue of the <u>New Statesman</u> concerning Gramsci's attitude towards the crisis in the Bolshevik party after the death of Lenin has created wide interest. I think readers of the <u>Week</u> will be interested to note what Livio Maitan wrote in <u>World Outlook</u> (a labour press service published in Paris). Maitan is a well-known Italian Trotskyist and the author of several books on Trotsky. He writes:

"...the Italian Communist weekly Rinascita published the complete text of a letter which Antonio Gramsci, one of the founders of the party and without doubt one of the leaders of greatest stature in the history of the Italian workers' movement, sent to the leaders of the Soviet Communist party in the name of the Political Bureau of the Italian party in 1926...while not sharing the political orientation of the Opposition, Gramsci in no way associated himself with the campaign of denigration then under way and even recalled the revolutionary merits of leaders like Trotsky, Zinoviev and Kamemev. He took a stand against any measures that might lead to a split..Rinascita, after recalling that upon receiving this letter the International centre decided to send its representative J.H. Droz to Italy, also published Togliatti's reply to Gramsci, a reply that showed Togliatti was already on the side of the Russian majority...Gramsci replied with another letter that rejected the arguments of Togliatti. But, according to Togliatti, this second letter has been lost.

"K.S. Karol, commenting on the publication of Gramsci's letter, states that its text was not previously known and that "some of Gramsci's companions becoming Trotskyists....solemnly testified that this missive...had most certainly been sent to Togliatti ... But mne of them having a copy of the document, they could not furnish irrefutable proof of its existence or reveal its contents." Referring to the silence with which Togliatti had met the questions on this subject pressed by Trotsky's biographer, Isaac Deutscher, ... Karol adds: "Everyone came to the conclusion that he would take the explosive secret of this correspondence with him to the other world."... Karol does not seem to know that the text of the letter was. brought to light by Tasca, a former leader of the C.P. and a member of the Comintern, who broke to the right even before 1930. After a later political evolution that was altogether lamentable, Tasca, published the letter in France by 1938. After the end of the war he circulated copies of it in restricted circles in Italy around 1950. In January 1956, the complete text was published by the Italian Trotskyist paper Bandierra Rossa and was then reprinted by other opposition publications...

"In fact, an Italian publisher has just brought out a thick book of Gramsci's writings, including the letter. It was precisely on the occasion of the publication of this book that Rinascita published Gramsci's letter a few days in advance... The truth is first of all that Togliatti could not take the secret with him to the other world. The letter was already published and available to anyone interested. Secondly, he could not even hope that its circulation would remain limited. because it was included in a book that would have wide circulation. It was not Gramsci's letter but Togliatti's reply that had not yet been published. The question posed then is rather: why did Togliatti publish his own letter, which shows him to have supported the hard Stalinist core..it must not be forgotten first of all that if Togliatti was not entirely on the line this was because he was Bukharinist (at that time Bukharin was with Stalin). In the second place, Togliatti is desirous today of playing the role...of someone who is concerned about historic truth... As for the consequences of publishing...it will increase the number of thos who believe that the official Soviet attitude toward not only Trotsky but also Zinoviev and Kamenev is becoming more and more untenable...."

GENEVA: A NEW BEGINNING IN WORLD AFFAIRS?

The "Geneva Charter", which emerged from the U.N. Conference on World Trade and Development, may prove to be a turning-point in world affairs: the hopes .of the masses of the Third World, and of fighters against war and poverty everywhere may turn upon the effective implementation of this so-called "Magna Carta" of the poor nations. Colin Legum (writing in the Scotsman, 20th: June) suggests that the outcome has a three-fold significance: 1) Both blocs at last responded to the rise of the new nations by avoiding dogmatic, Cold War approaches; the realisation seems to be percolating through - even to Sir Alec! - that the decisive and dangerous confrontation now lies in the poverty-stricken, ex-colonial areas. 2) A new U.N. organ was set up "to create jointly new trade and new wealth, so as to share a common prosperity"; thus, the tendency for the U.N. to become a platform for the under-privileged in their fight for social justice grows. 3) The Afro-Asians achieved a link-up with Latin-America, to form "the 75" -"a trade union of the poor nations"; it is, of course, upon this effective unity that the other positive achievements really depended, and upon its continuation that the realisation of the rather vague proposals and general hopes of the Charter will depend.

The Charter will confirm the view of those who believed that the U.N. can become a positive instrument of social justice on a world scale, and that, given the right attitudes, we can break down the terrible divisions in the world peacefully and constructively. Whether the unity of the "75" can be the basis for a safer world will depend on attitudes in the "overdeveloped" areas. The left in Western countries has a vital role in building unity with the Third World in its struggle for a decent living standard, and in pressing for new attitudes and policies. Meanwhile affluent Britain remains frozen in a provocative Cold War alliance; spends £2000million on arms; and carries on an imperial frontier-war of the classic type in Arabia while the annual model change in affluent Detroit costs as much as India's total investment programme.

MARK LANE'S STATEMENT TO THE WARREN COMMISSION

I am here in response to your request that I fly back from Europe to appear before you today. As I indicated clearly to you when I appeared before your Commission on March 4, 1964, I will continue to make available to you all the information in my possession.....I think it appropriate that I inform you of the questions being asked throughout America and in many areas of Europe....In meeting your responsibility to still doubts that persist and grow in America and abroad you should, I suggest, be awa.e of the questions most frequently being asked of the Commission. They are:

1) Why has the Commission been chosen on a political basis with 2 Republicans and 2 Democrats (both Southern Democrats, one being so busy leading the filibuster against the Civil Rights Bill that he found little

time for Commission work)?

- 2) Why has a 7-man Commission been chosen that is comprised of 6 men without any judicial experience and a majority without judicial temperament..
- 3) Why has the Commission labelled as "TOP SECRET", (the Government's highest secret classification) all the material secured by it? And in that light why has the Commission publicly announced or secretly leaked information tending to show Oswald's guilt while suppressing all information, testimony and documents tending to show Oswald's innocence?
- 4) Why has the Commission denied to the Defendant, Lee Oswald, the right to counsel chosen to represent him by his family? Why has it been necessary to conduct hearings behind closed doors with the right of confrontation, cross examination..the presentation of defence witnesses..obliterated?
- 5) Why has a Commission been chosen of men all with important Governmental connection, men who would be ineligible under American law to serve upon a jury were Oswald alive and being tried?
- 6) Why has the Commission prejudged this case by establishing, before it took one word of testimony, six panels that presumed Oswald's guilt?...
- 7) How is it possible that the "Oswald Diary" given to the Commission with guarantees of confidence and marked "TOP SECRET"...is being printed throughout the United States on the eve of the Commission's final report?
- 8) Was not the Chairman of the Commission, Justice Warren, accurate when he stated some weeks ago: "You may never get the facts.." if you rely on the Commission?
- 9) Why has the Commission permitted witnesses to be held "in protective custody" and incommunicado for long periods of time before testifying before the Commission? Why has the Commission permitted the FBI, the Dallas police and the Secret Service to frighten and intimidate witnesses and order them not to speak about the case?
- 10) Why did the Commission state that it would not conduct its own investigation but it would "rely upon the existing governmental investigatory agencies", meaning the Dallas Police, the FBI and the Secret Service, when it is clear that (they) have a vital stake in the...myth that Oswald was the "lone assassin"?
- 11) A member of the French House of Deputies (asked the following) during the Dreyfus case. It might well be addressed to the U.S. Government now. ... "If the Government has nothing to hide, why has the testimony in this case been secured in camera, behind closed doors?"
