## Selassie Asks League to **Take Measures Against**

**Fascist Aggression** 

GENEVA. Sept. 29 .- Heavily inreased shipments of Italian troops gainst Ethiopia, and the general defensive mobilization which has een Ethiopia's response, have evoked the fear in League of Nations circles today that war in East Africa is a matter only of days.

Emperor Haile Selassie today notified the League that all of the Negro nation's ten million adults ould be mobilized to defend the country against the impending Fascist invasion

Joseph Avenol, League Secretary Jeneral, immediately relayed Haile Selassie's ominous con on Ethiopia's defensive nobilization to members of the League Council and to Edouard Benes of Czechoslovakia, Presiden of the League Assembly.

The Assembly adjourned vesterday subject to immediate call for action in emergencies



A large section of the youth believe in the demagogic promises of fascism. But the broad masses of these youth already see through the fascist de-ception and some sections are ac-tively coming out against fascism, fighting for their partial economic demands. tively connectively connectivel

It is necessary to go into the mass youth organizations and join them in their work." Mikhal then concluded his report with a fervent appeal for the inter-national unity of the youth. The session ended after Walter, of Germany, mounted the rostrum and read the greetings of the in-trepid underground C or m u nist Party of Germany to the Sixth World Congress of the Young Com-munist International; and the Con-gress sent heartfelt greetings to Ernst Thaelmann.
"On behalf of the tens of thou-sands of underground fighters of the Communist Party, on behalf of over 100,000 anti-fascist prisoners, and on behalf of the German revo-lutionary proletariat, the Central Compress of the Y.C.I.," ead the message from the German Commu-nist Party.
The Congress then sent the fol-lowing greetings to Ernst Thael-mann, leader of the German work-ing class, held prisoner by the Nazis:
"Across all seas, across all arti-ficially created barriers and obsta-cles, across prison walls, we send you, Ernst Thaelmann, symbol of all that is honorable and just in the German people, greetings!"
