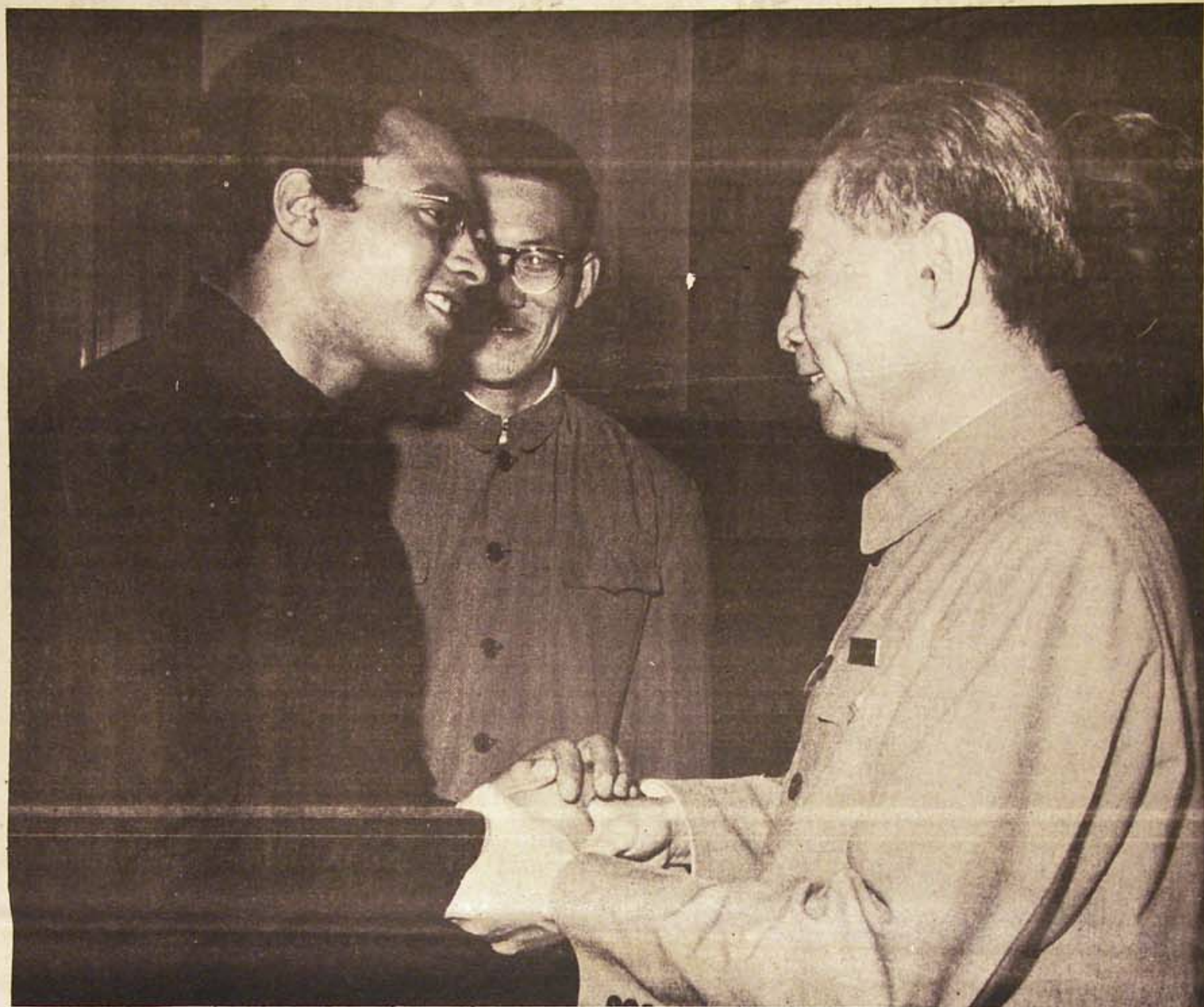

A FRIEND IN THE U.N.

The U.S. Government's Secretary of State William P. Rogers really showed himself, and the government he represents, this past week. On the brink of tears and outrage, Rogers made a sudden announcement that arrogantly spoke for the American People. He said he felt the U.S. should and would cut or eliminate the funds it contributes to the United Nations. The fact that the money he spends or withdraws with a wave of his hand actually belongs to the American People seemed of little or no concern to Rogers. The fact that millions of people work every day and receive paychecks that are considerably reduced by tax invasion, and that this is the money of which he was speaking, seemed insignificant to Rogers.

All this childish hysteria and talk of taking away one's toys and going home stemmed from a U.N. decision on October 25th. On that day, seventy-six

countries (against thirty-five, and seventeen who declined from voting) finally cast their vote in favor of the People of the world. The vote was being cast to finally admit that the People's Republic of China was the true representative of the over 800 million Chinese people. And, it was decided, as part of that decision, to no longer recognize China's Province of Taiwan as the U.N. representative for the Chinese People. It is hard to imagine why this was not done before. The U.N. is supposedly an organization representing every country in the world.

The U.N.'s pretended aim is to use this organization to peacefully resolve world problems among the different countries. The entire stated aim, in other words, of the U.N. is to advance Peace on Earth. Why then would the U.S. government suddenly decide to talk about withdrawal of U.S. contributions from the only organization in

the world where so many people have gathered together for the purpose of world peace.

The U.S. is upset because the U.N. decision to seat the actual representatives of the Chinese people threatens its long-standing domination of the world's people. For the past 22 years, the U.S. has pushed a fantasy program to ignore one-quarter of the earth's population, represented by what the U.S. conveniently called "Red" China (the People's Republic of China). The U.S. government has for this amount of time wanted the American people to live under an illusion, that the government of 800 million people on the mainland of China does not exist. A government which leads 800 million people is obviously one with the people, and can-

THE GRAND JURY OF THE PEOPLE OF THE COMMUNITY OF THE UNITED STATES, IN THIS INDICTMENT, ACCUSE THE DEFENDANTS OF THE CRIMES OF CONSPIRACY TO COMMIT MURDER IN THE FIRST DEGREE, MURDER IN THE FIRST DEGREE, ATTEMPTED MURDER IN THE FIRST DEGREE, AND CRIMES AGAINST HUMANITY, ALL UNDER THE PRINCIPLES OF INTERCOMMUNAL LAW AS FOLLOWS:

FIRST COUNT

That the Defendants, Richard M. Nixon, Nelson A. Rockefeller, Russell Oswald, Vincent Mancusi, Henry Williams, Et. Al., and each of them, did commit the crime of Conspiracy to Commit Murder in the First Degree, in that they did willfully and maliciously conspire amongst themselves to commit and to be committed the crime of Murder in the First Degree. To wit, the willful, wanton and brutal murder of 33 inmates and 10 guards at Attica, Wyoming County, State of New York, on or about September 13, 1971.

SECOND COUNT

That the Defendants, and each of them, did commit the Crime of Murder in the First Degree, by directly approving, ordering and supervising the brutal, genocidal murder of inmates and guards of Attica Correctional Facility, by a wanton, cold-blooded attack, by gas, rifles and shotguns, upon the unarmed prison-yard population, thereby directly causing the deaths of 33 inmates and 10 guards.

THIRD COUNT

That the Defendants, and each of them, did commit the crime of Attempted Murder in the First Degree, by directly approving, ordering and supervising said attack, as fore-said, wherein upwards of one hundred inmates were seriously wounded; and by willfully and knowingly resisting all attempts by the people to give medical aid and attention to the wounded.

FOURTH COUNT

That the Defendants, and each of them, did commit Crimes Against Humanity, or endeavored by the following acts:

1. Refusal to consider or act upon the legitimate and reasonable demands of the inmates of Attica Correctional Facility, repeatedly made and requested during the entire period of June to September, 1971.
2. Refusal to allow inmates to seek passage to Non-Imperialistic Countries.
3. Refusal to grant complete amnesty to inmates for any actions taken on or after September 9, 1971.
4. Failure to consider, act upon or exhaust all peaceful means to settle the dispute which arose on and after September 9, 1971.
5. The inhumane use of brutal and excessive force, and the complete disregard for human life, evidenced by the takeover of the prison directly approved, ordered and

supervised by the Defendants, and each of them.

6. The inhumane use of brutality after the takeover, including indiscriminate gunfire, beatings and clubbings.

7. The inhumane use of a gauntlet, beating defenseless, unarmed, naked prisoners, causing serious harm to many hundreds of people.

8. The inhumane refusal to allow any proper medical care or attention for the wounded, directly leading to the deaths of several prisoners.

9. The denial of the inmates' rights to legal representation by the willful exclusion of attorneys after the takeover.

10. The willful conspiracy of fraudulently concealing the true nature of events from the people, including the fabrication of atrocities allegedly committed by inmates, all of which charges were untrue; and the deliberate cover-up of the facts involving atrocities committed by the invading forces, including deliberate murders, beatings and torture.

A TRUE PEOPLE'S BILL THE PEOPLE OF THE COMMUNITY

This indictment from community people is being delivered to Nelson A. Rockefeller and Richard M. Nixon and other defendants via the Mass Media. The trial from this indictment will be held Sunday, October 31st, 2:00p.m., at the St. George Hotel, 51 Clark Street, Brooklyn, New York.

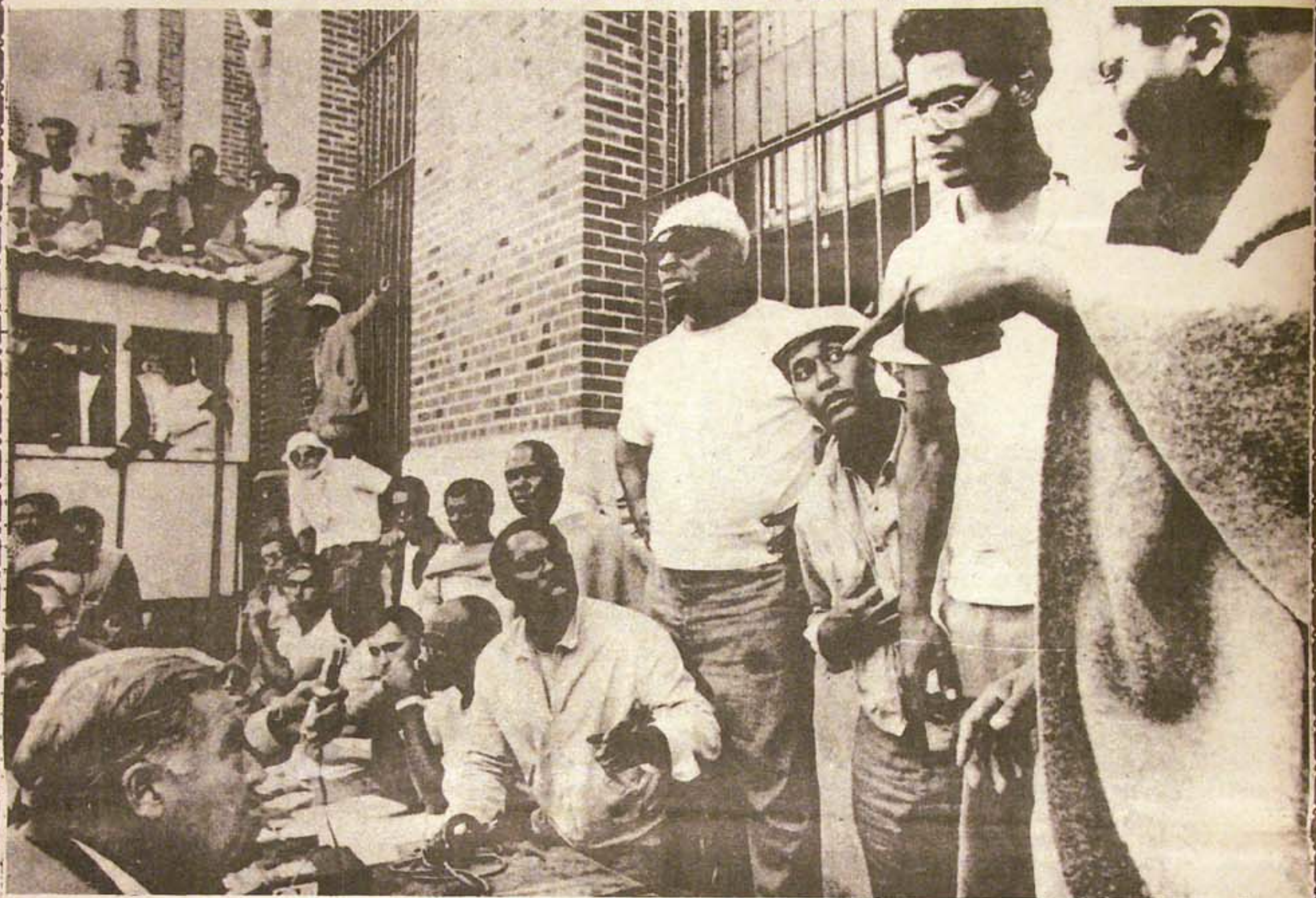
This indictment is a people's Command that all said and named defendants including Nelson A. Rockefeller, and Richard M. Nixon, must appear at THE SUPREME TRIBUNAL OF THE PEOPLE'S COURT IN AND FOR THE COMMUNITY OF THE UNITED STATES OF AMERICA.

The People's Tribunal will try all defendants in absentia if they do not appear.

ASSEMBLYMAN VOTES AGAINST NIXON



"THE INMATES HAD NO LOADED GUNS."

To cast his vote with the People, Wisconsin State Assemblyman Lloyd Barbee made the following comment:

Governor Rockefeller has proved to be more ruthless and wasteful of human resources than his grandfather. At least his grandfather did it for money and apologized later by giving some of his blood money back to society and seeing that his children were trained to save his conscience.

Everybody knows that the "United States" locks up more offenders, for more different types of offenses, for longer periods of time, than any other country in the world.

For Governor Rockefeller to secretly permit slaughters, with "White House" approval, via telephone, to move in on the signal of Oswald (Wisconsin's contribution to inhumanity) is a wanton and disgusting act of courage.

It's interesting to note that the white press so far has been more sympath-

tic with the actual slaughterers than with the convicts and hostages. The prisoners had grievances that were conceded by Oswald to be just, but he indicated they were to be convicted at some future time. United States' prison reform is long overdue. New York and California are employing genocide against the rebel reformers and calling them "militaristic and hard-core radicals".

From the Lindberg kidnap case on up to the most recent case of which I am aware, no one has considered killing the hostage in order to kill the kidnappers.

One reason that I think those blood thirsty, vengeful murderers chose to use tear gas and bullets on convicts and hostages alike was based on the Black and Puerto Rican make-up of the prison inmates. Another reason for this over kill was based on a psychopathic love for the establishment's law and order. Actually, law was sacrificed for order. This type of order

requires increased repressive ruthlessness from the state and police. Thus, judicial justice (law) is lost.

Government must always apply the rules of due process and fairness before it punishes anyone. If it does not, the oppressed must use the necessary means for redress to survive, let alone thrive.

We expect mobs and vigilantes to execute first, lie, scare, investigate later and apologize next, if necessary. The slaughterers killed first and lied to the public. The white press published a lie that nine hostages had their throats cut by the prisoners. The truth was told later, that all nine hostages were not killed by the prisoners, but by the police, sheriff and prison sharpshooters. The inmates had no loaded guns.

I submit that what has happened in New York will be repeated across the nation unless the real freedom lovers rise up and take action for criminal law reform and prison reform. Those civil reforms and elimination of racism are part of the same war for justice.

Some of the early commentators on the horror at Attica indicated that the racial tensions and rebellion common to American society have just seeped into prison and that a hard core of black militants have become politicized and defiantly claim racist prosecution at every turn. Any fair critic of the U.S. prison system will know that Blacks have been punished more often, for a longer period of time than any race; and this has been true since the time of slavery.

So it's not at all a new thing. What is somewhat surprising to me is that it has taken so long for prisoners to demand decency and be willing to take a real revolutionary stand. I applaud them and wish there were more like them. If perdition (Hell) exist, I hope the slaughterers are condemned to see, inhale and live in the festering gore created by their misdeeds.

A LONG TRAIN OF ABUSES

Comrades Herbert McGee and Vincent Robinson, members of the Louisiana State Chapter of the Black Panther Party, were in Lee's Villie, Louisiana in September. Lee's Villie is located about ten miles from the fascist army training camp, Fort Polk. The Brothers didn't go to Lee's Villie to harm anyone, which was the

apparent idea of the F.B.I., C.I.A. and local police in the town. They were there passing out information and literature to the people. While Vincent was standing there talking to a brother from that community, explaining to him the purpose of the Black Panther Party, a police car pulled up beside them. The fascists got out of the car, approached the brother and insulted him. One of them, with the most obvious racist intent, said to Vincent, "Hey, Boy, stand right there." He demanded identification. Seeing that Vincent was from out-of-town, the two pigs immediately put him under arrest.

By that time, Comrade Herbert, who was not far away, saw what had happened. He caught a ride and followed them to where they were taking Brother Vincent.

Vincent Robinson was charged with vagrancy, soliciting, disturbing the peace and resisting arrest. His bond was \$699.00. When, minutes later, Herbert arrived, he too was charged, with vagrancy and disturbing the peace. His bond was \$585.00. The jail which housed the Brothers has been condemned since 1942. It is not fit for a human being: there is no heating system; there is no medical attention for inmates. Inside, the Brothers, Herbert and Vincent, were almost subjected to a beating. Guards ordered the rest of the inmates to give Herbert and Vincent a good "work over", or they would be "worked over" themselves. Some of the prisoners told Vincent and Herbert how they had heard the pigs conspiring. Because of this and subsequent discussions, the pigs divide-and-conquer tactics failed.

We have seen, through their practice across this country, that the police and pig agents are trying to kill every revolutionary and progressive person in the United States. No life is sacred to them.

The Fascist Regime would like all their treachery hidden in the dark. Therefore, they create stories for the mass media and wait for a response from the people. Then, they kidnap, brutalize and murder in the name of justice, so they won't seem "wrong" to the people. However, the consciousness of the people has risen. This became clear in the events that followed Herbert's and Vincent's arrest.

On the second day in the fascist jail, Comrade Herbert asked for some paint and tools, to make the place fit to sleep in. Two hours later, both he and Vincent were removed from their cells and secretly placed into the "dungeon". On the third day, the fascists threw hot water into the cell. Because the brothers were not defeated, the police stepped up their terror tactics, by shooting gas and roach poison into

their cells. The two comrades held their position. Yet, each day the brothers were and have been confronted with such harassment.

Lee's Villie, Louisiana is one of the last frontiers for the Ku Klux Klan. The fascist regime of the United States is solely responsible for the racism

and the degrading conditions to which the people are being subjected in Lee's Villie, and across the country. The people must seize the means of production and technology and make the wealth of the United States serve the interests of all the poor and oppressed people of this country, and the world.

EVEN JURIES ARE BANNED IN BOSTON



In most states throughout the American Empire, the only eligibility requirement for jury duty is that a person be a registered voter. Also, generally the potential juror comes to court to be questioned by the defense who may be able to exempt him. Of course, even with this method, most juries across the U.S. end up dominated by white, middle-aged, middle class people. This naturally explains the large number of convictions across the U.S. of Black and other poor people. In Massachusetts, however, a juror is not required to be a registered voter. The state has constructed a highly exclusive process of jury selection. Massachusetts does not even make the slightest pretense at creating even the illusion of a jury of one's peers. The same vicious men who misinterpret and arbitrarily carry out their version of the law are choosing the jurors too.

In Massachusetts, local policemen draw up a list that allegedly includes the names and addresses of all citizens in their (the policemen's) particular county. Generally, we know that the police follow a certain pattern: they are conservative in political viewpoint, usually white, working-class men. We are able to know from that that the people they select for the prospective jurors' list will be most probably those who have most closely assimilated the values and thought patterns of this racist society. They do not wish to see the very people that have bolstered their arrest quotas walk away from the court room. It would benefit their private interests, and those of the state, if the police listed for jury duty those people in the community who are of the same mind as themselves. This first step in this form of jury selection reeks of out-right fascism (the police state).

The policemen's list goes on to an election commissioner. He "selects"

(according to state law) that 10% of the citizens over the age of twenty-one for whose personal and moral integrity he can personally vouch. Here again, the state imposes upon the people the value judgements and character analyses of one man. What would be the logical conclusion of a white, middle class, public official when "considering" an "uneducated", Black man, living in indecent ghetto housing, with under-nourished children, etc. It would reasonably follow that his racism would make him conclude that a Black was of too low moral character to be on a jury. This phase of the selection process also defines the age of 21 as minimum for the mature development of the human mind. The age limit is used as the basis for a person being able to judge between "right and wrong, good and bad". Therefore Massachusetts jury selection not only discriminates on the basis of color, but also on the basis of age.

The County Clerk then handles the list. More people are excluded. This is done, seemingly, at the mere discretion of the County Clerk. The first group of people he excludes are doctors, nurses, teachers, mothers of small children, and the clergy - people whose position or profession might make them prone to be understanding and compassionate: in others words, those with the potential for a human response. In addition, the clerk may also look down the list of names and addresses and exclude people from a certain geographical area. If nothing else this will exclude the poor and oppressed, especially Black people.

After this blatant expression of racist maneuvering, that is sure to rid the juries of any resemblance of a peer group for the average defendant, the final step in the process, the so-called random selection of twelve

jurors takes place. However, by the time the list has reached the courtroom floor and is available for the "random" sampling, the prospective jurors, for the most part, will be middle-aged, middle-class white men and women.

Certainly that group of people, on the whole, does not like change of any sort. Therefore, if the defendant were of the fomentors of change, he would be automatically guilty, in their (the jurors') minds, long before the start of a trial.

A clear example of how the so-called jury selection system in Massachusetts really works occurred recently in Boston: In September, 1971, the civil and human rights of Peter Almeida and Robert "Big Bob" Heard, two members of the State Chapter of the Black Panther Party were violated. They were both sentenced to 6 months in prison following a 2 hour trial for allegedly burning mattresses. The charge of arson

stems from an incident which occurred in Billerica House of Corrections, over one year ago when the brothers protested their 24 hour a day restriction to the 5 by 7 foot cells in which they were being held. Their illegal conviction and sentence can only be fully understood within the context of an unfinished sequence of events which the vast difference between the theory and practice of American "democracy" clearly exposed. They are not the first nor will they be the last, victims of a racist judicial system which openly holds Black defendants in contempt; where the outcome of the trial by jury is inherently structured to produce convictions.

While being illegally held at Billerica on excessively "high and outrageous" bail (\$10,000.) for a charge last year that stemmed from a police raid on a Black Panther office, Peter and "Big Bob" began to protest the racial slurs and general inhuman characteristics of most penal institutions in this country, in open and direct violation of both the 6th and

14th Amendments (both define the right of the individual to a trial by jury of their peer group - peer being someone from the same economic, racial, and social background), a jury of 3 men and 9 women, all white, sentenced these brothers to jail.

The juries in Massachusetts are in fact and by law picked by the police and the courts to serve the interests of the ruling class circles in maintaining wealth and power. They pick jurors to try the very people they have arrested, often beaten, and brought to trial. Massachusetts is like the other states in that poor and oppressed people there cannot receive a fair and impartial trial. The difference is that there the courts have become so blatant with their means of instant repression, that the people have no choice but to destroy that decadent judicial system and build a new.

L.A. POLICE DEPARTMENT LIES BADLY

Four members of the Black Panther Party, Tommye Williams, Robert Bryan, Craig Williams and Albert Armour, along with nine members of the Black community are currently on trial for conspiracy and assault charges. These charges stem from the vicious pre-dawn police raid upon three Los Angeles offices of the Black Panther Party in December of 1969. After five months of trial, the prosecution is expected to finally rest its case within the next few weeks.

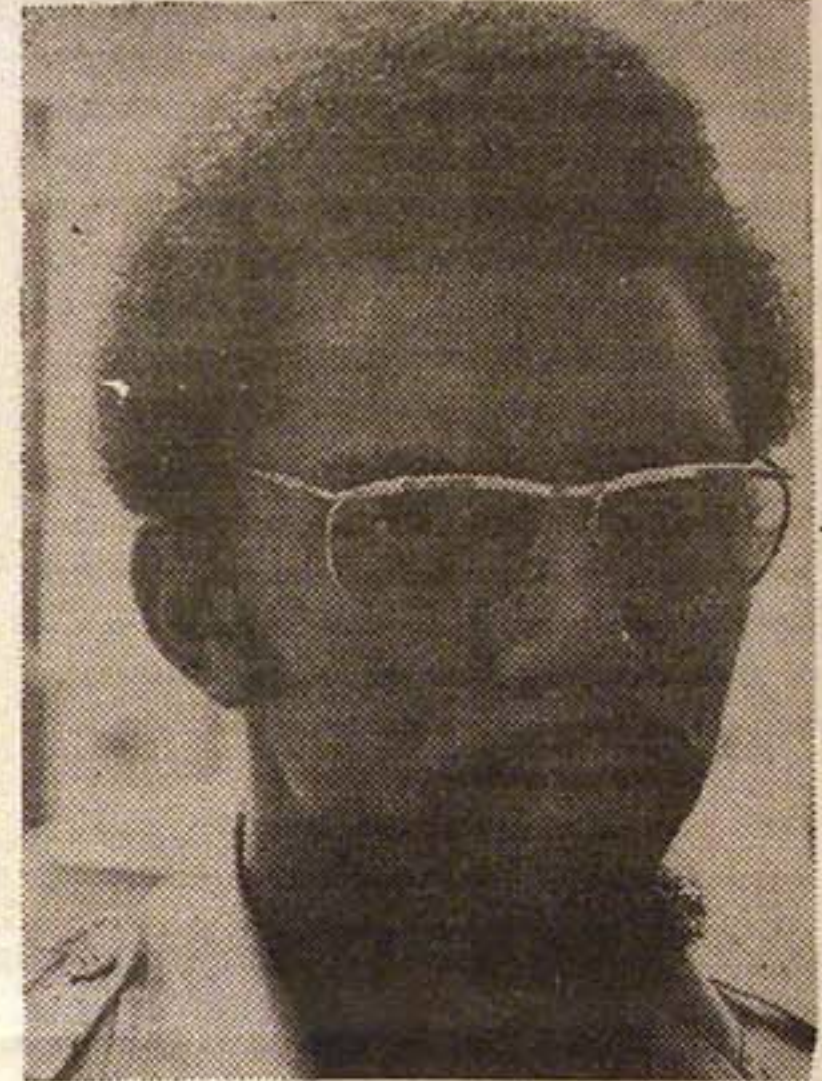
Since the conclusion of testimony by the State's star witness (over two months of lying), a Black police informant, Melvin "Cotton" Smith, several weeks ago, a succession of police officers have testified.

Sergeant Raymond Callahan, of the Criminal Conspiracy Section (CCS) of the Los Angeles Police Department, spent several days on the witness stand. Prior to the police raid on Party offices, he coordinated all information available on the Black Panther Party from local and federal police agencies. On December 2, 1969, he secured "No Knock" arrest warrants that served as the the pigs' excuse to attack the Black Panther Party. In the same breath, however, Callahan alleged that he never

attended "planning meetings for the raid", and that he had no knowledge that people, other than those three named in the arrest warrants, lived in the three different locations raided.

Later, members of the Special Weapons Assault Team (S.W.A.T.) of the LAPD, who carried out the raid, testified. Although a total of 300 police were assigned to the whole operation, there were only 65 members of SWAT (none of them Black). Because SWAT activities are not included in regular, daily, Los Angeles police functions, members of this special team have to work "overtime". A member of SWAT since its inception in late 1966 or early 1967, a Sergeant McGill (who was in charge of making entry into, invading the actual premises of the Southern California Chapter's main headquarters on Central Avenue) testified that there were a total of seven officers at their assigned positions at the front door of the building at 4115 South Central Avenue. McGill described how these men were armed with flack vests, AR-15 rifles, hand weapons and battering rams. Never knocking on the door, at 5:29 a.m. - to which he admitted - in the early morning darkness, McGill claims to have announced to those inside to "open up", as he was a policeman and had some warrants to serve.

When there was no answer, McGill

says he ordered his men to force open the door. When the door was opened, McGill dramatizes how his innocent men were met with a burst of gunfire, which wounded three of them. After the unsuccessful entry attempt, McGill called for "jet axes" (explosives), fragmentation grenades and other extra artillery. He did this because he felt, as he calmly put it, it "would be necessary to possibly kill some of the people inside."

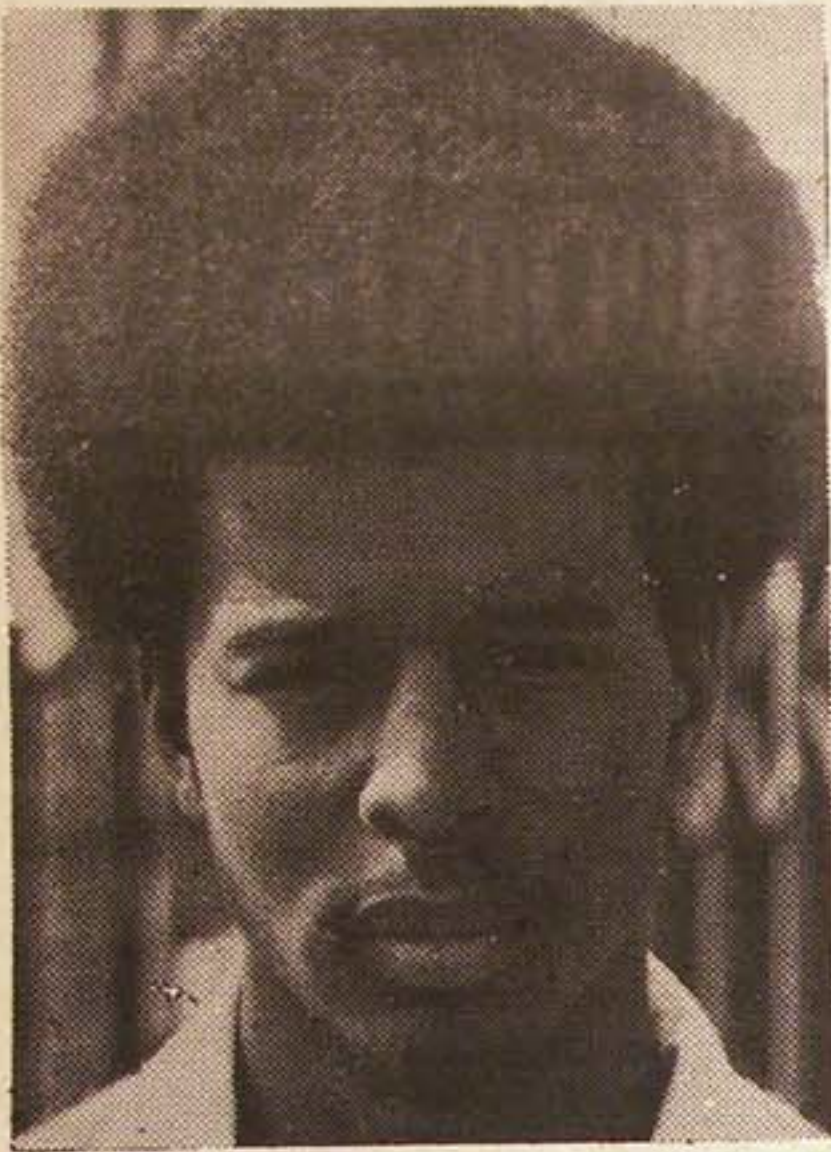

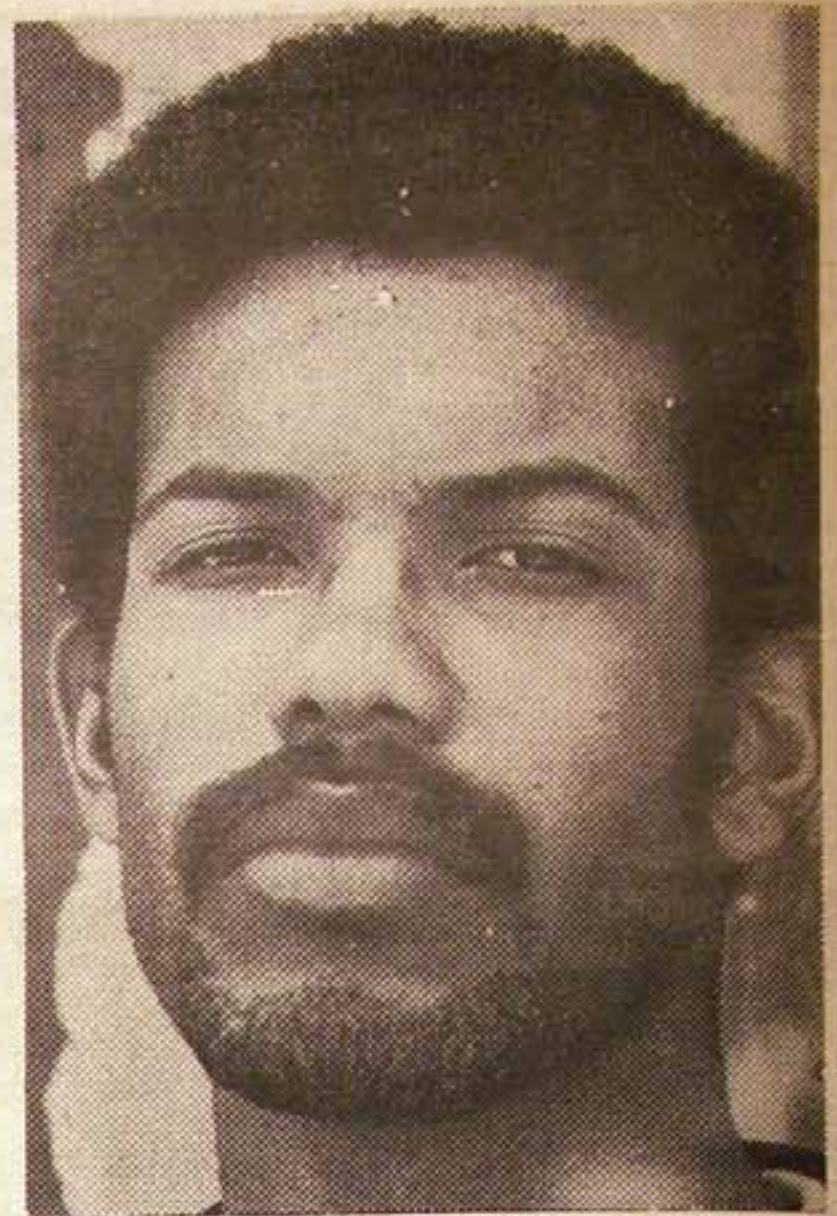

Because of revolutionary, armed resistance, no one inside any of the three facilities raided by this police army was killed that morning. Now, two years later, four Black Panther Party members, Tommye, Al, Craig and Robert, along with the others and a jury of seven Black people, three Chicanos and two whites, have been subjected to a constant train of lies and distortions from police witnesses.

Thus far, the testimony of one pig has been omitted from the transcript and replaced by his prior testimony, made during a pre-trial hearing. The judge said the earlier testimony was more correct. Also, two other pigs are being investigated for impeachment. And, motions have been made for a mistrial because of the bias and prejudice of the presiding judge, Dell.

'MOZAMBIQUE IS OUR HOME'

The United States Empire is the chief perpetrator of exploitation, brutality and genocide against the people of the world. We are members of a world community made smaller by advanced technology and communication. In order to liberate the whole of humanity from this Empire, we struggle together. A blow to the Empire in any part of the world is a victory for the people in any part of the world.

In last week's issue of the Black Panther Intercommunal News Service (October 22, 1971) we printed information about Mozambique and the heroic struggle of the Mozambican people, and their revolutionary organization FRELIMO (Front for the Liberation of Mozambique). Following is more information about FRELIMO and Mozambique's liberation struggle.

On June 16, 1960, the Mozambican people staged a peaceful demonstration demanding the right of the people to be free and independent. The Portuguese colonialists responded with bullets and grenades. In the massacre that followed, more than 500 people were killed, and countless others wounded. June 16th taught the Mozambican people that rhetoric, that theory alone would not liberate them. They learned that revolutionary violence was the only avenue left. So, in 1962, FRELIMO was formed, and armed struggle began in 1964.

Today in Mozambique, the people celebrate September 25, 1964, as an historic and heroic day. On that day, over 250 FRELIMO fighters waged a courageous defensive assault for the liberation of Mozambique. This first organized move against the Portuguese

mercenaries marked the beginning of the Mozambican people's fight for the liberation of all of Mozambique. Prior to that, there had been small uprisings and the defense of the country was primarily waged on a regional level. That is, each tribe would fight on its local level. An editorial in "Mozambique Revolution" (FRELIMO's official news organ), written shortly after the Second Party Congress meeting in 1968, describes those times: "They were merely revolts. But now, however, the aim of the struggle was the freedom of the whole country, the whole of Mozambique. The fighter who fired first may have been a Jawa, a Makonde, a Changana, a Macua (different tribes). But, he was not just fighting for the liberation of his region. He was probably fighting in a region far from his own, amongst

Southern tradition, like baseball and aggressive warfare, is part of the American life-style. When the racist ruling class refers to the "southern tradition" or the "old South", they refer to an image of "lovely" white ladies and "fine" gentlemen sitting on the verandas of large white houses engaged in poetic conversation,

drawled out in sweet, melodic tones. Black people, however, know the "southern tradition" in its ugly reality: The hanging tree, for the Black man who is even accused of so little as looking at the "lovely" white woman; the tar and feathers; the vigilante mobs of "fine" gentlemen; the bombings of Black churches; the "NO NIGGERS -

Whites Only" signs; the kitchens and fields of the master - all adding up to the complete disregard by those in power, and their followers, for the rights of Blacks as human beings, or even the thought in the first place, that we are human beings.

To be familiar with a particular way of life, however, is not to accept it or to tolerate it. We are simply familiar with the phenomenon of the "southern tradition". We do not accept it. Earlier this month, deep in

George pulled the hand brake ("I was afraid to hit the brakes, because the truck might roll..."). The truck slid halfway into a ditch. By this time, the two pigs chasing them, E.C. Mullins and J.B. Dyer, had called for other police. Altogether, twenty-eight full grown pigs emerged from their various cars to attack the three young brothers, once they had stopped. As Brother Calvin stated, "There wasn't any wreck. We just slid into the ditch. Nobody was hurt until the police officers got there." All twenty-eight

Dixie, Black youth of Memphis, Tennessee, righteously exhibited the anger and dissatisfaction of Black people with the "southern tradition". They also forecast the means through which an angry people will finally resolve the contradiction between ourselves and our oppressors.

On October 16th, three young Black brothers were driving a truck along a country road, outside of Memphis. The truck belonged to the father of the driver. The driver was 15-year old George Barnes. The passengers were 14-year old Calvin McKissack and 17-year old Elton Hayes. It was a good day. They were out on a Saturday afternoon, looking to have some fun. Brother George Barnes bet his two friends that he could drive to the top of a hill before other cars could reach the bottom. The idea came to him when he saw two other cars coming over the top of the hill. They took off. The whole area was empty. There was hardly anyone around, except three friends in an old truck having a good time.

As Brothers George and Calvin and Elton were riding like the wind up the hill, George spotted flashing lights behind them. After turning a corner,

pigs converged on the brothers. Brother George later described the horror: "I grabbed my head and they began poking me in the ribs with sticks. I could see policemen on their knees in the ditch, swinging their sticks up in the air. But, I couldn't see who they were. Then, they knocked me down and started kicking me in the side and stomach. I never heard anything from Calvin or Elton. All I could hear was cops calling us everything but a child of God..."

"When I got up," George continued, "they were still swinging the sticks; but I didn't know on who. They carried somebody out of the ditch and put them in the sheriff's car and let out - for the hospital, I guess." Inside the pig car Brother George Barnes recalled the conversation: "They cursed us all the way to town; and one time one of them spun around in the seat, shook his finger and said, 'Don't you know if you had killed those two officers in that car, it would have been worse for you than raping a white woman? We'd sure enough killed you and left you laying where you fell.'"

Seventeen-year old Brother Elton Hayes was beaten to death in that

ditch. It was his body that Shelby County Police (of which Memphis is a part) whisked out of sight. It was youthful Elton Hayes that they had beaten beyond recognition.

To disgrace this tragedy even more, a Black police officer who was on the scene could have prevented Elton

Hayes' death. Shelby County Deputy Sheriff, Lieutenant Wilkes, not only participated in beating Elton Hayes, but also was in a position within the police chain of command to have ordered the rest of his fellow-pigs to stop. Wilkes was one of the five County police on the scene; the other twenty-three were

city police. In their pig hierarchy, the County forces have authority over the city; and Wilkes was the highest ranking dog among the other County deputies.

Now, what shall we say for Elton Hayes. The Black youth of Memphis, particularly, did not say much. They acted! On Saturday, October 19th, there were memorial funeral services for Brother Elton Hayes. His distorted face was clear evidence of the viciously sick nature of the various pigs who took their turns on him. No Black youth, in fact, really no Black person in Memphis, could forget. Instead of sending flowers, some of them chose to take action against the oppressors in any way they could. Recognizing the close (if not inseparable) tie between

business and government, they began destroying the immediately available signs of our oppression. On the night of the funeral, some people burned a place called Speedy's Drive-In to the ground.

Their anger was vented in many ways from then on, and for many more reasons. Not only had the pigs beaten Elton Hayes to death, they lied about it to the People. The murder of Elton Hayes was recorded on official police reports as a "traffic fatality". Then, to even further underestimate the People's intelligence, Memphis Police Chief Henry Lux (who has since resigned) called himself "relieving" the twenty-three city pigs of their duties.

He neglected to mention that they were still receiving their pay. Leave with pay can only amount to a paid vacation. Then, there was the question of the other five pigs. None of them were even reprimanded. The instantly angry response of the Black community had eked the little image of concession out of Lux. Nothing moved the county authorities, so it seemed.

The shock of Brother Elton Hayes' murder had hardly rocked the Black community, when, on the very next evening, vicious, unconcerned, racist pigs violated the People again. Supposedly, rushing to an area where there was a fire-bombing, two pigs decided that they didn't need to stop when Robert Reed, Jr. crossed their path. He was three years old. He is dead. Memphis pigs ran over him and killed him.

They have said that they are sorry.

Certainly, this was unbearable. Many more fires were set. Memphis Mayor Loeb was in a dilemma. He didn't even imagine that the good Black folks of Memphis could be pushed too far. He generously decided that he had better talk to some Black people to settle things. Even the curfew that he had imposed was being ignored by the masses of Black people. Calling for a meeting with "responsible" Black leaders, he naturally neglected to include members of the Tennessee State Chapter of the Black Panther Party, whose main office is in Memphis. Among those who were a part of this meeting, however, was Black singer Isaac Hayes, who was in the area to entertain. Along with STAX Recording Company, Hayes promised Loeb an end to the "rioting" if the curfew would be lifted. Hayes, after his performances, went out into the Black com-

munity with the intent of quelling the "riots". He bought free records and candy bars. The idea of giving away STAX records and candy bars did not work. STAX' and Hayes' promise was not fulfilled. Black people, especially the youth, moved against various businesses (the reminders of oppression) with the harsh memories of Elton Hayes and three-year old Robert Reed, Jr.

Suddenly, the people's uprising stopped. The People have decided to wait until the next City Council meeting, where the demand for the arrest of all officers involved in Elton Hayes' murder will be heard. The People will decide the next move.

PEOPLE'S PETITION

TO INDICT RICHARD M. NIXON AND NELSON A. ROCKEFELLER FOR MURDER — ATTICA

On September 8, 1971, Attica prisoners inhumanely incarcerated at Attica State Correctional Facility in New York State, while humanely treating guards who were in their custody, initiated peaceful negotiations for their human rights. On September 13th, a pre-planned, overt, mass, murderous attack and assault to kill and maim was ordered and launched with the approval and instructions of Richard M. Nixon and Nelson Rockefeller. This conspiracy to commit murder on the part of Nixon and Rockefeller was willful and malicious. It deliberately rejected and ignored further negotiative guidance of over 1,200 prisoners, their human rights, the lives of over 40 guards and prisoners who were killed and countless others who were wounded. Oswald, State Commissioner of Corrections, following instructions, did in fact, transmit such an order to Captain Henry Williams of the New York State police force, and such an assault was made with 1,700 State troopers and National guardsmen, culminating in the brutal murder of 32 prisoners, 10 prison guards and the wounding of over 100 prisoners in attempts to murder all prisoners at Attica State Prison.

WE, THE UNDERSIGNED, THE PEOPLE OF THE U.S., CITIZENS ONE WITH THE WORLD COMMUNITY, CONSCIOUSLY INDICT RICHARD M. NIXON, U.S. PRESIDENT, AND NELSON A. ROCKEFELLER, N.Y. STATE GOVERNOR, ET. AL, FOR: (1) CONSPIRACY TO COMMIT MURDER, (2) THE ACT OF FIRST DEGREE MURDER UPON SOME 42 PRISONERS AND GUARDS, AND (3) ATTEMPTED MURDER UPON THE OVER 100 WOUNDED, AT ATTICA. AND, WE, THE UNDERSIGNED, GO FORTH TO DEMAND THAT THE COURTS AND LEGISLATIVE REPRESENTATIVES THROUGHOUT AMERICA DULY CHARGE GOVERNOR NELSON ROCKEFELLER AND PRESIDENT RICHARD NIXON, ET. people of other tribes. He was fighting for the liberation of the whole of Mozambique." Since that time, FRELIMO has become stronger and even more a part of the people. Today, there are more than 10,000 FRELIMO fighters.

As a result of this, Portugal, a major colonial power in Southern Africa, has now been forced to call upon its most reactionary friends, in its attempts to thwart the Mozambican people's struggle for true independence. These old reactionary friends in NATO (North Atlantic Treaty Organization), the United States, France, Britain and Germany, have supplied weapons, planes, training, and even troops. Portugal, one of the weakest colonialist powers occupying Africa, was only admitted to NATO (1949) because of the strategic location of its colonies. At that time, they controlled Mozambique and Angola, which are located on the Eastern and Western coasts of the African continent, respectively. The seaports of Mozambique and Angola are very crucial to the world trade and markets of the reactionary forces. Although the supposed purpose of forming NATO was for protection of Western Europe from invasion or attack by Russia, NATO's true aims can be seen in its aid to Portugal against the Mozambican people. NATO's plunder of the oppressed countries of the world and their mutual aid and protection for any of its members in their exploitative endeavors is not new. For their true purpose is to keep oppressed countries under the domination of NATO members. NATO is an alliance of reactionary powers, designed for this aim.

This aim was clearly exposed at the last meeting of NATO in Lisbon, Portugal this year. There, it was proposed that a new organization be formed, encompassing both South America AND South Africa. They went so far as to give a name to this proposed organization, SATO (South Atlantic Treaty Organization). It is obvious what the intent of this new organization will be, the protection of the United States Empire's and its overseer's (like Portugal) interests;



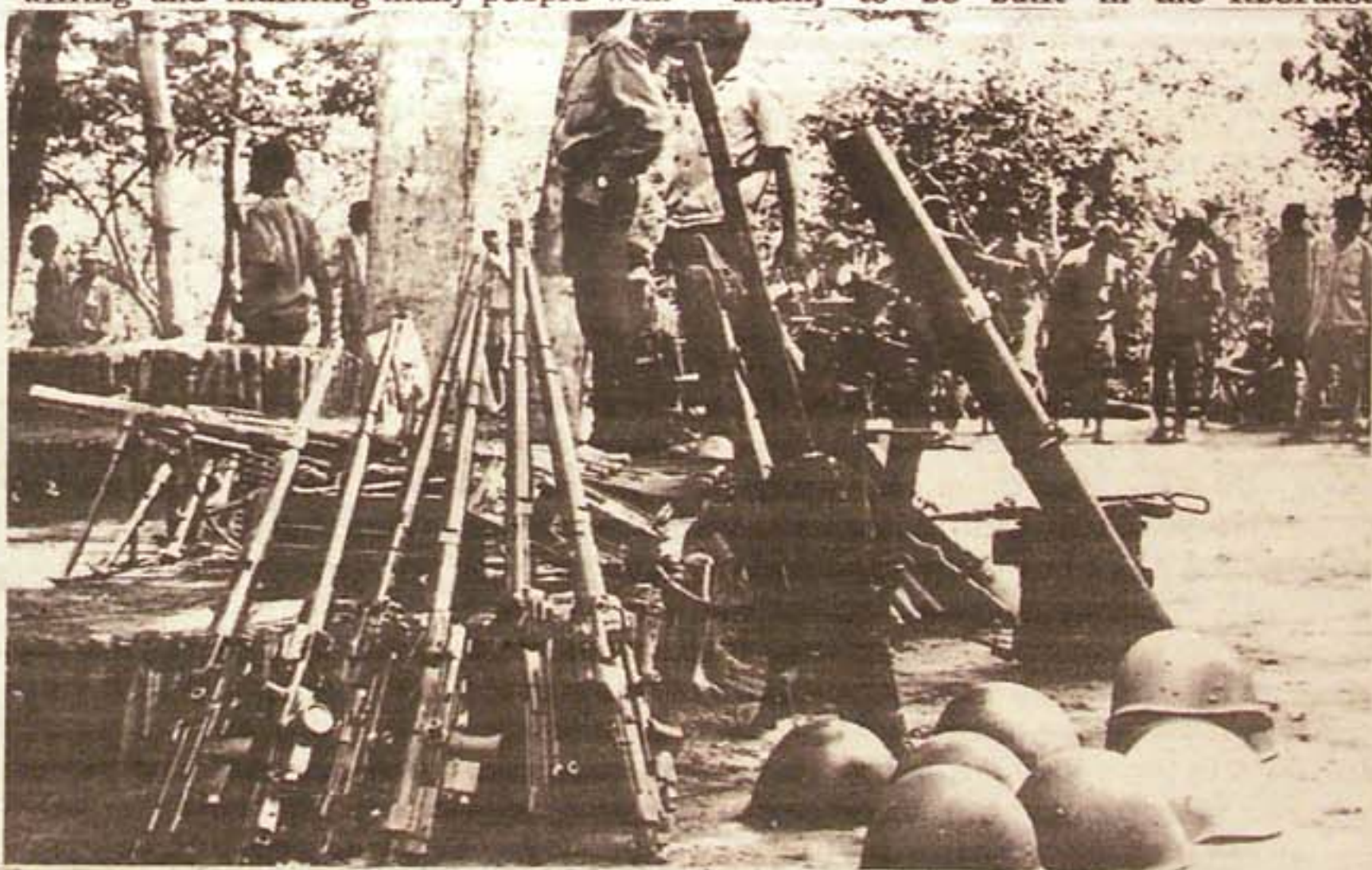

and to thwart the people's liberation movements and struggles on those continents.

Although Portuguese troops outnumber FRELIMO fighters six to one, the strength of the Mozambican people is defeating the enemy. Because the troops of Portugal and their hired hands (mercenaries) cannot win battles on the ground, in combat with the revolutionary forces, they have used more vicious tactics. Like their friends, the U.S. particularly, Portuguese fighters are bombing non-military areas of Mozambique. They are killing and maiming many people with

("Provincial Army of Volunteers" - mercenaries).

Even in the air, however, the Portuguese are having difficulty. For, when the Portuguese do find a well-protected FRELIMO base, they hesitate to strike. They have lost too many planes from the strong anti-aircraft fire of FRELIMO's forces. However, the Portuguese refuse to admit even small defeat. They are still attempting to defeat the Mozambican people's struggle on every front. For, on another level, they have engaged their American friends to finance a dam for them, to be built in the liberated

napalm. They are destroying the beauty of the land with chemicals. They are utilizing the United States' training and techniques in Vietnam-style bombing raids, and search and destroy missions upon the people. In 1970 alone, over 63,000 tons of bombs and 128,000 troops (combined forces) were brought to bear against the Mozambican people. Portugal spends over two million dollars a day to destroy Mozambique, and its other rebel colonies, Angola and Guinea Bissau. Portugal employs its airforce, navy, regular police and the PIDE (Portugal's version of the CIA), as well as the OPV

Tete Province. The site of this dam just happens to border on racist Rhodesia. This diplomatic, political and military tactic is for the purpose of containing the people's struggle north of the Zambezi river. It would supply electricity to racist South Africa and Rhodesia, provide for the eventual settlement of over one million whites in Mozambique, and (Portugal hopes) prevent the growth and expansion of the liberation movement. (This same tactic is also being employed in Angola, where the Portuguese are

planning to build another dam along the Cunene river.) It is doubtful this dam will be completed. The people of Mozambique do not wish this.

Portugal is even attempting an appeasement program in the yet-to-be-liberated portions of Mozambique. They are giving the people some "privileges" and cutting down on taxes. They actually believe that this old U.S. trick will stem the tide of resistance in the rest of Mozambique. Comrade Samora Moises Machel, President of FRELIMO, summed up the feelings of the people of Mozambique when he said, ".....Many comrades have spoken about all that they have suffered under the Portuguese, and nearly all of them spoke of the oppressive taxes and the beatings. If these things were stopped, would we stop fighting? Of course not. Because we are fighting Portuguese colonialism of which these are just one aspect." Also, we know these old games will not work if we understand another FRELIMO fighter, Kamiomi Botao, when he said, "I am fighting the Portuguese because when I was a child I can remember that my father used to go to work in Rhodesia and when he returned he brought home only a small piece of cloth that wasn't even big enough for my mother. I thought that he was just a waster, but when I grew up I found that I also earned very little and most of the money had to go in taxes. I saw whites come from Portugal with nothing and within a few months they had enough money to buy a car and many other things. When we had no money to pay our taxes, we were beaten and put to forced labor. The prices of our products were fixed by the buyer and when we protested we were just told that we should not play around with the Portuguese. To travel even a short distance we had to have a pass. What is the use of living like this? I want our independence. As it is necessary to fight for it, I am fighting....".

The reactionaries who kill and maim men, women and children in Mozambique, kill men, women and children in Vietnam and in the oppressed Black communities inside the United States. But the Mozambican people are winning, just as the Vietnamese people are winning, just as all of the oppressed people of the world will someday win over the oppressive United States Empire. The reason for the Mozambican people's continued victories stems from the fact that FRELIMO is one with the people. The survival programs instituted for the liberated zones benefit the people and

serve them. The food that feeds the freedom fighters, as well as the people, is grown in these liberated zones and shared among all the people. The over 200 primary schools, hospitals and other programs are not FRELIMO's programs, but the People's.

The heroic struggle of the Mozambican People is in fact successful because of this unity. Everyone in the community is part of the liberating force to free Mozambique. Everyone contributes to the survival of the liberated zone in any way that he can. The hospitals and clinics are set up to maintain sanitation and health services for the people. In one year alone, over 100,000 people were vaccinated against smallpox. People's shops and stores have been set up so that the things that the people have, such as food they have produced, can be fairly exchanged for the things that they do

chers do everything to help us, they are comrades....".

For the first time, even while engaged in this war of liberation, the People are beginning to know what it is like to live as human beings. As the People, themselves, say of the struggle, "FRELIMO is all of usFRELIMO is the unity."

In the liberated areas, the repressive and brutal regime of the Portuguese has been replaced with a people's government. There are frequent and countless community meetings throughout the liberated countryside. The meetings are attended by peasants, students, members of local committees, and guerrillas from the area. The people have open discussions and political education classes. They are fully aware of who their true friends and enemies are, and why they are

not have. The schools are free. People who never thought that they would be able to go to school under the Portuguese terrorist regime, go to FRELIMO's schools. A comrade from Machanga Province, also a member of FRELIMO, spoke of the treatment she received when she was finally "allowed" to attend Portuguese-run schools: "....It's very different from how it was with the colonialists. For instance when I was in Lourenco Marques, white pupils were with the teacher and we were put in a separate room. Once a woman said to the teacher that she was wasting her time teaching a negress. Now in the Institute that FRELIMO runs the tea-

struggling. They know that until FRELIMO was formed and initiated, the Portuguese over-ran their villages, exploited and murdered their people. As President Samora Machel stated at one of these community meetings, "Our main objectives are to expel the Portuguese and to liberate our country, to liberate everyone, men, women and children. And by liberating we mean not only from Portuguese colonialism, but also to establish a new life for our people with justice and equality, a society where no exploitation will be possible."

not be ignored as though not there - if we are really speaking of representation.

Nixon and Rogers, and those who came before them, arbitrarily decided that the Province of Taiwan (14 million) represented the true government of the Chinese people. The fact that the U.S. military operates out of Taiwan is, of course, not mentioned. (This is a familiar tactic to Black people, for Nixon and friends like to make people believe that Blacks, and other poor people in the U.S., are truly represented by them.) In order to deceive people, they referred to Taiwan as "Nationalist" China and to the government of the 800

Taiwan must be represented. They will be, as they desire, by the People's Republic of China. Besides, for 22 years 800 million people have not been represented fairly. For 400 years, 30 million Black people in this country haven't been represented at all. Black people certainly haven't heard Rogers talk about how "sad" that is. That is why we ourselves are struggling. That is why so many of us have died and been murdered, to have our rights as human beings in this world recognized.

However, Rogers must be kidding anyway. If, as he claims, U.S. money supports most U.N. programs, the withdrawal of U.S. funds will be very

the U.S. to be upset. A bit of their Empire may start falling in every corner of the world with the mighty voice of the Chinese People. The Chinese People and the government of the People's Republic of China have NEVER occupied a single territory in the world that belongs to another people. And the People's Republic of China does not support that program. The People's Republic of China has consistently advocated self-determination for all people by the people. The U.S. won't be able to so easily run everybody's business and rob everybody with the People's Republic of China sitting on the U.N. Security Council.

What makes Rogers' statement actually funny is that the U.S. dollar is becoming worth less and less among the world's peoples. Nixon called it the "de-valuation of the dollar". It is funny because Rogers feels this will threaten someone. The question is who: It is our hard-earned money, which money is becoming worth less and less, and which was sponsoring the most vicious and reactionary programs against the People of the world ever known to man. Even more funny was Nixon's last ditch stand, when he reached the level of begging the U.N. not to vote just one more night. When Albania called for a vote to be taken in the U.N. to recognize the People's Republic of China and to un-seat Taiwan, Nixon knew (from last year's vote on this same question, if not the handwriting on the wall) that the true Chinese People's government would be

seated. Before that, Nixon had tried to get the U.N. to agree that the so-called "Two Chinas" be seated. When that move failed, he ordered U.S. United Nations Ambassador George Bush to demand that this vote be counted as an "Important Question". An "Important Question" vote means that two-thirds of the majority there must agree to a particular issue. When, on October 24th, the U.N. decided, in a 59-55 vote (15 abstentions), that the issue would not be voted upon as an "Important Question", Nixon started begging for more time. It was too late. The people of the world voted (by a simple majority) in their own interest.

The People's Republic of China is now represented in the U.N.; Taiwan is no longer being fronted off as the representative of the Chinese People. The U.S. military based on Taiwan may have to go elsewhere. Many things may happen. But, we are certain, that with this decision, the people of the

million on the mainland as "Red" or "Communist" China. This ridiculous statement actually had people referring to "Two Chinas". This is another example of how Nixon wishes to decide for the people what is their decision to make.

Now that the world body, the U.N., has finally admitted that one-quarter of the earth's population exists, Rogers and Nixon want to withdraw our money and say that the whole world doesn't exist. And, the U.S. government leader in Taiwan, 84-year old Chiang Kai-Chek, even mumbled something about the U.N. being a "den of iniquity". Twenty-four hours before being finally kicked out, Chiang didn't seem to feel this way. While the People's Republic of China was ignored by the U.N. for 22 years, Chiang and Nixon didn't feel this way. Now, all the people of the world are just "sinful", particularly those who voted to recognize fact. Rogers and the boys are even running around saying that this is unfair to Taiwan. They're saying that those 14 million people on

self-defeating. For, under the banner of the U.N., United States troops and U.S. controlled troops have sneaked into more than half the countries of this world and taken over other people's territory: U.N. troops occupy the 38th parallel (the dividing line between North and South) of Korea, separating a whole people, in the interest of "peace"; U.N. "advisors", under Kennedy, came to Viet Nam only a few years before the troops; U.N. "aid" and "educational" programs force the racist U.S. ruling class way of thinking and culture upon millions of people around the world (like they have thrown off their decadent culture and life style on Black people in this country); under U.N. work programs United States big businesses are making millions of dollars selling their cheap products to the world's people; and United States CIA agents infiltrate the affairs of the world's people under the U.N. banner.

However, there is a good reason for

world will benefit. The U.S. can't bully China, as it has so many (as it did Ghana and Japan. The U.S. forced a favorable vote from these two communities, for example, when both of them at one time might have voted for the U.S. resolution to seat "Two Chinas". The U.S. promised its old

friend Japan that it would drop a newly-imposed 10% tax on Japanese goods coming into the U.S. and even promised to return Okinawa to Japan.) The U.S. dollar did not, however, buy everyone's agreement.

We Black People and all oppressed people here in the U.S. (where the U.S. government arrogantly insisted the

U.N. building be located), we oppressed people here in the U.S. must know that Nixon never cared about our needs and desires. The Chinese People do. The People's Republic of China, the Chinese people believe we should actually govern ourselves. We have a friend now in the U.N.

BE IT FURTHER RESOLVED, that the State of California nor the United States of America will conduct an unbiased investigation of the killing of George L. Jackson's body.

BE IT FURTHER RESOLVED, that the United Nations Charter provides for international cooperation in promoting and encouraging respect for human rights, and that the United Nations shall promote universal respect for, and observance of, human rights and fundamental freedoms.

BE IT FURTHER RESOLVED, that the right to live is a fundamental human right.

HENCE, I HEREBY DEMAND THAT THE UNITED NATIONS TAKE JURISDICTION OF THE CASE OF GEORGE L. JACKSON AND INVESTIGATE HIS DEATH.

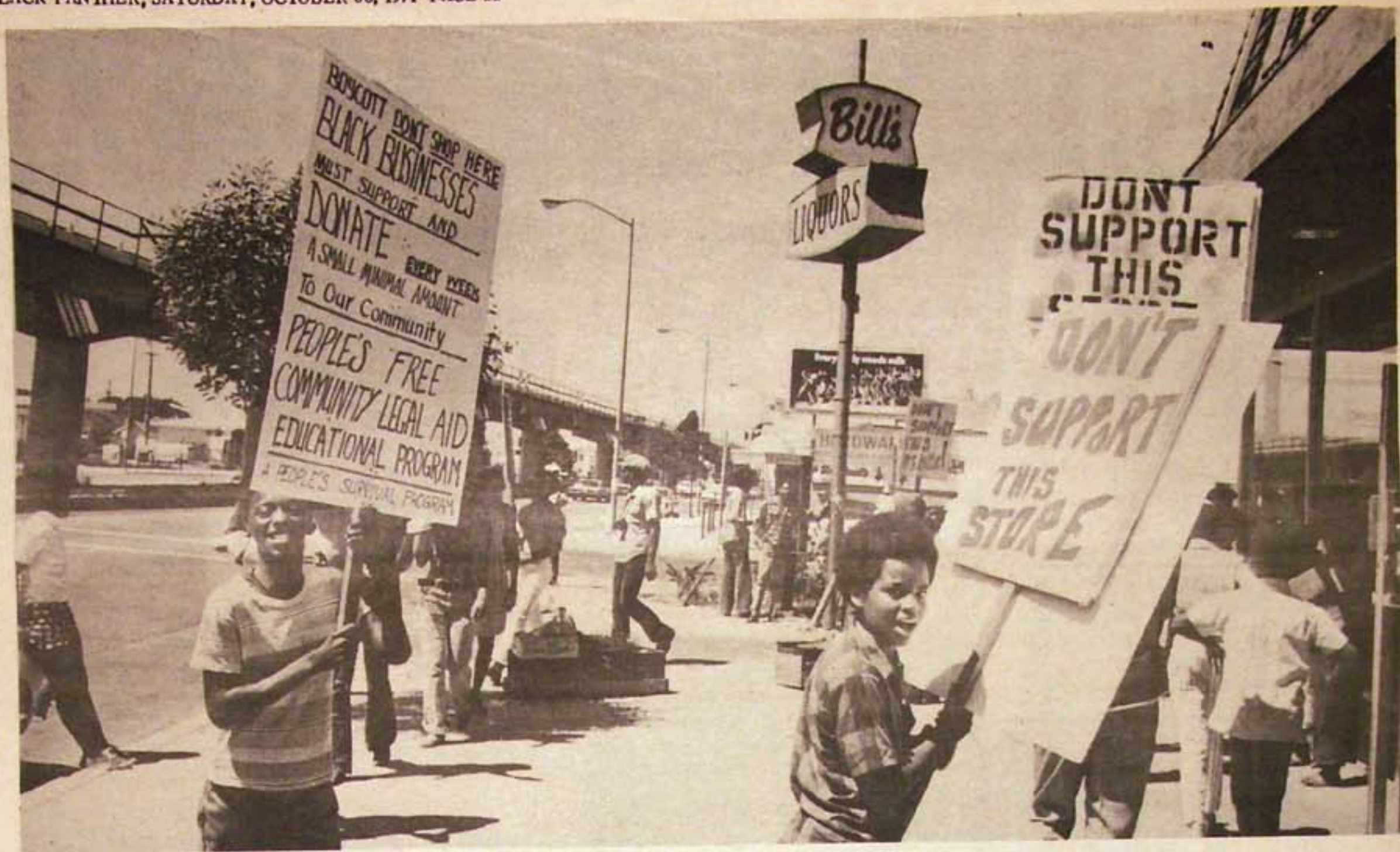

THE PEOPLE'S COMMUNITY SURVIVAL PROGRAMS

BILL BOYETTE AND THE AD HOC COMMITTEE OF BLACK BUSINESSMEN REFUSE TO GIVE A CONTINUOUS NOMINAL AMOUNT TO:

The Sickle Cell Anemia Research Foundation - Developed to test and establish a cure for sickle cell anemia, the deadly disease that particularly effects Black people; often incapacitating, crippling, and resulting in death. Black people will be tested free of charge to determine whether or not they have the trait or the disease itself. The purpose of the clinic is to create better educational programs around sickle cell; to increase screening and testing; to maintain a research advisory committee with a group of doctors who have been researching sickle cell anemia.

People's Free Medical Clinic - Established to provide free pre-natal care, preventive medical care, immunization shots, general health care, free testing for sickle cell anemia, and free referral to specialists.

People's Free Clothing Program - Black people cannot afford exorbitant prices for clothing. The People's Free Clothing Program provides clothing that is both sturdy and stylish.

The David Hilliard People's Free Shoe Factory - Shoes from the David Hilliard Free Shoe Factory will be given free of charge to anyone who needs them. Without proper shoes people are prone to illness and disease.

The Angela Davis People's Free Food Program - Organized to provide free food for Black and poor people. Capitalist exploiters have too long over-charged us for inferior food.

People's Free Ambulance Service - The People's Ambulance Service will provide free transportation 24 hours a day. Often an ambulance will not appear in our community until hours after it is called and then there is a charge for a service that should be a human right.

Intercommunal Youth Institute teaches our children how to think, using the theory of dialectical materialism. 40% of the institute curriculum time is spent doing community work. The whole world is their classroom.

Liberation Schools - Created to give Black children the correct view of their role in the present-day society. The Liberation Schools are designed to become community schools under the larger youth institute.

Legal Aid Educational Program - To provide the people with free legal first aid (how to prevent and handle arrests), free community legal aid classes and help in obtaining lawyers.

Free Breakfast Program - To feed children a free, healthy, hot breakfast before school in the mornings. Children cannot function in a classroom situation if they are hungry. The Free Breakfast Program provides a much needed diet that is adequate in vitamins, iron and protein.

The Free Bussing Program - To provide free transportation to the prisons (which are usually isolated in remote areas) for the families and friends of prisoners incarcerated in maximum security prison camps.

Free Plumbing and Maintenance Program - To provide free plumbing repair and service for the houses of people in the community.

The Intercommunal News Service - Created to provide news for and about the oppressed communities of America and the world.

BROTHER DAVID HILLIARD, POLITICAL PRISONER AND CHIEF OF STAFF OF THE BLACK PANTHER PARTY, WAS IN FACT WRONGFULLY CONVICTED ON FALSE CHARGES BY A PREDOMINATELY WHITE RACIST JURY, AS ALL MEMBERS OF THE OAKLAND BLACK COMMUNITY WERE SYSTEMATICALLY ELIMINATED FROM THE JURY SELECTION PROCESS IN HIS TRIAL.
