


March In Procession With Vanzetti's Ashes; **Police Commissioner Refuses Permit**

Despite the fact that Police Commissioner Joseph A. Warren has refused to grant a permit for a funeral procession for the ashes of Sacco and Vanzetti, Mrs. Clarina Michelson of the Sacco-Vanzetti Memorial Committee stated vesterday that the procession would be held in any case. The Memorial Committee was brought into being for the purpose of arranging the Sacco-Vanzetti memorial demonstration in New York.

Mrs. Michelson has issued a call? to the various Sacco-Vanzetti committees in the city to take part in the memorial exercises. Each committee will be represented by a delegate who officially will take part in the demonstration. Union Square Demonstration.

It was announced by the Memorial Committee that the ashes of the two men will be taken to Union Square, where a monster mass meeting will be held.; Union Square was chosen because the owners of all the larger halls in the city have refused to allow the memorial services to take place on their premises. Officials of the memorial committee stated that possibly the police department was responsible for the refusal of the hall owners. Consequently, it became absolutely necessary for the funeral exercises to be held out of doors


I. L. D. WARNS OF SCHEME TO FRAME **CHESWICK MINERS**

PITTSBURGH, Pa., Aug. 26 .- The arrest of more than twenty miners in Cheswick, Pennsylvania, arising out of the attack by state troopers upon a peaceful protest meeting for Sacco and Vanzetti, holds all the possibilities for the creation of another

Thousands of workers had gathered in Cheswick, on the eve of the execution, to urge the liberation of the two martyred labor fighters, when a troop of the state Cossacks rode into the crowd with drawn clubs and guns. Gas bombs were poised for use against the unarmed and pacific workers. Men and women were struck at, right and left, by the Cossacks who have a black anti-labor reputation thruout the state and who have been condemned time and again

egionnaires Set Sail From New York for Protest Awaiting Them In Paris

"AMERICAN LEGION CONVENTION WILL NOT BE TOLERATED," DECLARE FRENCH NEWSPAPERS

WASHINGTON, Aug. 26 (FP).-Bitter French opposition to the proposed Franco-American festivities and the American Legion parade through Paris Sept. 19 is revealed in editorials in leading newspapers.

Quotidien: "Let there be no more talk of it. The cruel end of Sacco and Vanzetti rules it out. Such a festival would look like a mockery of universal mourning. It could not be tolerated."

Paris Soir: "Last night's events (mass protests) ought to open the eyes of the guardians of public order. They prove that you cannot defy public opinion without risk. They prove, too, that if the authorities obstinately insist on holding this parade of the American Legion they will be incurring grave responsibilities. The people of Paris, we assert, will not only refuse to make a Franco-American festival of September 19, but will not tolerate this procession of the American Legion. This festival ought not to take place; it cannot take place."

PARIS, Aug. 26 .- With the meeting of the cabinet council of the die-hard Poincare government to consider plans for the reception of the American Legion here September 19th, French workers have agreed upon a systematic boycott of American goods and films.

Leading the drive to prevent the opening of the Legion convention and parade on the Champs Elysees, L'Humanite, Communist daily, today published a large photograph of a souvenir ash tray representing in bas relief a drunken American soldier dancing with a nude French girl. The ash trays are being widely circulated.

URGE ARREST OF COMMUNIST DEPUTY.

The arrest of Deputy Vaillant Couturier, one of the editors of L'Humanite, is being demanded by die-hard dailies here because Couturier is urging a war on the Legion convention, and the setting aside of September 19 as a "Day of Mourning" in memory of Sacco and Vanzetti. The anti-Legion drive is growing rapidly despite the opposition of die-hard dailies and of the Poincare government. French workers are taking a great deal of interest in the opposition on the part of Berlin labor to the visit of Mayor "Jimmie" Walker of New York City. Walker's visit, reports from Berlin indicate, is stirring the same opposition among workers there that the Legion convention is arousing here.

This sort of insipid propaganda became, in this case, positively murderous, as it tended to spread defeatism and despair among the ranks of the working class.

Liberty in Boston

To those not actually taking part in the swift moving chain of events revolving around the burning of Sacco and Vanzetti, it would be difficult to comprehend and correctly analyze the complete significance of the distorted and half-told stories which were blazoned in huge headlines in the capitalist press thru the nation.

The kept press of Boston with few exceptions, has gone out of it's way, since Gov. Fuller white-washed Thayer & Co., to whet the appetities of its readers for the approaching execution by placing side by side pictures of the martyred workers and pictures of a juror's house which was "mysteriously" bombed last week.

Police terrorism was complete in every detail, their job being to vigorously suppress every voice, be it ever so meek, that was raised in protest against the carrying out of the last act in this tragic holocaust.

I was one of a group that comprised the second platoon of pickets in front of the State House. The sidewalk was literally swarmed with police both in "harness" and civilian clothes, while mounted police rode leisurely up and down the street. Hordes of newspaper reporters and camera-men made traffic difficult and the crowd which filled the north-west corner of Boston Common was rapidly growing in size and was forced back to the center of the Common by the police repeatedly.

Our picket line was given the usual order to disperse, but being firm in the conviction that we were exercising our rights of peaceful persuasion as guaranteed by law, we continued to move along the curbing in an orderly, determined manner holding our placards high.

A detail of reserves swung around the corner and were loudly applauded by a group of legionnaires, just leaving the State House after going thru some form of ceremonial hocus-pocus, and in a few seconds we were pounced upon and rushed against a stone wall. The police were ordered by their superiors to "take a good look at these people, so you will know them when you see them again," which was followed by the "grand march" to the Joy Street Station. Several times during the long walk to the jail we were cheered and applauded by sympathetic workers and liberals from Beacon Hill.

The noble blue-coat who escorted me was of a questioning turn of mind. He inquired if I believed in god and on receiving an answer in the negative burst out: "That's what the trouble is with all you people, no respect for god's laws and no respect for courts." He suggested that I should read Pope Pious' Encyclical and learn something. I agreed on condition that he familiarize himself with the writings of Marx and Engels, as I believed as two members of the wage-earning class we should share our literary views.

Once lined up in the station house we were searched and booked and I was relieved of my copy of The DAILY WORKER by an understrapper who barked out that "papers like that don't belong in THIS country." While being assigned to our cells we were given a rousing welcome by our fellowworkers of the first picket line. Some one raised his voice to the tune of "Solidarity Forever" and all hands responded with a vigor that made our filthy old cell-rooms ring. Meanwhile the women, particularly those comrades of foreign birth, were herded in the guard-room where they were forced to put up with all sorts of insults and indignities from the cops. These girls were not to be bested, however, and when asked by the "brave officers" when they were going back to "Rooshia" they were quick to reply "When is the Boston police force going back to Ireland?'

More and more pickets were brot in, each new since the days of the Boston massacre.

group being given the same welcome cheers. When the cheering subsided the first question asked our newly arrived comrades was: "How many of you were taken in this time and how many more are waiting to go on the line?

Evidently the thundering challenge of our many voices chanting the "Internationale" was more than our hosts could endure for three cops walked to the end of the cell-corridor where they stopped for a bit and then walked out grinning sheepishly. Our noses soon discovered the meaning of their mysterious mission when the sickening fumes of a "stink bomb" was wafted into our close, damp cells. By the way, this is a crime under Boston "law," but after all weren't we only workers? What difference? The ladies in the smoke-filled guard room were also given a taste of chivalry as practised by Bostons' stink bomb-throwing guardians of law and order Perhaps this was not enough, for when several of the ladies requested the privilege of using the toilet they were ushered into our cell room section and in plain view of the male occupants of the cells they were told to use the vile accommodations of an empty cell where all the scum of the underworld are confined.

Later in the day Powers Hapgood arrived and was locked up in our section. After hastily outlining the situation "outside" he joined us in singing and cheering until he was suddenly taken from his cell and whisked away to the Psychopathic Hospital where he was held for some time incommunicado.

Perhaps the most interesting part of our sojourn behind the bars was the sifting out of two strange "fellow-prisoners" who were suspected of being stool-pigeons. Just before the last line of pickets was brot in, a roll-call of each cell was suggested. Everyone was asked to give his cell-mates, his name, address, occupation and reason for being on the picket line. All were able to give a satisfactory account of himself excepting one stranger on each side of the jail. These two had been busy thruout the early part of our "visit," while our bail was being arranged, in asking all sorts of trick questions, etc., and had aroused suspicions. One of these fellows was found, I was told by one of the pickets, with a gun on his person and was later observed chatting with an officer before being assigned to one of the cells, which held from four to five prisoners. When he was asked point-blank by his cell-mates, why he was in Boston, he replied, "I was sent by a certain organization to do a certain thing." What the organization was and what the "certain thing" could have been is best answered by the fact that he was nowhere to be seen when the pickets were arraignd in court Tuesday morning.

After being arrested for carrying a placard onthe Common, William Patterson, president of the American Negro Labor Congress, was told by the arresting officer that "this is the first I have seen a Nigger bastard who is a Communist." Patterson was singled out by a mounted policeman who tried to ride him down, only the fact that he, (Patterson) dodged around a tree saved him from the sharp hoofs of the horse. After being released on bail Patterson took his place on the State House picket line and soon found his way into jail where once more he was the object of the vicious race-prejudice of thick-skulled police.

These are only a few instances of some of the examples of rabid fascism prevailing in Boston, they are the facts which never see the light of day in the capitalist papers until given the "proper" angle by labor-hating editors. I have also tried to portray the splendid spirit of solidarity of the workers who carried on their unflinching protest in the face of the most ruthless repression known to Boston

Today we remember not only Nicola Sacco and Bartolomeo Vanzetti, murdered by Massachusetts in 1927, and Joe Hill, writer of songs of the revolution.



SACCO-VANZETTI MURDER TYPICAL OF CAPITALIST "JUSTICE," SAYS INTERNATIONAL RED RELIEF

Vanzetti Writes to Dante Sacco

Last Sunday, barely thirty hours before he was murdered in the Massachusetts eletcric chair, Bartolomeo Vanzetti penned a letter to Nicola Sacco's 14-year-old son, Dante.

"Your father is one of the bravest men I ever knew," he wrote to the boy who was seven years old when his father was framed and thrown into prison. In conclusion, he urged him to join in the movement "against the exploitation of man by man." The letter follows:

*

My Dear Dante: I still hope, and we will fight until the last moment to revindicate our right to live and to be free, but all the forces of the state and of the money and reaction are deadly against us because we are libertarians and anarchists.

I write little of this because you are now and yet too young to understand these things and other things of which I would like to reason with you. But if you do well, you will grow and understand

your father's and my principles for which we will soon be put to death.

I tell you now that all that I know of your father, he is not a criminal, but one of the bravest men I ever knew. Some day you will be able to understand what I am about to tell you, that your father has sacrificed everything dear and sacred to the human heart and soul for his faith in liberty and justice for all. That day you will be proud of your father. and if you come brave enough, you will take his place in the struggle between tyranny and libertyand you will vindicate his name and our blood.

If we have to die now, you shall know, when you will be able to understand this tragedy in its fullest, how good and brave your mother has been with you. your father and I, during these eight years of struggle, sorrow, passion, anoni agony Even from now, you shall be good, brave, with your mother, with Inez and with Suzie-brave, good Suzie-and do all you can to console and help them. I would like you to also remember me as a comrade and friend of your father's, your mother and

Inez. Suzie and you, and I assure you that neither I have been a criminal, that I have committed no robbery and no murder, but only fought modestly to abolish crimes from among mankind and for the liberty of all.

Remember, Dante, each one who will say otherwise of your father and I is a liar, insulting innocent dead men who have been brave in their life. Remember and know also, Dante, that if your father and I would have been cowards and hypocrites and rinnegators of our faith, we would not have been put to death. They would not even have convicted a lebbrous dog; not even executed a deadly possoned scorpion on such evidence as that they framed against us. They would have given a new trial to a matricide and an habitual felon on the evidence we presented for a new trial.

Remember, Dante, remember always, these things; we are not criminals; they convicted us on a frameup; they denied us a new trial; and if we will be executed after seven years four months and seventeen days of unspeakable tortures and wrongs, it is for what I have already to 1 you; because we were for the poor and against .ne exploitation and oppression of the man by the man.



Sacco and Vanzetti. They have been murdered by the social system that the writer sponsors.

They are dead. It is aimed instead at the many millions of foreign-born workers who writhe upon the wrack of modern industry, multitudes dream-

ing of a better day, when their tortures may come to an end.

This "Thomas X, Bender" is not alone. He is typical of the 100 per cent "American" who furnishes support for the fascist activities of the American Legion, who puts on a night shirt, hides his face behind a mask and parades in the darkness as a member of the Ku Klux Klan; who is anxious to tell all the world that, "if you don't like this country, why don't you go back where you came from?"

This Bender type of mind dominated the jury in the court of the black-gowned Thayer, getting the verdict of "Guilty!" and the sentence of "Death!" against Sacco and Vanzetti.

It is the type of mind that the enemies of labor hope to exploit to put thru the next session of congress legislation for the registering, the finger-printing and the photographing of all foreign-born workers, preliminary to inflicting the same regulations upon all workers.

This brand of capitalist legislation is not new. It has been before congress in various forms ever since the "red raids" of 1920, ever since Sacco and Vanzetti, two Italian workmen, were torn from friends and family and thrown into prison, to be forced for seven years along the tortuous road that led to the human slaughter house of the

It was this nest of persecution that spawned the frame-up of Sacco and Vanzetti. But American labor, native and foreign born, will acept the challenge and take up the cudgels of battle.

Foreign and native born labor in the United States will unite at the double grave of Sacco and Vanzetti, cement their forces and wage relentless war against the common oppressor-the capitalist foe.

Workers of all nationalities, of all colors, have joined in protest against the murder of Sacco and Vanzetti. The clubs of the police have fallen alike upon the heads of Negroes and white workers. Police horses and motorcycles have been used to charge against demonstrations of workers speaking a multitude of different tongues. Police wagons have been filled with demonstrating workers, making no differentiation as to which country they hailed from, or whether their ancestors dated back to the revolutionary forefathers of this country. Arrests have been made indiscriminately; sentences dealt out wholesale, for daring to protest against the legalized murder; allagainst the working class, not against American or Italian, Lithuanian or German, Polish or Hungarian worker, but against labor unified in a great struggle.

The struggle against the slayers of Sacco and Vanzetti has brought upon protesting labor a baptismal fire that cannot help but amalamate the forces of those who toil.

One of the many expressions that must be taken by this unity is the growing campaign for the Protection of the Foreign-Born. 



Greater energy than ever is needed today, however, to combat this slavering capitalist beast that stands forefeet upon the prostrate forms of Sacco and Vanzetti.

From the earliest times the wretched of Europe fled across the Atlantic seeking better times in this country. No human being walks soil in America who has not had some foreign ancester. There has been no greater tide of migration, in all the world's history, than the flood of human beings, especially during the last century, that has poured into the United States

By 1880, the arriving immigrants reached a total for the year of 457,257 and the next year far surpassed the half million mark.

The year of greatest migration was 1907 when 1,285,000 arrived in spite of the money panic that set in during this period. If the war had not broken out in 1914, this year would have established a new record. At that the total reached was 1,218,480. The year of the American entry into the war, 1917, found only 296,403 new arrivals in this country.

But that was also the year that world capitalism cracked. Up thru the bloodsoaked soil of czarist Russia came the gnarled fist of Worker-Peasant Power. The Proletarian Dictatorship not only swept aside czarism. It shook and cracked the pillars of capitalism thruout Europe. Even American greed felt the sinewy fingers of revolutionary toil tightening about its neck, thumbs upon its throat.

"Selective immigration" was the first weapon of retaliation. The law not only provided for a there examination of those entering the country, but also provided for the deportation of "undesirables." America ceased to be a haven for political refugees. Even the belief in governmental change, without an act of advocacy, became grounds for deportation.

Raleigh Paper Prints Socrates' Farewell as Sacco and Vanzetti Die

RALEIGH, N. C., Aug. 26 .- With out comment, the Raleigh News and Observer on the day before the electrocution of Sacco and Vanzetti published the address of Socrates to his judges. For opposition to the estabished order, Socrates was condemned to death. He said:

The difficulty, my friends, is not in avoiding death, but in avoiding un righteousness; for that runs faster than death. I am old and move slowly and the slower runner has overtaken me, and my accusers are keen and quick, and the faster runner, who is unrighteousness, has overtaken them. And now I depart hence condemned by you to the penalty of death, and they too go their ways condemned by the truth to suffer the penalty of villainy and wrong; and I must abide by my award - let them abide by theirs. I suppose that these things may be regarded as fated-and I think that they are well.

And now, O men who have condemned me, I would fain prophesy to you; for I am about to die, and that hour in which men are gifted with prophetic power. And I prophesy to you, who are my murderers, that immediately after my death, punishment far heavier than you have inflicted on me will surely await you. Me you killed because you wanted to escape the accuser, and not to give an account of your lives. But that will not be as you suppose; far otherwise. For I say that there will be more accusers of you than there are now; accusers whom hitherto I have restrained; and as they are younger they will be more severe with you and you will be more offended at them.

For if you think that by killing men you can avoid the accuser censuring your lives, you are mistaken; that is not a way of esiape which is either possible or honorable; the easiest and noblest way is not to be crushing others, but to be improving yourselves.






