# Work for Feb. 4

The Committee of the Chicago Unemployed Councils writes: "We had a conference on Sunday, January 3 ... worked out a complete program of action. . . . We have set ourselves the goal of securing 500,000 signatures, (including among them 500 collective endorsements), for the Workers' Unemployment Insurance Bill. We will also try to establish unemployment insurance committees in 50 neighborhoods, 10 flop houses, 200 workers fraternal and benefit organizations, 50 trade unions and in 20 shops. We have mobilized workers' organizations for local struggles, collection of signatures and in support of our preparations for February 4th. A committee was elected to take charge of the campaign and give leadership to this united front movement.

In a recent report from Chicago there was mention of a plan to organize, systematically, block committees for the collection of signatures. The Daily Worker wants to find out what has been done to carry out this proposed plan and how it works so that these experiences can be given to the other districts.

PINEVILLE, Ky., Jan. 12 .- Hearing of the nine arrested strike leaders and workers of the National Miners' Union, the International Labor Defense, and the Workers International Relief, came up this morning. The cases of Allen Taub, I. L. D. attorney, and Mason, Collette and Patrick, local strike leaders, will come up later separately.

Taub, Bental of Chicago, Stone, Taylor and Bingham of Pineville were the defense attorneys. The miners had been told if they came in the case would be postponed. Fifteen hundred cam anyway. 
The Kentucky constitution has a section headed "The right of revolution," providing the people may change or abolish the government in any way they see fit.

a strike to start January 1, against starvation and terror. They elected a Southern District Board of the National Miners Union, which thousands of Kentucky miners have joined, and this board openly and legally made strike preparations, and called in representatives of the Workers International Relief and International Labor Defense to assist in supplying food to the strikers and to handle all necessary legal business matters in connection with the fight for the right to organize and strike.

In the most public manner possible the National Miners Union, Workers International Relief and International Labor Defense established offices at 105 Virginia Ave., Pineville, on January 1st, the first day of the strike

Over 50 mines struck that day, and the strike has continued to spread from day to day since then. Thousands of men are involved. They are Itriking against what the companies pay as wages as low as 32 cents a ion, but in which cheating on weights by the companies reduces the actual wage to 20 cents or lower. They are striking against such poverty that has already starved to death dozens of children in these fields, reduced men and women to living in rags, afflicted by diseases brought on by hunger, living in shacks unfit for stables.

They are striking for 50 cents a ton. \$4.80 day wages, payment for dead work, no discrimination, payment in U. S. currency instead of scrip, etc. They are striking in the face of a terror instituted by deputized company gunmen who break up their meetings with machine guns as at Harlan, January 1; at Black Star, January 3.

In the course of this strike, miners came into the 105 Virginia Ave., Pineville office in large numbers to join the union and to receive relief.

W charge that the coal operators, using the Bell County deputies and Judge Van Beber's court as weapons, actually conducted the raid and arrests January 4 to cripple the strike and relief activities, and that they did this in the hope that by starving to death additional numbers of men, women and children, they can force the miners to work in a state of virtual slavery for the actual wage of 20 cents a ton or lower.

We have repeatedly demanded a public hearing and this hearing has been repeatedly postponed by the court in order to prevent our answering the slanders and lies circulated against the union by the coal operators and their newspapers.

Since January 5 and January 7, dates set by the court for the hearing, thousands of strikers came into Pineville, to demand our release and hear what we had to say. The court has not dared to permit these miners to hear our defense. We still demand a public trial, and we do not accept as a substitute any such surprise hearing before a hand-picked audience of coal operators and their agents as was offered us January 8.

A further attempt of the operators to deny us defense is shown by the fact that as scon as Attorney Allan Taub of the International Labor Defense appeared in Pineville, he was also arresed and thrown in jail on the ridiculous charge, first of criminal syndicalism which was later changed to the equally ridiculous charge of conspiracy to overthrow the government.

We assure the striking miners that we are whole-heartedly for them in this struggle, that we will stay in jail forever before we change our loyalty to them or abandon our support of their strike demands.

We urge the Kentucky-Tennessee miners to continue to spread their heroic strike, and to picket in masses, to build their strike committees, both local and central, to march on the mines not yet struck and bring them out on strike, and to build up their defense and relief apparatus more firmly than ever. Join the N.M.U.!







A Japanese armored train which was corrying reinforce ments from Tahushan was derailed and overturned by partisan troops Only ten men, of the whole force escaped without wounds. While these en were holding an electric power station at Pataohao, near Tahushan,



## A NON-PARTY WORKER CRITICIZES THE PARTY FOR NOT SUFFICIENTLY EXPOSING FATHER COX

(A LETTER FROM A SYMPATHIZER)

Org. Dept. Central Committee Dear Comrades:---A few days ago I saw in our Daily Worker requests for suggestions from

workers on improving the work of the Party. I would like to write of the work among the unemployed in Pittsburgh. I attended several of Father Cox's meetings.

Every worker has heard of Cox and many think he is doing "good" work. Yet very little seems to be done by the Party to show how Cox is fooling the workers.

All the newspapers are giving Cox lots of publicity. He speaks, too, over the radio and everyone is talking about him.

I read in the Daily Worker that a few Party members were arrested giving out leaflets at Cox's meetings. I have attended every meeting of Cox lately and I haven't seen one of the Party leaflets yet.

I don't think the Party organizes a good distribution of the leaflets. You know comrades. Cox always has police and detectives at his meetings or around his church. So leaflets should be distributed by many workers. Girls can be used for this work, too. I have not come across any worker yet at Father Cox's meetings who saw one of the Party leaflets.

Then again the Party should do something about this Cox march to Washington that took place. I have several neighbors who went on the march. Some have come back and some are not yet back, though Cox came back Thursday night to Pittsburgh. I guess the rest are still on the road somewhere.

The ones who came back had a hard time and sure froze and starved plenty. Why don't the Party get lots of unemployed to march down to Cox's church and show him up at a demonstration? Comrades, it is a shame to leave a man like Father Cox fool so many workers as he is doing. The Party may be doing a lot for all I know. But this much I do know. That I have attended Cox meetings that were packed with unemployed and have seen no signs of the Party showing him up.

I also know that many of my friends attend Cox meetings and have not seen any sign of the Party. I sure would like to see the unemployed get on to Cox. I think as long as they follow Cox and believe in him, the workers will never get nowhere.

I'll end this letter now. Sorry to have it so long, as I know you are busy. I work yet, though only two days a week, in

### **Black Bread Versus** Blackguards

The Sacramento, Calif., "Bee" of Jan. 5, magnifying the yarns told about the Soviet Union by a "native son," one I. B. Williamson, who has returned from an 18 months job with the Soviet as "an instructor in driving tractors," makes black blacker in its interpretation of the "sorrows" of Russians who live on "black bread." We are getting a bit tired of this sort of slander, and after consulting authorities we take up cudgels against this peculiar but persistent form of anti-Soviet propaganda.

The black bread of the Russians is made of the whole grain of the rye, which contains all the organic minerals, such as lime and iron, essential to physical health. It is, indeed, like the real whole wheat bread (as distinct from. much fake "whole" wheat sold in America) that American dietetic experts recommend for people who have become ill from lack of these mineral elements

Alfred W. McCann, junior, the nutritional specialist, is authority for the statement that in the ordinary loaf of whole wheat bread there are sevency grains of these organic minerals, whereas in the white bread loaf there are only eighteen Further, a great number of ills result from the weakening of resistance by deficiency in these minerals precisely because of a diet lacking them The pellagra of the South is a notorious example.

Thus it is clear that no tears need be shed over the Russians because they eat black bread. Indeed, according to a doctor, well known as a medical authority, they are better off than the Americans who think they're smart because they eat a lot of junk that's had for them. This doctor, who is a warm friend of the Soviet Union told us that he when reading some Soviet short stories, ran across a passage where a peasant was saying: "Now we will be able to eat white bread, like the nobles did."

"And I thought," said the doctor, "You darned fools; you'll be getting a lot of fancy diseases

1. Political discussion in the unit should be developed primarily on the basis of mobilizing the membership for the specific unit mass activities and the unit's participation in the general campaigns of the Party. #### ATTITUDE OF SOCIALISTS TOWARD WAR.

THE Socialists have always condemned wars between peoples as barbarous and bestiak. Our attitude towards war, however, differs in principle from that of the bourgeois pacifists and anarchists. We differ from the first in that we understand the inseparable connection between wars on the one hand and class struggles inside of a country on the other; we understand the impossibility of eliminating wars without eliminating classes and creating Socialism, and in that we fully recognize the justice, the progressivism and the necessity of civil wars, i. e., wars of an oppressed class against the oppressor, of slaves against the slave-holders, of seris against the landlowners, of wage-workers against the bourgeoisie. We Marxists differ both from pacifists and anarchists in that we recognize the necessity of an historical study of each war individually, from the point of view of Marx's dialectical materialism. There have been many wars in history which, notwithstanding all the horrors, cruelties, miseries and tortures, inevitably connected with every war, had a progressive character. 1. e., they served the development of mankind, aiding in the destruction of extremely pernicious and reactionary institutions (as, for instance, absolutism or seridom), or helping to remove the most barbarous despotisms in Europe (that of Turkey and Russia). It is therefore necessary to examine the historic characteristics of the present war taken by Itself.

The basis for such discussions in the units shall be a prepared, political statement by the District Buro and District Agitprop Department. The general district statements should be briefly supplemented by the section or unit buro applied to their local tasks and problems. The District Buro should bring into the sections and units its important political discussions which have an immediate bearing on the work of the Party. The District Agitprop and Org. Depts. to decide on the general topics for discussion in the sections and units.

4. Section and unit buros to decide on political discussions based on their section and unit activities. (Activities of unemployed branch. shop concentration, work in the mass organizations.) These discussions should receive the active assistance and guidance from the District Agitprop and Org. Depts.

5. City-wide ar section functionaries' conferences should be developed in preparation for the mobilization of the membership for important campaigns, review of important campaigns, or discussion of some serious wrong political tendencies which reveal themselves in the practical work of the district or section. The discussions at the functionaries' conference to be followed up at unit meetings. 6. Special steps must be taken to improve the

political life of those units located outside of the district headquarters.

7. In connection with the recruiting drive, the training of new members assumes particular importance. The 6-week training course for new members as suggested by the Agitprop Dept. should be organized without delay. The statement of the Agitprop Dept., which explains the purpose of the 6-week training course and the methods of organizing the course was printed in the Daily Worker, Dec. 22 issue. The title of the statement is "The Political Initiation of New Members."

8. The elementary political theoretical training of the membership is essential for enabling it to grasp and understand the basis for the practical tasks, to develop confidence and enthusiasm in the growing practical activities. The system of classes in fundamentals of Communism must become the basis for the elementary political theoretical training of the membership. Such classes must be at once established on a unit scale (in exceptional cases on a section scale). It would not be advisable to hold classes on the same night as the unit meeting, as this will make it impossible to develop political discussions on the unit mass work, nor will it allow the carrying through of the regular classes

9. Propaganda literature is of the greatest importance in the raising of the political level of the membership and in the political mobilization for mass work. The discussion in the units and classes to be linked up with reference to definite reading material. In the center of our reading material must stand THE COM-MUNIST.

The National Hunger March expressed the bitterness of twelve millions of unemployed, of millions of part time workers and of all of the toiling masses who find themselves dying of slow starvation or being rapidly reduced to absolute pauperism as a result of capitalist crisis and greed.

As a direct result of the Hunger March and the campaign connected with its organization and return, the various so-called relief agnecies and institutions in all parts of the country bestirred themselves. Fearful of the bitter resentment and of the fighting mood of the masses which the Hunger March expressed, senators, congressmen, state politicians everywhere came forward with all manner of demagogic proposals for federal and state relief. At the same time, the National Hunger March roused addi-

tional fighting spirit among the broad masses and strengthened them in the struggle for unemployment insurance and for more adequate immediate relief.

Exactly one month later, on January 7th, another "Jobless Army" appeared in Washington. The capitalist press which sought in every possible way to minimize and belittle the National Hunger March, exhausted its reporters, typesetters, vocabulary, imagination and arithmetic in the effort to glorify this "Jobless Army" and especially its leader, Father Cox. Figures on the numbers in-

volved in "Cox's Jobless Army" varied from 45.000 down to 10.000. Actually some 5,000 men (no women) came into Washington with Cox. But, the City of Washington and

the Capitol grounds presented an altogether different picture on Jan. 7th than on Dec. 7th. The streets were not crowded with hundreds of thousands of workers as on the day when the Hunger March paraded with their banners, placards, songs and defiant shouts. No unusual numbers

"It's Against the Constitution"

We're not speaking of the U.S. C. but the constitution of the American Legion. You see, down where the buckaroos are building the Hoover Dam, at Boulder City, Nevada, near Las Vegas, the Legion is putting up a building for its "post."

It seems that someone around there has raised the question of the Legion's reactionary policies, and the Las Vegas "Review-Journal" publisher the Legion reply, as an effort to put over the scheme for getting contributions locally for tha building. 'The paper says:

"In view of questions that have come up recently, members of the publicity committee have asked that mention be made here of the fact that the Legion is obligated to strict nertrality on all questions concerning religion, politics and industrial strife. This is a part of the national constitution. Furthermore, the state convention of Nevada has amended the constitution of this department to specify that any post in Nevada which may enter into a labor dispute in any way shall lose its charter." This is the usual stuff about "the constitution." But the fact remains that the Legion has actively led in scabbing and strike-breaking in countless strikes, that it leads the lynching and clubbing gangs against workers everywhere, and -of course-covers its violation of its own constitution with gabble about "upholding law and order."

It will do the same in Nevada, and if taken to task for it, will use the alibi that those Legion members who scab and break strikes and beat up union organizers, "acted as individuals" and the "post" was not "officially involved"-so the constitution is upheld, the strikes are broken, and the Legion's reputation is spotless.

But let some Legion post composed of workers. work for the election of a Communist candidate: oh, then, of course, it would be "violating the constitution" and would have to be expelled.
