The Building "Boom" Bubble

Only three days ago the well-oiled Roosevelt propaganda machinery began to issue again large clouds of prosperity ballyhoo. This time it was the supposed 128 per cent increase in building which was hailed as the ever-elusive "turn" in the crisis of capitalism.

In the "Daily" of two days ago we showed how the very figures upon which the Roosevelt ballyhoo is based, give the lie to the cheery talk of returning prosperity.

Now a leading capitalist statistician, A. L. Jackson, Vice-President of Economics Statistics, Inc., states that figures for May have been subject to "erroneous interpretation". He points out that more than 75 per cent of the so-called increase was due to an increase in the estimated costs of certain public works in San Francisco, not to any real increase in the construction of actual residential or commercial building.

And the official Department of Commerce figures, showing an actual decrease of 16 per cent in actual building construction for the month of May, expose what a shabby distortion of the truth are the prosperity stories of Roosevelt's publicity agents.

Why Moley Speeds to London

WHAT is behind the sudden dash of the leading lobe of the "brain" trust, Raymond Moley, assistant secretary of state to direct the American delegation at the London Conference? How does it come about that Bernard Baruch, the liaison officer between the House of Morgan and the Wilson regime, this astute imperialist banker who helped create \$3,000 war multi-millionaires, not overlooking himself, at the same time becomes the "unofficial president" of the United States.

Events had reached such a pass at the conference, its rupture appeared so imminent, the clash between the various big powers so clear especially between the United States and Britain, behind which, with their own contradictions stand France, Italy and the other European powers) that it became necessary to send Roosevelt's main whip to lash out the fundamental program of Wall Street in the present struggle.

The hub of the controversy is the struggle for world markets by the imperialist powers gathered at London. Around the discussion of stabilization of currency goes on the struggle for markets. The financial structure of world capitalism has been broken down and distorted by the crisis. The currency stabilization struggle at the conference touches the central nerve of the whole neurotic structure of world capitalism and resulted in the jitters that crept over the American delegation. Each power wants to stabilize the others currency at a disadvantage to its competitor in the struggle for markets, and at an advantage to itself. It is similar, and a counter-part to the struggle around armaments. Each capitalist power wants to reduce the armaments of its competitor while aiming to greater advantage itself.

With the American program of inflation, forced trustification, and the concerted drive for world markets, the European powers know it is useless even to enter the second stage of conflict and dickering around tariffs. So long as England maintains its present level of currency (though it is already off the gold standard), and so long as France, Belgium, Switzerland, Holland retain a gold currency, no matter what the tariffs, the power given to Roosevelt to continue inflation would completely undermine any agreements, even if any were arrived at.

But through its policy of inflation it could cut tariffs, and with the lower prices it would gain on the world market, and with Roosevelt's dictatorial power constantly to lower these world prices, it could smash through any tariff arrangement.

The struggle for world markets which was intensified as a result of the crisis, is made a thousand-fold more bitter with the wrecking of the currency stabilization of world capitalism. Each struggles for the greatest advantage, and Moley is rushing into the breach because the clash has become so heightened.

The policy of American imperialism is not to relinquish its present advantage of inflation, with the future promising more for two main reasons. First it is not in the interest of Wall Street internal program of a smashing attack against the workers' living standards and second, it is not in line with its international program in the drive for world markets.

Though Moley may be speeding across the Atlantic, and Roosevelt may be pleasantly tacking the Amberjack II, the policy of Wall Street has already been clearly written down by the present delegation. It is that stabilization has no place at the conference, except as a bargaining point. "The fact is," said the latest statement of the delegation, "this was never the concern of the delegation." This is just an attempt to cover the fact that they were caught napping and had made some concessions on stabilization which Woodin, Roosevelt, Baruch and Moley were forced to spike and which accounted for Moley's departure.

The line that Moley will follow is officially stated to be that "The American government feels that its efforts to raise prices are the most important contribution it can make, and that anything that would interfere with those efforts and possibly cause a violent price recession would harm the conference."

That spells war at home, sharper class war against the American workers, and the drive to war among the imperialists for markets, colonies, international financial dominance.

"Not Considered Essential"

In their demagogic support of the Roosevelt attack on the standards of life of the masses embodied in the "Industrial Recovery" act the officials of the American Federation of Labor told us that the principle of collective bargaining would be established everywhere. Now comes the military satrap and open shop employer, Hugh S. Johnson, administrator of the act, who gives the lie to this claim. In the "basic code" for all industries Johnson says:

"Basic codes containing provisions respecting maximum hours of labor, minimum rates of pay and other conditions of employment, which are in themselves satisfactory, will be subject to approval, although such conditions may not have been arrived at by collective bargaining."

Thus the demagogic about collective bargaining gives way to the practical proposals that eliminate even the pretense to collective bargaining.

AMERICAN DELEGATION IN DECLARATION OF TRADE WAR FOR WORLD MARKETS

London Conference Told No Attempt Will Be Made to Peg the Dollar in Near Future

Franc Breaks on New York Market at News that France Will Immediately Go Off Gold Standard

NEW YORK, June 23.—Unconfirmed reports that France was planning immediate abandonment of the gold standard brought a deluge of selling as the stock exchange closed today. The dollar was weakened all day in relation to other currencies, although the fall in the franc caused the dollar to turn upward from the earlier low in relation to that currency.

LONDON, June 23.—An open declaration of a trade war on a scale unequalled in the world struggle for markets was made by the American delegation at the world economic conference today. The American delegation acted on coded instructions received from the United States. Immediately after receiving the message from Roosevelt they went into session, meeting far into the night to formulate their proposals.

The statement bluntly stated that "stabilization was never an affair of the delegation" and that any attempt to peg currency at a given level was "untimely."

Continuing the statement said: "The reason why it is considered untimely is because the American government feels that its efforts to raise prices are the most important contribution it can make and that anything that would interfere with those efforts and possibly cause a violent price recession would harm the conference more than the lack of an immediate agreement for temporary stabilization."

This is clearly seen as continuation of the policy of the Roosevelt administration of raising prices at home, and beating down the dollar in relation to other currencies so it can dump its surpluses on the world market at cut-throat prices.

That the journey of Professor Raymond T. Moley, personal representative of President Roosevelt, is to further carry forward this defiant challenge of American imperialism, is now clear to all.

A.F.L. Joins "Prosperity" Drive With Fake Figures

Federation Leaders Support Roosevelt Act in Fight Against Unemployment Insurance; Assist War Preparations

With eager loyalty the labor bureaucrats of the A. F. of L. are rushing to the aid of the imperialist Roosevelt government in its attempt to fasten upon the American working class the shackles of the "National Industry Recovery Bill."

They have just issued a widely-publicized statement asserting that since March, the month of Roosevelt's inauguration, over 1,629,000 workers have found jobs. They state that the steady and continuous growth in the army of unemployed during the last four years has at last come to an end, and that workers are now beginning to return to work.

This statement is timed to appear at the very moment when the employers are organizing monopoly groups to cut down employment by speed-up, to slash wages under the guise of minimum wage contracts, and to stagger employment by the introduction of the 30-hour week. It is timed to give the illusion of fast returning prosperity so as to quiet the resistance of the workers to the latest attack on their living standards.


Deliberately Distorted But what is actually happening? Is the steadily rising ocean of unemployment beginning to recede?

In the first place, the figures of the A. F. of L. have always been notoriously biased in favor of the bosses. Whenever possible, the statisticians of the A. F. of L. have always tried to support the position of the employers. A notorious example is in the matter of unemployment figures.

At a time when the most conservative of capitalist statisticians admitted the existence of at least 17,000,000 unemployed workers, at a time when the 17,000,000 estimate of the Labor Research Association was confirmed by a leading capitalist economic organization the Alexander Hamilton Institute, the A. F. of L. came to the support of the Hoover and Roosevelt governments by insisting that there were only 12,000,000 unemployed.

The latest report of the A. F. of L. faithfully continues this policy of assisting the capitalist government and the bosses against the workers.

U. S. Workers Fulfill Anti-Fascist Pledge to Zetkin Tomorrow

Demonstrations Throughout the Nation on June 24 Against German Fascism

NEW YORK, June 23.—As the ashes of Clara Zetkin, veteran leader of the German Communist Party, are borne to Red Square in Moscow, the workers of the United States, pledging to continue the class struggle to which she devoted her life, are preparing for a giant nation-wide anti-fascist demonstration tomorrow, June 24, National Anti-Fascist Day.

The Trade Union Unity League has issued a manifesto signed by William Z. Foster, calling on all revolutionary unions and opposition union groups to support to their utmost the campaign launched by the National Committee to Aid the Victims of German Fascism, and to unite in participation in the demonstrations tomorrow against German Fascism.

The huge New York demonstration in Union Square, preceded by a march from Madison Square at 12 noon, the rallying point of the anti-fascist organizations, will be addressed by Robert Minor for the Communist Party, Erna Stans for the German United Front, Ben Gold for the Needle Trades Workers Industrial Union, A. J. Muste for the C. P. U. S. A., and other prominent speakers. A Wagenknecht, of the National Committee to Aid the Victims of German Fascism will be chairman of the mass meeting.

RULING BY JUDGE SHOWS COLLAPSE OF FRAME-UP AGAINST NEGRO YOUTHS

"Victoria Price Evidence Not Corroborated," Is Basis of Horton's Decision

Mass Fight Compels Judge to Reverse Former Decision; Labor Defense Hails Victory

I. L. D. Calls for Broader Protest Movement to Force Release of 9 Framed Boys

DECATUR, Alabama, June 22.—Judge James H. Horton, who on April 17 sentenced to death Haywood Patterson, first of the framed-up Scottsboro boys to be retried, today granted a new trial for the Negro boy on the ground that his second conviction was based on "insufficient evidence". Patterson was not brought from the Jefferson County jail in Birmingham to be present at the hearing.

Horton read from a prepared document, in which he said that "No defendant should be convicted in a prosecution for assault when the evidence of the prosecutrix bears evidence of unreliability. Under the circumstances it was necessary to have corroboration of Victoria Price's testimony, and there was no such corroboration. Her testimony was in almost square conflict with that of the examining doctors of Scottsboro."

The decision was rendered after George W. Chamlee of Chattanooga, chief Scottsboro defense counsel, and Osmund K. Franke of New York, appeared in court to demand a new trial for Patterson.

That this tremendous victory in forcing the setting aside of the verdict and the ordering of a new trial for Haywood Patterson is a direct consequence of the I. L. D. expose of this hideous frame-up, is proven by the fact that when the jury brought in the verdict against Patterson, Judge Horton refused the defense motion to dismiss the case.

Judge Horton did not set the date for the new trial. Just when this new trial will be ordered, in view of the admitted collapse of the prosecution case as evidenced by Judge Horton's decision, is not known.

With the nine Scottsboro boys confined in a cage in the Jefferson County prison in Birmingham, there is a strong likelihood of the authorities following a policy of dragging out the proceedings indefinitely.

Immediately following the decision in the Haywood Patterson case, the authorities announced that the hearings in Juvenile Court of Eugene Williams and Roy Wright, which were to have been held tomorrow, have been indefinitely postponed.

RECOGNIZE USSR SAYS U. S. ENVOY

NEW YORK, June 22.—Alexander Pope, President Roosevelt's special emissary to the Soviet Union, returned to the United States today and said that he would strongly recommend that the President immediately appoint an American envoy in Moscow with status similar to that of Boris Skvirsky, unofficial Soviet representative in Washington. Pope added that if certain conditions were fulfilled, he would urge that the United States officially recognize the Soviet Union within a year.

SOVIET AIRMEN TO HUNT FLYER
MOSCOW, June 22.—M. Sheveloff, chief of the air service of the Soviet Union, has wired the Soviet government's station on Chukot Peninsula, near Alaska, to get in touch with American wireless stations in a combined effort to search for James Mattern, missing round-the-world flyer.

Mattern has not been heard of since his second take-off from Khabarovsk, Siberia, last Wednesday.

GREEN JUGGLES JOBLESS FIGURES TO HIDE WORKERS' CONDITIONS

Unemployed Councils Statement Exposes Green's Lies; Calls to Intensify Nationwide Struggles for Unemployment Insurance.

"To put across the ballyhoo of the Roosevelt government and to help the bosses foist the industrial 'recovery law on the workers," says a statement of the National Committee Unemployed Councils, "William Green, president of the A. F. of L., is resorting to the tricks of the Hoover government, which fired Ethelbert Stuart for exposing the Hoover figures on unemployment.

"Green states that 1,629,000 workers have returned to work in the months of April and May." This is an unmitigated LIE. According to reports of the Department of Labor (which are not too reliable and are deliberately falsified, as the case of Stuart proves), there were employment increases of 1.6 per cent in April and 4.8 per cent in May. According to Green there were 13,359,000 unemployed in the United States in March. (This figure is far underestimated, for the Alexander Hamilton Institute, a very conservative institute, declares that there were 17,000,000 unemployed in the country in March.) However, taking Green's figure, we find an employment increase of 213,744 in April and of 629,970 in May. This makes a total of 843,714.

"This is not due to the 'new deal,' by any means. Green includes in this the military forced labor camps for the youth. Green also states nothing about seasonal increases, which, according to the Department of Labor amounted to 48 per cent in canning and preserving, 13 per cent in dyeing and cleaning, ten per cent in building construction, etc.

"Green would evidently include also the people who are sent 'wood for a hand out.' Perhaps he even includes people on the chain gang, working off their sentences.

"Obviously, however, Green and the officialdom of the American Federation of Labor, have attached themselves to the propagandist machine of the Roosevelt ballyhoo government, so as to allow the issue of Social and Unemployment Insurance to be forgotten.

"The industrial 'recovery' bill will reduce the living standards of the workers to a level not experienced by this generation of workers in the United States. It will leave millions of workers unemployed. The fight for the right to live continues. The rank and file of the A. F. of L. and independent unions will join with the militant organized and unorganized workers, represented by the Trade Union Unity League in fighting against the shameful deceiving provisions of the 'recovery' bill; and together with the masses of unemployed workers of this country led by the Unemployed Councils, will fight for Social and Unemployment Insurance at the expense of the employers and the Roosevelt-Wall Street government."

Herndon in Prison Has Faith Workers Will Set Him Free

Negro Youth Suffering As Result of Bad Food; Asks Workers to Send Him Books to Read

By HANK FULLER
ATLANTA, Ga.—Suffering from the effects of the restricted diet allowed men coped up in Fulton Tower and from the year's confinement to which he has been subjected, Angelo Herndon, 19-year-old leader of Negro and white unemployed, peers at you through his glasses today and talks of the coming freedom of the South.

Herndon, the bosses maintain, is a dangerous criminal. He is, they insist, not at all the quiet, studious boy who sits talking with the interviewer in Fulton Tower. He is not the emaciated, tired, obviously worn youth who shows the strain of unhealthy diet and foul air. He is not a victim of a dilapidated plumbing system which continually allows excrement to dribble into the stinging rivulets across the floor cells, the "law" would have you believe.

"What is happening in the cell, the movement? Are there new developments in the relief situation? How is the Scottsboro case coming on? What are the German workers doing to fight Fascism in Germany? What will be the next step in the Mooney case? Have more Negro farmers been murdered?"

These are the questions which Herndon asks. These things make up his life today, just as they did a year ago, when he committed the "crime" of being a Negro worker who understood the need of militant action to force the bosses to continue giving something for the relief of the unemployed white and Negro workers. Because he was these things, he led an unemployed demonstration. And, because he led an orderly demonstration which broke no law, though it did break the tradition of racial hatred established by the white bosses, he has been sent into the living death of Fulton Tower.

Looks Toward Future
Today Angelo Herndon looks toward the future. The state of Georgia maintains he is a desperate character, not fit to be allowed his liberty on bail. This attitude does not surprise the man Angelo Herndon. Nor does it surprise those who are familiar with the case. They know, as he knows, that Eugene Talmage, John Boykin and the rest of the official gang responsible for the continued martyrdom of Herndon, are hiding behind the filaments of legalistic technicalities when they deny him freedom on bail. They know, as he knows, that only in-

creased protests and stronger demands on the part of the masses of workers will enforce his right to bail while the case is being fought. They question, as he questions, the continued illness of the judge which has repeatedly postponed court action looking towards a new trial.

"Well," says Herndon, as his visitor turns to go, "I know I'm coming out. I know the things the law is doing to me right now make that certain. You see, the workers of Georgia, both white and Negro, won't stand for this sort of thing. They know what I actually did. They know their own hunger and misery. They know my case and their own cases are all a part of the big fight for food and shelter for the starving workers who produce all food and shelter. Through their organization and their protest, both white and Negro, employed and unemployed, they will better their own conditions and they will free me."

There is conviction in the quiet tone of the young man. His slender shoulders, bowed by years of hard labor in a coal mine when he was a mere child, straighten. "No," he says, "the workers won't forget me. Goodbye. And tell them to keep fighting."

He calls after the visitor: "Say, send me some books if you can. Be sure to remember the pamphlets. I want to know what is happening in the fight outside while the bosses have me copped up here."

The grated door swings shut. Outside is streaming the free Georgia sun. Inside, behind his thick glasses, Angelo Herndon is following the fight for food which he has led and will lead again.

NEW TRIAL FOR SCOTTSBORO BOY

(CONTINUED FROM PAGE ONE)

Ala., granting a new trial to Haywood Patterson, one of the nine innocent Scottsboro boys, brings out more clearly than ever before the power of mass protest from Negro and white workers backing legal moves. William L. Patterson, national secretary of the International Labor Defense, said yesterday. "The decision is a complete repudiation of Judge Horton's own statement, made after the retrial of Haywood Patterson, that he was postponing the retrials of the other boys because of remarks attributed to Attorney Samuel S. Leibowitz, who defended Patterson.

Exposes Frame-Up

"It exposes the fact that the Alabama prosecutors of the boys simply had no evidence to offer in their attempt to send these boys to their deaths on framed-up charges.

"The decision also is evidence of the splendid example of the courage of the white people in fighting on behalf of the boys as exemplified in the stand of Ruby Bates and Lester Carter, whose testimony laid the basis for the tremendous victory in Athens, as well as of the colored workers who united with the whites in the struggle and the world-wide protests.

Result of Protest

"The tremendous mass protest developed by the I. L. D. drew to the attention of Ruby Bates, formerly star witness of the prosecution, and Lester Carter the underlying issues of Negro national rights, including that of serving on juries and the abolishment of Jim-Crowism which were involved in the Scottsboro frame-up."

Although hailing the decision as a great victory for the I. L. D. and the mass protest movement initiated by hundreds of thousands of persons throughout the world, Patterson warned that only an even more powerful such movement would finally attain the release of all the boys.

"This victory must also give greater support to the fight to free Tom Mooney," he said, "who is another one of the victims of the ruling class frame-up."

The I. L. D. secretary called for resolutions demanding the immediate dismissal of the cases, and safe release for the nine Scottsboro boys, wires to be sent to Gov. B. M. Miller, Montgomery, Ala. He also called for the broadest united front for the liberation of the Scottsboro boys and Mooney, appealing to all workers, Negro and white, in trade unions, churches, as well as liberal and fraternal organizations.

Funds are urgently needed, Patterson urged, to carry on the fight for the release of the Scottsboro boys, pointing out that despite the decision of Judge Horton, many legal and other moves remain to be made before the freedom of the boys is achieved.

"We ask all workers and other sympathizers to help with immediate contributions, so we can carry the fight to complete victory. These contributions should be sent to the National International Labor Defense headquarters, at 80 East 11th Street, New York City," Patterson said.

industries. But not only have these re-hirings not even touched the main army of unemployed, but the new jobs are of an extremely temporary and seasonal character. In the steel industry, it is openly admitted by even the most reactionary newspapers, such as the Wall Street Journal, that the present activity is based solely on the expectation of rising prices, and not on any real demand for steel. Since there is not the slightest sign of any basic demand for steel from the railroads and the building trades, the steel "boom" is doomed to certain collapse as soon as the inflationary stamp begins to weaken in its force. And all the workers recently rehired will be inevitably thrown into the streets.

In the rayon industry, in the steel industry, in the chemical industry, there has been a steady increase in the placing of war orders. The Winchester Rifle Company recently hired several hundred workers for day and night shifts at starvation wages. The feverish preparation for war

Starlight Affair Sunday for Marine Convention Funds

NEW YORK—Recent months have seen the first strike and other struggles aboard ships in nearly a dozen years. These strikes have been led by the Marine Workers' Industrial Union. Only last week a strike on a Munson liner, led by the union, compelled the hiring of a mess boy, thus defeating the attempt to make the seamen do extra work.

He will also deal with the war plans of the imperialist powers. Browder will speak in the evening. Previous to this, starting at 3 p.m., there will be a big sports program—track events, baseball and soccer games, mass drills, etc., participated in by many labor sports groups.

At night there will be a great musical concert by all the workers' choruses, the Freiheit, Ukrainian and other singing societies. There will also be a concert of classical and revolutionary music by the Workers' International Relief Band. Another feature will be a program by the Workers' Dance League—an anti-war dance sketch.

Plenty of Money for Wines for the Rich, But Poor Go Without Water

NEW YORK CITY.—Reading in the New York Times on June 8 the story of all the favorite drinks of the London Constatians, reminds me of conditions in Rumania. The Consul from that country specified that they want wines from Nicotri and Dragsani, Tsucia from prunes, Drojida from grapes, Scavica from rye, and Rachin from potatoes.

Now these are all good brands, but is this news that requires front-page space in the "Times"? Will the "Times," after reading this letter of mine, publish on the front page that the Rumanian population in certain cities are suffering from a shortage of drinking water in the hot summer days? I recently revisited Rumania, the country where I was born, and you could get water from the faucet only twice a day, for a couple of hours and at a specified time. My statement could be backed up by their own correspondent providing he would care to consider this news. I noticed this shortage of water especially in the city of Galatz, located on the Danube River, with a population of 80,000. From the taxes squeezed out of the poor population, there is plenty of money to keep up the army and a whole retinue of officers, prince, princess, and expensive palaces. There is plenty of money for their favorite drinks for their third delegates to the Conference. But there is not one cent for expanding a water plant, so the poor population can get a drink of water. The rich, of course, are always provided by their cool wine cellars with all kinds of delicious beverages.

Grocery Store Strike

NEW YORK.—A strike at the Dobkins Fruit Store, 235 Schenectady Avenue, Brooklyn, was called to demand reduction of hours and increase in wages. The worker employed here is compelled to work 102 hours a week, 7 days for \$17 a week. Two grocery stores are on strike at 44 Hester Street, Manhattan, and 47 Suiter Ave., Brooklyn. The workers were locked-out when they refused to take a cut in wages.

N. Y. TRADE UNION NEWS FUR UNION SETTLES 40 ASSOCIATED SHOPS

Strict Measures Are To Be Taken To Enforce Agreement; Jack Schneider Arrested

NEW YORK.—New developments on the fur front where the furriers are involved in a bitter struggle against the bosses and their A. F. of L. scab agents, indicate clearly that victory will be achieved and the pogrom bands will be defeated.

Forty-six firms, among which are the most important members of the Associated, have settled with the union. About 40 more of the large firms are still on strike. The bosses are becoming more and more desperate as a result of the failure to force the furriers to register with the scab council. The following developments took place during the last few days: In the fur market the police and detectives have seized a Greek furrier, member of the Industrial Union and without any reason have beaten him severely.

Arrest Schneider Yesterday afternoon detectives swooped down on the office of the Industrial Union and placed Jack Schneider under arrest on the framing of charge of felonious assault. He was taken out of a shop meeting which he was addressing.

A number of scabs appeared at the office of the Joint Scab Council claiming that they are being thrown out of the places where they were sent to scab and that the manufacturers are settling with the Industrial Union. At the same time they disclosed the fact that although they were scabbing, they were underpaid and not even given the scale of wages.

At a meeting of the fur trade board last night it was pointed out that a number of manufacturers are utilizing the present situation prevailing in the trade to violate their agreement with the union and not maintaining conditions. The trade board decided to take strict measures and see that the agreement for a minimum wage scale, the 40-hour 5-day week with no overtime, and unemployment insurance is being enforced. A special committee was elected for this purpose and it was also decided, if necessary, to increase the staff of organizers in order not to permit such violations. The trade board has also decided that the fur department enforce no work on Saturdays and to organize a committee of active members that will be in the market on Saturday morning and see that this is carried out.

Today, Friday, 2 p.m. there will be a special meeting of all strikers in the auditorium of the union, 131 W. 38th St., 2nd floor, where the report on settlements and further activities will be given. Hearing on the suit against the industrial union for the bus and the F.L. against the Union is coming up today at 10 a.m., in part one, Supreme Court, before Judge Shientag.

500 WIN 4-DAY METAL STRIKE

NEW YORK.—Five hundred workers won their four-day strike and succeeded in ousting the two "efficiency" experts employed by the Closure Co., metal bottle cap manufacturers, in Long Island City. When the efficiency experts started to use the stop watch system and arranged a new wage scale which would slash their wages drastically, the 500 workers went out on strike leaving only 71 minor employees working. After picketing for 4 days and holding a demonstration on Star Square in Long Island City the boss of the company threw out the efficiency experts.

Government Cuts Pay at Marine Hospital

NEW YORK.—Workers at the Marine Hospital at Stapleton, Staten Island, are being forced to work five days a month without pay and to be two days off, by the latest announcement of the government is that a new cut of 3.4 per cent will be imposed in addition to the 15 per cent cut which the workers received on May 1st. The latest cut is to apply to all federal employees and is to go into effect on July 1st.

The workers at the Marine Hospital are indignant at being forced to take a cut on top of losing 7 days pay a month. The Federal Employees Union has taken no action on this cut.

Increase Quotas for Labor Camps, Lie About Conditions

Camp Officials Say "Conditions Good, Plenty of Food"

WASHINGTON, June 22.—The forced labor army will reach the number of 314,000 by the end of the month and will be three times the size of the regular army. Already it has reached a strength of 237,984 men.

The quota of 240,000 is now increased and will probably reach another 100,000.

So far the government effort to recruit the veterans for the camps has met with little success. Only 2,800 of the quota of 25,000 joined. Indians from the reservations who join the camps are kept segregated. The government is desirous of keeping them away from the influence of other workers, so as to keep them from organizing together.

Officials in charge of the camps say that the food served to the recruits is good and the men get "all they can eat." That this is a false statement is seen by numerous letters from boys in the camp printed in the Daily Worker frequently.

JOBLESS STRIKE AGAINST FORCED LABOR, ELKHART

700 at Strike Meet; Exhibit Rotten Food Given Out As Relief

ELKHART, Ind., June 22.—Seven hundred workers turned out for a mass meeting to hear the report of the strike committee. The strikers' ranks are solid against forced labor. At the meeting an exhibit of the rotten food given to the jobless on forced labor jobs was exhibited. Pieces of rotten bacon were shown by workers as samples of the food given them.

Officials are refusing relief as a means of breaking the strike. When 20 representatives of the strikers went to the trustees' office for food they found that it was suddenly locked. At the offices of the United Charities they were also refused any consideration. The committee informed the officials "we will remain here until relief is issued." At five o'clock the officials called the police and 13 of the committee were arrested. When the strike committee called on those present at the mass meeting to appear at the hearing the next morning, the city official immediately released them. They were told "not to come back until we send for you." But the same committee will return today with the demand for relief.

75 Metal Workers Strike Against Wage Cut in Radio Plant

NEW YORK.—75 workers in the cub department of the Dubilier Condenser (Radio) Plant in Brooklyn went on strike on Wednesday after the company had refused to meet the workers' demands to withdraw a wage cut.

A committee of the Steel and Metal Workers' Industrial Union held a meeting with the workers. Learning of this, the superintendent announced to the workers that the cut had been withdrawn. The action was due to fear on the part of the company that the strike would spread and that the workers would turn the strike into a struggle for higher wages.

The Steel and Metal Workers' Industrial Union calls upon the workers to organize committees in every department elected by the workers and pledges its assistance to prepare a real united struggle for better conditions.

Letters from Camps to Daily Worker Show Officials Lie

The men in the Civilian Conservation Corps received good food "and all they can eat," according to Washington officials. The capitalist press immediately picked up these remarks and painted the glories in the camps. Numerous letters printed in the Daily Worker from recruits in the camps prove the official statements as false. We print here from letters received today by the Daily.

From Camp 670, Michigan (a Jim-crow camp for Negroes): "The way the boys stick together up here is something marvelous. For instance, one day we were all at work. And trucks brought us our dinner... two loaves sandwiches and black coffee. And come to find the sandwiches maggots in them."

Glenns Camp in Michigan: "Worked in water up to and past our knees, without being furnished rubber boots as a safeguard. And dinner at noon time consisted of a can of beans for two, half-cooked rice with a substitute for milk. Breakfast was made up of some artificial or concentrated milk mixed with 5 gallons of water and some cereal."

Chillicothe, Ohio: "Our eats are seldom right. When there is enough to eat, it is not seasoned, so your stomach is full. It will even ache, but you are still hungry. We wash, cook, drink and swim in the same water (water for cooking and drinking is supposed to be sterilized), which only gives it a worse taste than natural."

John D. Jr. and President's Kin Want Own Taxes Cut

NEW YORK.—John D. Rockefeller, Jr., asked for an \$800,000 reduction in the assessed valuation of his Van Tassel apartment group, now assessed at \$1,500,000. Roosevelt's son-in-law, Curtis B. Dall, wants a reduction from \$34,000 to \$32,000 on the assessed value of his property.

These living in the secluded residential section of Tarrytown, N. Y., have asked reduction of 40 per cent on their personal property, totalling over \$2,000,000.

Commodore Strike Is Now in Fourth Week

The strike of 80 workers in three departments at the Hotel Commodore under the leadership of the Food Workers Industrial Union is now in the fourth week. The strike committee is intensifying its drive for relief for the strikers. STRIKE WON IN AUTO BODY PLANT

Cleveland Workers Force Pay Increase, Build Union

CLEVELAND, Ohio, June 22.—Two hundred workers at the Bender Body Co. won an important partial victory after a four-day strike here, when the company was forced to concede a 10 to 15 per cent increase in wages, a 48-hour week, fixed rates of pay, and pay for time spent by foremen to prepare the work. The boss agreed to deal with the shop committee on any grievances that may occur.

A union was formed inside the plant, which two-thirds of the workers joined. The strike is the first in ten years in this company. Many of the workers did not feel sufficiently confident to hold out for the full demands and returned to work on Monday.

The strike committee then decided to compromise on the original demands which were for a 33 per cent increase and a 44-hour week, which might have been won. After the organization in the shop becomes strengthened, the workers intend to fight to raise their wages to meet the increased cost of living.

A good spirit prevailed among the strikers, who agreed to accept the partial victory and return to work.

REPUBLICANS LOSE JOBS

NEW YORK, June 22.—Five deputy marshals and four bailiffs, all republicans, were dropped from the government payrolls by United States Marshal Fred Pulver, who said he was acting upon instructions from Washington. All who lost their jobs are republicans. The Roosevelt administration will give all such jobs to loyal Tammany lackeys on the old theory "to the victor goes the spoils."

LEHMAN INSPECTS CAMPS

ALBANY, N. Y., June 22.—An inspection of the forced labor camps in New York state will be made by Governor Lehman. The governor is leaving for his summer home at Lake George, where two of the camps are located nearby.

CLARA ZETKIN'S BURIAL SHOWS ANTI-FASCIST SOLIDARITY OF U. S. S. R.

Her Life a Flaming Symbol of Proletarian Revolution

Answers Lying Charge That U. S. S. R. Aids Hitler Dictatorship

MOSCOW, June 22.—The burial of Clara Zetkin's ashes in the Kremlin wall on Red Square, the signal for a great demonstration of the Soviet workers, symbolizes the answer of the Soviet Union to the lying charge that the U.S.S.R. is aiding the Hitler regime in Germany.

Clara Zetkin, though dead, has become the symbol of Soviet solidarity with the German proletariat, of the Soviet workers' loyalty to the heroic anti-fascist fight of the German working class which Clara Zetkin personified.

Despite the rigid Nazi censorship, the Zetkin funeral demonstration in Moscow will filter through the ears of the German workers, encouraging them to continue and widen their resolute struggle against the Hitler dictatorship.

Clara Zetkin was active in the anti-fascist struggle to the day of her death. The day before she died she was dictating an article attacking the Second International and the Socialist leadership as chiefly responsible for the success of the Fascists in Germany. Clara Zetkin's memory will live on, inspiring the workers of Germany and the whole world to continue their battle for the victory of the proletarian revolution.

NEW YORK, June 22.—Yesterday the Jewish "Forward" Socialist daily, printed a scurrilous editorial on the death of Clara Zetkin, in which it said: "After the war she joined the Communists and thus really ended her career in the German labor movement. . . . The speech which she delivered in the Reichstag (demanding the impeachment of Hindenburg and calling upon the workers to establish the Soviet Republic of Germany—Ed. D. W.) made a most painful impression on all her old friends."



PEASANTS ON TAX STRIKE IN POLAND

10 Killed in Clash With Police, 28 Hurt, Over 100 Arrested

WARSAW, Poland, June 22.—Nine peasants and one gendarme were killed, and 23 peasants and five policemen injured, when the police clashed with peasants on a tax strike in Grabini and other villages not far from Cracow, ancient capital of Poland.

The peasants, under Communist leadership, refused to pay taxes, and forced their way into forests belonging to big landowners to obtain the lumber they were too poor to buy. The police, summoned by the landlords and the tax collectors, fired upon the peasants when they refused to disperse, but the peasants stood their ground and fought back heroically.

More than 100 peasants have already been arrested by police reinforcements summoned from neighboring cities, and more are being arrested daily, according to an official government statement, which admits having suppressed news of the peasant uprising until now.

ARICA MADE FREE PORT BY CHILE

BUENOS AIRES, Argentina, June 21.—The Chilean Government announced yesterday that the port of Arica, Pacific outlet of the railway to La Paz, capital of Bolivia, will soon become a free port. This action effectively nullifies the Argentine restriction imposed embargo on Bolivian imports, and reflects the growing influence of American finance capital in Chile (the recent nitrate agreement between the Guggenheims and the Chilean government, etc.).

Brazil is reported to have offered its mediation in the Paraguay-Bolivia Chaco-war, which Paraguay is said to have accepted eagerly, but Bolivia has rejected the offer. This is due to the fact that Brazil is one of the pro-British nations of South America, as is Paraguay, while Bolivia is one of the countries controlled by American imperialism.

It is very little in comparison with the life and blood that is being sacrificed every day by the revolutionary workers in their heroic struggle against fascism. None of us should rest in peace until fascism, with its awful consequences of bloody oppression, terror, hunger and war, will be conquered and destroyed.

ROOSEVELT FINANCES NANKING GOVERNMENT

Lends \$50,000,000 to Aid Campaign Against Chinese Soviets While He Refuses Relief for Starving Millions in United States

Recently, the Reconstruction Finance Corporation announced the extension, with Roosevelt's approval, of a credit of \$50,000,000 to the National Government of China to purchase American cotton and wheat in the open market. It is claimed that this is done to "reduce" the surplus stocks of wheat and cotton. But even the bourgeois press says this won't help much since China is going to buy only 10 to 15 million bushels of wheat and one million bales of cotton out of a present surplus of 300,000,000 and 13,000,000 respectively of each.

The New York Evening Journal, a Hearst paper, in an editorial on June 14, entitled "Millions for China, but not a Cent for New York," assailed this loan bitterly, saying China "is as bankrupt as any nation could be"; she has "no responsible government, and the chances of its ever paying back is about 1,000 to 1," etc. This Hearst paper, is attacking the loan in order to stir up jingoistic sentiment and at the same time pretend to be the friend of the unemployed. Nevertheless, it makes the workers and farmers, especially the unemployed and their family, think in one respect—"Hoover and the Roosevelt administrations gave \$1,875,116,624 of R.F.C. funds to bankers, railroads, and insurance companies. The latter gives sanction to R.F.C. to advance \$50,000,000 to China, despite little chance of its being paid back as a loan. Yet this same government won't do anything to aid millions of American workers, farmers and their families who go hungry and unclothed. Why?"

Let us consider first Nanking's purpose in getting this loan. We will understand it better then.

"Where Nanking Wishes to Place Them?" George G. Anderson, of the New York Herald-Tribune, let the cat out of the bag when he wrote the following: "After referring to this loan as a 'savior' for 'rehabilitation of China' (Kuo-min-tang China, of course—R.K.), he says: 'The gov-

ernment at Nanking is not in the wheat or flour business, nor is it operating cotton mills. Its purchases in this country will be promptly sold to the operators of flour and cotton mills (this aiding Chinese capitalists—R.K.) and the proceeds, less amortization and interest payments, will go where the Nanking government wishes to place them."

Now, workers and farmers of America, know very well from previous experience, for example, the 1930 Federal Farm Board sale of 15,000,000 bushels of wheat in Nanking, where Nanking wishes to place them, i.e., as Anderson says, sell them. Towards anti-Communist campaign expenses, to be sure! Besides, that part unsold will be used to feed and clothe Chiang's army.

For the past few years, the position of Nanking has been very precarious. The successes of the Red Army under the leadership of the Chinese Communist Party was a constant threat. Four times, Chiang's anti-Communist "punitive expedition" indignantly failed at the hands of the Red Army. The fifth, which is now going on, at the expense of effective resistance to Japanese invaders, and with German advisers and American munitions, airplanes, etc., is also doomed to a similar failure. Even the great city of Hankow was not so long ago in danger. Something must be done. To "free itself" of outside "worries," so that it can concentrate upon the inside enemy, Nanking was willing to con-

clude, despite mass indignation, a "truce" with Japanese invaders. And it did. But for a real anti-Red campaign, the army must be fed, clothed and well equipped. Yet the Nanking Treasury, due to official plunder and heavy anti-Red campaign expenses in the past, is empty.

Nanking—An American Lackey. American imperialism has maintained its influence in China chiefly through its Chinese lackey, the Nanking government. The Nanking government, however, besides being threatened by the rising tide of Soviet revolution, is challenged by the rival government at Canton, which has British support, and now is intruded upon by various doubtful figures, such as Pan Fu, generalissimo, and other heavy anti-Red campaign expenses in the past, is empty.

On top of all this, the failure to properly defend the country from Japanese invaders who carried out a total slice from Chinese territory, increased dissatisfaction of the masses against Nanking. So, the United States is very anxious to help Nanking in order that thru its Nanking lackey to be able to continue its struggle against Japan and in the first place against the Chinese people. "Fortunately," the Wang Ching Wei-Chiang Kai Shek-Soong clique is carrying on a campaign to build "national unity" ostensibly later to "effectively" fight against foreign invaders. By all means, they must be assisted. And here the interests of the ruling clique of Kuomintang at Nanking and U. S. imperialism meet. The loan is therefore made.

Directed Against Chinese People. The ability of Nanking to pay back the loan is not so much a concern to the U. S. imperialists. The very strengthening of its hold over China, if attained, will mean a blow against its rival imperialists, in the first place Japan and England, and far exceed the mere \$50,000,000 loan. Besides, the entire \$50,000,000 are not to be spent on the Chinese people. It is to be spent in the United States and the proceeds

and shipping of purchases are to be done by American firms and steamers. We can very well understand why Roosevelt gave sanction to this loan. It is done for the benefit of the boss class.

The announcement of this loan had immediate international repercussions. London severely criticized it, contending it "may conflict with the 1920 banking consortium, to which U. S., Britain, France and Japan were parties." The Canton government, it is reported, is "not satisfied" with the arrangement. It is "sending a special envoy to Tokyo" to have "secret deals."

In China, today, tens of millions go hungry and unclothed because of the mercenary Nanking government, incessant civil war among the rival factions, corruption, and imperialist plunder. Nanking is allowed to "buy" \$50,000,000 worth of wheat and cotton in the United States. But they are not to be used to feed and clothe these millions. They are to be used for the benefit of a handful of Nanking cliques which eventually means benefits to the handful of American bosses.

In the United States, 17 million unemployed starve. There are tens of millions of bushels and bales of surplus wheat and cotton respectively. They are to be handed over to Chiang-Kai-Shek and his henchmen 5,000 miles away, but they are not to be given to the hungry American masses. This is the logic of the bosses and we know, now, why.

The Roosevelt administration spends millions to finance the Nanking mercenary armies. The starving millions in the United States should demand that the enormous surplus of wheat, cotton and other products be used for the starving unemployed. The \$50,000,000 loan to Nanking should be turned into a relief fund for unemployed, instead of financing the wars of Nanking against the Chinese people, against the Chinese Soviet, and against the Chinese workers. The American workers should also demand the withdrawal of all U. S. troops and warships in China.

Wallace Threatens to Launch Dumping Drive

Will Raise Bread Prices to Consumers at Home to Carry on Cut-Throat Competition Abroad

CHICAGO, June 22.—Higher bread prices, hence further beating down of the standards of life of the masses at home, in order to carry on cut-throat competition in the world market—such is the program put forth by Secretary of Agriculture Henry A. Wallace in a speech yesterday before the National Millers' Federation convention.

Wallace made the brazen statement that efforts will be made to force consumers to pay the highest possible prices for bread in this country so that the American flour trust can dump wheat on the world market at less than 20 cents a bushel.

Secretary Wallace said some means had to be devised to get rid of the 350,000,000 carry-over of wheat, because there will soon be

U. S. INTERVENES TO "CALM" CUBA

Bourgeois Groups Hail Welles' Mediation

HAVANA, Cuba, June 22.—American imperialist intervention in Cuba was officially admitted today when Senator Fardo, Liberal, arose in the Senate last night and declared: "We must remove the mask. Intervention is already decreed."

His speech caused a political sensation, and the President of the Senate hurriedly shut him off, and ordered a secret session of the Senate.

The intervention of Senator Welles, American Ambassador in Havana, has accepted American intervention, masked in the form of mediation. Machado himself has also come out for Welles' arbitration.

All these moves for a compromise between the conflicting groups of the business and landlord class are meeting with opposition from the Cuban sugar workers and peasants, who are waging a bitter class struggle under the leadership of the Communist Party and the Cuban National Federation of Labor for shorter hours and higher pay in the sugar industry, and for the abolition of super-profits and sugar mills.

Load Munitions for Japan in Chester

(By a Worker Correspondent) CHESTER, Pa.—The Japanese steamer "Yamaguchi Maru" arrived here in ballast on June 12. She is loading heavy rates of castings, auto parts, and other heavy material for the imperialist war lords of Japan. —O.

Chiang Kai-Shek's executioner, a worker, was killed in a clash with police in Nanking. The worker was carrying a banner for the anti-fascist struggle.

MANCHUKUO ARMY TAKES NORTH CHINA

Civil War in Szechwan; Canton Orders Boycott Yangtze Flood Peril

SHANGHAI, June 22.—Thousands of Manchukuo troops are secretly marching into the "demilitarized zone" north and east of Peiping and Tientsin, according to dispatches from Tientsin. Over 6,000 troops have entered the zone within the last few days, taking over the policing of the zone, which the Chino-Japanese treaty provided was to be entrusted to the Chinese.

All rail service from Tientsin east has been suspended.

Thirty Manchukuo railway guards were kidnapped by insurgents, who derailed a freight train near Kirin, Southern Manchuria yesterday, according to dispatches from Mukden.

Civil war is again raging on a large scale in far-off Szechwan Province between Governor Liu-Wen-hui and rival militarist leaders for control of the rich area. Severe fighting is going on near the city of Kwan-Hsien-Sze, 30 miles northwest of Chungtu, provincial capital. Thousands of refugees are fleeing to the south.

Manchukuo Boycott in Canton. The Canton Political Council has ordered a complete boycott of Manchukuo exports, and the continuation of the anti-Japanese boycott. This step of the British-controlled Canton regime is a repercussion of the Anglo-Japanese trade war in the Far East and New Zealand tariff rises on Japanese exports recently decreed.

Yangtze Flood. The waters of the Yangtze River are rising rapidly, reaching the 46 foot mark below Chongking and exceeding 43 feet at Hankow. A dike at Wuchang, opposite Hankow, broke, inundating farm areas and drowning eight workers. Hankow itself, industrial center of China, is threatened with a disastrous flood as the Yangtze waters are rising 18 inches from the top of the levees.

JAPAN BUILDING NAVY BASE OFF SIBERIAN COAST

\$2,000,000 Harbor "To Aid Fishing Fleet" Planned

TOKYO, June 22.—Under the pretext of providing a harbor for the Japanese crab-fishing fleet operating off the coast of Soviet Kamchatka, the Japanese Navy is taking steps to construct a naval harbor and base, at the cost of \$2,000,000, at Paramushiro, the northernmost tip of the Kuril Islands, off the East Siberian coast.

The Nationalist newspaper "Kokumin" provocatively asserts today that Japan will raise the question of the Soviet Union ceding Vladivostok, Soviet Pacific port, to Japan in connection with the eventual sale of the Chinese Eastern Railway.

Although denied by the Foreign Office, this "trial balloon" shows the aims of Japanese imperialist expansion in the Far East. What is raised today as "possible ceasation" becomes forcible annexation tomorrow.

Meanwhile further action of Dollar is awaited with consternation in Lombard St., and British press comment is bitter and to the point.

BERLIN, June 20.—Maximilian Spichalski, a worker was sentenced to five months in prison yesterday for spitting on the swastika flag, emblem of the Nazis.

The judge ruled the Hitlerite party banner was equivalent to the national flag.

NAZIS SUPPRESS SOCIALIST PARTY, OUST DEPUTIES

S. P. Leaders Tried to Evade Blow, Accepting Fascist Rule

BERLIN, June 22.—The Hitler regime today banned the German Socialist Party, suppressed its newspapers, confiscated the party's property and unseated all Socialist deputies in the Reichstag and other parliamentary bodies.

This action, coming on the heels of the Socialist leaders' decision to reorganize the Party, make it acceptable to the Fascist rulers, is a sequel to the similar action taken with the trade unions, which were seized by the Nazis immediately after the Socialist union leaders had declared their readiness to cooperate with the Fascist regime. In both cases the evident unwillingness of the Socialist leaders to fight for their organizations' survival showed the Fascists that they would offer resistance to their complete annihilation.

NAZI INTERNMENT CAMP FOR WOMEN IN WUERTTENBERG

SAARBRUECKEN, Saar Territory, June 21.—A concentration camp for women Communists has just been set up by the Nazi government of Wuerttemberg at Goteszell, next door to the State Penitentiary for Women. Among the prisoners interned in the camp are the wives and daughters of the Wuerttemberg Communists imprisoned in the Feuberg camp at the western end of the State.

They have to live in stone-floored barracks, and on many days the stone floors are as cold as ice. They are completely cut off from their families and friends. They are not even allowed to receive visitors and are not even told the charges on which they are being held communists.
