Report Shows That Their Salaries in England Are Very Poor.

> By TH, ROTHSTEIN. (Special Correspondence.)

LONDON, Jan. 3 .- A most interestlight on the economic position of so-called new middle class has thrown by the recent investigaloss of a committee appointed two uire into and to report upon the int and distribution of income, of which the results have in part just been published. Hitherto all such indries referred to the earnings of the working class, that is, to wages. The present inquiry is the first attempt to measure the salaries, that is, the earnings, of that "new" middle class which is alleged to have taken the place of the former social stratum small independent producers.

The committee had set before itself the following task: What proportion of the salaried classes are earning more than £160 a year—a figure which represents with tolerable accuracy the poverty line of the middle

JAPANESE PROTEST AGAINST ALIEN BILLS

Consul General of San Francisco Warns of Offense to National Pride.

SACRAMENTO, Cal. Jan. 12 .- An official protest against the proposed anti-Japanese legislation in States is made in a letter from Mat suzo Nagai, consul general at San Francisco, to Senator Leroy Wright. chairman of the senate committee on federal relations.

"I think the people of this stat hardly realize the deep concern felt in Japan on this subject," says the consul general. 'Discrimination at this time would be particularly sur-prising to the Japanese people, in view of the efforts which have been made during the past two years to cultivate the good-will of the Ameri-can people, and to prove to them the sincerity of the Japanese good-will."
