EL PASO, Tex., Jan. 25 .- With fighting between Mexican federals and insurrectos expected momentarily at San Ignacio, across the river from Fort Hancock, a company of United states infantry from Fort Bliss arrived at Fort Hancock early today and immediately camped along the bor-der. San Ignaclo is fifty miles east of Juarez, and the troops are prepared to prevent any violation of the neutrality laws should the battle occur. The four troops of cavalry from Fort Sam Houston are expected to arrive this afternoon and will assist the infantrymen.

After a sharp skirmish Ignacio was captured by the insurgents Sunday and the jefe politico was thrown into jail. Later the rebels withdrew to the San Ignacio mountains to prepare for an attack by federals who left Juarez Monday night. A second de-tachment of federal troops left Juarez yesterday for Guadaloupe, fifteen miles away.

THEODORE INDORSES BOY WINS SUIT INSURGENT LEAGUE

Article in Outlook Places Him at Head of New Party.

Theodore Roosevelt, the ex-President of the United States, who is now being held in check by Wall Street until a skillful politician is needed to quiet popular discontent, has written an article for the Outlook in which PERJURER EXPOSED he places himself at the head of the

newly organized insurgent party.

That Mr. Roosevelt is in favor of the things for which the organization stands is proven conclusively by the article, which is over his signature. He discusses these suggestions which are part of the platform of the new organization:

referendum and recall. The latter is the one suggestion which the ex-President handles in somewhat conservative fashion.

Speaking of the recall, he says How Wary He Is!

"As regards the recall, it is some-times very useful, but it contains un-doubted possibilities of mischief, and, times of course, it is least necessary in the case of short term elective officers. I believe that it would be a good thing to have the principle of the initiative and referendum applied in most of our states, always provided that it be safe guarded as to prevent its being used wantonly or in a spirit of levity." "I believe in adopting every device for popular government which is in theory good and when the practice bears out the theory. It is often im possible to establish genuine popular rule and get rid of privilege without needs. 


WHITE SLAVER'S VICTIM BALLOT BOXES ARE FOUND IN A LAKE

A MONUMENTAL CRIME.

The horrible tragedy is now finished.

Eleven men and one woman have been slaughtered by the govenment of Japan after a secret trial.

Twelve others have been immured for life, and two more have been imprisoned for terms of unknown length.

It is to be supposed that the rulers of Japan are now congratulating themselves on having attained their purpose.

Recalcitrant radicals have been exterminated or rendered harmless. Their very names and memory have been made odious by designating them as anarchists. And if there are any radicals, or "anar-pine war. chists," left in Japan, the terrible fate of their comrades will surely Japan paralyze their wills and cause them to cower in impotent dread before

Such, no doubt, have been the calculations of the Japanese rulers. On no other assumption can their ruthless procedure be explained.

The Japanese government has branded these men and women as anarchists. But the holding of anarchistic opinions, of one kind or men and another, is not in any civilized country a punishable crime. And no of the world will receive the full value frequent. crime recognized as such in any civilized country has been proven. against the accused, for their trial was sealed in secrecy.

But it is not even certain that they were anarchists. It is a well known trick of despotic governments to brand their opponents as anarchists. This has been the habitual practice of the Russian government. But the civilized world now knows what estimate to put use. upon the veracity of that government. The Russian revolution has at all to engage in a scramble for shown that Russia is filled with "anarchists," that is to say, determined and tireless opponents of despotic government.

Nor is it at all certain that the Japanese government has really attained its purpose of paralyzing its opponents with fear. The Russian government, which has pursued similar ends with similar nefarious means; has signally failed. Every government that refuses to yield to the irrepressible spirit of the age is bound to become an object of hatred to its more enlightened subjects. The Japanese government will form no exception to this rule. It is destined to lose in cities as desire so should be encourexternal prestige and power because of internal discord and strife.

The slaughter of Denjiro Kotoku and his eleven comrades, far from securing the safety of the Japanese rulers, is on the contrary calculated to raise up against them a host of dangerous enemies, all the more dangerous because secret. Henceforth we may expect to Judge Sulzberger, of Philadelphia. hear from time to time reports of secret plots and conspiracies to avenge the violent death of the martyrs, of further reprisals by the government, and of still more desperate hazards taken by the revolutionists. He imbibed socialism in this country, which he visited some

Were the activities of Denjiro Kooku manifested in Europe or America, he would be regarded simply as an unusually pestiferous type of labor while the leader," in the opinion of the London News.
