While workers engaged in certain ployments are specified, such as the angused in the erection or dem-los of bridges or buildings, oper-ors of elevators, durricks, or hoistng apparatus, workers on scaffolds; hose using wires, cables, switchboards, or apparatus charged with pleetric currents: those engaged in work in which powder, dynamits, or other explosives are used; operators on railroads in every branch of outmines, quarries or cuttings; in ce-

Section 3 provides: If, in course of any of the employments above described, personal injury by accident arising out of, and in the course of the employment after this act takes effect, i. e., caused to a working person employed therein, is in whole or in part contributed (1) a necessary risk or danger of the employment or one inherent in the nature thereof, or (2) failure of the employer or his efficers, agents or employes, to com-

not have dared refer to Mexico as being in a class with Central America, but reports have it that Ameri can troops may be sent into Juarez just as American marines are landed in Central America when Washington wants to protect a despotic presi dent, or ald a revolutionist who le under promise to hand good thing to prominent capitalists in the even of success.

American Troops Ready.

Twelve troops of American cavalry were today ordered by Major General Wood to proceed to the Mexican border and be prepared to "preserve neutrality and protect American interests." American interests in this case are the interests of the American capitalists who have millions invested in Mexico. To such as these Diaz has been most liberal, giving them invaluable grants of mineral lands and forcing his miserable subjects to labor for starvation wages, and sometimes in absolute slavery.

These are the "American interests" which must be protected, and the intimation is plain that at the first excuse and, perhaps, without waiting for one, Taft will order American soldiers to enter Mexico and prevent the rebels from taking the city on the pretext of preserving iaw and order. There has been no law and order in Mexico for years, but while the law-lessness was of Diaz's making, no American interests were imperiled, and no American troops were needed. One Washington dispatch quotes Secretary of War Dickinson as saying: "We have no intention of sending any American troops into Mexico at this time. To send troops across the border would be an extreme measure, and one which we are not prepared to take at this time. But the troops are in readiness for such acction if it be deemed desirable later."

"While I was still in the Philippines I received orders assigning me to the command of the Department of Texas, but these orders were later rescinded and I received orders to proceed at once to Samoa to suppress an out-

break among the natives. "If I were to make public the na-ture of these orders your hair would stand on end.

ture of these orders your hair would stand on end.

"When we got to Ballangiga, in Samoa, we found the wounded had been mutilated and burned. I gave instructions to my men to aght the savages to a finish, but to my knowledge not a single woman or child was killed by my soldiers during my campaign. We taught the savages a lesson, however, that they needed badly.

"When I came back to this country I was pictured as a monster. Instead of coming home a hero, as I expected, I was retired two years before my time had expired by that man Roosevelt, who afterward lauded his friend. But after a man has worked for many hours, and is tired out, it's pretty hard for him to keep from breaking an occasional dish. We haven't any way, either, of knowing whether the proprietor keeps a correct account of the breakage, or whether he cheats us. As it all goes in a collective account we can't very well tell whether that amount has been actually broken or not.

"Then, too, you'll notice we are soaked for missing articles. As is well known, many rich people have a mania for collecting 'souvenim,' such as silver spoons, knives, salt cellars, etc., from hotels and restaurants that they visit for the first time. But when they take anything we are charged fir it, we who for a ment's hard labor don't get as much as they spend for one good meal.


