## DIX APPOINTS A **GANGSTER JUDGE**

ALBANY. Feb. 10.—Governor Dix today named Francis K. Pendleton, former Corporation Counsel of New York, to be Supreme Court Justice in the place of the late Edward B. Whitney.

Pendleton has always ocen an organization Democrat. He inherited his Democracy from a line of distinguished ancestors, one of whom, Edmund Pendleton, presided over the Virginia House of Burgesses when Patrick literry made his famous "liberty or death" speech. His grandfather on his mother's side was Francis Scott Key, author of "The Star-Spangled Banner."

His father, George H. Pendleton, was United States senator from Ohio and a candidate for Vice President on the tie'et with General George B. McClellan, and in 1868 Tammany Hall boomed him for the Presidency. President Cleveland appointed him Minister to Germany.

Mr. Pendleton was born in Cincinnati fity-nine years ago. He was announted corporation counsel by Mayor McClellan. In the last mayoralty campaign he was mentioned as a possible candidate himself.
