

THE SACRED CITADEL.

All the stupidly conservative and reactionary elements of the country appear to be of one mind in regard to the Arizona constitution. From Taft and Wickersham down to the New York Times, they exhibit the sweetest brotherly concord upon the proposition that Arizona must not be admitted into the Union so long as she retains in her constitution the provision for the recall of judges. Let Arizona do as she likes with all her other officials. Let her adopt all the democratic nostrums upon which Populists-and alas. also many Socialists-lay so much exaggerated stress. Let her toy with the initiative, referendum and recall to her heart's content. But the judges she must let alone. The sacred expounders of the law she must not draw into the game. The power that has become the supreme political power in this nation, the power that lords it over the people and the people's chosen representatives, the power that makes laws never sanctioned by the people, that annuls laws passed at the express demand of the overwhelming majority planted a cross on the palace of the of the people, and that has introduced into the United States the infamous Russian "administrative process" in the form of the injunction-that power must not be interfered with in its career of encroachments and usurpations.

It is the same old story. The plutocracy and its organs in government and press care little about all your agitations on behalf of this or that particular reform, but they care a great deal about your attitude toward the judiciary. This is their central political stronghold, and to attack this stronghold or any of its outlying fortifications is the one unpardonable sin. Roosevelt committed this sin. His punishment was instant and thorough. And if the plutocracy has its way. Arizona will be kept in a territorial condition until she bows humbly and worshipfully before that fetich of American capitalism-the judiciary. -:0:-

PEACE AMONG EXPLOITERS.

On December 16 of last year, at a meeting of the American Society for the Judicial Settlement of International Disputes, President Taft made the following remarks:

If now we can negotiate and put through a positive agree-ment with some great nation to abide the adjudication of an inter-national arbitral in every issue which cannot be settled by negotia-tion, no matter what it involves, whether honor, territory, or money, we shall have made a long step forward by demonstrat-ing that it is possible for two nations at least to establish as be tween them the same system of due precess of law that exist-between individuals under a government.

It is at present impossible to say whether the President himself attached any real significance to these words at the time they were spoken, or whether he merely gave utterance to the platitudes and pious wishes current on such occasions. But whatever the real purpose of the President, his words have been taken rather seriously in other countries. Sir Edward Grey, the British Secretary for Foreign Affairs, expatiated upon them in the House of Commons, and press reports have it that Mr. Knox and Mr. Bryce are about to commence negotiations for a general arbitration treaty. In view of the international position of Great Britain, which is at present extremely unfavorable, a general treaty of arbitration with the United States would manifestly be of great advantage to her. According to the same press reports, the French Government is also eager to adopt a similar treaty with this country. The international position of France is even more precarious than that of Great Britain, but on the other hand, it is impossible to conceive of any serious causes of friction between this country and France.

Socialists would be the very last to offer the slightest opposition to any arrangements looking to the prevention of war among nations. International wars are produced by the rivalries and jealousies of the various national capitalistic groups, and everything hat would tend to keep the masses of the people from participating in the quarrels resulting from these financial rivalries is welcomed by us. We are decidedly in favor of general arbitration treaties, not only with France and England, but also with all other nations. that although such treaties with the great powers have come within the range of probability, at least in so far as the United States are concerned, they are absolutely out of the question

with the weaker nations.

The powerful capitalistic nations may, for their own advantage, decide not to carry on war among themselves. The financial and military resources of the great nations are at present so nearly equally balanced that all of them may shrink back in fear from hazards of war. But so long as capitalism endures, peace among the great nations would only mean a still more ruthless exploitation of the weaker nations. Thus the peoples of Africa were handed over to the tender mercies of the European capitalists by that very delimitation of "spheres of influence," which prevented the outbreak of war among the nations of Europe over unsatisfied African ambitions. And if ever a similar arrangement should be arrived at in regard to China or Turkey or Morocco or any other nation that has been backward in capitalistic development, that arrangement would be equivalent to the signing of a death warrant ose nations.

Genuine international peace on the basis of national and humar equality will only become possible under Socialism.

SELF-ADVERTISING.

What may be the possible purpose of the bill introduced into the New York State Senate by Senator Frawley for the incorporation of Andrew Carnegie's benefactions?

According to Senator Frawley himself, it is not intended to establish a new fund, but rather to consolidate the work of funds already in existence. But what possible purpose may such a condation serve? How, for example, will the management of the Carnegie libraries be improved by consolidating their funds with the "hero fund," the funds for various colleges in England and the United States, the peace endowment fund, the teaching fund,

Some of our fellow citizens will probably be inclined to look for some sinister purpose. We do not share their suspicions. We believe that the incorporation will serve no other purpose than to satisfy Mr. Carnegie's vanity. The mere introduction of the bill has served to advertise the fact that Mr. Carnegie's benefactions aggregate the stupendous total of over \$183,000,000.

Th bill is therefore a form of self-advertising. But it should also serve to advertise the stupendous exploitation to which the workers of the Steel Trust are subjected.
