

WHITE PLAGUE ON INCREASE IN

This State Spends Less to Eradicate Disease Than Others.

ALBANY, April 10 .- As the result of over three years' campaign against tuberculosis by the State Department of Health, State Commissioner of Health Porter today is of the opinion that the money has been well spent and that the State appropria-tion should be increased in the fight to eradicate the disease. In the monthly bulletin of the department, Porter calls attention to the fact that New York State, the wealthiest in the Union, spends for health purposes 1.5 mills per \$100 of assessed valuation, compared to an average of 8.5 mills by the other States, From statistics compiled by the de-

partment, Porter claims that it is to assume that the tuberculosis situation in the State is improving The lowest annual mortality from tuberculosis occurred in 1902, the total for the State was 12,882. In 1903*it increased to 13,194, and to 14,158 in 1904. It remained in the 14.000 mark until 1908, the highest 14,000 mark until 1905, the highest figure, 14,406, being reached in 1907. In 1909 the mortality for the whole State dropped to 13,995, and figures just compiled for 1910 show an in-crease to 14,047. In 1910 there were 158 deaths from

consumption per 100,000 population, as against 205 deaths per 100,000 population in 1890. For a period of twenty-five years 1 per cent of the deaths have been from consumption: in 1909, 10 per cent; in 1910, 9.5 per

The lowest mortality from pulmonary tuberculoses in Greater New York was 7,589 in 1992, and in the same year the rest of the State had its minimum mortality of 4,993. "I find nothing in the evidence to show any discrimination against Matthews because of his color, and there is not sufficient evidence brought out to warrant a charge of wholesa discrimination on the part of the Cigar Makers' Union in other sections of the United States. If credence is to be given to the testimony of the witnesses who charge race prejudice, it can only be accepted as dealing with the individual cases. An allowance must be made for racial sus-ceptibility to believe in discrimina-tion, which is always heightened by any rebuff in seeking employment. Even a tendency in a few factories against any particular race is not sufficient in itself to justify that race in declaring war against the international union of that trade.

"If it could be proved that the in-ternational union as a matter of prac-tice had countenanced or tolerated a system whereby members of the col-ored race who belonged to that union were debarred from employment in all sections of the country, the Socialist party could not do otherwise but approve of the course pursued by Matthews, as this policy would mea that a colored person could not see employment freely in all parts of the United States, even though willing to abide by the conditions of labor prescribed by the union. The Socialist party would also be compelled to withdraw its recognition of the Cigar Makers, Union as a representative la-Makers' Union as a representative bor organization. "Furthermore, Matthews appears to have been willing to sacrifice the principles he now enunciates, namely, that of standing by his race, if the Cigar Makers' Union would come to the relief of the Spanish workers and abolish team work in the factory. INDIVIDUAL AND CLASS RESPONSIBILITY

When the horrible disaster in the workrooms of the Triangle Waist Company occurred there were various antagonistic views as to the cause of the trouble and as to the source of the responsibility. Many stoutly maintained that it was simply an instance of class reck ness. Others were certain that it was attributable to official corruption and stupidity. Some were equally positive that it was due to ineffective shop organization, lack of fire drills and deficiency in understanding the layout of the building. Still others pointed to the individuals who should be blamed, and they strenuously shouted that these individuals should be punished.

Now comes the New York Tribune, a paper that sees no wrong in capitalism, no good in Socialism, and dire disaster in trades unionism. It has a very illuminating, a very striking article on the battle that is waged against adequate fire protection. It goes to the length of showing who the persons are who wage that ball battle. From its list the following may be taken:

Provident Savings. You have in that list about every variety of opinion, about very species of endeavor, about every sort of an individual you find anywhere in this capitalist world. There is the good man, e bad man, the family estate and the banking corporation. Yet ch and every one of them, for some reason or another, opposed tterly any request to render safe the property owned, and which was sclared, by fire experts, to be a menace to those who occupied it.

As two typical but contrasting cases, Mr. Cockran and Mr. Brisbane may be taken. They are enemies, on paper and on the atump. Brisbane owns a workshop at 76 West 47th street. W. stump. Brisbane owns a workshop at 76 West 47th street. W. Bourke Cockran has a combination building in which are a store, warehouse and workshop at 993 Third avenue. When the cry of alarm went forth from the Building and Fire departments, did these two eminent gentlemen and well-wishers of the public rush to carry out the changes asked for? No, indeed; they fought with all their power to prevent them.

Cockran is as hot after returns from real estate as Brisbane is and Brisbane is as hot after returns as the Astor estate, which he has hit many and many a time. What all of them want is MONEY. and they do not care how they get it so long as it is sufficiently plentiful.

The one reason they invest is to get dividends, and anything that interferes with dividends is a thing that they oppose. As mere senti-mental appeals, as rhetoric and a fluent flow of words do not interfere, they indulge in them. But a simple request, suggestion or order asking them to make their dividend-yielding property safer is a thing to be fought.

In this list is every shade of opinion in the capitalist class. carries most of the real estate dealings of the capitalist class. All its members, no matter what may be their outside declarations, are opposed to any reform in the building code, any action that will force m to spend money to render safer the lives of those who must use their buildings. What they say does not count. What they do counts for a great deal. And all of them are bitterly opposed to the instituconditions that will render a repetition of the Triangle disaster an impossibility. All of them take that position because they are of the capitalist class, and consequently work for their own pockets all the time, even if it means death to the wage slave.

ALL EXPLAINED

Now that the matter has been set forth we can all understand it. The reason why the troops were sent to the Mexican border is because Mexico, without our knowing it, had entered into a treaty with Yet that is not the reason, because it is denied in Washington. The real reason was that President Taft feared "anarchy," and anarchy is anything that interferes with business and dividends. This, really, must be the explanation.
