SPANISH IN MOROCCO

MADRID. June 12.—A special meeting of the Spanish Cabinet was called today to consider the French opposition to Spain's Moroccan course, the chief grievance of France being the Spanish occupancy of Larache and Alcazar.
France will be assured that Spain intends only to protect her interests and the lives of foreigners in that part of Morocco which, under the Algeoiras treaty, is her sphere.
The real secret of Spain's activities, however, is known to be the fear that France will encroach on Spain's "rights."
It is denied here that Germany is influencing Spain, even indirectly. There is the highest authority for the statement that Spain got Germany's promise of non-interference before she decided to increase her military strength in Larache and Alcazar.

It would be useless to conceal the fact that a large portion of the public look upon these meetings as a sort of malicious defiance of the law by lawless people in the interests of lawless people. The press has been very careful to leave such an impression in the minds of its readers that they will look upon such protests as this, as the systematic efforts of enemies of organized society to bring the law into discredit, and eventually reduce society to anarchy and chaos. And I may say that under the circumstances the view is one that might be expected and in a certain sense is a natural result.

Not only the press, but every channel of communication by which the public can be reached, has also been pressed into service to foster this view. Politicians of the Roosevelt type, magazine writers and clergymen, everyone who has the ear finance for this purpose as far as possible.

Guilt Already Assumed.

The guilt of the accused men, the McNamara brothers, is tacitly assumed where not shamelessly asserted, and those engaged in this business put on a mask of seeming impartiality by urging all and sundry to suspend judgment until the trial demonstrates clearly the guilt or innocence of the accused. And especially is this urged upon those who assume the innocence of the accused until they are proven guilty.

Our laws guarantee them a fair trial. What more can they or anyone else ask? Do you Socialists and trade unionists want to subvert all law and order? Are you not willing to wait and acquiesce in the verdict after a fair trial is given? What is the need of these meetings? On what is your complaint based?

Assurances Disbelieved.

And it is those questions we have And it is those questions we have to answer. It is not that we have not answered them many times, but that rather what we resty, what we complain of, is utterly isnored and we are again and again met with the parrot-like repetition of the assurance that these men will get a fair trial. Here then is our answer; here is where we take issue with these complacent assurances of impartiality. We state boidly and bluntly that we have no reason to believe them, but We state boldly and bluntly that we have no reason to believe them, but every reason to suspect their truth. And our auspicions are not based upon vasue and intangible things, but on facts and experiences in this and in similar cases.

REICHERT A VICTIM OF AMERICAN NAVY

MEASLES NOW ONE OF FATAL DISEASES

ALBANY, June 12.—That the control of measles, which is a communicable disease, is one of the most difficult problems that confronts a health officer, due mainfy to the fact that it is treated lightly by those afflicted, is the contention of the State Department of Health in a bulletin issued today.

According to the department, measles has caused 1,000 more deaths than scafflet fever during the last sixteen years. The department says it is a mistake to expose children to the disease on the theory that they must at some time during life have it, and that it is less severe in the child's younger days.

Two and one half per cent of all the deaths in Emisland are charged to measles, almost a quarter of a million deaths occurring during the past twenty years. The department urges that all public places he kept thoroughly clean and ventilated and that school teachers report immediately to health officers suspected cases.

BALDWIN'S EFFORT

Big Plant Tied Up Completely, Being Helpless Without Regular Men.

(Special to The Call.)

PHILADELPHIA, Pa., June 12.—
The attempt to start up the Baldwin Locomotive Works today was a pitiful failure, only a few hundred men reporting out of the thousands needed to run the big plant.

The tie-up is complete. Baldwin's workers are highly skilled and experienced men and it is impossible for the company to obtain scabs competent to fill their places.

SENATE PASSES BILL FOR DIRECT ELECTIONS

Hancock's Clique Fire Seaman Who "Knew Too Much."

JAILED AND ROBBED

Once Acquitted, He Is Made Do Time, Then Is Fined and Dismissed.

Where is the patriot whose hear

will fail to thrill at the sight of his beloved government catching young men for naval service, fleecing them of their manhood and material possessions and then kicking them ashore as "unreliable" when they fail to sink rapidly enough to the degraded level of a satisfied sailor?

Arthur Reichert enlisted in the United States Navy seven months ago. Last week he was thrown ashore with nothing left but his manhood. If he had been willing to surrender that he would still be one of our brave boys in blue on the U. S. S. Hanccock.

The naval authorities at the Newport training station placed Reichert under arrest for attempting to cross the threshold of quarantine, a violation of rules, acquitted him of blame in that connection, selzed him again a short time afterward, gave him five days in "solitary" on bread and water, then thirty days more without pay and a fine amounting to \$146, and finally the "undesirable" discharge.

All of these official proceedings were conducted in violation of rules in the sailors' blue book. Reichert knew they were and the naval officers knew they were and the first three thirds and first him of the proceedings were and the first is why they called him admirate Read.

the punishment administered to Reichert grew out of his single offense of almost entering quarantine-

Several days after this Reichert met the witness who had lied at the hearing. Hot words ensued and the witness, a strapping big fellow, said he would settle the matter once and for all if Reichert would come outside the building and fight it out with

nsts.

Reichert accepted the challenge and gave the fellow a drubbing he will never forget. Then the man who had lied at a hearing of his comrade, tried to bully him later and was whipped in a fight of his own picking, decided to get revenge and Reichert found himself a prisoner, charged with creating a disturbance.

Reichert was made to stand a summary courtmartial while the other fellow went free. The four officers who acted as judge's at the trial stated in their report to Admiral Rogers that

in their report to Admiral Rogers that Reichert was a bad fellow, BUT SINCE HE WAS SUCH A FINE BAKER, AND BAKERS WEBE SO MUCH IN DEMAND, THEY RECOM-MUCH IN DEMAND. THEY RECOM-MENDED THAT HE BE NOT DIS-MISSED FROM THE SERVICE BUT GIVEN THE THIRTY DAY SEN-TENCE AND THE FINE OF \$75, which was all the money he had on the books.

While awaiting trial, however, Reichert was kept in solitary confine-ment for five days. Admiral Regen approved the recommendation of the trial officers and Reichert then began serving out his thirty days' sentence.

The blue book also provides that while undergoing punishment other than solitary confinement a sailor shall be provided with his mattress to sleep on. Reichert was not given a

Not one seaman in a hundred knows the blue book or any of the admiralty laws. This is why they are such easy victims of brutal exploiters seaman in a hundred and why the service, both merchant and naval, is composed of a degraded lot of human beings who have lost all power to resist and are willing to stand for any kind of treatment accorded

It was while undergoing the pun-ishment approved by Admiral Rogers that Reichert's enemies decided that they would kick him out of the navy despite the fact that he had already been tried for all of his "crimes" and was being punished for them. Reichert knew too much, had too much manhood and was too ready to

demand his rights to make a good sailor in the United States Navy. Despite the blue book and the fed-

Despite the blue book and the federal statutes, sailors have no rights and the sooner they come to know it the better for the service.

The naval officers therefore got together and dug up that old story about him entering quarantine. They pressed it so hard that Captain Patrick Horrigan, of the Newport station, digregarded the fact that his admiral had already passed sentence on Reichhad already passed sentence on Reich-ert and sent a report to Washington asking that the sailor be given an un-desirable discharge from the navy. Thus it was that after Reichert had

done five days in solitary confinemen on bread and water and had served all but three days of his thirty day sen-tence, he was dragged out and dismissed from the navy.

Officers Take His \$60.

But that was not all. Every man-who enlists in the navy is given a \$60 outfit of clothing by the government. On the day he was finally dismissed from the navy. Reichert had \$63.97 coming to him on the books.

As another way of showing their hatred of sailors who give them trouble by knowing too much, the officers of the Hancock took \$60 from Reichert's coming pay and set him ashore with \$3.07. They said he would have to pay for the clothing he had

In spite of the fact that Reichert is an expert baker, having recommenda-tions from several big concerns in New York, his undestrable dis harge from the navy states that help not qualified to fill any job.

Not content with having robbed him

while he was in the navy, these of-ficers of the Hancock sought to give Reichert a black eye even after he had left the service by stating that he was not qualified to fill any job.

Yet, by a strange mishap, they told the truth about him in one particular, stating that his record for sobriety was perfect. Reichert does not drink, another sign that he is not the kind of man who is most welcome in our

er man who is most welcome in our glorious navy.

Reichert lives at 132 Christie street and his friends are determined to have Congress investigate his case and demand that he be given an honor-able discharge from the service.





JUST A PECULIAR DIFFERENCE

For many weeks the city authorities have been issuing many warnings that unless the people were economical and used less water there might be a disastrous famine. The old days of independence when each family had its own private well have gone never to return. In those good old days when people drew water from the old oaken bucket, the germ covered bucket, there were times when certain wells ran dry. But no one died of thirst. He went to his neighbor and borrowed a pail of water. Sometimes, it is true, he got typhoid through doing it, for independence and hygiene did not always go hand in hand in the matter of the country

But the period arrived when the well was recognized for what it usually is, a cumbersome, ineffective and frequently unclean source of a prime necessity. So society combined and began to store water and distribute it through pipes and thus satisfy the needs of great communities. The result of this step from good, sturdy individualism to rank paternalism was that people received more water and better water than they ever had before and they got it with less effort. Even the poorest were fairly assured that they could have access to a sufficient water supply. As a result sickness was reduced because the adequate means of cleanliness and flushing being at hand it was poscible to flood away from the crowded, swarming cities the filth that had formerly caused infection.

Here, certainly, was a triumphant indication of the power of co-operation. And it was more than that, because it indicated a line the city at least must take in handling a basic question. There were none of the old school, during the threat of a water famine, who advocated a return to the "good old days," when each family had a more or less-usually less-sanitary well in the back yard In fact, the whole drift of comment was in the other direction.

"Let us perfect the water supply," they cried. "Let us make it adequate. Shortage threatens rich and poor alike, and is social crime. The fountains are running dry. The vegetation in the parks is wilting. The whole city is menaced."

Not one bright individualist rose to demand that we dig wells and thus get the water we could not get from the depleted reser-

But Saturday and Sunday a copious rain fell and all the people rejoiced. All the capitalist papers commented complacently upon the matter, as though they had brought it about. Everybody, in spite of the devastation caused by the storm, in spite of the appalling lightning and thunder, was overjoyed when it happened. It means that this problem, at least, would not bother us again for many weeks, if it did again during the season. It was one of those matters replete with great possibilities of disaster, which could be lightly considered when the real danger was passed.

While the introduction of water works is contrary to all the old theories of the self-sufficiency of the separate family, with its own little well, and while the coming of rain to give ample water to millions of people is an excellent argument for social co-operation, there is also one lesson in a connection that cannot be over

The working class of this city can now, possibly, go to the city parks and when thirsty get free from a public drinking fountain a dipper of water instead of being forced to pay a penny to a private corporation for a small glass of water. That is what has happened when the sources of the city water were filled, and when there comes enough water to supply all ordinary demands for months

But suppose that instead of water there was an ample supply of some other necessity. Suppose the warehouses were filled with goods and the elevators were piled to the bursting point with grain. What would happen then? Why, there would and those who needed goods the most could not get them. Those who were starving could not get food. Those whose garments were in tatters could not get clothing. Those who were ill could not get medicine. Those who needed light and fuel could get neither. And it all would come about merely because there was plenty, and more than plenty.

Because there was more than plenty those who have control of the means of production would not find it advisable to manufac ture more. Consequently, they would shut down the mills and factories, throwing countless numbers of people out of work. They would hold fast to the commodities already in hand, dribbling then out so that profits should be realized. Men and women and chil dren might starve, but there would be no relaxation of the grip on the wealth until profit had been extorted.

But the water supply is owned by the community, and usually it is employed for the benefit of all the people. But other things, just as necessary, are owned by private individuals and they are held for private profit. They are used to extort revenue from those who need them, though this causes misery and death.

There is no individual or group of individuals, there is no class. with any more right to commodities than there is a class which has a right to hold and peddle out the water supply. The class which does hold the commodities did not create them. That was the work of those who use them, of those who suffer so acutely when they have created too much.

So this talk of a water famine, and the sudden breaking of the famine, should bring to the minds of all people that great and important point in the Socialist program-wealth belongs to the producers of wealth. Unless it does belong to the producers there will be suffering. At present it does not, and suffering is widespread. There is but one way to put a stop to the suffering and to the erims, and that is for the producers of wealth to retain possession of it, take its control and distribution into their own hands.

Those who have it now in their possession, and who wax fat and rich from it, have no more right to do so than they would have had to monopolize the recent rainfall.

-:0:-GAME AND HUMAN LAWS


