as possible, Berger has forwarded the department's letter to a prominent la bor lawyer of El Paso, Tex., who was one of Berger's informants, and asked him to prepare all the charges and evidence in a complete and compre hensive form. The same is to be submitted to the Department of Commerce and Labor.



The court holds that sections 308, 315, 330, 331, 332, 374, 375 and 376 of Chapter 7 are valid enactments and not an unlawful interference with interstate commerce. These sections provide that a license fee of \$5 shall be paid for each wagon, that the drivers shall be licensed upon a certificate of competency and pay a fee of 50 cents, and that a bond of \$1,000 shall be given for each licensed vehicle for the safe and prompt delivery of all articles.



This would necessitate the employment of more men in the postal service, but it

On Wednesday afternoon when the transatlantic liner Olympic steamed past the Battery on the return trip of her first vova several-thousand people took advantage of the opportunity to gratif the national desire of beholding the biggest thing in the world in the marine line

And with her length of almost 900 feet, her 100-foot beam and her 45,000 ton displacement, dwarfing everything else affoat into utter insignificance, the sight was certainly calculated to draw a crowd.

Four years ago a similar gathering assembled to watch the other giantesses, now displaced by the Olympic, the Mauretania and Lusitania, entering and leaving port on their maiden voyages. Now these great vessels attract no particular attention.

And next year when the Cunard company sends its new 50,000 ton liner across, the Olympic will have lost interest for the admirers of the "biggest in the world."

Still this admiration for the greatest is by no means a reprehensible trait in a people, for it certainly signifies a desire for progress and is completely in accord with the tendencies of the day. The only drawback is that we are not always able to discern the

really big things and their significance in modern society. largest locomotive, ship or building the eye can always see, but the mind does not fully understand their import. There are thousands of people who admire and approve of the

tallest skyscraper or the largest transatlantic liner who have no approval or admiration for the bigger thing that made these big things possible—the trust. On the contrary, they consider that it is too big and should be made smaller by being broken to pieces.

Yet the Olympic is actually a trust product and without the trust could have had no existence. She belongs to the great shipping trust controlled by Morgan and known as the International Mercantile Marine, which is a combination of half a dozen of the largest transatlantic lines.

Olympics, Mauretanias and Lusitanias only come into existence at the expense of their smaller competitors. The little five and six thousand ton liners of twenty years ago have either been broken up or driven from the Atlantic trade into some less important traffic, to be broken up after a few years' unprofitable service. Even more pre tentious vessels share a similar fate. On the appearance of the Lusitania four years ago, for instance, the Lucania of the same line, a magnificent 13,000 ton vessel, a few years before the largest and fa est affoat and with a transatlantic speed record, was sent to the shipbreakers. The Etruria and Umbria, almost as famous, went the same

And the trust operates in an exactly similar manner When it comes into being its smaller competitors are broken up and disap-pear. Its coming necessitates their vanishing. Just as the new giant liner drives its competitors from the seas on account of its su size and efficiency, so the trust effaces its competitors for the same

Tell the average man that the Olympics and Mauretanias should be broken up and their places filled by a dozen fourteen-knot boats of three or four thousand tons, and if he did not regard you as a lunatic, he would probably say the thing was impossible, that we couldn't go back to inferior service if we wished, that it would be as sensible to propose that the railroads should be torn up and the locomotives scrapped in favor of stage coaches and ox wagons.

But in all probability the same man would quite agree with you if you proposed the destruction of the trust in favor of a return to competition, and would laud the members of the Supreme Court as he wisest beings on earth in making such an order.

-Such a contradictory attitude is only possible because we can only recognize necessity in some great things to the exclusion of We admire the great liner, but detest the trust that is reothers. sponsible for her existence.

When the American people really see greatness, not only in the bulk of things visible to the eye, but the great causes that produ these things and the same necessity that underlies the existence both, their intelligence will lead them, not only to desire still g things but to take a hand in their production, their control and fa

They will demand the trust of trusts, the collective ownership of the giant means of production and transportation—the Olympics and

the privately owned trusts that make them possible. They will demand Socialism, which is the greatest thing in the world, and which will produce things greater than any the privately owned trusts has ever been able to produce.

And when the Olympic of the future, with ten times the tonnage and twice the speed of the present one, passes the Battery, they will not only be able to feast their eyes upon the "biggest thing affoat,"

but can also add, "it belongs to us," as well. At present all they can say about the Olympic is that she is big

and belongs to Morgan. But it will not always be that way. Sooner or later the Ameri can people will consider themselves bigger than Morgan and will in-

And the investigation will show them that Morgan is only bigger than they are because he owns more than they do-because been permitted to regard himself as the owner of things made by the

social and collective labor of the American people. And when they reach that point, the rest will be easy, and the biggest things in the world will become the collective property of those who produced them by their collective labor.
