## SECRETARY OF WAR TALKS ABOUT CANAL

### Stimson Sees Sunny Side of Seamy Situation in Panama.

Secretary of War Stimson came to New York yesterday and in an interwith several reporters, had a lot to say about the conditions at Panama and the work on the canal. He spoke of Cuba and Porto Rico, too. Stimson has been on a tour of these parts and has inspected the Maine. The gist of his remarks was that business is good down there. Stimson's observations were confined chiefly to trade

"I was particularly surprised at the cleanness of things in the canal zone," said the secretary. "You know how much one hears of the filth of Southorn countries. There isn't any filth country can surpass the zone in sanitary conditions. There are 30,000 men on the pay roll there, but the amount of sickness is surprisingly small. The best evidence of the healthfulness of the place is to be een in the chubby, sun browned children.

"The most important piece of work that is being done at the Culebra cut just now is the shaving down of the side hills. The great weight of these hills caused the bottom of the cut to push upward. When this weight is emoved, the engineers tell me, the cut will be free from further disturbance. There is no other disturbing question before the engineers, and there is no question about the work completed in the specified time.

# INEVITABLE CHANGE

Wants Probe to Adjust Sherman Law to Suit Capital and Labor.

WASHINGTON, Aug. 14 .-- A resolution authorizing the creation of a oint commission of the Congress to study commercial and industrial conditions in the United States with a view to the enactment of a new antitrust law has been prepared, and soon will be introduced in the House by Representative Martin W. Littleton, of New York, a Democratic member of the Special Committee appointed to inquire into the affairs of the Steel Littleton is convinced. after careful study of the question. hat leaders of labor and representatives of "big business" should have an opportunity through the medium of a properly authorized commission to tell Congress just what changes, if any thould be made in the existing Anti-

Littleton argues that if the law is obstructive of progress it should be changed, and this view is gathering strength in Congress.

The New York member believes that all parties in interest-labor, capital. and the public generally-should be invited to give their views as to what laws should be passed to preserve the good that is in present-day corporate management, eliminate the evil, and permit the corporations to be conducted within clearly defined limita-

Littleton explains his purpose in the

following statement:
"Aside from the question as to whether y or many concerns exist in violation the Sherman Anti-Trust law is the main remedial question as to what is to be the future of legitimate industrial de-velopment. In other words, now that the velopment. In other words, now that the law has been construed by the Supreme Court, is it a wise and wholesome law? Is it too weak to reach real offenders, or is it too drastic upon centralized industry? What is a lawful organization under the law? And is there any way to know whether it is violating the law until it is too late to escape disaster?

"At all events it was created at a time and under circumstances when the presented and the court of the cou and under circumstances when the pres ent industrial problems were not before the men who voted for it. Since that time we have seen an industrial revolu-tion. We have seen all of the business of the country tied to or made dependent

upon vast corporate organizations and the money of the country invested in them. Collective industry has spread over the whole country and business coperation has taken the place of business operation has taken the place of business warfare.

"We cannot evade this important question. We ought not to wish to evade it. The well being of the whole country depends upon it and it is the highest test of patriotism and courage to deal squarely and resolutely with it."

### DECLARES STORY ON **WORKHOUSE TRUE**

Delaware Physician Confirms clair's Charges Against New Castle Hell Hole.

WILMINGTON, Del., Aug. 14.—Up-ton Sinclair has stirred up a hornet's nest for the trustees of the New Castle County Workhouse, where he and eight other Ardenites were imprisoned for eighteen hours for breaking the Sunday blu

laws.
Sinclair wrote a letter to J. Frank
Ball, president of the Board of Trustees,
in which he brought serious charges as to the way the prison was conducted. Sin clair declared the air breeded diseases clair declared the air breach was the food was not fit to eat, the yard was not large enough to permit the proper not large enough to permit

not large enough to permit the proper exercise and the cells were fifthy.

Dr. Albert Robin, medical director of Hope Farm and chief physician of the tuberculosis dispensary, is one of the many men who have been aroused by many men who have been aroused by Sinclair's charges. Dr. Robin made a personal inspection and has written his opinion for the benefit of the public. He substantiates many of Sinclair's charges. Dr. Robin's letter is in part as fol-

ows: "Frequent references to the prev-dence of tuberculosis in the New Castle County Workhouse have attracted public attention and aroused the suspicion that while generally exaggerated, the assertions are more or less well founded. In tions are more or less well founded. In-deed, from our general knowledge of the causation of tuberculosis, we may con-clude beforehand that a prison offers the most favorable conditions for the devel opment and spread of the disease.

Tuberculosis is a disease of the 'shut in,' the undernourished, the overcrowder and those with a general low vitality.

"That the prisoners are underfed is shown by the low cost of maintenance to which, by the way, the prison report point with pride." At the present high

to which, by the way, the prison reports 'point with pride.' At the present high cost of food it is difficult to maintain a person on 8 cents a day. The food must be of the cheapest grade and lack in variety, even if theoretically nutritious.

"Dr. Rumford, the present physician to the workhouse, admits the prevalence of tuberculosis in the workhouse, in one form or another, and also deplores the same want of provision for the proper

same want of provision for the prope care of the consumptive inmates."

## GAYNOR'S OFFICIAL DEFENDS CHARTER

Drummond of Charities Department Slaps at Prendergast.

Commissioner Michael J. Drum mond, of the Department of Charities, says in reply to Controller Prendergast that he is the man "behind the clause" of the new charter, which gives him the final audit of the expenditure of city moneys allotted to charities. The terms used by Prendergrast in attacking the provision he characterizes as "violent and extraor-

In taking on himself full responsi bility Drummond says:

"I have no political ambitions to further, no axes to grind. I believe I am regarded as truthful. I was pre paring to retire from business when Mayor Gaynor, an old-time friend asked me to be his Commissioner of Charities. I had been interested in charities all my life and for many year have served as member of committees or the boards of charitable in stitutions. Thinking that I might help the poor and serve the city, I ac

"When the charter matter came up the Mayor instructed me, as he did the head of every other city department, to give the most earnest atten tion to the chapter covering my work This I have done to the best of my ability.

"The Controller says with slurring sinincance that I went to Albany about this matter. He wants to know whom I represented. I did go to Albany be cause the Cities Committee advised me their draft was about ready and asked me if I had any suggestions. I had a right to go to Albany or anywhere I represented my department and its work and nothing else.

"If I were younger and had the time to enter political life, I now think I would try to join that body. There is less cant and hypocrisy, less lying and mud slinging; fewer attempts to mislead the public and more political decency and honor in it than in some of its opposing organizations. But Tammany Hall expressed no in-terest in the charities chapter in the charter. I do not see how it could have any interest in that chapter." Of the chapter itself Commissioner

Drummond asserts that it has been well drawn; that it is comprehensive and adequate and altogether the best and adequate and altogether the best charities code that the city has ever had. It embodies not only the good features of the 1900 charter, but the best of the Ivins and Hammond char-ters. ## SHEER NEGLECT AT MATTEAWAN

Inquest Into Death of Murdered Patient Reveals Shocking Conditions.

MATTEAWAN, N. Y., Aug. 14.-The aguisition by Coroner William J. Haight into the death of John W. Coburn, a New York patient at the Matteawan State Hospital, who was kicked to death by another insane patient named Antone Krulich, and which was held this afternoon at the hospital, developed the fact that an attendant had left his fifteen charges alone for at least fifteen or twenty minutes, that Coburn did not receive any medical attention the night before he died, and that although Krulich had practically killed a man he was not punished for his crime, but allowed to remain in the ward a week before being locked up in the hospital jail.

Dr. James V. May, the new superinteudent recently appointed to fill Dr. Lamb's place at the hospital, arrived this afternoon and was present at the inquest, York patient at the Matteawan State

Lemb's place at the hospital, arrived this aftersoon and was present at the inquest, as was William McCabe, confidential agent to State Superintendent of Prisons Colonel Scott. Ex-Police Magistrate Sherwood Phillips assisted Coroner Haight in the examination of the witnesses, and although McCabe showed the disposition of not desiring to inject himself into the case, he was often of assistance to the inquirers in bringing out the salient points of the case.

"Is it customary for you or any of the attendants to leave the wards alone and go but for a period of time?" the Coroner asked Ernest Blake, the attendant in the infirmary ward in which the

## TO ENLIST UNION AID FOR CONEY CAR STRIKERS

Leaders Will Canvass Labor Bodies to Tell of Struggle.

TIGHE DENOUNCED

Knights of Labor Man Said to Be Playing in Hands of Bosses.

The strike against the Coney Island and Brooklyn Railroad is still on. The men demand a minimum wage of \$2 a day. Strike sympathizers and union men will refuse to use the lines owned by this company, and will continue to boycott them until the company settles with its men. The lines are Smith street, Franklin avenue, De Kalb avenue, and Hamilton ferry.

With eighty of the De Kalb avenu ranks, the striking car men on the Coney Island and Brooklyn lines laid out new plans yesterday for vigorous agitation among the public to abstain from riding on the cars of the struc

While all of the De Kalb avenue men did not strike, leaders of the striking car men said that enough men struck to cripple the De Kalb avenue line and to include it among the other struck lines so that union men and friends of labor in general

will now abstain from riding over it. Every evening this week officials of the car men will go before trade acquaint them with the fact that all of the routes operated by the Coney Island and Brooklyn Railroad are now tied up, and that the only way to help the strikers is to abstain from

riding on the cars. Union officials declared yesterday that the company is hard pressed. This declaration they based upon ac-tual figures. On the Smith street line, they said, cars were generally run every two and a half minutes. 

# SCORE MEAT TRUST

### High Prices Driving Customers From Markets, They Say.

Retail meat dealers were indignant yesterday with the action of the Beef Trust in raising the price of meat . and 4 cents a pound in the last week As a result of this raise in prices the retail meat markets were doing hardly any business yesterday.

A. Koelsch, who is president of the Washington Market Retail Dealers' Association, voiced this indignation in emphatic terms. He said:

"For the past five or six weeks the wholesalers have been advancing the price in carcas, but it was not until two weeks ago that the retailers put up their prices. We are paying 3 cents pound more now for beef than we were six weeks ago. Then the price ranged from \$ 1/2 to 9 cents a pound. Now we pay 11 1/2 and 12 cents.

"Incidentally, the price which we are paid for suct and shop fat, has been reduced. A year ago we were getting 71/2 cents for suct. Now we get only 4 ½ cents a pound. Shop fat a year ago brought 3 ½ cents. Now it brings only 21/2. The concern which buys these by-products is in the combination."

on this transaction, says:
"Clearly the industrial department
of this company was informed immediately after the accident that deedent hat a father and mother living in Italy, and their names and addresses were given. It also knew that the employer was the trustee (under policy) and that it could have paid to him. Instead, in pursuance of its policy of profit sharing decep-tion, where the beneficiaries were in distant lands, it took advantage of the presentation of an undertaker's claim; in effect, to get rid of its obligation of \$200 for \$45, apparently deliber-ately intending to sit quiet until the period specified in the policy for presentation of claims by those legally entitled thereto should lapse, and thus take \$155 from ignorant foreigners, whose representatives in the shape of the Italian Consul it later attempted to deceive as to the transaction,

# SENATOR HEYBURN

Move to Speed Up Suprene Court Draws Fire of Idaho Reactionary.

WASHINGTON, Aug. 14 .- Senator Jonathan Bourne awakened the constitutional lions of the Senate today when he introduced a bill "to provide rules for speedy and final decisions of questions concerning the constitution ality of national and State laws and constitutional provisions, and for the interpretation and construction of the federal law and Constitution."

Under this imposing title the Bourn bill requires a unanimous decision of the court to decide an act unconstitutional. Another requirement of the bill was that acts should be construed liberally. The bill requires inferior tribunals to certify constitutional questions to the Supreme Court forth with for action. Such questions are to be certified in advance of the trial of the cases out of which they grow, and the Supreme Court is authorized to dvance them to speedy hearing.

When Senator Bourne's bill was read. Senator Heyburn, of Idaho, took the floor and condemned it in unmeasured language. Other defenders of the constitutional and time honored government forms rallied to the support of Senator Heyburn and legal fire was exploded in plenty.

### Senator Defends His Bill.

Senator Bourne, in justification of his bill, said:

"A considerable number of the members of both Houses of Congress are learned in the law, and some of them are lawyers of considerable renown. In each House there is a Com mittee on Judiciary composed of the strongest and ablest lawyers in each body, which committee gives particu lar study to constitutional questions arising when proposed laws are under consideration.

"Because Congress is a co-ordinate cranch and because of the careful attention the members of Congress give to constitutional questions arising re garding legislation, it has been held by the United States Supreme Court that no act of Congress should be held to be a violation of the Constitution unless the conflict appears beyond reasonable doubt.

"The Supreme Court has, however in numerous instances, held to be unconstitutional acts of Congress which part of the members of the Supreme Court believed to be entirely in har mony with our fundamental law. In cases such as this there certainly ax isted a very substantial doubt whether the measure in question was in fact in contravention of the Constitution.

"In my opinion, unless a State law or an act of Congress is so clearly unconstitutional that the court will be unanimous in so dectaring, the decision of the court should uphold the validity of the act,

"The purpose of this bill is not to allow one, two, three or four members of the Supreme Court to overrule eight, seven, six or five members of that distinguished branch of our government, but rather to enable one court to prevent, eight, seven, six or five of its members from overruling the wishes of the nation as expressed through Congress or the wishes of a sovereign State as expressed by its electorate or by its Legislature."

### What the Bill Provides.

The Bourne bill provides: "That in any action, suit or proceeding in the Supreme Court when the meaning construction or interpretation of any Constitution of the United States shall be drawn in question or decided, the same shall be interpreted and conmonly understood in everyday use. mous decision of all its member cide that such literal interpretation is not the true expression of the legislative intention and meaning in the language in controversy."

Senator Heyburn denounced the proposed scheme as a "cross between populism and anarchy; as dangerous the outrages of the Black Hand and the mob; designed to destroy the confidence of the people in their institutions and their government."

Continuing his impassioned discource, Heyburn said it was simply another move in the attempt to have the minority rule. All these new po litical cults are based on that principle, he shouted. The most dangerous thing about such schemes, he said was that they were usually put forward by clever men, who talked much of the rights of the people, the op-pression of the people and the dangers of monopoly until alarm is cre "Then the people ask, 'Are we be





It may be admitted also that at times the selection for editorial matter is not always the best possible; that it often happens that a relatively trivial occurrence is selected for comment much more important matters left unnoticed.

Of course, it may be replied that sometimes a most important Socialist truth may be developed from an apparently unimportant incident, on the theory that "straws best show how the winds blow."

But the main object of an editorial column, we take it, is not so much to acquaint the reader with what the editor may think n a certain subject, but rather to develop the thinking powers of the reader himself; to familiarize him with modern Socialist criticism, so that he will be at no loss to analyze for himself the occurrences which he may think important and which, for the reasons bove given, are not commented on in Socialist editorial columns. If this object is attained, we consider that the editorial work has fulfilled its chief function, and is the principal justification for its

As all men are fallible, editors included, a mistaken viewpoint their part is not a particularly serious matter unless, perhaps, contravenes some well settled Socialist principle or policy. Nor is it a serious cause for complaint if at times the most important de duction from the matter treated is omitted, and deductions of minor import appear instead, for no pretense can be made that the eye and swarms and batallions everywhere simultaneously with us? Whew:

Like many other subjects, the one we are discussing here is not exhausted but the space is, and it is, therefore, necessary to bring it to an end—with the concluding remark that its appearance is not due to complaints received about the editorial work, or lack of sub-jects, but rather that the profusion of matter worthy of editorial comment is so great that the fact itself seemed worthy of comment in this column
