LONDON, Oct. 27 .- The British Foreign Office is considerably perturbed by news of General Li Yuen Hung's proclamation of a Chinese republic, with himself as Fresident. The official judgment is that the devolpment marks the revolutionary movement's transition from the merely riotous stage to that of a genuine civil war of large preportions. Despite the correctness of the attitude the revolutionists have thus far maintained toward for-eigners, it is felt that so extensive a struggle in a country like China can bardly last long without grave risk to secidental interests

It is understood here that the diplo-matic representatives have not yet re-plied to General Li's proclamation. Obplied to General Li's proclamation. Objection will certainly be raised, however, to his announcement that he proposes to administer the customs at all ports captured by the rebels. These customs are already pledged as security for foreign loans and the British inspector general of Chinese customs wants them.

The new government's notice that vessels carrying contraband to ports under imperial control will also be objected to.
