### TWENTY LOSE LIVES IN FRENCH R. R. WRECK

SAUMER. France, Nov. 23.—Sixty passengers, it is estimated, lost their lives through the plunging of a train into the River Thouet this morning, owing to the breakdown of a railroad bridge on the State railway at Montreuit Bellay, in the Irepartment of the Maine-et-Loire.



WASHINGTON, Nov. 23,-Walter I. Fisher, Secretary of the Interior, went squarely on record today before the National Waterways Commission as being opposed to putting restrictions upon the monopoly of hydro-electric power. He declared that water power was "essentially a monopoly," and in granting permits for licenses for de-veloping of the power of streams, the Secretary declared that he would not put into the contract any restrictions as to monopoly. He even went so far as to declare that the monopoly was in some instances an advantage to the public.

He followed this up with the old plea that only big companies can make the necessary extensions and

that they are needed to develop sparsely settled regions. In view of the demand which the governing authorities would impose on a corporation seeking a permit, ne thought it was only due the grantee that it should not be "harassed" by small competitors.

To pay a last honor to the memory of Gustav Mahler, the late conductor of the Philharmonic Society, the Metropolitan Opera House and the Imperial Opera of Vienna, the largest audience of the season thus far gathered for a Philharmonic concert filled Carnegle Music Hall, last night. The program was designed by Josef Stransky, Mahler's successor, as a tribute to the decessed maestro. It opened with the Funeral March from the first movement of Mahler's Fifth symphony and included the Prelude and Glorification and "Good Friday spell" from Wagner's "Parsifal" and the Third ("Heroic"), symphony of Beethoven.

Hundreds of late-comers stood in respectful silence as the Mahler funeral march was given an exceedingly painstaking performance by the orchestra he directed for two years. Although there may be some mental reservation concerning the justification for or patriotism of lynching un-No desirable citizens, he does not mention high rent figured in; no extravagant fix- it. In fact, he is indignant only to this extent:

"The repeated race riots and lynch ings that have occurred in the North-ern States during the last decade or so must have convinced the least ob-servant that neither race feeling nor the tendency to lynching is in a sense peculiar to the South. It is a horrible

peculiar to the south. It is a distribution, for which the whole country must bear responsibility.

"But mere denunciation of the crime of a mob amounts to little or nothing. We must recognize what the N. E. Corner 26th Street Dreadful though it is for the mob by such a crime, it would be an even worse calamity if the community did not feel the fury of indignation which produces the mob spirit; and such a fury of indignation should be able to seek satisfaction under the law and not against the law.

"There is no question whatever that there are serious breakdowns in the administration of justice in America; breakdowns for which we all of us are more or less responsible—the people as a whole, the Legislatures, the lawyers, and the courts.



The dramatists would perhaps be nore fully comprehended if they were permitted to speak for themselves. but sometimes the dramatist is a man of few words-except those he puts into the mouths of his characters. few words of Ibsen outside of his dramatic works are admirably clear. t has been held, for example, that beenism is a repudiation of all ideals Hear him: Hear him: "I gave up universal standards long ago, because I ceased believing in the justice of applying them. I believe that there is nothing else and nothing better for us all to ize ourselves

A repudiation of whatever hinders self-realization, of whatever outer influence weighs upon man and pre-vents him from attaining what his own spirit prophesies. Little wonder that he was not content with modern civilization—an influence from without, unrelated to man's inner neces-

He expressed to Professor Dietrichson his conviction of the need that the intellectual soil be "thoroughly turned up and cleansed and all the swamps drained off." But he was not led by his discontent to wish for a return of the good old barbaric days, when that soil was a barren waste; on the contrary, he speaks so enthusiastically of the "emancipated and emancipating spiritual conditions of the great world" as to show clearly his belief in the permanence and mind's necessity for free
