LONDON, Jan. 24.—The American Minister at Peking has called in all Americans living in outlying parts of the city, according to a news agency dispatch from Tientsin.

The friction between the Manchu troops of the imperial army and Yuan Shi Kai's force of Chinese troops is constantly increasing, and a serious conflict may be precipitated. conflict may be precipitated

PAU, Jan. 24.—Maurice Tabuteau, the French avlator, flying in his monoplane, made world's records today for the distances of 200, 250 and 300 kilometers (124.28, 155.35 and 186.44 miles, respectively). He covered the 200 kilometers in 1 hour, 54 minutes and 21 seconds, the 250 kilometers in 2 hours 22 minutes and 57 seconds, and the 300 kilometers in 2 hours and 51 minutes.

The record for 200 kilometers has been held since September 8, 1910, by Aubrun, the French aviator, who flew the distance in his Bleriot monoplane at Bordeaux in 2 hours 18 minutes and

30 3-5 seconds.

Tabuteau also established new records for a flight of two and of three hours. In two hours he covered 205 kilometers, 287 meters (127 miles 5 furlongs), and in three hours 316 kilometers, 287 meters (196 miles 973 yards).



It is one of the most desperate fights on the part of the working class that aggregation of force can be overthrown price of feed for a dozen horses for has started in a long time, and it deserves support.

Those who have read the appeal of the strikers and who have followed the methods used in fighting against them cannot but be impressed by the utter recklessness and criminality of the respectable citizens. Besides the men and women who are on strike, there are many children also out, children who have just arrived at the age where it is legal to exploit them, but who, nevertheless, should still be in school and should still be permitted to play. But they are parts of the human machinery of the great mills, and their lives are being crushed out.

There is one public service official in the mill towns who is always reasonably sure of plenty of business. He is the undertaker. A great part of his trade comes from those who die youngthe youths and maidens who die of consumption that results from factory work. Unless those who go into the mills are of extraordinarily tough fiber, it is not long before they succumb. If they are sturdy, if they have good stamina and a fine reserve of energy, they can look forward to the delight of being old, dragged out, sapped. dried and withered men and women at 30 or 35.

Yet, the mill towns are sources of good incomes. There are many stockholders who live in elegant and cultured leisure on the sufferings of the mill hands. Many an assured income is derived from the mills on the Merrimac. These incomes are for a few only. Those who produce them are the workers who have been hunted through the streets, who have been ridden down by the soldiers, clubbed by the police, and accused of dynamiting by criminal detec-

tive agencies.

Their fight is based upon very moderate demands. They do not wish to starve as quickly as they have been starving during the past few years. The cost of living has been steadily going ard. Not only have their wages not increased, but their chances of steady employment have decreased. Recently the employers worked one of the meanest games that have been played in what is really the meanest industry in this country. When the fifty-four-hour law was passed, the mill owners scaled wages down from the old fifty-six-hour basis. It is a fact that under the new condition of affairs, in spite of the fact that the working time is two

hours less, the output is as great, if not greater, than it formerly was.

This comes from two reasons—first, that labor has been intensified, and secondly, that improved machinery has been introduced to such an extent that the individual production of the workers has

Not satisfied with this, the mill owners sought to steal a few cents from each pay envelope. They were getting as great a dividend—in some cases a greater—but this two hours a week was a horrible eyesore to them. They wished to take away from the workers all benefits that might come from these two hours. must have known the poverty and degradation that existed. They knew that in the mills there were few workers who were able even to live half decently. Yet they grudged them the slight benefit that would come from these two hours. It was an unspeak-ably contemptible thing to do. Yet the doing of it was wholly in keeping, was quite typical of the attitude the mill owners and stockholders have always taken toward the mill hands.

WHAT HAPPENED TO RILEY

From Great Britain comes the startling news that the Rileys have joined the union.

The Rileys, be it known, were for several weeks, recently, two of the most important people in the kingdom, though they were but humble weavers.

But Joe Riley and his wife have passed into oblivion and the union at the same time, and nothing more will be heard of them.

They were the two noble souls whose sturdy independence of character scorned the coercion of the weavers' union in the great cotton kingdom of Manchester, and whose refusal to join that tyrannical body caused the great lockout of 300,000 cotton operatives. Their undaunted attitude drew the most flattering encomiums

Their undaunted attitude drew the most flattering encomiums from the employers and the press of their country. Telegrams of congratulation and appreciation were showered upon them from all parts of the kingdom, and our own John Kirby, of the National Association of Manufacturers, who has a most sensitive discernment in perceiving true nobility of soul, sent them a cablegram encouraging them in their noble stand and bidding them persevere thesis.

And they did. They stood pat.

And in the meantime the employers who had showered them with appreciations and promises of support began to dicker with the 300,000 locked-out weavers and finally came to an understanding

with them.

By which understanding the 300,000 went into the mills again and the Rileys became the locked-out. But nobody paid any attention to them and the telegrams and congratulations ceased.

Finding that the promises of support were not realized, and that they could not get employment, in despair they applied for membership in the union and were admitted. A half dozen lines in connection with an item on the condition of the cotton trade are now deemed sufficient to recount this tragedy of two heroic souls. In the meantime the wheels spin merrily round, the interrupted process of production has been resumed, and the Rileys, bending wearily over the looms, have learned the old, old lesson that will endure while capitalism and wage slavery endure—that no scab is a hero to the masters any longer than they have use for him in that particular role.

The Kaiser, it seems, has never understood the meaning of the movement that calls itself Socialist in Germany. He has been mistaking its membership for red revolutionaries. bent upon appropriating the property of the capitalists and undermining his throne, and under this erroneous conception has been permitting them to get on his nerves, so to speak, not knowing that he could find instant relief in perusing the editorial comments on the election in his empire which are now appearing in the great

American press. Here, for instance, is a sample of the imperial nerve tonic prepared in the editorial sanctum of the New York Tribune:

"While, for the sake of conveni-ence, Mais militant party (In Ger-many) is called Socialist, it is not that in the sense in which the term is used here (in America), but is rather in which the term ... democratic. Doubtless its most spicuous leaders are theoretical cialists, opposed to private ownership of property and the like, and a cer-tain proportion of its membership is of that faith. But there is no doubt that the great majority of those who vote its ticket are not Socialists at all in our common acceptation of the word, but are believers in republican-

ism or democracy."

It is a new business for American editors to hand out journalistic consolation to European monarchs, and they have apparently gone in for it only since the general rise of Socialonly since the general rise of Social-ism into public attention. It is a far cry back to the days when the Amercan editor was expected to hurl de-fiance in the teeth of European monner of Jefferson Brick, and announce the terrible effect upon "Queen Vic-Gazette." which was sent to her spe-cially marked and addressed. The new policy is now to assure Kings and Kaisers that they have nothing whatever to fear from Socialism, which is only a convertent name for a lot of people who are really as harmless and meaningless as our Republicans and Democrats.

Socialism in Germany is not "op posed to private onership of property and the like," declares the Tribune. lit is 'only here in this country that Socialism is adentified with such opposition. Of course, Socialism here was "imported from Germany" and is thoroughly "un-American," as every editor knows, but a little contradiction of this sort is a matter of no moment. It is quite possible to

no moment. It is quite possible to hold the opinion that while the origitransplanted across the Atlantic has not only preserved but increased its original "red" complexion, and at the same time declare that Socialism can never obtain a foothold in this coun-
