## Report of This Month's Fierce Municipal Fight.

The Socialist Labor Party's Big Vote Remains Solid Despite All Chicanery, Carried on for Months, and Brought to a Climax on Election Day, to Break It Down-A "No Politics in Unions" Gompers Man at the Dirty Work of

NEW BRITAIN, CONN., April 22.-The city election in New Britain is over. We are credited with 700 votes, besides 29 more that were impudently thrown out in the 2d Ward by the counters on the pretext that the envolopes inclosing them were not properly sealed, the decision by the Moderator being brazenly given in every case NOT BEFORE, but AFTER the envelopes were cut open and found to tain Socialist ballots. Our watchers were unceremoniously kept at a distance from the counting table by a policeman, at the order of one of the local slavedrivers, Wetmore by name, the son-in-law of P. Corbin, who is one of the largest ilding hardware manufacturers in the world, his factories being located in New Britain, and Wetmore being the superintendent. That man Wetmore went so far watcher's dared once to step a little nearer to the counting-table, he, in regular capitalistic style, said to the officer: "Why don't you keep that thing away?" meaning our comrade, who, being a wageworker, must be considered, like any other part of the shop, as a thing, and nothing more.

To fully appreciate the significance of the fact, the comrades in the country must remember that it is the first time that our Section went into a mayoralty contest with a full ticket in every ward. Last har the contest was only for one-half of the members of the Common Council, election for mayor and other city officials taking place only once in two years. Workingmen Having Been Shot Down in Cold Blood on the French West India Island of Martinique, Alexander Zevaes, a Socialist Member of the Chamber, "Calls the Government to Account-Striking Contrast, Between the Manly Conduct of Class-Conscious Workingmen in Legislatures, and the Poltroonish Conduct, on Similar Occasions, of the Class-Unconscious Mahers, Princes, Rosses, and Other Specimens, Elected Here.

To-day, being again interpellated from several quarters, the Minister answers us, "Light is not yet secured; we shall eventually establish the responsibil-ity; have confidence in the Government; will issue proper instructions." seems to us that it is not by issuing instructions that the Government should end, but that, on the contrary, it should begin therewith.

#### Capitalist Responsibility.

It is truly singular that, after two months, the Government should come again before the people, asking for further delay. ("Hear! Hear!" from several benches on the extreme Left.)

The Minister has sought to cover his Governor of Martinique. He recognized full well, as the debate clearly proved, that at the bottom, at the very foundation of the occurrences, there lay a question of an economic conflict, a question of wages Indeed, it was upon the refusal of the employers to keep their previous promise a raise of wages that the strikes of Martinique broke out. The employers, protected by the complicity of the Governor and of other public officials on the island, failed in their given word. Thus we see from the start a capitalist responsibility pointed out by the facts themselves. ("Hear! Hear!" from the Left.)

There is a second responsibility The Minister has vaialy sought to extenuate it. But he could not help admitting it. It is the responsibility that rests upon the military authorities, particularly upon Lieutenant Kahn. a raise of wages that the strikes of Mar-

#### Military Responsibility.

The Minister declares to us: "Lieuten ant Kahn limited himself to faithfully following the orders of his Captain." refers to the military witnesses. Truly, this attempt at switching off the true responsibilities, and blurring them with such artifices, looks like trifling with the Chamer. (Applause from benches at the extreme Left.—Protests from others.) It not self-evident that the military witnesses are bound together by that passive obedience that compels them to give right to their superior, to their Captain? Con-

to their superior, to their Captain? Consequently, "instructions" from that quarter are doomed to fail.

In the meantime what already transpires, and strikingly so, from the several testimonies, produced at the tribune; what transpires norably from the account of the Mayor of Fracois, M. Clement, is the lack of cool judgment, inconceivable and criminal on the part of that officer. ("Hear! Hear!" from several benches on the extreme Left.)

What is certain is that the shooting took place without the provisions demanded by the law having been complied with. What is certain is that the troops—whether soldiers or officers—were not menaced. They could not, then, invoke the right of legitimate defence, seeing that, as has been proven here, the troops and the strikers entered into conflict at a distance of 35 metres, and that, further more, it is an established fact that, of twenty-five victims, one half were shot in the back. Consequently, there is nothing, you can allege nothing, to justify the abominable massace that we are deploring to-day. (Renewed applause.)

The Governor's Responsibility.

#### The Governor's Responsibility.

But apart from the responsibility that rests upon the employers, apart from the responsibility that rests upon the military authorities, there is, whatever the Ministe may say to the contrary notwithstanding a direct responsibility that rests upon the administrative authorities, the responsi-bility of the Governor of Martinique (Renewed applause.)

No doubt, gentlemen, it was the officer who gave the order to fire; no doubt it was upon his criminal and insane order that upon his criminal and insane order that twenty-five French workingmen fell, struck by French bullets. But who was it that sent the troops to that spot? Is it not the Governor himself? What were the circumstances under which those troops were directed to march to Francois?

In the first place, as you have been told, there was no strike at Francois. It was in a neighboring settlement, at Robert that the workingmen in the sugar industry had by common accord decided to quit work.

work.
Accordingly, there was no agitation as Francois: no trouble, no disorder could be proved there. According to the admission of the Minister, no wrongful act had been committed there, neither against persons nor property. Why, then, the intervention of troops? ("Hear! Hear!" from the banches in the extreme Left.)

#### The Capitalist Carries the Government His Vest Pocket.

And what still more aggravates this in tervention of troops upon the field of labor—that has now become a field of slaughter—at Francois is the circumstance of the troops having been sent to Francoi upon the simple request of an employer. ("Hear! Hear!" from the same benches.)

Thus it is found that the Governor himself obeyed the order of the employing class. (Tunult.) Generally, when troops are sent to a place where there is a strike, the pretext invoked is that the

Nor is this all, gentlemen! Where are those soldiers quartered? Where is that officer quartered? If I remember rightly, at the time f the Creusot strike, one of our colleagues protested because the officers and soldiers, sent to Creusot, were lodged in the houses of the manufacturer. On that occasion, if I err not, the President of the Council, or some other representative of the Government, left constrained to recognize the justice of the complaint, and to issue orders that the troops evacuate the premises of the employer, whose employees were on strike. Now, in this Martinique instance, the troops sent to Francois upon the demand of the employer are bivouacked on the premises of that identical employer.

The Governor's responsibility is fully established. It is he who placed the troops at the disposal of the employer, if the officer was the arm, the Governor as the head that directed these operations.

"Strikes," "Riots," "Disorder," "Necessity of Troops," All on Paper.

CROTON LANDING, N.Y., April 22.deep, ill-smelling mystery surrounds the "strike at Cornell Dam."

Last year, New Yorkers saw a conduc tors' and motormen's strike entirely brought on and almost exclusively fought out- in the papers. It was a Stock Exchange strike. The "bears," who wanted to buy stock, boomed the strike; the "bulls," who wanted to sell, ran down the strike, and declared it non-existent. The mystery in that case was soon obvious the contradictory attitude of the New York press gave the tip, and the facts were soon discovered. But in this Cor nell Dam instance the mystery baffles all conjecture, except to point to the deepest laid plot yet planned against Labor, and in which the capitalists and politicians have interests all pulling one way. The New York papers are all full with reports of "violence," "disorder," "excitement," "disorder," "excitement," "embattled strikers," "lawless mobs" at Cornell Dam that we, right here, see nothing whatever of. What can that

Some seven years ago, when the Croton sheds were torn down and new acqueducts were to be built, a large number of Italian workmen came or were brought this way. Suddenly the inhabitants of this place were startled with the information (arrived by the New York papers) that we were here in the milst of "riots." with "embattled strikers" "terrorizing" the peace, and that the militia was called out. Since the arrival of the militia, every law of the land has been violated by the troops. Houses were searched for "arms unlawfuuly secreted" (a new offence, knocking another hole into the Constitution, which guarantees the right to keep arms); hardly any were found, whereupon men as innocent as unborn babes were arrested, landcuffed and marched off. One man was killed; and that event adds to the deep mystery of the whole affair. He was Sergeant Douglass, of the militia. There is well-grounded suspicion that he was killed by one of his own men!

Until the dust, wholly raised by the capitalist Government itself, settles, the mystery remains unfathomable. In the meantime, Sheriff Malloy, whom many of these Italians voted for, is known to be threatened with arrest in default of payment of a liability incurred under suspicious circumstances; the former holders of the shanties, now owned by the Italians, are anxious to drive these men out, and in that way be able to resell the whole thing; the contractors and politicians seek to get in here a new set of Italians, green men, whom they may pluck, while the present Italians have become too knowing for them; the Seventh Regiment is anxious to blot out the stain of its skulking from the Spanish war by spilling some workingmen's blood;—and behind all these hvena interests stands the Demo. Republican Government playing some, as yet inscrutable, political game. Government playing some, as yet inscrutpolitical game Such is the situation here.

## BUFFER STATES

## The British Scheme of Empire Tried by American Fakirs.

What Persia, Afghanistan and the Iudian Princes Generally are to England, the Pure and Simple Unions' Labor Fakirs Sought to Be to American Capitalism Against Socialism-Complete Failure-O'Connell's Complete Discomfiture.

England, in holding India, is compelled to be ever on the alert to prevent the overthrow of her supremacy there. Not alone must she secure herself from attack within India, but also from attacks from with-Being unable to keep a garrison in the country sufficient to overawe the population, she is forced to array one section against the other in order to keep up the old racial antagonisms. But to do so, she is forced to allow certain native Princes to keep up a fiction of authority, and to give them large sums out of the revenues for "purposes of state," i. c., so that the aforesaid Princes may live luxuriously, surrounded by a barbarous retinue, and have the ability to go on, and stay on, a protracted debauch. In return for these favors, the Princes keep up certain irregular forces for the protection of the "state"-which means England's power.

The natives, recognizing the authority of their own Prince, are, by the means just referred to, kept "peaceable" and in The Princes, being under obligations to England, are in duty bound to protect the source of their living and put down, with the utmost severity, any appearance of disloyalty to England. Thus India is, to a great extent, held from the inside for England.

On the outside of India, England is threatened by Russia, which is rapidly enveloping her northern frontier, both on the east and west. Here, again, England plays a game not to be sneezed at. Instead of occupying the "states" immedi ately on her borders and being put to the burden of keeping therein a garrison, she allows those states, notably Afghanistan and Persia, to exist astindependent states, with their native ruler in absolute supremacy. These she subsidizes with sums of money, thus securing the fealty of those in power. At the same time, she always holds over their heads the threat

Russia, in her march through Asia, has given due notice, by her acts, to the heads

given due notice, by her acts, to the heads of the independent states of their fate when Russia at last occupies a country. Therefore native rulers are very apt to oppose the designs of Russia. For these reasons England can always depend on such states standing as a buffer between India and the aggressions of Russia. A very appropriate name has been found for such states in "Buffer States."

Capitalism has in the past in this country kept her subjects peaceable and quiet by means of some very poor imitations of the native Princes of India—the labor fakirs—who have been looked upon by the workers as their natural leaders, and who have sedulously kept the workers in ignorance at so much per. This system of police is coming to an end, as it is in India, owing to the fact that the workers are beginning to understand that the fakir is but the tool of the oppressor, and are now paying less homage to him than in the past.

#### MAY DAY.

On the First of May, two days hence the Socialist Movement in this and other cities will celebrate the International Day of Labor. This year, in most instances the occasion wll derive special significance from he circumstances of its being connected with DAILY PEOPLE festivities.

May Day has gradually changed its character. From being originally mainly a demonstration in favor of the Eight-Hour Day it has become a demonstration of class-conscious revolutionary labor-solidarity: and so strongly marked is this feature that the impure elements in the Labor Movement have either left it severely alone, or have flown to the other extreme and seek to temporarily conceal the ulcer of their existence under its fair name. In either case, the true character of the May Day is brought out in all the greater relief; and, as stated above, this year is emphasized by its connection wih the series of festivals that are to herald into existence the first Socialist daily in the land-THE DAILY PEOPLE.

Nothing better than that can, at this season, typify the present significance of the May Day. May Day to-day means the bold entry on record by the wageslave class of the fact that it is on the march from the midnight cells of enslavement, in which it has been held confined, to the upper regions of light and freedom; that its "time" is up, and henceforth it is no longer to be dominated, negligeable quantity, but an ever more dominant and leading factor in society. The birth of THE DAILY PEOPLE implies a cutting of the navel string that held the proletariat in ignored seclusion. With THE DAILY PEOPLE that comes to an end, and a new era dawns with midday brightness, in which the cause, he interests, the aspirations, the needs of the working or proletarian class are heralded in tones as clear as hitherto only the views of the dominant capitalist class were.

Long will the May Day of 1900 be remembered : it marks an era.

#### FROM THE SEAT OF WAR.

The appeal by the four now ex-members of the N. E. C., from the decision holding them in contempt of court, was to be argued on the 20th instant. Owing to the large number of cases ahead of it, that it will come up on the 11th of next month.

The motions to obtain a stay of the execution of the decision in contempt have failed. The thirty days within which to pay the fine or be imprisoned expired on the 23d instant. The comrades under sentence are, accordingly, theoretically, liable to imprisonment at any time, seeing that, being poor men, there is no money to be got out of them. From the latest information received, they are still at large, but ready to submit to arrest for the Party's sake, as any and all loyal Party members are. But this, of course, is not the end of that tune. Not by a good deal. The Party's innings are yet to come, and come they will in due time. But time is not yet.

But this is not all that has occurred during the week.

It will be remembered that all these proceedings against these comrades result from an action instituted gainst them by the Volkszeitung Corporation on the fraudulent allegaion that they were not members of the N. E. C. of the S. L. P., but were issuing THE PEOPLE as a private act in violation of the Party's orders. From this it will be noticed that all these injunction orders, etc. can not affect the real issue, to wit, who owns THE PEOPLE. the S. L. P. or the Tammany Volkszeitung? Now, then the Party, not being a compact of swindle like the Corporation, neither proposed to nor allowed the real issue to be settled by any surreptitious methods, such as the Corporation schemed Accordingly on July 18, four days after

the Corporation started its swindle-suit against the individual members of the N. E. C., the Party itself instituted an action against the Corporation itself for the property of THE PEOPLE. This action is now coming up on the calendar and approaching trial, and the Corporation is proportionately trembling in its boots about it. The case came up on the calendar during the week, and the Corporation fraudulently sought to have it layed off on the false allegation that "the issues therein had been settled" (!!!); and it attempted some more back-door manoeuvres by trying to hand up to the Court a bunch of "affidavits," no doubt filled with more police-spy matter. The Court, however, gagged at that, and to the discomfiture of the Corporation, the Party's case remains on the calendar, where it will be reached in measurable time.

Finally, the proceedings against the Editor of THE PEOPLE are hanging fire.

THE PEOPLE, the name of the Party's organ, remains, and will continue in the Party's hands. The S. L. P. consists of men, not monkeys. It holds the fort.

#### POLITICAL and ECONOMIC.

If quibbling can save the neck of the capitalist system, whatever may happen to it, it won't hang. This, for instance, is the way that the New York Sun disposes of the danger that besets the Trust magnates:

magnates:

There is no reason to be so terribly frightened at the progress monopoly is at present making as some politicians and newspaper writers profess to be. In fact, the outery against the gigantic corporations which have latterly come into existence amona us, is due rather to enyy of their supposed profitableness than to a real conviction that they are a menace to the country's welfare. Shares in them, it is observable, find plenty of purchasers, and the dividends paid by them are pocketed without compunction. So long as this demand for participation in the earnings of monopolies continues, opportunities for gratifying it will be multiplied, and this, whether the monopolies be those of the products of labor or those of labor itself.

So, then, the fact that there are "plenty" of purchasers disposes of the trouble! By "plenty" is here meant, not a majority of the people, nor yet a strong minority of these, but a large quantity of money. Thus the fact that capital in the shape of money and congested in the hands of a few men, is plentiful, settles the safety of the Trust.

A correct reasoner would conclude just the reverse. The more plentiful these moneys, anxious to invest in Trust stock, be, all the surer are the signs of a widening area of "envy." Now, then, "Envy." when it has risen to the size of a popular magnitude, has wrecked many an "envied" institution. The path of history is marked by the wreckages that "Envy' wrought. Nor will "envied" Trust-stock, held in private hands, fail in due time to one of these milestones

A pamphlet has been issued by the "Women's Synodical Society of Home Missions in the Synod of New Jersey," which pamphlet, under the head of "Our Special Work for the Year 1900," makes the following declartion:

Patriotism as well as religion is calling on us in thunder tones to save our beloved land from Mormonism, Socialism, intemper-ance, Sabbath desecration, materialism, and other evils that threaten us.

Is this a case of pure ignorance? No. It is a case of unqualified, Pharisaic hy-

The precious Synod in question cares little about the "desecration of the Sabbath" by their capital that draws interest on the Sabbath as on any other day, and by the capitalist institutions that are operates on the Sabbath as well as on any other day, and thus fleece the working

class right along.

The precious Synod in question cares little about Mormonism, except as a pretence. It knows full well that, under this capitalist system, which Socialism alone is in the field to overthrow, polygamy does flourish right under the shadows of the churches, and polyandry, too; and that the one and the other are, not protected merely, but the very pillars of this

synodical social system.
"Thunder notes," indeed! But it will not be the imitation thunder of synodical restarring of Pherican the synodical rest at the ballot box. The power of the capitalist class to plunder the working clas in the shops stands upon slippery ground. The lower ing of the earnings of the workers, that is going on, fleecing the working class of ever larger slices of the product of its labor and placing these stolen goods into the hands of the capitalist class seems irresistible and complete. Yet it is not. That power needs the backing of the political or public powers to do its nefarious work. Without the public powers, the capitalist class could not continue a day in their pursuit of plunder. Legislatures, Executives and Judiciaries in the hands of the class-conscious working class would strip the idle capitalist class, whom the Tituses represent, of the laws that now they pass in their own behalf, and against the workers; would strip them of the militias, police and judicial "Gatling guns," with which they browbeat the workers into submission to being plundered. In short, capitalism, being as all other social systems, essentially a political institution, needs and sedulously guards its political power. In this respect, however, capitalism is week

Capitalism's weak spot in politics lies

in the fact that the people—wage earning workers as well as capitalist spongers—are equipped with the suffrage To every one capitalist vote there are 100 workingmen's votes. The working class, accordingly, has its plunderers where the hair is short. It can out-vote them, thus tak ing possession of every single branch of the political powers, and thus turn upon the sponging capitalist class the very guns it needs to uphold its supremacy and oppress the workers with. This state of things has long been felt to be dangerous by the capitalist plunderers, and they have long been straining to remove the danger. The ideal move in that direction would be to simply take the suffrage from the hands of the workers. This move was at-tempted, but was dropped like a hot potato. It had to be dropped because its very boldness gave notice of its purpose and raised a hurricane of opposition. Since then the same end has been pursued but in covert ways. The next be to depriving the workingman wholly of the ballot is to remove the opportunity for him to use it. It is in that line that the capitalist plunderers are now moving, and that is the line of operation of the Tituses. Annual elections means annual opportunities for the workers to use their ballot, and that means annual frights for the capitalist looters of the workers. These opportunities are to be gradually reduced; from biennial, the elections will become decennial; and so on until elections will be so far removed from each other that the capitalist class need not in the cocoanut of the biennial election bill that the Hon. G. M. Titus of Iowa is so proud of. He is doing the disfranchising work of the plunderers of the work

This bil is to be voted on by the people of Iowa next November. The capitalists generally will be in favor of it, and intelligently so: it means safety to them. Th vorkers cannot be intelligently in favor of it: it means a good, long step in the direction of their enslavement.

The workingmen voters of Ohio should snow that proposed amendment to the Constitution of their state under an avalanche of adverse votes, and thus give notice to the Tiruses and the Unionist decoy ducks that they and their dirty game are seen through.

The system that reduces labor-power to a commodity and throws an ever-increasing surplus of it on the market, thus creats a law of depreciation that affects all trades and grades of labor alike. And that law cannot be combatted on the trade unionist plan of "Help me and I will help you," because it renders all ever more powerless to help either themselves or their fellow wage-workers. Its destruct ive action can only be stopped by the overthrow of the system of which it is the inevitable result .-- From Vogt's address on the S. T. & L. The Present Muddle Made Clear-Scampishness of the Leaders.

BUENA VISTA, PA. April 12.—Chaos reigns supreme in the Pittsburgh mining district, resulting from a "misunderstanding of the scale," so says the ostentatious oracle, Plug-Ugly Pat Dolan. On the 1st about 20,000 men ceased work through the scale not being satisfactory to The action of the men in this inof course, reflects discredit upon Since the trouble arose the officials have time and again tried to induce the men to resume work; in some they have proved successful whilst in others they have met with stubborn resistance from the men, who have demanded a district convention.

#### The Difficulties

are of three kinds :

First.—The tipple hands have not been ecorded the same advance that the miners and inside day labor received, viz., twenty per cent increase. It might be aid that they are ignored entirely; nothing is mentioned of them in the scale's according to the opinion of the coal combines, the organization has no jurisdiction

According to the opinion of the coal com-hies, the organization has no jurisdiction over them, and it appears the point has been conceded by the officials. Secondly.—The drivers of the river mines are demanding \$2.40 per day, or an increase of twenty per cent above last year's prices. It might be added, also, that the scale price last year for drivers was \$1.75, though the drivers of the river nines received \$2 per day.

Thirdly.—The coal combines desire to run the "run of mine" system at some of their mines, which is contrary to the spirit of the Indianapolis agreement.

"The Eight-Hour Day."

The first question is of deep significance to the mine workers when taken from the eight hours per day standpoint. The coal combines are insiduously scheming against it, and it is but a question of time when the miners will revert back to the organization are continued. Truly speaking, the U. M. W. organization is im ing, the U. M. W. organization is im potent. It conducts its business upon the compromise plan, which means precisely the obtaining of benefits of a retail character, while surrendering to the capitalist coal barons benefits of wholesale significance. On the 31st uit, while the mine workers were holding public meetings commenforating the eight-hour work day as the "greatest achievement of the 19th century," the coal combines were notifying their tipple hands that they would receive \$1.60 per day of NINE HOURS!

reald receive \$1.60 per day of NINE HOURS!

The mine workers observe the point, and see the eight-hour day endangered; hence the solidarity (though not class-conscious) manifested at this time. The men are aware that, if the tipple hands are forced to work an hour longer each day, they will dump all the coal at hand in the evenings, consequently there will be no coal at the pit mouth in the mornings until it is brought from the face workings. During the time between the starting time and the coal arriving at the pit mouth, the tipple hands are idle; and esides, the drivers are idle a portion of the time, because they must wait until the miners load the coal. Consequently, with this manifestation of idleness, pressure will be brought to bear upon the miners to sither commence earlier or work later to keep a supply of coal on hand and keep day hands steadily employed.

"It seems to us, then, that all those conditions make it a duty for the hencst element of organized labor, for the class-conscious element, for the Socialist element, to stand up and make a determined fight, so as to relieve the American wageworking class from that particular species of leeches who suck its life blood as hungrily as the capitalists do; who, when they do not or cannot squander the funds of the Union, contrive at lenst to suppress the development of that spirit of solidarity which alone can enable the working class to effectively resist the capitalist class. And in order to free the labor movement from those leeches—which do not belong to; which actually have turned the Trade Union organization into agencies of capitalism—the Socialist Trade & Labor Alliance was organized."

The address of Delegate Vogt is a clear and vigorous presentation of the Socialist conception of a bonn fide labor union. Briefly, yet pointedly and with absolute accuracy, is given the history of the Trade Union in the United States—its lack of solidarity, its corrupt leaders, its alliance with the political parties of the capitalist class, and its lack of tangible results for the working class.

#### New Haven Election.

NEW HAVEN, CT., April, 22,-The S. L. P. vote at the city election was 600, out of 11,200 votes cast. Only minor offices were to be voted for, and, naturally little interest was taken. Less than one-half of the registered voters cast their ballot. We had a full town ticket and candidates for one Alderman and three Councilmen, in nine out of fifteen wards

"benefits" while maintaining the "agreement," which McGuire, Gompers, et al., fondly hope will in time come to rank as a "Gentlemen's agreement."

The attempt to accomplish the end sought was started by the machinists led by that extremely "native" Prince. Mr. O'Connell, and has been a sorry failure. 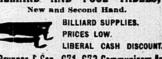
