SANDGREN SAYS IT IS AROUSING EXCEPTIONAL INTEREST.

Sandgren is well known to readers of The People, having initiated the discussion on "As to Politics." He is slightly over medium height, good ning heartily in the ba regarding the intellectual warfare he has set in motion.

On his trip across the continent, Sand gren stopped at Chicago, where he met Daniel De Leon, the Editor of The People, and was present at his lecture in that city. Asked for information and his impressions regarding the latter event, Sandgren said recently to a Daily People representative:-

"Daniel De Leon spoke on the West side in Chicage on March 4th, under the auspices of Local 85, I. W. W. A splendid proletarian audience of about 400 listened to the address very atentively and without any disturbance, a thing, I am told which does not always happen on the West side, as some lecturers have found out to their sorrow.

"In his lecture De Leon traced the evolution of Revolutionary Unionism to its culmination in the industrial form of organization, adopted by the Industrial Workers of the World. The Knights of Labor, the first tentative effort in this direction, the speaker dismissed briefly, as it was of little moment. "The Socialist Trade and Labor Alli-

ance was the next manifestation of the current setting in the direction of revolutionary economic organization. But the S. T. & L. A. lacked "the soul" rie organiza of a revolutionary economic orga-tion it was not industrial in form.

"The first organization industrial in form,' the speaker said, 'was La Resis-tencia, the organization which originated tencia, the organization which originated among the Spanish cigarworkers in Tampa, Fla. These men proceeded to extend their organization to other industries and were successful in a degree which struck the masters with fear. In fact, Gompers had to be called upon to

"On his trip through the West, De Leon will undoubtedly address larger audiences than any Labor agitator before has done. In Nevada startling preparations are being made for De Leon's and in San Francisco he will probably address some 4,000 people. D. Haywood,

He also stated to the local financiers that Detective McParland was in daily dread of his life and that he attended mass every morning in order that he might be in a "receptive mood" when the Almighty ealled him.

Caldwell, Ida., March 7 .- The attorneys for the defense in the Moyer-Haywood case argued a motion to-day for the dismissal of the case on statutory grounds. By the statutes of Idaho, a suit which goes over two terms requires a re-indictment. The prosecution is carrying its illegal tactics to the very end, trying to carry on the trial on an expired indictment. An advised case to settle the matter would take at least twenty or thirty days-a further delay.

These three capitalists have bought the expensive plant of the Worcester, Mass., 'Spy," a capitalist paper that failed.

Undeterred by the ill omen of raising their venture upon a plant with failure for its record, they are in for business at Labor's expense—the business that "radical" capitalists are frequently seen ready to ply—the business of raising a pedestal for themselves and bossing things. In full masterhood of the paper, its capitalist owners hired "A. M. Simons, Editor" as they would hire a scrub-woman. They hired him, not because they think he can vocalize their unvocalized sentiments, but because they know that he will scrub as they dictate, and they are confident in this because of the plasticity that they noticed their applicant for the editorial scrub-womanship to be fitted with when he crooked before them the pregnant hinges of the knee that thrift may follow fawning. That the spineless S. P. should be so afraid of owning its own press as to allow itself to be owned by press" is nothing new. Nevertheless, connected with and flowing from these manipulations are a series of incidents valuable to watch, and droll to contemplate. .

The machinations of "A. M. Simons, Editor" to secure the editorial scrubwomanship of the "Daily Socialist" by the grace of its capitalist owners has had for its immediate effect the rifting of the hitherto compact set of shyster lawyers and other "intellectuals" who hitherto bossed the Chicago Socialist party's Tammany Hall machine. Those who are not in favor with the capitalist triumvirate realize that the bossing will henceforth be done by those who are in the good graces of the triumvirate. This means a diminution of the only thing Socialism means to them. Hence-WAR! When men fight, war is tragic; when monkeys fight, war is clownish. It is so in this instance. Hitherto, the leading intellectual who decried the "Anarchistic language of the S. L. P.," the "S. L. P.'s use of such terms as 'Working Class' and 'Class' Struggle,'" the "S. L. P.'s narrowness in not realizing that the 'intellectuals' and the middle class, not the stupid working class, are the ones to establish Socialism," etc., etc., the "intellectual" who led in these views was a dapper lawyer, Thomas J. Morgan, later known to fame as "Tommy-I-I" from the fondness he entertains for himself. Now, Tommy-I-I is among the "outs" of the former compact set of bosses. "A. M. ### **ANTIPATRIOTISM**

ADDRESS OF GUSTAVE HERVE AT THE CLOSE OF HIS TRIAL FOR ANTI-MILITARIST ACTIVITY, BEFORE THE JURY OF LA SEINE, DECEMBER, 1905.

Translated For The People By Solon De Leon

#### [Translator's Note.]

Gustave Herve, historian of note and Professor of History at the Lycee of Sens, in Yonne, France, was arrested in the autumn of 1905 for signing, with several others, an anti-militarist poster with which the highways of that country were placarded at the time of the annual military maneuvres. He was tried before the Jury of the Seine district in December, 1905, on charges of preaching insubordination and treason; was convicted and sentenced to four years' imment, and his Professorship revoked. Later, on the accession of Clemenceau to the Prime Ministry in the early part of the present year, he was freed in the general amnesty announced by the latter, but not restored to his chair.

The following is his speech to the jury, at the close of his trial. S. D. L. 1

#### PREFACE TO THE FRENCH EDITION.

All Socialists call themselves Internationalists. Among all Socialists, to be an Internationalist means to be in favor of the International Workingmen's Association.

But there are two widely different ways of understanding the international unity of workingmen. There is the interpretation of the patriotic internationalists, and

that of the antipatriotic internationalists.

The patriotic internationalists say: "The present countries, as history has made them, are ethical bodies, whose existence is of use to human progress. In spite of their shortcomings, hard as they are on the workingmen, they, the workingmen of each country, are in duty bound to defend these countries in case of attack.

We are internationalists, but if the country in which we happen to have been born is attacked, we will defend it to the death."

Which is to say, in good French: "Workingmen of all countries, unite; but if your masters order you to cut each others' throats,

This singular sort of internationalism failed a few months ago, o fulfill its promise. If war had broken out over Morrocco, between the capitalist classes of France and Germany, the two proletariats, th and German, would have protested through the mouths of their parliamentary declaimers; they would have exchanged resolutions preclaiming the fraternity of the two peoples; and then, with the utmost fraternity in the world, the two proletariats, French and German, would have set about murdering each other, to decide which of the two capitalist crews should control the Morroccan markets.

But fortunately, there is another way of understanding internationalism:-however much Jaures may declare it "sad, vile, base, repugnant, and reactionary," it is, nevertheless, the only logical and ical form of internationalism.

This second interpretation, I have already treated at length in "Leur Patrie" (Their Fatherland); I treated it in briefer form before the jury of la Seine, in the declaration which follows; it can be up more briefly still in these words:

"The present countries are cruel step-mothers to the proletariat. "They are all alike, more or less, particularly now, that the italist regime is rendering uniform the material, intellectual and tical life of the the laboring classes of all countries, now that he introduction of the capitalist regime in Russia will force even a itself to grant to the Russian workingman the essentials

of political liberty. There is at present no country so superior to any other, that its working class should get themselves killed in its defense.

In case of mobilization, regardless of who the aggressor appears to be (for, after all, when a war breaks out, one can never tell who the real aggressor is), the proletariat of the belligerent countries should respond to the call to arms, by an insurrection against their rulers, to try, each within his own boundaries, to establish the Socialist or Communist regime.

"Rebellion sooner than war!"

The patriotic internationalism and the antipatriotic resemble each other as does day, night. .

The former is compatible with a legal career; the latter is a vice prohibitory to one's entrance to the bar, at least to the bar of Paris, which proclaims that "the universal conscience disapproves

The first is in the best odor with the French free-masonry; the second has been solemaly repudiated by the grand councils of the Grand-Orient de France, and the Scottish lodges.

The patriotic internationalism permits a Socialist candidate to whistle in a goodly number of non-Socialist votes; the antipatriotic internationalism prevents a Socialist candidate from getting any

votes but these of the conscious revolutionists. The one leads to vice-presidency of the Chamber of Deputies, and within an ace of the ministry; the other leads before the jury

So far, the Socialist Party, run in all countries by its parliamentary general staffs, which are in turn controlled by their vote-catching prepossessions, has refused either in its national or international congresses, to come out flat and distinguish between these two so widely opposed forms of internationalism.

The question is sure to be brought up in the next national convention of the French section of the International, and subsequently at the next International Congress.

It will be asked point blank of the Socialist Party, whether or no it will respond to the next order for mobilization by an insurrection, and whether or no it will resolutely take up the study of ways and means best calculated to insure the success of such an uprising.

The Party's answer will show whether it has degenerated into a party of politicians occupied solely with electoral pottering, or whether it is a party of revolutionary activity.

At the moment of my entrance into prison, perhaps for four years, I commit to the care of the militant Socialists of the various sections of our International, the following plain exposition of antipatriotic ideas, for the holding of which twenty-five comrades and myself are about to enjoy, in "the freest and sweetest of home-lands" an aggregate of thirty-six years' imprisonment, and 2,500 francs' fine.

I entrust it to them with the hope that they will spread it everywhere, and in spite of everything.

I am of the conviction that after the reading thereof, it will be understood by all Socialists who know what they mean when they speak of the class struggle, and also, and equally well, by the jury of la Seine itself, that antipatriotism is not a "sort of anarchism," or a "secondary action," but one of the most effective forms of "direct action" against the capitalist class, and at the same time a practical, didactic method of developing in the proletarian masses a full and un-clouded class-consciousness.

#### ANTIPATRIOTISM.

Gentlemen of the Jury :--

The trial is scheduled to close to-day, after the speech of Urbain Gohier. We were overjoyed to find that our good friend Gohier of the Dreyfus affair, who was our comfort throughout, in hours of difficulty, that our Gohier had not been warped, as for a while some feared, to the bloody and senseless antisemitism which is just now . the dishonor of Russia

Our lawyers say, and it is far from us to doubt them, that after his mighty invective against militarism, that after such spirit, such humor, such ability, such logic, acquitment is certain for all of us.

In fact, if acquitment were our sole purpose in coming here, it, would be to our interest, after hearing Gohier, to keep quiet.

It is encumbent upon me to state why it is that we have sought to prolong these debates, at the risk of adding to your fatigue, and of detaining you here several days longer, at the end of December, the time of the expiration of your terms, and of the family festivities common at the close of the year.

It is certain that my friend Gohier-I can say it without offending him,-is the one among us, who by his birth, education and language, is least distantly removed from you; he is the only one among us, in whom still remains, perhaps, a grain of patriotism.

If we should allow the trial to close with the impression produced by his discourse, it would look as if we were trying to hide, to shelter ourselves behind Gohier. Enough calumnies have already been flung at us; we have no desire to invite any more.

We have, moreover, another reason for speaking. It is not every day that the government supplies us with so resounding a tribunal as this. As a rule our public declarations reach your ears distorted, hard to recognize. Here we speak before the pick of the reporters of the Parisian press. We would never forgive ourselves for having let slip so auspicious an opportunity for making known to the whole public our exact beliefs.

I left to my friend and counsel, M. Lafont, the task of defending my person; a necessary task, for it was not demanded that my evil reputation should work harm to my fellow-defendants; but also a difficult one. For four years you have been reading, in your morning papers, that my life was occupied in trampling the flag in the mire, or in calling all the officers, without distinction, lace-frilled veterans, as if there were not among officers, as among the members of all other professions, both honorable men and scoundrels. An error, a lie, which you have heard trotted out every day for four years, has very nearly, I am afraid, become for you an unimpeachable truth.

For myself, however, I reserved the more interesting work of laying before you our antipatriotic belief, that belief which has mistakenly been dubbed "Hervéism," as if such propagandists as Yvetot and the other militant trades unionists who side with me, delayed to spread their antipatriotic doctrines until I plunged into the fray. This I say, not to lessen my share of the responsibility, but for the sake of truth. My role has merely been to disseminate certain ideas and sentiments which I have seen spring up among the proletarian and peasant classes, and of which I am but the doctrinaire, the theorician; and, for some time past, the standard bearer and the central figure.

These antipatriotic ideas are, at any rate, sufficiently new among the masses of the trades unions. Like all new ideas, they shock public opinion; they will seem shocking to you. It was that way with early Christianty; it was that way with Republicanism, at the time when republicans were looked upon throughout the country as bloodthirsty monsters, destructionists, and incendiaries.

There was once a heretic named John Huss. A century in advance of Luther he heralded and demanded the Protestant reformation. For that crime the council condemned him to be burnt. As this first martyr of Protestantism ascended the pile, an old devotee of the town of Constance came bringing yet another fagot, which she threw on the heap, evidently thinking it not high enough. "Sancta simplicitas," said John Huss, shrugging his shoulders in gentle pity.

That same devotee's spirit has been exhibited to-day, in this room, where the lawyers had hardly raised their voices in defence of the accused, when a young barrister, just admitted on probation, declared, on the advice of the Order, that we were only fit for the guillotine. It was not the guillotine, but the stake, that the worthy young fellow meant.

It is, indeed, the stake which, like all heretics, we deserve, who are heretics to the religion of patriotism. For the patriotism of modern nations is a religion, a religion fostered from the very cradle by the same devices that all religions have habitually made use of.

You know how a Catholic is made. They begin with the infant in the cradle. The mother, while fondling it, teaches it prayers which it learns to repeat like a parrot; she informs it that there is a God, a paradise, a hell. Its brain, soft as wax, receives all these impressions without resistance.

When it reaches the age of seven, the mother, thinking all for

the best, turns it over to the priest, who sows in the young head, with no niggard hand, the naive Biblical legends which were current in Israel 2,000 or 3,000 years ago, at a period when the Hebrew people had about as much intellectual culture as the Negroes of Bchanzin.

At the same time, the theatrical pomp of the religious ceremonials, the music of the organ, the semi-obscurity of the churches, the incense swung in clouds from the altars, the sumptuous costumes of the officiating priests, all strike the imagination and set the nerves to tingling; from that time on, the child may become a scientist as great as Pasteur, yet his mind will refuse to work or to act in the matter of religion.

The process is no different for making us-and perhaps you. gentlemen of the jury-into patriots.

At an age when the critical faculties are not yet awakened within us, we have heard at the family table tales of horrible villainies committed by the Germans or the English, and deeds of glory achieved by the French. The German youngsters are at the same time being filled with stories of all sorts of crimes perpetrated by the French, the English, or the Russians.

We are taught that France is the land of the brave, the home of generosity and chivalry, and the refuge of liberty. They are saying the same things of their countries to the children of England, Germany, Russia, Japan; and in our innocence, we believe it all.

For Christmas presents, our fathers and even our mothers give us tin soldiers, guns, drums, bugles and trumpets.

And when this beautiful education has made of us patriots in the bud, the school-secular as well as parochial-puts the final patriotic touches on us. Do you recall those little school manuals in which the history of nations is doctored so as to present the French fatherland in its greatest glory? The German children are put through exactly similar courses, only these confine their praises strictly to Germany.

Do you recollect those textbooks of history which on each page cynically present some scene of carnage, or the likeness of some' warrior? They do not treat us to only one; all of them are there pictured: Vercingetorix, Charles Martel, Duguesclin, Bayard, all the generals of Louis XIV including those who set fire to the Palatinate, all the generals of the Grand Army, who stained the banner of Valmy with blood from the veins of every nation; and finally, not even forgetting the vulture Napoleon himself, on his lofty perch in the Place Vendome.

Beneath each picture, are commentaries each line of which drips with hatred to foreigners, with national conceit, and the worship of the saber, all beautiful sentiments which the reading of the Petit Journal (with five million readers), the Petit Parisien, and other dailies of equally immense circulation, does nothing but foster and develop.

- In order that the patriot may be perfect, in order that the virus may strike through to the bone, it only remains to rig him out in the pomps of war, which are even still more impressive than the pomps of the church.

It is no longer vestments glittering with gold and precious stones; these are replaced by uniforms in loud and gaudy colors, with red and blue, with gold braid, rosettes, and plumes.

The music of the organ is substituted by the more intoxicating strains of brasses and trumpets.

There are no more simple processions; these are replaced by grand reviews, after which we have all run, to see march by, in the sun and the dust, the interminable ranks of instruments of slaughter and of young men-the flower of the nation-marked for future butcheries. And then when, at the end of a stick, there passes the bit of cloth which stands as the sacred emblem of the land, a religious thrill runs from head to foot through the gathered patriots, and they uncover before it, devoutly, as their great-grandfathers uncovered before the blessed sacrament.

Ah, I know that I am wringing your consciences, gentlemen of the jury, and I wring them all the harder because you know that I speak the truth. I know that I am wringing the universal conscience of which the bar of Paris has instituted itself the so eloquent mouthpiece. But do you think that Voltaire, Diderot, and the other encyclopedists hurt nobody's conscience? It is indeed to be lamented, , that every time a new society issues from the womb of a dying system, it does so only by a slow and painful process of parturition, which produces, quite contrary to the wish of the accoucheurs, the greatest anguish in the bosoms of those with whose previous convictions the new ideas do not happen to square.

Your letter of February 28 requesting my personal recollection of the matter in dispute, at hand-the matter that led up to the making of the motion by the N. E. C. member, J. Connolly, and its defeat, and the meaning or effect of this I suppose the inclosed clipping from action by the N. E. C. toward the Party to-day's Daily People is superfluous to and the editor of our Party organs.

In complying with your request, let me say, at the very outset, that I have carefully read the letter to, and the reply by the editor, in the matter. After consulting my own notes, I find that the reply by the editor, as to the cause leading up to, and the intent of the action taken, is in accordance with the facts, and consecutive as they took place, and I have no doubt will be corroborated by the minutes of the N. E. C. session though they were kept in long hand, and the motion itself is, perhaps, recorded, and not the arguments upon

Furthermore, comrades of New Jer-Comrade Connelly could have arrived at the interpretation of the action by the N. E. C., that he reported to you upon the doings of that session, as brought out in your letter to Comrade. De Leon, editor. It can only be the re-sult of sentiments and ideas that ignore entirely the scope and purpose of the N. E. C. as well as that of the editor, as laid down in the Constitution as well as resolutions adopted by the legislative body, the National Convention, and then approved by referendum vote of the membership of the Party.

The refusal of the editor to publish

the reply of the Sub-Committee on the Transvaal matter, for the reasons stated by the editor, was before the N. E. C. for consideration. After the matter had been presented Connolly made his mo-I am not sure whether it said tion. N. E. C. or Sub-Committee of the N. E. C. has the right to publish any matter in the Party organ. I am inclined to believe that he put it N. E. C. as I recollect speaking upon his motion and point-ing out that what the motion intended was so obvious that a motion was ridicinlous, and worse-was irrelevant to the matter under consideration: the rights the evening of March 3, on account of and powers of the Sub-Committee and the editor. The majority of the N. E. members by their votes gave expression to the same views, hence the defeat of Comrade Connolly's motion.

If he meant the N. E. C. Sub-Committee, the same result follows, as it went contrary to a motion previously adopted unanimously, and given in full in De Leon's answer, and was therefore out of order, hence it was voted down. This is in substance, to my recollection, the acts by the N. E. C. that form the basis of Connolly's report to you and causing your inquiry.

If you will consult the Party's con stitution, the provisions governing the N. E. C., you will find, even if the Connolly claim were true, it would be null and void. But what passes my understanding is: how the rejection of a motion, though improper, senseless and irrelevant and out of place, if admitted to be sensible, for argument's sake, has a constructive force, that is, votes away the supervision of the N. E. C. over the Party's organ.

As these is a vote being taken to send nutes of the N. E. C. session to State Committees, which, no doubt, will be carried, it will afford the opporunity to verify the above and further make evident the action taken as regards the letter of the Transvaal. The motion defining the functions of the Sub-Committee, as well as what constitutes an emergency, restates the general laws as interpreted by the N. E. C. governing the parties concerned.

In deliberating upon these matters the powers and duties of the editor of our press dovetailed into the matter more or less, and necessarily so. As a member I had the opportunity to observe the differences of opinion as to his conduct due, in my opinion, to lack of ep-preciation of all the factors and condi-

tions bearing upon the publishing of our press as well as upon present Party laws. But I for one use this opportunity to resent with all emphasis the gratuitous insult of Comrade Connolly in making the statement that sentiment for the editor was the motive for rejecting his motion. The present Party law giving the editor charge of the contents of the Party Press does not confer any power that entitles him to reject anything "he sees fit." To refuse publication he must give his reason for such action, and if not satisfactory appeal to the N. E. C. national convention, etc., is open. On the other hand, Comrade De Leon's conception, as stated in his letter to you, of his relationship as editor to other agencies of the Party are my own and the N. E. C. adopting a motion inviting the editor to the sessions of the Sub-Committee without vote is other evidence of

In conclusion only good can come from ventilation of the matter. It enables the membership as a whole to refresh own understanding of the respective functions of the Party's executive and administrative organs, although the manner in which it came about is to

I suppose the inclosed clipping from you, for you will very likely have read the letter that several of us New Jersey S. L. P. men sent to Comrade De Leon and his prompt answer, before this reaches you. Of course, those of us who sent the letter are desirous of knowing as soon as possible what are the personal recollections of the N. E. C. members who attended that N. E. C. meeting, their personal recollections with regard to the question at issue.

For myself, I already know what your recollection is. As you know, I was present at the N. E. C. Sub-Committee meeting of February 24, when Connolly, having made practically the same statement which he made at the New Jersey Convention, Comrade Teichlauf volunteered the information that he was present at the N. E. C. meeting at the time of Connolly's motion and that n was all about the Sub-Committee's powers with regard to the Party press and not the N. E. C. powers in the premises. You corroborated Comrade Teichlauf. Nevertheless, as you are a member of the N. E. C., and as the other comrades who also signed the letter to Comrade De Leon were not present at this incident of February 24, I should like to have you inform us direct, your recollections in the matter. I shall esteem it a favor if you will make a prompt answer to our request, address ing letter to my house address as given at the top of this sheet. Jersey City, N. J., Dear Comrade:-Yours of the 28th of February, 1907, at hand, and contents noted. I must say that Comrade Daniel De Leon in his letter in the Daily People of February 28, 1907, stated the proceedings of the N. E. C. and the action of that body on January 7th and 8th, 1907, better than I could do it. I must further approve of it as correct so far as my memory goes. I am not able to remember just the wording of the motion made by Comrade James Connolly. As a member of the Sub-Committee at that time I was at first in favor of the motion of Connolly, but after the discussion the point was clearly made to me that it was dangerous to adopt a motion of that kind and I therefore recorded my vote against Connolly's motion-with the disapproval of the Sub-Committee mem-

Being one of the four mentioned that defeated the motion of Comrade Connolly, I wish to state that I was not moved by sentiment for the aditor of The People or any one else in any of my actions at the sessions of the N. E. C. Nor was I influenced, hypnotized or mesmerized by any one, but used the dictates of my reasoning powers (of which I hope I have some), and used the same for the best itnerests of our organization and fulfilled my duty to our organization as I pledged myself to do when accepting the nomination for member of N. E. C. And furthermore, I wish to state that in the course of a discussion on any issue in which arguments are presented showing me that a former opinion which I held was not based or correct basis, that I certainly would change that opinion if the benefit of the change would accrue to the party of the

Now to the question involved. I certainly did not understand throughout our deliberations that the N. E. C., by voting as it did upon the motion presented by Comrade Connolly was voting away its power of supervision of the editors of any of the party organs or any other rights or duties which are imposed upon it by the constitution of the S. L. and I reiterate that it was not a question of the rights of the N. E. C., but as Comrade De Leon in his answer states to the members of the party of New Jersey, that the question was what were the duties of the Sub-Committee of the N. E. C., and what constituted an emergency in which case the Sub-Committee of the N. E. C. was to act upon same without putting the matter before the N. E. C. there not being sufficient time to do so without endangering the party organization or any of its institutions.

I further wish to state that the answer of Comrade De Leon to the N. J. members demanding same is correct in all its details, as far as my memory serves me, having taken no notes of the proceedings as it was almost impossible to do so and at the same time follow the business being transacted at the sessions of the N. E. C., which business demanded the closest attention of the members of the N. E. C. to act upon intelligently.

If the members of the N. E. C. and other comrades who were present at the second day's session of the N. E. C. when Comrade Riehter presented his resolution and before it was put to a vote recollect that during discussion of same. I said it was unnecessary to vote on same as a resolution or motion to the same effect defining the duties and what constituted an emergency for the Sub-Committee of the N. E. C. to act upon was decided at the first session of the N. E. C. as now constituted (January, 1905). I being the only member present that served in the same capacity at the time referred the N. E. C. to minutes of the session above referred to if they could be produced; but another member of the N. E. C., I cannot recollect who it was, stated it would do no harm to reaffirm the same; the resolution was then endorsed.

Therefore, having supported the motion defining the duties as well as what shall constitute an emergency at the session of the N. E. C. (January, 1905), and as a matter of course supporting like resolution which was offered by Comrade Richter at the session of the N. E. C. of January, 1907, and after charing the arguments of Comrades Bohn, De Leon, Moren and other comrades relative to the Transvaal letter episode, I concluded that there was no emergency, as it mattered not whether the letter in question was sent before or after election in the Transvaal, as long as it was decided not to aid them financially on account of their position in regards to the race question, etc., there-fore, upholding Comrade De Leon as against the Sub-Committee of the N. of those who are at present declaring their lack of faith in political action. At first it was everything to them, and general (economic) interest, or what when the facts failed to justify their they take to be such." estimate, it became nothing. Now the economic movement occupies their minds to the exclusion of everything else. The political movement is nothing. But the I. W. W. isn't going to bring the Social-ist Republic into existence the day after to-morrow. At the very best it has, within and without, a tremendous struggle before it; and what of those who expect more of it than circumstances justify? Will the dissatisfaction born of the lack of a sense of the fitness of things, which carried them out of the political movement into the exclusively conomic, carry them out of the labo movement altogether, make of them hopeless pessimists? or will they rise to the stature of men, face the facts as they are and give them proper place and proportion?

Rome wasn't huilt in a day and at that the men who built it used every tool that came to hand. Can we, who have before us a task in comparison with which the building of a city sinks into insignificance, decline the use of such a mighty weapon as political action? That, in the hands of such an organization as the S. L. P. it threatens the existence of capitalism is made clear by the universal, systematic and year long efforts of the exploiters to render it of no avail. Only at its peril can our class fall back on antiquated and out-grown methods. Capitalism has a way of reaching down into the proletarian mind and poisoning the springs of action at their source and the only way in which this influence is to be overcome is to drop the hole-and-corner idea in the labor movement and bring it out into the light of day. And this means political action.

The political phase of the labor move-ment is as much of a fact and as indispensable to success as is the economic. hold to the opinion, expressed some time ago, that the ideal movement is that in which the political and the economic go hand in hand. We haven't arrived at that stage yet, but that isn't saying that we never shall. I would suggest to the 'Industrialists" that, before vociferously asserting the uselessness of political ac tion, it be given a trial at the hands of revolutionists. Condemn it when it fails under those conditions.

#### THE REAL REVOLUTIONARY NOTE.

Sunday morning the 9th inst. at Carnegie Music Hall, Alexis Aladin, the Russian peasant leader, sounded a note that will awaken a response in every working class heart in this country. Aladin spurned the questions put both in Europe and America, "Will you ever win freedom? Are you capable of self-government?" He answered "For centuries we have fought the hordes of Asia that you Europeans and Americans might have time to develop your nations and institutions." In this terse statement, Aladin disposed of two "serious" questions, showing freedom and self-government, such as we know it, to be dependent on those from whom the autocracy and its friends would fain withhold them.

This note awakens a response here. ecause the workers here are asked similar questions, to which they give similar answers. When asked, "Can you emancipate yourselves? Are you capable of self-maintenance and control?", its members answer, "We emancipated the negro and capitalism from chattel slavery; and make American society possible by our labor and ability." Like Aladin they turn the interrogation point against the oppressors, revealing once more that it is they who are incapable of self-emancination, support and control, and not those fain would rise. .

This note of dignified self-assurance is essential to revolutionary success. It is at once the motive and justification of every effort in that direction. The class that is not fundamentally essential in any period of social development, is without aspirations and defense. It cannot respond to the spirit of the age nor hope for aught else but dismal failure and moral decadence, such as are now evident in the case of both the Russian bureaucracy and American plutocracy. It argues well for the cause of political ration in Russia, and economic emancipation in America, that the movements in their behalf meet these requirements, and are opposed by such impotent forces.

#### SYMBOLICAL

Good symbólism accurately represents the idea for which it stands. The wingspeed; as does the uplifted arm and hammer the strength of Labor. In the March "Machinists' Monthly Journal," on P. 251, there is a picture genuinely symbolical of the meaning of "labor politics," encouraged by "labor leaders" of the Gompers and O'Connell type. The picture represents a crescent surrounding photo. At the right point of the crescent are mills and mines. From these, solid phalanxes, which grow broader as they come nearer, pours an army of workingmen. They stop before a ballot box to deposit their votes; after which they again form ranks, pass up to the left point of the crescent, and disappear into the mills and mines once more. This picture is genuinely symbolical, because it represents, with unfailing accuracy, the significance of Gompers-O'Connell "labor politics." Labor, according to these politics, exalts a man, while itself is condemned to a round of endless toil. "A good union man" secures office, no doubt on a capitalist ticket, but labor's existence is measured by its tramp from one mine or mill to her, in the search for a master unitalist wage slavery. A FALSE PROPHET. "Shonts is on the job" of relieving congestion via transportation in this city, according to the press. It is feared the job will soon be on Shonts looking fifty year's ahead, he sees where the center of the city's population will be, and he makes plans to tap it. In fifty years he will have to undergo treatment for his eyesight, for then his plans will be found inadequate, and instead of having tapped the problem he will find the problem has tapped, i. e., exceeded and exhausted, him and his ingenuity. This has been the history of past Shonts and it is likely to be the same old story with the present one.

The cause of this phenomenen is ap-

parent to serious students of social conditions. Congestion is not as matter of transportation but of concentration of industry and commerce in cities for profit. Industry and commerce require large numbers of men wemen and children living near at hand, or within easy access, to operate and conduct them. They have a tendency to develop more rapidly than the means of travel. Forty story skyscrapers and giant factories go up with a greater rush than subways are dug or elevated railroads are electrified The result is like attempting to force a quart of water in a pint bottle. Brooklyn Bridge "crushes" occur; "relief" is sought in a Williamsburg Bridge, where the same performance is repeated. And so it goes all up and down the line. Add to this, the oftconflicting interests of the transporta tion companies, as in the case of the Interborough and the B. R. T.; and a bad situation is made worse than confounded. At best, the increase of transit facilities serves but to accentuate, instead of relieving congestion; so that the more Shonts plans, the more he will have to plan; until, finally

he throws up the job in defeat. The remedy for congestion is to be found in the decentralization of commerce and industry for profit. A greater number of less unwieldy centers must be established. There is a tendency already in this direction in the founding of small cities by large corporations, such as Gary, Ind. Under commerce and industry for social use, as proposed by Socialism, this tendency can be accentuated. Commerce will be greatly diminished, as the necessity for the same will be greatly decreased, there being no robbery of be more than modern; rugged, strong, labor and no need for foreign markets,

Millions in wealth changed hands, leaving many much poorer than at the outset. The cause of this "rich man's panic" is said to have been "enforced liquidation."

What is this "enforced liquidation?" It is confiscation. It is the highway robber's plan of ambushing a victim and then murdering him in cold blood in order to obtain his valuables.

In this instance, the ambush consists of the means of exchange, which are used to induce loans and then force

The result of this looting of the looters-for after all, what is taken has already been expropriated from laboris to concentrate wealth in still fewer hands and make their power of exploitation ever greater. It is this very concentration of wealth in fewer hands, which brings wrinkles to the brow of the capitalist "thinker," a la Carnegie and Roosevelt, who, fearful of its uninterrupted tendencies, would fain restrict it, by means of graduated inheritances and other devices. It is this very concentration of wealth which is foreclosure on the borrower, compelling oppressing society, which seeks to esa settlement in stock or actual wealth cape its domination and consequently stances demand.

BRIEF SOCIALIST ESSAYS.

"MEN OF ONE IDEA."

Scorn not the appellation of "narrow," and "men of one idea." Reproach is of ten a badge of honor; epithet, a mark of distinction. The "narrow" men, the "men of one idea," have always been men of great achievement. Oneness of thought concentrates energy and ideals. The result is definite effort, a clear goal and success assured at the outset. multiplicity of ideas dissipates force. It makes wobblers, straddlers and twaddlers of men, leading to their befuddlement compromise and defeat. John Brown was a man of one idea; so was William Lloyd Garrison; likewise Wendell Philipps. Henry Clay personified many ideas; as did Daniel Webster. Posterity has no doubt as to which of these is the better: the Browns, Garrisons and Philippses surpass the Clays and Websters as electricity surpasses steam in dynamic force and power. Men of one idea, they were men of concentrated strength, and victorious.

Socialism is a thing of "one idea"-

society world-wide, owning all the na-

tural and social resources, and producing distributing and governing fraternally; one for all and all for one. Like all "singular" ideas, Socialism's greatness consists in its comprehensiveness. Socialism holds that land and labor cooperatively exploited produce wealth that should consequently be co-operative- that lower taxes will make me better off. ly owned and distributed. Socialism declares that the end of life is living; not a property-career for the few who posses the means without which that end is impossible: and who use their posession to extort the wealth co-operatively produced, from the producers. Pivoting life on social effort instead of class property, Socialism makes war on the propertied class in favor of society. The bacteriologist finds in the human body, beneficial and parasitic germs. By means of inoculation, he promotes the struggle between them, in order that life may be preserved and advanced. Socialism finds in the social body, beneficial and parasitic classes, the working and the capitalist classes, respectively. By means of agitation, education and organization he promotes the class struggle between them, to the end that society may continue to progress. Thus, the Socialists, the "men of one idea," are like all one-idead men-men of comprehension and depth. Don't be afraid of being "a man of one idea."

'In the old days of Socialism-in the "narrow" days of Marx, Engels, Liebkneeth and Guesde, with their insistence on the class struggle and no compromise, Socialism was a comparatively greater force than it is in the present day-the "broad" days of Bernstein, Millerand and Jaures, with their compromising revisionclasses." In the old days, Socialism hurled the weight of its power at Capitaism with unerring precision-it was like a thunders. bolt from a clear sky, shaking profoundly the placid arrogance of its foes, and promoting effectively working class interests, by its deadly destruction of capitalist thought. Now there is unsettlement, a reaction back to first principles, that is obstructed by the new conditions, and results in a diffusion of effort; the whole of which can best be likened, for the purposes of contrast, to a triflyclouded atmosphere. The destructive evolutionary forces of capitalism are at present doing more for Socialist progress than the constructive revolutionary forces of Socialism.

Garrison, "the man of one idea," said when called to account for his severe language, "I will be as harsh as truth." Socialists should paraphrase him, when accused of narrowness, saving "We shall be as narrow as history, and as effective. We will stick to the class struggle concentrating our efforts on the economic and political organization of the working class, for the overthrow of the present system of capitalism and the inauguration of Socialism." If we do that, "narrow" as we are, we will have accomplished a revolution that will make possible the brotherhood of man. Then, as always, will true "narrowness" conduce to a greater universality.

McPARLAND, CRIMINAL AND COW-ARD.

To the Daily and Weekly People In a press report the other day, as published in the Daily People, "Buckshot" McParland is reported as making use of the expression "That he feared no man." (This to Richardson, counsel for Stephen Adams at Wallace, Idaho.) I have no hesitation in saying that from statements made to me twenty-five years ago that he lied when he used the aforesaid language. There was one man in that ourt room that he dreaded, that was the prisoner at the bar, knowing that Adams would not swear to the truth of the con fession extorted from him.

Forty years ago on the first of next nonth, at that time a boy of 14 years, I, with our family, went to live at Buck, Mt. Carbon Co., Pa., and resided there until 1874, during that period were what might be called the strenuous days of Molly Maguirism; the panie of 1873 being on. I was away from the anthracite coal region until 1878. That year I was back again, in the Lehigh region From the time I left until I got back were the years during which the Mollies

were tried and executed.

Now for the statements as to "Buck shot's" bravery made to me by trust worthy men.

The first was in relation to the first trials held at Mauch Chunk. One Jack G. Hayes, who I remember well, told some of the young fellows in the patch where he lived that if he was at Mauch

not seem possible that any human being then being tried for. Hayes was supplied with money to go to Mauch Chunk. When he reached there he was kidnapped; placed in limbo, and was not liberated until after the men were executed. I questioned this statement at the time made, although made by a personal friend. He reiterated the above with em-

phasis. The second happened in Schuylkill County. The authorities were after Tom Hurley, which meant that "Buckshot" McParland was on the job. Hurley while on a passenger train in said county was apprised of the fact that McParland got on the same train at another station farther down the line. Hurley proceeded back through the train until he reached McParland and at the muzzle of a gur made McParland walk out on the platform and jump off. The train being under full headway, Hurley got off at the next station and that was the last of him in that section.

This statement I questioned at the

time made, claiming that while I could easily concede that McParland was a moral degenerate, I was willing that he should be allowed at least enough animal courage to defend himself if brought to bay. This was denied with an oath; the facts as stated were repeated, and cor-

roborated by a second party.

From the foregoing I am looking for something to happen at Boise during the Moyer, Haywood and Pettibene trials Especially in regard to witness for the defence. McParland, with physical force behind him, is, to my mind, capable of committing or causing to be committed any crime in the Decalogue or on the calendar; left to himself he is a coward. After the trail of blood he has left be hind him, I am justified in believing that when he shuffles of his mortal coil that his polluted body will fill a desecrated

Industrial development has caused some of these districts to decrease in population, others to grow enormously; so that districts for instance, are entitled to only one member, whereas were the basis of representation numerical they would be entitled to seven times that number. CAUSES DISEASE AND EXCITE-MENT IN GRAND JUNCTION, CAL.

Beautiful Natural Advantages Rendered Void by Dangerous Effects of Capitalism On Health and Happiness -Getting What They Voted For.

Grand Junction, Colo., March 5 .- The people of our little city are a little excited over the work of the present City Council. In order to explain the situation so the outside world will know the condition that now obtains, it becomes necessary to go back say ten years. Ten years ago a private company

owned the only water system in Grand Junction. A little later the people voted for and installed their own plant and water system. Instead of securing the best of everything and putting in a first class system in every respect, the Dem-O-Republican Council then in power farmed the job out to a cheap John of a contractor, who worked the city for his profit only. The pump he put in was no good and had to be cast aside. The reservoir was of no value and had to be rebuilt by the city, in fact, the whole system was "on the bum."

We will now drift off to the sewer system long enough to show how it was installed; then we will come back to the water question again.

The people of Grand Junction want the best of everything when they pay for it. But they are getting sick in ways than one of paying for the best and always getting the poorest.

The sewer system, like the water system, was built for the city by contract and we doubt if a poorer job was ever installed. But like the water system, its construction made large profits for the contractor and that is what a Dem-O-Republican Council is there for, to help work some graft. But the story that follows is a sad one and may be the means of losing Grand Junction's reputation as a health resort.

For years people came to Grand Junetion from all over the country with weak lungs or other organic trouble in search of good health, here where our warm sunshine and pure air would build them up and make them strong again; but now behold the change. While we still have the warm sunshine and the pure bracing air, with the finest fruit in the world for the people to eat, yet in the very best, highest and cleanest part of the city the people are sick by the score sick unto death, men women and children. It takes the strong as well as the weak, it is the harvest time for the doctors and undertakers.

What is the cause, you ask, of such change? Well, that is easy. It is caused by our rotten sewer system that was built by contract for profit and not for use; it is giving the people what they voted for and the end is not yet.

Mayor Bunting, in his paper Sentinel), in trying to defend himself and Council, said the sickness was not caused by filth and dirt in the city, as over the half of all the sickness was located in the cleanest section of the city; and outlined the district as being from 8th to 12th street and from Main street to Ouray avenue, a district only four by five blocks in size; but the Mayor neglected to explain that every home in the district he had outlined was connected with our rotten sewer system

It is hard for the Socialist to under stand how the people can continue to vote for such a bunch of chumps (or grafters). If you have voted the Democratic or Republican ticket you are getting a pretty strong dose of what you voted for. When you get enough of such folly you might make a complete change Socialist Liedertafel to your own advantage by voting th Socialist Labor Party ticket straight; words-Socialist Labor-at the top of your ballot. As long as you get what you vote for you have no kick at all.

Last spring the people of Grand Junction decided they wanted mountain water from a stream fed by clear sparkling springs. Bonds were voted in order to provide means to pipe the water from the stream selected to the city, a distance of some 20 miles. Instead of our Council constructing the pipe line themselves they have fooled along all summer and winter with a drunken sot of contractor named Mitchel and at last gave him (Mitchel) the contract just as they intended to when the bonds were It is claimed that John O'Boyle, who

is leader of the Council, is mortgaged to and owned by Orson Adams. This man O'Boyle was elected from the first ward and then moved from there to the third ward; but continued to hold his office in defiance of all law and justice. He had no more right to hold his office after moving out of the ward in which he was elected than a Governor of a State would have to hold his office if he should move to some other State. All of this proves what the Socialists

have always claimed, that all things under capitalism are run for and in the interest of the capitalist class, and it matters not how it is owned, if you want to change conditions you must change the system from capitalism to Socialism

It's needless to say that the undersigned won, and turned the \$5.00 over to the organizing fund of the I. W. PROTEST AGAINST MOYER, HAY-WOOD AND PETTIBONE OUTRAGE.

Trautmann and Cox Deliver Speechese That Meet With Approval-Big Sak of "Mitchell Exposed," and Industrial Union Pamphlete.

Panama, Ill., March 6 .- The miners' union had a Moyer and Haywood Protest meeting. It was well attended by all, the local miners and their families, and from nearby towns. Wm. Veal of East St. Louis was on hand. He sold \$5.25 worth of books. The slaves of the mine went after "Mitchell Exposed." It kept Veal and me busy grabbing the nickels, for they came in like a cyclone. Debs and De Leon went like hot cakes.

The first speaker was Wm. E. Trautmann, General Secretary-Treasurer I. W. W. He showed how the workingmen were being killed in the factories by the master class from East to West. The next speaker was W. W. Cox. He

outlined the I. W. W. He told them that was the way to organize. He also told them that was the reason that Moyer and Haywood were in jail. The miners tell me that is the kind of

talk they like to hear and they are getting d-m sick of the miners' union of the A. F. of L. kind. I think we will have an I. W. W. miners' Local here soon. The following resolutions were

Whereas, Moyer, Haywood and Pettibone, officers of the W. F. of M., Mining Department, were, through a foul conspiracy of the mine owners of the West. under the subterfuge of being accessories to the murder of Frank Steunenberg, ex-Governor of Idaho, arrested and kidnapped in the middle of the night and taken by special train from Denver, Colo., their home, to Boise City, Idaho, guarded by regular troops, members of the militia and Pinkerton thugs, landing them in a State penitentiary all without due process of law; and have kept them in iail for over one year refusing them a

Whereas, The threat has been made that these men shall not leave Idaho alive; believing that the Mine Owners' Association fully intends to carry out this threat;

Resolved that the only way to prevent them from carrying out this threat is to continue to announce to them and the public in general that if they carry out this threat, and judicially murder these men that thousands of the working class possible, put an end to this capitalist system which fosters the murdering of our class in the mills, mines and factories of our land as well as by the bullet, bull-pen and judiciary route.
