Opening Wedge For General Attack On Labor

The revoking of the charter of the Sailors Union of the Pacific by Olander and Scharrenburg fits directly into the plan of the shipowners to smash the maritime unions. Every day brings further proof of the close cooperation between these reactionary "leaders' and the shipowners.

It is now public knowledge, that the court procedure en-tered into by these so-called labor leaders, was prepared at least three weeks before the matter was even discussed in the I. S. U. Convention. This was brought out very clearly

by the lawyer in court.

"Leaders" Aid Employers

Describing the shipowners' threat-ened war as "an attack against the entire labor movement," the Council dispatched telegrams to Madame Perkins, Alameda County pink elephants. Conspiracy Against Maritime Unions Is Denounced

WASHINGTON, D. C., Feb. 1. → The City of San Francisco during the last month has handed down seven thousand potential vigilantes official permits to carry pistols, it

was charged today at the Capitol.

This assertion was made by Representative Vito Marcantonio (Rep., N. Y.). It furnished dramatic confirmation of the West Coast Marine Union's warning to the Roosevelt Administration that shipowners and their bankers are in "a nation-wide conspiracy" to let loose armed violence to the point of civil warfare.

Roosevelt leaders in the House this week denied, in statements of the press, that they are backing the new push for the gag legislation, known as the Kramer "sedition" bill and the Tydings-McCormack "military disobedience" bill. However, at least one is telling his intimates that they may "have to" jam these bills through if employers' pressure gets stronger, especially if "some-thing" should happen to present a pretext for congressional action.

Strike Might Give Pretext That "something" might be any-

thing. It might be a big strike. It might indeed be the very violence which the waterfront employers themselves are prepared to launch along the Pacific waterfront. This is the inescapable conclusion from direct information obtained by the Sunday Worker from sources which cannot be quoted.

Fight For Investigation
Liberal members of the House

GREEN TRYING IN SAN DIEGO

Vice - President Murray, speaking on Officers' Reports to the 34th Bi-Annual Convention of the United Mine Workers of America now in session with nearly 2,000 delegates present, accused the Executive Council of the American Federation of Labor of doing nothing for the organizing of the unorganized, stating:

"They are meeting now in bathing suits on the sands of Miami. If they have done anything at all, it has been to disorganize the workers rather than to organize them."

To give more proof of this charge, President Green revokes the charter of the San Diego Federated Trades Council. The excuse first given for this act of disor-ganization, was that the system of electing 5 delegates from each union instead of proportional representation, was illegal, and a new election was ordered. (Dem.; Calif.) told the Sunday Worker he is ready to introduce a House resolution calling for Congressional investigation of the shipowners' planned violence if a member of the Senate will sponsor it.

May Block Investigation

Senator Royal S. Copeland, chairman of the Senate Commerce Committee, which has jurisdiction in marine affairs, told the Sunday Worker:

"I am going to refer the maritime federation's communication to the commerce committee. I understand the Labor Department was handling this, but anyway I'm going to refer it to the committee members next week."

Copeland who has seen years of notorious service in pushing shipowners' subsidies and who enjoys the favor of No. 1 fascist William Randolph Hearst, can be counted upon to do one of two things: block the Congressional inquiry demanded by the workers; or even support it in order deliberately to direct it against the unions instead of against the employers. In one official quarter, it actually was sug-gested to the Sunday Worker that the workers had better remember that a Congressional investigation might find "conspiracy" among the workers, and come back with a recommendation for permanent union-suppressing legislation.

The obvious fact is, the Roose velt Administration, while not now pushing the legislation, will let it ride through on the first pretext furnished by the Chamber of Commerce—unless public pressure pre

of the maritime unions."

The Seattle Central Labor Countne protests its president, voted unanimously to send protests to William Green and to the I. S. U. Convention against the undemocratic-reactionary union splitting move in revoking the charter of one of the most progressive unions on the Pacific Coast.

At the San Francisco Central Labor Council meeting the employers met with a decidedly different situation than during the 1934 General Strike. By an almost unanimous vote, the Council went on record as supporting the maritime unions, adopting a resolution introduced by Harry Bridges of I. L. A. 38-79 which calls for an immediate congressional investigation of the waterfront situation.

Telegrams from V. Olander, secretary-treasurer of the I. S. U. and William Green demanding that the Sailors' Union delegates be not seated was ignored completely by the Council.

During the reign of terror in 1934 the shipowners and industrialists received considerable aid from the reactionary "labor" leaders. But not today. Save for a few. San Save for a few, San to support of maritime workers.

Open-Shoppers Followed Same **Tactics Before**

The filth the shipowners and their organ, The American Citizen are slinging at the waterfront unions and their leaders is old stuff. They made all the same moves in past open shop drives to break up the unions on the waterfront. They used the same steps to break up organization in the building trades, among the carmen and in other industries. The Waterfront Employers Association, the San Francisco Chamber of Commerce and the Industrial Association specially organized as a strikebreaking outfit, have always used violence, lies and the red scare in their unceasing campaign to change San Francisco from a union stronghold into a 100 per cent open shop city.

"Law and Order!"

The American Citizen has a lot to say about law and order. The Special Law and Order Committee of the Chamber of Commerce was set up on July 10, 1916, with the avowed purpose of breaking the 1916 waterfront strike against the employers' attack on wages and working conditions. At the mass meeting of 2,000 shippers and businessmen at which the Law and Order Committee was formed it was publicly announced that the Committee stood "for law and order and the Open Shop." (San Francisco Chronicle, July 11, 1916.) The chairman of the Chamber of Commerce, Frederick J. Coster, announced that two sub-com-mittees of the Law and Order Committee would be appointed:

One would raise one million dollars to finance the publicity campaign against the unions; the second "will devise ways and means of clearing the wharves of freight and insuring protection to all merchants." (San tion to all merchants." (San Francisco Chronicle, July 10, 1916.)

The Law and Order Committee did not stop with the waterfront, but extended its strikebreaking activities to all organized San Francisco industries. The same thing will happen again today, unless the whole labor movement backs the waterfront unions against this latest open shop drive. Coster, then head of the San Francisco Chamber of Commerce, boasts as follows of these strikebreaking achievements in an address delivered during February, 1918, a few months after the Law and Order Committee was formed:

UNIONS BACK LABOR PARTY

"The people can no longer rule themselves. We are RULED OVER. And the people can never rule themselves unless they own the party through which they seek to achieve their aims. Labor wants this Labor Party, and, by the pronouncement of the American Federation of Labor itself, labor has an inalienable right to the creation of this."

These are the words of FRANCIS GORMAN, VICE-PRESIDENT OF THE UNITED TEXTILE WORKERS OF AMERICA at the 55th Annual Convention of the American Federation of Labor. Since then a broad movement for the building of a Labor Party throughout the country has taken on great impetus. THOUSANDS OF TRADE UNION LOCALS, HUNDREDS OF CENTRAL LABOR BODIES, MANY STATE FEDERATIONS OF LABOR HAVE ALREADY COME OUT IN SUPPORT OF A LABOR PARTY.

Among the important unions in the country which have taken a definite stand for a Labor Party are: International Ladies Garment Workers Union, United Textile Workers of America, Amalgamated Clothing Workers, Fur Workers International Union, Brotherhood of Sleeping Car Porters, International Mine Mill and Smelter Workers Union, American Federation of Teachers, International Union of Hat, Cap and Millinery Workers, Hotel and Restaurant Employees and Bartenders Alliance, Bakery and Confectionery Workers Union, Bookbinders International Union, Flat Glass Workers Union, Jewelry Workers Union, Laundry Workers International Union, International Brotherhood of Paper Makers, Pulp and Sulphite Workers International Union, etc.

Has your trade union local come out in support of a Farmer-Labor Party? If not, raise this in your local union. Get your brothers to support your resolution. Win the membership of your local union for the building of a Farmer-Labor Party.

"Any one of a number of things would have justified the existence of the Law and Order Committee and the total expenditure of time, efforts and funds so far made. The defeat of the United Railroads strike . . . alone justified all the time, effort and money which the Law and Order movement has so far involved."

New Drive

Last week the shipowners, the Chamber of Commerce and other open shop forces backing the drive on the waterfront unions put thousands of dollars into printing 100,-000 copies of "The American Citizen" and distributing it through regular distribution agencies. This recalls Coster's report how they put their open shop publicity across in those days—in the 1916 campaign to render San Francisco labor helpless in the employers' hands by taking away this basic right to picket during strikes:

"It will interest you to hear briefly an outline of the cam-paign by which the Law and Order Committee carried the anti-picketing ordinance in spite of the general prediction that it would be impossible to carry such an ordinance against the strength of the labor union elements and other sympathizers. A five-way publicity appeal was made: by a circular letter through the mails to all registered voters urging that they vote 'Yes' and thereby prohibit picketing; by news columns articles in the daily papers; by paid advertisements in all papers, daily and weekly, American and foreign, including the district papers; by slides in moving picture houses; all culminating in a tremendous drive by four hundred telephone girls, working two shifts per day, using one hundred and seventy-five tele-phones, calling all persons in San Francisco having a telephone and urging that they vote 'Yes on Ordinance No. 8' and prohibiting picketing. The telephone officials declare that this was the biggest 'calling-up' job in the history of the telephone in the United States."

Open Shop Principles
Finally, here is the statement of the Open Shop principles on which the San Francisco Chamber of Commerce and its Law and Order Committee is founded:

"The Chamber of Commerce favors the open shop and insists upon the right to employ union or non-union in whole or in part as the parties involved may

elect....

(Continued from Page 1) the progressives were even more strongly represented than before, all pretense of constitutionality was thrown to the winds.

"Constitution Be Damned"

Green's answer to the protest of 33 unions out of 38 unions representing 85 per cent of the San Diego trade union movement, was the instruction to Joe Casey, his personal representative: "Take such action as you deem fit." With this blanket endorsement for any action he might take, Casey told the delegates: "The Con tion be damned' and promptly re-

voked their charter.

The only support that could be mustered for this union-smashing proposal were from the delegates from the Pressmen, Culinary Workers, Postal Clerks, Musicians and the Stage Hands and Theatrical Employees unions. The combined membership of these unions is not more than 500 members.

Casey Serves the Utility Interests
The main complaint and criticism against the Federated Council has come from the San Diego Chamber of Commerce and Public Utility Corporation. The growing strength of the trade union movement had to be curbed. They especially feared President Steinmetz, who, defeated for mayor on a Municipal League ownership program in the last election, would with the support of the Federated Trade Council, be guaranteed vic tory in the coming election. He had to be removed.

Gag Progressives

The San Diego Exposition, which runs until next July, has been toriously unfair to organized labor. The Federated Council, failing in its efforts to make the exposition fair to labor, were considering placing it on the unfair list. This did not suit the big interests. It had to be stopped.

The Council in general supported the progressive program of the Maritime Federation, and in general supported the progressive industrial union movement led by John L. Lewis. This did not fit in with the Green-Scharrenberg program. It had to be stopped.

The Federated Council secretary, Rogers, opposed Paul Scharrenberg for secretary of the California State Federation of Labor.

A committee of the Council was investigating the Labor Party with the possibilities of running Labor Party candidates in the next e elections.

There was no constitutional w & to stop these progressive movesno way to carry out the bidding of the Chamber of Commerce. There was only one way for them—the destruction of the Federated Council. The Chamber of Commerce alone was not strong enough to do this. This "honorable" task has fallen to Joe Casey. He has begun with the revocation of the charter.

Fight To Restore Charter

hraa union unions of San Diego, representing 85 per cent of the entire trade union membership, are fighting against this disruptive action of Green and Casey. They feel very confident that they will win the struggle. Their record (has anyone the record of Casey, except that he is the son of Mike Casey?) is, that since 1933 under progressive leadership a strong effective progressive trade union movement is being built in San Diego that does not take its orders and program from the Chamber of Commerce. This is not their fight alone.

Take up this question in your next union meeting.

(Continued from Page 1) against Communism have no bearing on the issue at hand. Such controversies are raised by the Citizen for the express purpose of obscuring the real issue.

Organized Labor The real issue is one of unionism. The waterfront uions are squarely under democratic control of the union men themselves. Every decision and every issue concerning these unions is decided by the vote of the men.

It is not a matter of whether you approve of Communism or not. It is a matter of whether you are going to support organized labor and democracy in the unions.

Who Would Gain?

Violence is being planned. But not by the waterfront unions and certainly not by the Communist These organizations have everything to lose from such violence and nothing to gain. It is the organized employers who are planning fascist violence against the unions, and you can prevent this violence by mass protest.

The editor of "The American Citizen," Henry R. Sanborn, is an erratic fool who is attempting to build a profitable career for himself on the basis of fighting Communism. He is striving very industriously at present to pose as a feared and hated foe of the Communists. He is constantly announcing alleged death threats and mur-Francisco labor heads are rallving der attempts against himself and his family.

No Basis

In the first place let us point out that in the whole history of the Communist Party of the U. S. A. there is not a single incident or fragment of evidence linking Communists with assassination, bombings or any other violence. Although many atempts nave been made to. frame-up the Party on such charges, none of these accusations have ever been confirmed by fact.

In the second place, all Communist literature vigorously admonishes against such actions and the Communist Party expels from its ranks any member who seeks to provoke them.

No Reason

The Communist Party never has and never will seek the life of any man by assassination. It despises Sanborn as a petty fool and a liar. It certainly does not fear him. As a dishonest and unscrupulous character, we recognize that he can do a certain amount of harm.

We also recognize that he is no more than a willing tool of the San Francisco Industrial Association-an ignoble toady-not important as a person. "The American Citizen" is a tin horn of the waterfront employers and our method of combating it is to print the truth in our own press.

Who Murders?

He deserves the fullest contempt of every decent-minded citizen. American people.

Union leaders and militant workers have been murdered often enough by the powers of finance capital in America — the forces which Sanborn represents. But not the slightest basis exists to charge either the unions or the Communist Party with such tactics.

Scharrenberg-Olander plan to cipline the Sailors Union of the Pacific by revoking its charter, would be carried at the convention, a delegation had to be gotten together which would support Scharrenberg and Olander in their union-splitting tactics. Only by the most flagrant violation of the constitution-by abolishing the right to elect delegates guaranteed by the union constitution appointing instead hand-picked stooges, was this accomplished.

This, however, they could not achieve on the West Coast, where all the delegates were elected according to the constitution. But they were able to carry it through in sufficient places on the Atlantic Coast and the Gulf by the usual "beefsquad" methods.

This was not easy because the at majority of the seamen on East Coast are against the signing of the old agreement, are for a new agreement based on West Coast articles, and for the organization of a Maritime Federation similar to that of the Pacific Coast on the Atlantic Coast and the Gulf. The total number of delegates to the convention had to be cut down to a number that would insure control. Out of the entire Pacific Coast delegation, representing 13,000 seamen, Scharrenberg could not find one seaman that would support him. From the East Coast and the Gulf only with beef-squad methods could they muster 18 hand-picked delegates. Just imagine 31 delegates constituting themselves as a convention legislating for nearly 50,000 seamen, and 18 hand-picked delegates deciding to revoke the charter of the Sailors Union of Pacific representing 7,000

"Responsible Unions"

The shipowners say they want esponsible unions," "responsible "responsible unions," union leaders." It is clear what y actually mean. They want a lue Book" company-union for the waterfront—a rink-hall union for the seamen. By "responsible" union leadership they mean leadership that will take orders from the shipowners, and not from the members of the union. The shipowners want union leaders like Scharrenberg, who was twice expelled from the union, in 1921 and

The shipowners are determined for a showdown. Their plans time and time again have had to be al-tered because the Maritime Federation has been able to expose them publicly before they were able to put them into effect. The maritime unions as a whole have always gone more than half way to settle disputes. Peace on the waterfront can only come when the shipowners abandon all idea of bringing back the open shop. The maritime unions are united and will defeat every attempt. Those companies that really want to work with the unions on the basis of collective agreements, and clarification of awards have no trouble. The trouble begins with the vigilante open-shop section of the shipowners. They will be defeated, as will their agents who are attempting to revoke the seamen's char-

Support the Sailors

This attack is against the trade union movement. The Sailors Union of the Pacific and the other maritime unions are the first ones selected for a concentrated attack. It is the duty of every trade union to accept this arrogant challenge of the shipowners and rally to the support of the Sailors Union.

The trade unions should condemn the action of Scharrenberg and Olander, who in the face of this attack of the shipowners give their support by beginning a dis-astrous inner-union struggle.

Mass Meeting For Modesto Dynamite Frame-Up Victims

Harry Bridges, Vandeleur and other well known speakers will voice the demands of the labor movement at a mass meeting at Dreamland, Sunday, February 16th, at 2:30 p.m., asking that the appeal of the case of the Modesto frameup victims be granted and the Standard Oil "justice" which sent innocent workers to the pen be reversed.

As in the present attack upon the sailors, the name of Scharrenberg and the bosses are linked up in this foul attack upon labor. Scharrenberg called the tanker strike without the consent of the rank and file and Standard Oil had a special prosecutor openly paid by it to assist in the frameup.

Only mass pressure through a state-wide boycott will compel Standard Oil to order its puppets on the Appellate bench to grant this appeal.

Modesto is the most recent incident in the long history of attacks on labor by Standard Oil, of which the Ludlow Massacre by Rockefeller interests is a dark chapter.

This Is What Unions Have Accomplished

Decent homes instead of miserably furnished rooms, a chance to buy clothes and shoes for the kids and milk for the babies, a chance to pay off the debts contracted in the old days of starvation pay and unemployment under the open shop system the shipowners are trying to bring back to the waterfront — these are some of the things the maritime unions have won for thousands of San Francisco workers under their leadership, which the shipowners' paper "The American Citizen" so vehem-

ently denounces.

The petty graft and brutality of the shapeup and gang boss system has been abolished. No more "ham hanging"; a longshoreman can get a job today without handing the gang boss a ham, or a case of wine, or a bottle of whiskey like in the old days. No more pitting gang against gang in the inhuman competition of the Blue Book days. No more unemployed longshoremen hanging around the docks starving while others work 60, 70 and 80 hours straight without sleep or rest.

Today there is fair and equal division of work on the docks. Four thousand longshoremen make a comfortable living, \$135 and over monthly average, where 1,200 worked irregularly before while a few star guys were making good pay the majority lucky if they made \$5 to \$15 a week. Everyone of the longshoremen forced to starve on relief in the Blue Book days

is working today.
Sailors' pay of around \$43 a
month and sometimes down as
low as \$25 before the 1934 strike is raised to \$62.50 and 60c overtime. Warehousemen, scalers and every maritime craft are getting higher pay, and job security.

All along the line the maritime unions under rank and file leader ship have put an end to the old system of long hours, low wages, driving speed-up, insecurity and brutal competition on the San Francisco waterfront. They have aided the neighborhood merchant by gaining wages for the men working on the waterfront that enable them to buy the things they have always needed and never could buy in the old days.

The maritime unions are doing a good honest job working actively to protect the interests of their membership and all San Francisco labor. They are carrying out the traditions of real American trade unionism. That is why the shipowners want to destroy them.

LOS ANGELES, Feb. 3.—The reactionary forces of finance capital and industry in Southern California want Fascism!

Hand of Reaction

In no other event is the hand of reaction to be seen so plainly, than in the current drive of the shipowners and big-shot bankers to drive a wedge into the maritime workers, in the closest co-operation with the Tory officials of the International Seamen's Union.

For months this beef-squad terrorized all honest workers in San Pedro, waylaying them individually and beating them into unconscious ness, until finally the workers re-belled. Fred Friedl, an official in the union, who led this gang of thugs, was riddled by bullets of police officers last June 22nd in a mysterious murder never fully solved. This happened less than 24 hours after Friedl was expelled from the union by a vote of 48

Two days later, the beef-squad attempted to "get" Smallman, who was incapacitated from a "few bumps" administered by these thugs a few days before, the "bumps" including a broken shoulder and four caved-in ribs. Smallman was protected by a handful of friends, and in the melee that followed, Riley received a fractured skull and died several days thereafter.

Murder-But No Charge Another beef squad was organized in the International Longshoremen's Association local in San Pedro, and one of its members early last September coolly murdered a rank-and-file member of the I. L. A., Arthur Ross. This vigilante, Edgar Rueb, has never been brought to trial for this unwarranted killing.

Last September he beat up Pauline Lemes, young Mexican girl weighing approximately 95 pounds! And then unsuccessfully tried to have her convicted on a 'disturbing the peace" charge!
Strikebreaking "Plan"

More terror is in store for the workers of Southern California, unless a united front is formed strong enough to defeat the reactionaries driving towards Fascism. Only this month the Los Angeles Board of Supervisors okeyed a "disaster plan" ordinace, providing for forces composed of the American Legion, Spanish-American War Veterans, and sheriff's squads, under the leadership of Sheriff Biscailuz.

The real intent of this "disaster plan" ordinance is not to take care of emergencies caused by natural disasters, such as earthquakes, fires, etc., but to organize a vigilante group to smash down workers and their

organizations. Challenge Fascism!

The militant, progressive trade dissension in the ranks of the unions on the Pacific Coast have become the center of the openshop employers' attack to destroy the organized labor movement and the hard-won working conditions gained by the unions. The employers sent a resolution to the ployers sent a resolution to the are inciting violence in such Fasconvention of the International Seamens Union demanding that ican Citizen," in the Hearst press, disciplinary action be taken against the "irresponsible" unions on the Pacific Coast. (The shipowners consider any union that they can not control, "irresponsible.") The officials of the International Seamens Union, complied with the demands of the shipowners, ordered the Pacific Coast District of the union to withdraw from the Maritime Federation, and revoked the charter of the Sailors Union of the Pacific.

This action was taken at a convention to which the majority of delegates were never elected, but appointed by reactionary officials in violation of the I. S. U. constitution. The only democratically elected delegates were from the Pacific Coast unions.

Employers' Aims

The employers hope to utilize this splitting action of the I. S. U. officials, Olander and Scharrenberg, to carry out their objectives. They want to create confusion and

There are forces at work in this country that would wipe out, if they could, the labor movement of America, just as it was wiped out in Germany and Italy. There are those of us who believe that the best security against that menace is a more comprehensive and more powerful labor movement."

Communist Role

The members of the Communist Party who belong to unions play a constructive progressive role there. The Communist Party re-quires its members to be good union men and women. At a secret conference of 200 represenatives of Big Business on the Pacific Coast, including the Waterfront Employers Association, the Industrial Association, and the Chambers of Commerce, held in San Francisco on September 8th and 9th, Roger Lap-ham of the American - Hawaiian Steamship Company said:

"We fear we will be maneuvered into a position where you other business men will demand that we arbitrate."

Herman Phleger, attorney for the Waterfront Employers Asso-

ciation, told the meeting:
"We have endeavored in the
last year to encourage respon-

sible union leadership among men whom the employers could edepend upon."

A. H. Lundeen of the Seattle Chamber of Commerce said:

"We are afraid we will be jockeyed into a position where other business men will demand that we arbitrate. We must have the backing of every branch of business if we are to win this struggle. And if we do not win, union labor will move in and organize your workers as it has organized ours."

Speaking of the elected leader of 4,000 San Francisco longshoremen and of the District Council of the Maritime Federation, Lapham

admitted:
"Bridges is stronger to than he was a year ago, unless his influence is eliminat-

ed, we can't get anywhere." We challenge the shipowners to deny and refute these facts showing a union-wrecking conspiracy of

the employers. Call to Action!

We appeal to every worker and every friend of labor to stand by the maritime unions in their struggle. Have your union demand a public Congressional investigation of the employers' plot, as the Central Labor Councils of San Francisco and Oakland have done.

Every union should follow the example of the Seattle Central Labor Council and protest the re-voking of the Sailors Union charter, and support the fight of the Sailors Union to remain a part of the International Seamens Union and the American Federation of Labor.

MARITIME FEDERATION EXPOSES SHIPOWNERS

Harry Bridges, president, and Mervyn Rathbone, secretary, for the District Council of the Maritime Federation exposed the nationwide conspiracy of waterfront industrial and financial interests to attack the maritime unions of the Pacific in a statement issued demanding a Congressional investigation into the shipowners' plot. The statement shows steps taken by the shipowners as follows:
"On a date yet to be decided,

probably in February, Waterfront Employers Associations of all Pacific Coast seaports will take the

following steps: "1. Full-page advertisements will appear in the larger daily newspapers which will state the intentions of the employers and present arguments in support

of their actions. "2. In an effort to maintain an appearance of peaceful resistance, they will then evict seamen and longshoremen from jobs by laying up ships, ostensibly because 'exorbitant' union requests make operation financially impossible.

"3. Recognition of all maritime unions will be withdrawn and the shippers will attempt to deal with the men only on an individual basis.

"4. Shippers will attempt dictorial control of wages and working conditions.

"In the advertisements, these

'arguments' will be presented:
"1. The unions are 'irresponsible' and 'fail to keep their agreements, thereby disrupting the free flow of American com-

merce!'
"2. The unions are run by 'Communists,' 'Reds,' and 'Radicals' whose objective is 'destruction of American shipping."
"3. Ships can be 'run only

at a loss' if owners have to pay living wages.

"4. Shipowners would be 'willing to keep agreements with responsible unions.

This Council of the Maritime Federation of the Pacific Coast therefore requests that our charges be made the subject of a Congressional investigation.

Such an investigation would be the means of preventing what would be, for America, an unprecedented attack on organized labor and the findings and recommendations might easily become the basis for a satisfactory settlement of problems which might have been a constant source of controversy on the waterfront for more than a year."
