Labor Rallies Behind Foster

Much Written-up Case of Burns-Daugherty Prosecutors Proves "Dud" in Michigan Court

Debs Out for Program of the T.U.E.L.

(Special to "The Worker")

CHICAGO.—"The workers of this nation need to be industrially organized without any further delay," writes Eugene V. Debs in the April Labor Herald. "It is the crying need, the urgent demand of the working class."

"That does not mean that dual unions should be organized. Not at all! I should be the first to oppose any such program. The lessons of the past experience warn against any such further attempt."

"The Trade Union Educational League, under the direction and inspiration of William Z. Foster, is in my opinion the one rightly directed movement for the industrial unification of the American workers. I thoroughly believe in its plan and its methods, and I feel very confident of its steady progress and the ultimate achievement of its ends. Of course, I also believe in political unity, and the necessity of the working class building up an independent political organization."

"The urgent, imperative need of thoroughgoing working class unity was never so glaringly manifested as it is today. Recent lessons growing out of the defeated steel strike, the defeated mine strike, and the defeated railroad strike, are tragically in evidence in the appeals they make to the workers of the nation. Each of these strikes that resulted in such disastrous failure could and should have achieved a clean-cut victory. The grievances in each instance were sufficiently flagrant to arouse the attention of the entire nation, and the conditions were so favorable for the successful outcome of the battles as they could possibly be."

"The only reason that the brave soldiers who fought these heroic battles against starvation went down to ignominious defeat, thousands of them having been rewarded with the blacklist in return for their lost jobs, is that they fought under a craft union instead of an industrial union standard, and consequently became the prey either of their misleaders, or of the designs of their masters and exploiters."

"Craft unionism today is not only an obsolete form of organization, but characterizing it bluntly it is a crime against the working class. Its sole purpose in the present industrial development is to keep the workers divided, arrayed against each other for the benefit of their masters and misleaders."

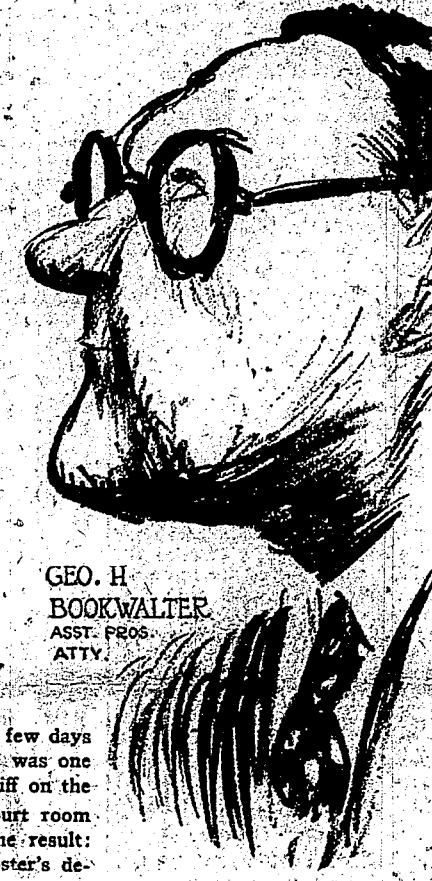

Here is the result: Judge White, the judicial referee, Frank P. Walsh, Foster's defender, and two of the prosecutors, Gore and Bookwalter, aren't they terrible looking chaps. Startling revelations, promised and heralded by the Burns-Daugherty attack on the Communist movement thru the trial of William Z. Foster, at St. Joseph, Mich., are falling on deaf ears as the prosecution offers its "Harry Orchards" and "Ortie Mac-Manigals" for the approval of court and jury.

Thru the "pay-triotic" energy of R. B. Whitney, erstwhile professor at exclusive Harvard University, head of the 100 per cent American Defense Society, the whole case of the prosecution had been spilled long ago thru the "exposures" of the Boston Transcript, and associated publications, and later thru the New York Herald, and any kept sheet that would buy its stuff.

In fact, the Burns Detective Agency, in full charge, it seems, of all the testimony in the case, has been peddling it around for the past six months to any capitalist sheet that would buy it, with the result that the "Michigan Trial" viewing the offerings of the prosecution, has the bad taste of "the morning after."

Wherever mass meetings of workers are held thruout the land, and the name of William Z. Foster mentioned, and the Michigan trial discussed, there is great enthusiasm for the secretary of the Trade Union Educational League, and the editor of its official organ, "The Labor Herald". Every indication is that, altho some reactionary officials may seek to use kept press reports of the Michigan trial to create prejudice against the militants, nevertheless, the great mass of the workers are with those whom Burns, Daugherty and other hireling prosecutors of the open shoppers, would victimize and send to prison, for their loyalty to labor.

This week's testimony has definitely shown that the Burns-Daugherty department of justice, at Washington, with the Burns Detective Agency as its ally, was definitely back of the Michigan raid, manipulating the Berrien County sheriff's staff, and the Michigan attorney general's office to suit its will, which is the will of William J. Burns and the big bosses of American industry.

Judge Rules that Everything Is Admissable at the Communist Trial in Michigan

COURT ROOM, St. Joseph, Mich.—The star of the State's star witness, Federal Detective Francis Morrow, became somewhat dim when he attempted to identify the questionnaire of W. Z. Foster, defendant in the Communist trial here.

Even after admitting that Foster was 15 feet away from him and that about twenty people were between him and Foster when the latter was alleged to have been filling out the questionnaire, and that it had been deposited upon a table among 74 other and like questionnaires, Judge White allowed it to be received and read to the jury. Morrow testified that Foster was industrial director of the Communist Party, stating that he knew this to be a fact because it had been announced at the convention and had been previously reported thru party channels. He produced a bundle of documents one of which he handed to the prosecutor who offered it as an exhibit.

It was at this time that he again got his wires crossed. He had testified that all party documents came thru the mails. The exhibit was a bi-weekly news letter and the paragraph which the prosecution wanted to introduce referred to Communist activity on behalf of the striking coal miners and called for maximum support on behalf of the West Virginia miners in their so-called treason trials, which followed their conflict with the coal barons. Other documents, read to the jury over the objection of Attorney Walsh, where the Communist party program and constitution, an article from the March issue of "The Communist" entitled

"Our Prisoners," and an article in the July number of "The Communist" entitled "The Vice of Purity". The prosecutor offered the theses and statutes of the Third Congress of the Communist International and the "A B C of Communism" by Bukharin. Judge White has ruled these to be admissable.

Montana Won for Unity of Labor Unions

BUTTE, MONTANA.—The Montana State Federation of Labor is the twelfth state labor body to endorse amalgamation. It adopted unanimously the amalgamation resolution introduced by Clem Bukard, representing the Silver Bow Trades and Labor Assembly. The resolution had previously been endorsed by that body and urges the creation of industrial unions for each industry by amalgamation of the existing craft and occupational unions.

Workers! Support the Labor Party Referendum of the Trade Union Educational League

The Trade Union Educational League has taken its first big step in the campaign to popularize independent working-class political action. It has sent out 35,000 letters to practically every local union in the United States. These letters each contain a leaflet outlining the position of the League regarding a Labor Party and a ballot whereon the multitude of local unions are requested to express their opinion on the commitment of the whole labor movement to independent working-class political action.

The communication points out the need for not only a united political movement, but also for a strongly built industrial movement, the two issues being linked together. A quotation from the letter follows: "Amalgamation and a Labor Party! These are the supreme needs of the labor movement at the present time. On the one hand, we must amalgamate all our craft unions into a series of powerful industrial organizations, and on the other hand, we must discard our present antiquated political policy

of rewarding friends and punishing enemies and organize a militant Labor Party, capable of defending our political interests. The recent great strikes of shopmen, miners, and others, with the Government entirely on the side of the employers, shows the absolute necessity of a Labor Party. The future progress of the entire labor movement depends upon the accomplishment of these two basic and vital measures. Amalgamation and a Labor Party."

In order to learn the sentiment of the rank and file of the labor movement generally on the proposition of independent working class political action, each of the 35,000 local unions is requested to vote on the following proposition: Resolved: That we endorse the formation of a Labor Party by the whole trade union movement, to be based upon direct representation from the local unions, and to include as affiliated organizations all existing working class political parties."

Wide-spread interest has been aroused by this unusual referendum. Labor papers from New York to California have carried long stories about it, and have commented favorably upon the project. In thousands of unions it is becoming the subject of conversation. Does the labor movement need a Labor Party? Do the rank and file want a Labor Party? The referendum will give the answer.

Every union man should see that this referendum is brought to the attention of his local union. If the members are not yet thoroly posted on the issue, they should have it explained to them in short talks by those who have studied the question. The statement issued by the National Committee of the Trade Union Educational League gives the conclusive arguments to bring forcefully home the lesson of the need of a Labor Party. This statement is now available in leaflet form at a small price, a few of these distributed in each local union will quickly clarify the issue and bring the organizations enthusiastically into line.

Every reader of THE WORKER should join at once in this great educational campaign. Talk about Amalgamation and a Labor Party. Raise the issue in your local union. Distribute the leaflet issued by "The League." Introduce the resolution cited above. Send in the vote of your local union to the Trade Union Educational League. Rail Heads Balk Efforts at Solidarity

The general caliber of the men to be found at the head of some of our labor organizations, as well as how little attention they pay to convention instructions, is well exemplified by the farcical amalgamation negotiations carried on between the presidents of the Brotherhood of Railway Trainmen and of the Switchmen's Union of North America.

At the 1922, Toronto Convention, of the B. of R. T., a resolution was adopted calling for the amalgamation of the B. of R. T. and the S. U. It specifically stated, "Inasmuch as the yardmen of this country are organized into two separate orders, which in the past has had a harmful effect, and their interests would be better served by uniting into a single and stronger organization, this Convention is in favor of making an offer to the Switchmen's Union looking to the merger of the two orders."

Shortly afterward President Lee, "merely for your information," sent this resolution to President Cashen. The latter wrote demanding further information. To this Lee said, "I am unable to give you any additional information other than contained in the resolution." The only argument I remember presented to the convention by those supporting the resolution, was that in the interest of trainmen and yardmen, one organization only should be arranged for.

Taking his cue from Lee's deliberate sabotage of the amalgamation resolution, Cashen backed away from the proposition altogether, saying, "In the absence of a definite understanding as to the intent of this resolution, the Board finds itself in the position where it is unable to take action. It is our opinion that the intent of the resolution has for its end the absorption of the Switchmen's Union by the Brotherhood of Railroad Trainmen. This apparent intent is totally at variance with the fundamental principle on which the Switchmen's Union of North America is based." He then plumps for craft unionism complete. With such reactionary leadership, how can railroad men make any progress?

The plutocrat's rapacity stops only at the labor capacity of the worker—and oft-times not even there.

Testimony Shows Daugherty's Department of Justice Planned Raid in Michigan

ST. JOSEPH, Mich.—The trial of William Z. Foster, charged with the violation of the Michigan Criminal Syndicalism Statute, entered upon its second week with Special Agent Wolf of the Department of Justice, continuing the identification of documents alleged to have been seized at the time of the raids. Under a grilling cross-examination by Frank P. Walsh, chief counsel for Foster, it became quite evident that the Bridgeman raids were conducted by the special agents of the Department of Justice and that the Sheriff's office participated merely to give a semblance of authority to a most questionable procedure.

Sleuths Conveniently Forget Wolf testified that he had never heard of Allan Meyers, general manager of the Burns detective agency until the day following the raids at Bridgeman. This, in spite of the fact that he had been a Pinkerton detective for about eight years preceding July 1919, when he became an employee of the Bureau of Investigation, Department of Justice, of which Mr. Burns is the directing head.

In fact, all the Burns federal detectives denied they had ever heard of Meyers, the manager of the Burns Agency, previous to the Bridgeman raids. Yet it was quite evident from Wolf's testimony that Meyers had advance information concerning the raid, as he appeared at St. Joseph from New York City the morning following the raids.

After the raids, according to the testimony worked out of Wolf by Mr. Walsh, the seized material was at all times accessible to the federal agents who had keys to the room in which the material was kept. Meyers also had access to the documents but the witness could not remember whether or not Meyers had examined any of them while alone in the room. Walsh asked Wolf, "Did you not say to the Berrien County Board of Supervisors that Berrien County would not be put to any expense for what has taken place, and what will happen in these cases. The money will come to pay all expenses. The source from which it will come I cannot say at this time, but it will come?"

Wolf denied making such a statement and when he was asked if Max Berger had not done so he reiterated that he had made no such statement.

The Battle to 'Get a Jury'

ST. JOSEPH, Mich.—The first prospective jurymen to admit he once was a member of a labor union was challenged by Prosecutor Charles W. Gore, and dismissed from the jury box. Foster will be tried for unlawful assembly under the criminal syndicalism law. William Gatchell, who said he was a former member of the Cement Finishers' Union, Chicago, now farmer, was dismissed. Another man who said he was a member of a union, and had read Marx very closely, was questioned by Prosecutor Gore, under guidance of Max Berger, "anti-unionist expert" from Burns' Department, Chicago.

"Do you believe in the fundamental right of the American people to make revolution as expressed in the Declaration of Independence," was a question asked each venireman by Walsh. Prosecutor Gore countered with, "No, you believe criminal syndicalism law a good law and should be enforced?" incessantly today as yesterday. Also Foster's leadership in steel strike and packing house workers were prominent factors in asking jurors whether they were prejudiced. Prosecutor Gore today asked juror whether he understood steel workers had better working conditions now and whether he attributed improvement to Foster's activity, if so whether it would tend to prejudice him in favor of Foster.

One retired capitalist, living on investments, this morning admitted fixed prejudice. He was excused. Another business man admitted fixed opinion, he also was excused. A roar of laughter was created by a jurymen who said he had talked with a storekeeper, who declared his show window had fallen in and thought it was because Communists were in town. Juror said this had not prejudiced him.

The case takes more and more a social atmosphere as auditors catch thread of deep political ideas and class struggles thruout the world. Walsh frequently refers to First, Second and Third Internationals, and international associations of business men—such as the chambers of commerce, asking whether prospective jurors realize that all phases of life have become of international scope, and whether they believe workers have same right to organize international associations as capitalists have.

Mr. Walsh based his question on an affidavit which he held in his hand. Incidentally an affidavit making such a charge and naming Burns, himself and Representative Ketcham, Congressman from this district, was filed by a member of the Berrien County Board of Supervisors and was one of the grounds upon which the defense based its motion for a change of venue.

The second affidavit is a matter of public record. This is significant when it is realized that Michigan has a statute forbidding the use of outside funds for a public prosecution. Mr. Wolf was excused shortly after the noon recess much to his relief.

The next witness was Francis A. Morrow. Morrow announces himself as a "federal employee". He was a delegate to the Communist convention last August and is counted as the State's star witness. He testified that he was a duly elected delegate from Philadelphia, and gave "expert" testimony regarding the structure of the Communist Party and attempted to explain its functions.

Morrow Well Schooled

He was generally ready with his answers before Prosecutor Smith had fully framed his questions, which gave the impression that he had been thoroughly rehearsed. He identified "the call for the convention," which Judge White allowed to be read into the record over the strenuous objection of Mr. Walsh. He identified a number of documents which were read into the record. Mr. Walsh objecting. He told of how Duffy of the Grounds' Committee had dropped the roster of delegates which he had picked up and hid for this trial, a statement so raw, and palpably a falsehood, that it called forth a smile even from those on the inside of this prosecution.

occasion there is a general demand for a monster open-air demonstration in Charleroi early in April when Howat will return to District Five.

The word is to be scattered far and wide and probably 25,000 people will gather to protest in opposition to this outrage against free speech.

The Pay-Roll Gang in Action

Shortly after the doors were opened, the pay-roll gang entered and ostentatiously grouped themselves in all sections of the hall. Acting President Fagan, Vice-President elect (according to the official report) Patton, Secretary-Treasurer Hargest were there; also, Greulac, O'Leary, Feeney, Robertson, Malone, Wolcott, Dobbins, Van Bitner, Henderson, Hynes, Gulick, and 30 or 40 more.

Black looks were exchanged between the miners as they observed this aggregation enter and realized that hundreds of dollars of their hard-earned money was being squandered by the gang in this invasion of the meeting with no possible good purpose.

No sooner had Chairman William Guiler, of the Progressive Miners' group, announced the first speaker, Wade Rigger, of the Coke Region General Relief Committee, than Fagan sprang to his feet. Although informed repeatedly by the chairman that the meeting had a definite program to follow and that he and the others would be given a voice at the proper time, Fagan persisted in his attempt at disruption. Hypocritically repeating the parrot-like formula that he did not wish "to disturb the tranquility of the meeting," he insisted on being allowed to dictate the program. In an endeavor to allay the distress of the Acting President, Howat rose and volunteered to lay aside the regular program and accept then and there the challenge to debate made by Fagan the preceding Sunday at Canonsburg. But this seemed to take away from the valiant defender of the machine the appetite for verbal battle and he sidestepped by offering for slaughter other sheep of the fold, namely Van Bitner and Feeney, "authorities" on Kansas situation and coke region respectively.

Finally sufficient order was restored to allow Rigger to make a few remarks, after which Max Lerner was introduced. His short talk on the subject of relief for the locked-out miners of the coke region was constantly interrupted by cries of savage rage from O'Leary, Feeney, Fagan, and the rest, determined to break up the meeting even tho they demonstrated their total unfitness to be leaders of any other organization than a gang of thugs. The refusal of the coke region miners to allow themselves to be starved to death without a protest, and their loyal determination to make this protest from within rather than from without the union has irritated the machine to the point of desperation. As Lerner led up to the question of a collection for the benefit of the coke region victims of the International's cruelty, which from the crowd which packed the theater and overflowed into the street, and indicated its response by outbursts of applause, promised to amount to many hundreds of dollars, the frenzy of the gang, inspired by Fagan, O'Leary, Van Bitner and Feeney, grew uncontrollable. Just at the moment when Lerner was calling for the ushers to start the collection, a squad of police, under orders of the burgess, and acting chief of police, stopped the speaker by lowering the curtain and ordered the meeting to disperse, on the grounds that the actions of the disturbers were leading to certain riot.

The gang had been victor. The miners had been kept from hearing from the coke region, which persists in living when it was supposed to die peacefully months ago, and from being told the hideous story of the crucifixion of Alexander Howat and the other officials and the members of District No. 14. Yet with every such victory defeat comes all the nearer. The miners of District No. 5 will rally as never before to the support of Howat and the coke region miners when they hear of the disreputable methods taken by the machine to prevent Howat and the coke region even from telling their story.

The Stuff Jingoos Are Made Of!

SEATTLE.—Fraud and graft against his wartime buddies is charged against Ralph Horr, bolshevik-baiter and prominent in the councils of the Foreign War Veterans' organization, in suits filed in court here by business men. Horr, who stumped the country lecturing against radicalism among ex-service men, is said to have taken nearly \$15,000 by padding the payroll, issuing duplicate bills, pocketing money in excess of expenditures, and accepting side money from a carnival show which he brought to Seattle when the veterans held their annual convention here in 1922.

The French "Committee of Action" in its proclamation to the French proletariat says: "Order of mobilisation must be taken as a signal for us to mobilise our forces." The Union of Ex-Soldiers calls its members everywhere to act with the Communist Party and to stand against war.

Oh, that's all right, just give it time. You learned a lesson, anyhow. And I'm giving you back your job, too, after all the trouble you gave me. Phil, show you how to run the press right. You better go downstairs, it's after half past eight. You say you can't use your thumb? Aw, it's all right, it'll limber up. You don't have to use your thumb on the press any way." And the boss walked into his private office. And Charlie walked downstairs to the power press. But a moment later the boss was out of his office, and yelling after Charlie: "Hey, Charlie, wait a minute. You're right. That thumb ain't in a condition to use. I guess you're right." McCarthy who made the appeal before the central body has been appearing before local unions in Philadelphia soliciting support. Many unions in the city are helping financially and by sending resolutions demanding the dismissal of the case to the Governor of Michigan.

Deserting the Fayette Coal Miners

PITTSBURGH, Pa.—The following statement can now be authoritatively made:

The present Lewis administration of the United Mine Workers of America sent a committee of six prominent officials to investigate the Fayette County, Pa., coal strike. This committee, after close investigation, unanimously reported the strike as being in a healthy condition and recommended that more help should be furnished by the International Executive Board and that the strike should be vigorously prosecuted. Their report recommending this policy was mailed Dec. 20, 1922, to President John L. Lewis. In spite of this they made a week later an entirely different report to the International Executive Board.

A WHITE GUARD "Y"

The N. Y. Chapter of the Knights of Columbus have bought seven tenements at Eighth Ave. and 51st St., where they are going to erect a twelve-story building for their "general welfare and educational work." The new building will contain "one of the finest auditoriums in the city, gymnasiums, swimming pools, restaurant, 300 living rooms, class rooms for the educational work and meeting rooms and offices to house a large percentage of the Councils of the Knights of Columbus in Manhattan and the Bronx." This promises to be a new, purely White Guard type of "Y."

FOR 1924

The Appropriations Bill for 1924 now before Congress calls for the expenditure of 85 cents on every dollar of Federal taxes to pay for war. To develop and maintain land forces it calls for \$340,341,396.23.

THE MILITARY IRON HEEL

House Committee Resolution 78 asks for a commission to investigate the best and most practical methods for "drafting all the resources of the United States, human and material, for national defense, so that in event of future wars every man and woman may be called under the flag for assignment to duty for whatever service, military or civil, the individual is best fitted, and every plant, agency, and facility may be called to universal service, all in sublime sacrifice for the country." (To make the above "popular," no doubt, a little jargon is attached which reads "and not a penny of war profit shall inure to the benefit of private individuals, corporation or combination.")

IN JERSEY

The Haddonville and Mount Ephraim Detective and Pursuing Association is an "amateur police" organization composed of 750 solid citizens; among them seventeen "pursuers." They are practicing, like so many of these "civic bodies," for "combatting crime" upon petty crime cases, to perfect themselves for later emergencies when a rising working class will demand their attention. "In the event of a crime being committed, the pursuers organize posses of men and block off and capture escaping criminals. Crime has been at a minimum within the area covered; as posters announce a good cash reward for the capture of any person committing a crime against any member of the association."

TEACHING EM TO SHOOT

How can the children of the Boy Scout movement be taught to shoot straight and yet not be given guns, which may prove a stumbling block thru the objection of many parents of children? They seem to have solved that problem in Chicago. There the Boy Scouts are being encouraged in the practice of archery. Bow and arrow make no noise, need no bullets, and give perfect practice for straight shooting, steady nerve and hand and good muscle. Time enough to put the gun in his hand later. The bow and arrow Douglas Fairbanks used in his Robin Hood picture is offered by a Chicago paper for the best essay on Archery, only members of the Boy Scouts participating in the contest.

From Cover to Cover

Henry Noel Brailsford, an erstwhile liberal who was shocked at the horrors of the aftermath of the War, turned socialist, joined the Independent Labor Party, became editor of their main organ, and wrote another book, "After the Peace" (Thomas Seltzer). It is a gloomy picture of postwar Europe, and is illumined by occasional flashes of a very keen insight. But like all who try to combine the bewildered honesty of the liberal with the irresolution of the mild socialist, his conclusions, his attempted remedies, are woefully weak. The statement that Capitalism can no longer feed Europe, may be "startling" to the editors of the New Republic, but I humbly suggest that we have had some sort of a suspicion to that effect for some time. After all, might not all the gloom be dispelled by having Mr. J. Ramsay MacDonald, leader of Mr. Brailsford's party, attend another reception in silk breeches and long stockings, and shake the hand of his most gracious majesty, George V, Rex Britannicus, India, Ireland, Egypt, Mesopotamia and the House of Morgan.

Fritz Adler, leader of the 2 1/2 International, and of the Austrian Social Democrats, has in conjunction with the Christian Socialists, framed an "Election Law," directed solely against the Communists. The Act provides that all imprisoned or interned under previous laws, including those of Horthy, are disfranchised for three years. The formation of Communist Party organizations, thanks to Adler and his consorts, is accompanied with the most severe consequences for the members.

Wage Cuts Planned by Mine Owners

(Special to "The Worker")

PITTSBURGH, PA.—Now that the United Mine Workers' Organization has deserted the coke region miners, the operators can be expected to begin wage cuts in order to win back as much as possible of the huge fortunes spent in strikebreaking activities.

During the past week a cut of \$2.50 per day was put into effect at the Smiley plant near Fairchance, and when some of the men who quit in protest applied at another plant, they were told that the same was going to be done there.

Along with this goes the effort to weed out the militants from among those who, forced by starvation, had gone back to the mines before the strike was called off, or who, loyal to the Union, had applied for work as ordered by the International, and succeeded in getting back. At the great Buckeye plant 25 men were discharged a few days ago because it was discovered they still claimed membership in the United Mine Workers.

Thus is increased the number of jobless in the region, which is already largely due to the inability on the part of a great many to get their jobs back. Besides applying for their former places, thru a committee representing them and the other members of their Local Union, President Woods and Treasurer Wisdosh, of Fairchance Local Union, went as individuals to get their old places, and were told that the mine was not getting enough cars to keep the men busy that were already employed.

The answer of John O'Leary and William Feeney to those who complain that they are unable to get work in Fayette County is that many mines in the union district are in need of men. John Sinko, of Brownfield, called their bluff in this matter. He visited several mines whose names Feeney gave him, and was turned down flat. The truth is that the mines in the union districts have for months been badly overcrowded. There were plenty of miners in the union districts in normal times and thousands migrated there from the non-union territory after the Cleveland Agreement.

In face of these conditions which demonstrate that the policy of the United Mine Workers' organization as laid down to the Fayette miners in the January convention has been an utter failure, Feeney and O'Leary continue to repeat the discredited formula: "Get your jobs back; keep up your local unions; pay dues; if you can't get work in the coke region, we will move you to the union field in District No. 5; don't come back for any more relief as we won't have any more for you." Such piteous appeals as are secured by the locked-out miners require on their part a long and humiliating argument with the men in charge of the relief headquarters, which without doubt would have been discontinued weeks ago had it not been for the action of the Progressive Miners and Pittsburgh Miners-Relief Conference in giving publicity thruout the country to the treachery of the union.

Under the pressure of the militants aroused by this publicity, the International has not dared to leave the field entirely, but in order to make a show of activity, has moved its coke region headquarters across the river from West Brownsville where they had been for ten months, to Brownsville, in Fayette County. They have also announced that the strike is to be continued at several plants near Brownsville which are adjacent to unionized mines. But the seriousness of this proposal can be judged from Denbo, one of these mines, where the strike was carried on during the last week of February by eight married and a few single men. For this group, supporting a strike and not being helped merely until they could get jobs, the Headquarters gave during this week the princely sum of \$56 to supply 16 adults and 30 children.

If William Z. Foster should wish to write an additional chapter to his booklet on "The Bankruptcy of the American Labor Movement," he would have no trouble in filling it with splendid examples from the actions of the officialdom of the United Mine Workers in their efforts to liquidate the coke region strike.

The "Italian Fascisti" in America

The New York Times announces in all seriousness and approval, that an organization known as the "Italian Fascisti of Boston" has been formed in the New England metropolis, the counterpart of similar organizations in other large cities in this country.

No loud outcry is raised by The Times against the banding together of these American counterparts of Mussolini's arsonites and assassins in the homeland. No demand is made upon the department of justice for the extinction of this murder crew, with headquarters in New York, in touch with G. Bastianini, the political secretary of Mussolini.

These "Fascisti" in America, getting their inspiration from the Mussolini dictatorship in Italy, have already a long list of crimes to their credit. The prevention of the Carlo Tresca meeting at Waterbury, Conn., was followed by the shooting up by these hoodlums of the meeting addressed by Antonio Presti, at Lawrence, Mass.

It is encouraging to note that the forces of organized labor have been quick to realize the danger. This was shown at the mass meeting held at the Amalgamated Temple, in Brooklyn, where more than 2,000 Italian workers—tailors, shoe makers, carpenters and other building tradesmen, barbers—pledged themselves to combat Fascism as a regime of "terror and assassination."

The situation demands an immediate and complete united front of all radicals among the Italian workers in this country—unity of Communists, Socialists and Anarchists against the common enemy, the American brand of Mussolini's Fascisti, who will serve bosses of all nationalities in their war upon the organized labor movement.

If Mussolini can organize his Fascisti in this country, then Horthy, of Hungary, can come here and organize bands of White Terrorists, and the Bavarian Hitler can send his emissaries into our midst and organize royalist Germans for the restoration of the Kaiserdom.

The 100 per cent American open shoppers stand ready to utilize these reactionary organizations, no matter of what breed, for their own vile purposes, even by incorporating them bodily into the American Legion or the Ku Klux Klan.

All labor must unite now to combat the spread of Fascism in America by helping the Italian workers in this country scotch the Mussolini snakes already in our midst.

Needle Trades Must Amalgamate, Is Declaration of T. U. E. L. Militants

The International Committee of the Needle Trades' Section of the Trade Union Educational League has declared in emphatic terms that the present craft form of organization must give way to a departmentalized union embracing all the workers in the needle trades under the banner of the American Federation of Labor.

In a four-page leaflet that is being distributed thruout all the needle trades' unions in the United States and Canada the militants of the Trade Union Educational League have pointed to the defects in the present form of organization. In place of decisive action in case of strikes against the employers the organizations in the needle trades, not involved in the actual struggle, now extend "moral" support and sympathy. Neither sympathy nor moral power won a strike. What is needed is power to combat the employers.

The leaflet points to the consolidation of the various manufacturers with the "open shop" forces in the United States, and points to the necessity for the workers closing their ranks in order to effectively combat the open shoppers. Furthermore the tremendous problem of organizing the unorganized can never be successfully solved until there is one union in the industry that can make an irresistible appeal to all workers, and can show by its achievements that a wide breach separates the conditions of the unorganized and organized workers.

Not Federation, but Amalgamation. The futility of federation is clearly depicted by reciting the history of the Needle Trades Alliance in its impotence against the employers.

There is widespread demand for amalgamation among the rank and file of all the needle trades unions. The leaders of certain unions, realizing the extent of this demand, have tried to pervert the sentiment into the abortive channels of a Needle Trades Federation. This propaganda on the part of the reactionary officials is merely an effort to thwart the will of the membership and prevent effective organization.

New England Granite Cutters Understand the Big Strike of Red Russia's Workers

LANESVILLE, MASS.—Red Russia on strike against the capitalist world—this the granite workers of this town could grasp, for they had just passed thru a seven months' fight against wage slashing. The Red Army as the pickets, and workers' control of industry and government as the goal, recalled to the granite workers their own bitter fight against increased exploitation. The Lanesville workers gathered in the Finnish Hall felt that the Russian workers were waging a struggle in the interest of all workers, wherever they happened to live.

Comrade James P. Cannon got his message across, thru his earnestness and forcefulness. He does not wait for inspiration, but is constantly perfecting his lecture. He approaches his lecture tour like an artist, taking infinite pains to make every sentence fit in. The writer considered it a rare privilege to hear the talk on "Russia Today."

As a result of the meeting, the establishment of a Scandinavian branch in Lanesville is a probability.

No reply has been received (March 9) by the Russian trade unions to their offer of 9,000 tons of food for the starving workers in the Ruhr. The reactionary social-democratic officialdom stands in the way.

Indianapolis City Council Stops Pickets

(Special to "The Worker")

INDIANAPOLIS, Ind.—An anti-picketing ordinance passed by the city council in 1919 has been upheld by the city court and the circuit court after months of litigation. Organized labor has fought this law bitterly as its existence means the destruction of one of the most potent of labor's weapons in its struggle against the capitalist class. The ordinance also outlaws the labor union boycott.

Now that the labor-hating employers of Indianapolis have succeeded in getting two of the lower courts to place their O. K. upon the ordinance the Associated Employers of Indianapolis have begun a nationwide campaign for the purpose of inducing other communities to adopt similar ordinances.

In the intense fight that was carried on against this ordinance the unions resorted to every method known to them that they might be able to inform workers in struck concerns that they were being used as strike breakers. The ordinance prohibited the display of banners so the pickets had letters sewed in their shirts reading "This Place Is Unfair To Organized Labor." They were arrested for this, sentenced to pay a fine and the circuit court upheld their conviction. The cases are being appealed to the State Supreme Court.

After this victory for the employers their association began circulating other cities in the country urging them to adopt similar ordinances. A copy of the Indianapolis ordinance is sent to councilmen and other legislators advising them to introduce it in their city councils. It is one of the most vicious legislative assaults yet made upon the labor movement and provides as a penalty a fine of not less than \$50 nor more than \$1,000, to which shall be added imprisonment in the county jail or state penal farm for a period not less than 60 days nor more than 2 years.

It even goes so far as to prohibit individual members of a union from talking to a scab concerning the nature of his employment or even mentioning the fact that there is a strike in existence in the place of his employment.

The labor unions of Indianapolis are determined to fight this ordinance in Indianapolis to the limit, as they know its success means its rapid spread to other cities. Many of the large International Unions have their headquarters in Indianapolis and transact millions of dollars worth of business in the course of a year and in case the ordinance is sustained they all propose moving from the city as a rebuke to the scab herding employers and their hireling city council.

Textile Conference to be Held May 5th and 6th

The General Amalgamation Committee of the Textile Industry, composed of rank and file militants of the various textile unions, is launching a huge campaign for amalgamation of all the unions in the industry.

Nowhere are the workers more ruthlessly exploited than in the textile industry. Wages are at a starvation level, working conditions are extremely severe, and only a fraction of the 1,600,000 textile workers are organized.

The formation, recently, of the Federated Textile Unions of America, a loose alliance of some of the larger unions, has only served to awaken the workers more keenly to the imperative need for organization, and for the consolidation of the workers' forces thru the amalgamation of all the conflicting unions in the textile industry into one mighty industrial organization, with interlocking departments corresponding to the main sections of the industry.

The General Amalgamation Committee of the Textile Industry will issue a call for a National Conference of the militants of all textile unions, to be held in New York on May 5th and 6th for the purpose of organizing a militant vanguard in the amalgamation campaign.

All together for amalgamation.

MOSCOW.—The railway workers of Rostov-on-Don have collected 9,000 gold roubles for the relief fund of the Polish communists kept in prison by the Polish Government.

U. S.-British Oil Conflict Approaches Breaking Point

The fierce struggle between the Royal Dutch Shell, the British Oil concern, and the American Standard Oil Company approached one step nearer a diplomatic crisis that will pave the way for a war between the two countries, in a decision made by Secretary of the Interior Fall just before his retirement on March 4. The decision has just been made public and is a body blow to the aspirations of the British government in its attempt to control the world's oil supply.

For years the British oil interests have been covertly penetrating the territory of the United States under the guise of organizing American corporations. The decision of Fall concerns one of these British controlled corporations and sets a precedent that applies to all. It will exclude, under any form of operation, foreign participation in oil leases in any part of the United States.

Since the only foreign country exploiting oil lands within the confines of the United States, is Great Britain, it is clear to all that the decision is aimed directly against the Royal Dutch Shell and in favor of the Rockefeller interests.

An Act of Revenge

This latest move of the Harding administration is an act of retaliation against Britain for having secretly contrived to get control of most of the world's oil supply outside the United States, while the old Standard Oil was slumbering in the belief that it would remain forever supreme.

The whole quarrel over oil came about thru the invention of the Diesel oil burning engine and its use in naval warfare. England, always alert to defend its supremacy on the sea, was quick to realize the fact that the nation that controls the oil of the world will, in future, rule the waves of the sea. So the conspiracy was launched to secretly control all the potential oil fields of the world and proceed to develop them. The British government gained control of the oil fields in Roumania, it penetrated the Argentine in South America, then it reached out to grab the oil of Mexico. This nation was a little too close to the preserves of the Standard Oil so a struggle for political control began in 1911 and has been raging ever since. Every act of assassination and violence occurring in the political life of Mexico since that date has been merely the political expression of the economic interests of the Rockefeller and Pearson group.

The Royal Dutch Shell operated under various names in different parts of the world thru establishing daughter concerns. In Persia its subsidiary is the Anglo-Persian Oil concern, in Mexico it is called the Mexican Eagle, in the United States it is the Roxana Petroleum Company and the Shell Oil Corporation of Delaware. It was only after the close of the war that the American capitalists realized that the Standard Oil Company was no longer supreme in its field. When the necessity for further expansion was realized the Rockefeller concern stretched forth its tentacles to embrace the oil supply of other countries, but everywhere it turned it found the way blocked by

Lewis Gang Pilloried by Alex Howat

CANONSBURG, PA.—The attempt of the henchmen of the President John L. Lewis machine of the United Mine Workers of America to intimidate the militant workers of this territory in order to stop the Howat meeting here last Sunday signally failed.

Alexander Howat, former head of the Kansas miners and leader of the notable struggle against the infamous Industrial Court Law of ex-Gov. Henry J. Allen, had been advertised to speak under the joint auspices of the Charters Valley Central Trades Assembly and the Canonsburg Labor Defense Council on behalf of the Fayette County Miners' Relief and the Labor Defense.

Before the meeting a gang of officials of District 5, United Mine Workers, led by one Fagan, District President, and Tom Hughes, executive board member tried to intimidate the officials of the Central Trades Council, and threatened to disrupt the meeting if Howat said anything against John L. Lewis, discredited president of the miners' union, and equally guilty with the unspeakable Allen for the imprisonment of Howat. Fagan and Co. were informed that the committee in charge would conduct the meeting and that they would brook no interference from anyone and that they were determined to see that the meeting was orderly.

The meeting was opened by S. Baker, president of the Central Council and when Howat arose to speak he received a rousing ovation. He related the story of his expulsion and his fight against the Industrial Slave Law with telling effect, causing round after round of applause from the audience.

A resolution was adopted calling for the reinstatement of Howat in the miners' union with all rights and privileges enjoyed previous to their expulsion.

During the discussion of the resolution Fagan jumped to his feet and challenged Howat to debate him. The chairman refused to consider such a challenge, declaring it was out of order, but Howat arose and immediately accepted the challenge, declaring that the debate could be held right there. Then the owner of the hall interrupted and asserted that the hall had not been rented for that purpose and that no debate would be held.

Fagan and Co. continued to interrupt, but when the question was put the resolution was adopted unanimously. Many former Lewis supporters, who attended the meeting, were so disgusted with the tactics of the machine henchmen that they denounced them in disgust and declared that they would support Howat to the limit hereafter.

The visit of Howat to the Pennsylvania field is the worst blow so far delivered at the Lewis machine, and all the retainers of that monstrosity of the labor movement, big and small, are scurrying for cover and trying to conceal their treachery by vilifying Howat, where plain intimidation will not work. Everywhere the rank and file is anxious to learn the facts about the actions of Lewis in the Kansas expulsions and as soon as they learn, they immediately desert the Lewis standard.

The net proceeds of the meeting were divided so that 75 percent went to the Fayette Miners' Relief and 25 percent to the Labor Defense. Max Lerner spoke for the Labor Defense and received a rousing ovation.

Grafters in Russia Face Death Penalty

MOSCOW — A graft trial has opened in Moscow which may end in the death penalty for some of the 28 defendants.

Conspiracy on the part of several high officials in the Centrosyos (Central Cooperatives), together with a business man named Shane, is charged, with intent to defraud the state for private gain, by diverting large sections of the state fish business into a private trust named Ribac.

Shortly after the new economic policy began more than a year ago, Shane began business with about \$100,000 and within a few weeks was operating with 20 times this sum. He made connections with officials in the Centrosyos, which had at that time the monopoly contract for disposing of all fish caught by the government fisheries, which are the main large scale fisheries in Russia.

Through his confederates, Shane learned regularly the price at which the Centrosyos was willing to sell fish, and then offered this fish himself at a higher price to the local cooperatives, while his confederates kept back the offers from the Centrosyos. When Shane got orders he handed them over, as if coming direct from the local cooperatives, got permits on that basis, thus inserting himself as middleman and pocketing the difference in price. He also kept for long periods the sums advanced by purchasers, speculating on money which had been sent to the Centrosyos.

A few months later, becoming richer and bolder, the group organized Ribac, a private fishing corporation, which aimed to control the market of Moscow. They intercepted goods sent to the Centrosyos and handled the business themselves, even stealing letters which might have implicated them.

Graft of this kind, involving officials in control of public business and privileges, is regarded in Russia as "economic counter-revolution" and treason.

The criminal code carries penalties as high as death to the principal participants, especially if they have been trusted officials.

Boston Strike Is Won by Solidarity of Rank and File

Now that victory has been achieved in this immediate struggle, the energy of the militants will be devoted to the task of propagating amalgamation of unions in the needle trades industry.

Spend Much for Schools

Private Charity Gets Excited

Again the cry of socialism and paternalism is being raised in Albany, N. Y., against certain measures pending before the legislature. The most important of these are those aimed to increase the powers of the child welfare boards operated by the State. These bodies carry out the laws relating to widows' pensions and the care of children left parentless.

At present, the residence of widows, the laws of guardianship and care of children and the amount granted to widows make the existing Widows' Pension Law far from satisfactory. It is very difficult to fulfill the requirements of the law and so very few can actually receive any help from the State. The case must be a very extreme one before the mother can procure any help.

When widows are helped, the money given them for each child enables the children to remain at home instead of having them committed to some institution, should the mother be forced to work. But this sum is so inadequate that mothers must go out to work in order to feed the children. Still the sum, small tho it be, is a great help.

Those who do not receive this pension are forced to go to private charity organizations, usually run by their religious denominations, and leave the destiny of their children in their hands. The children may be committed to institutions or "boarded out" with private families who usually have something to gain by the transaction.

A few years ago, the institutions run by private organizations were investigated and the most appalling facts were discovered. Filth, cruelty, and exploitation were found. Some "homes" manufactured various articles and there are places that run laundries. The profits go, of course, to the institution.

This present method is championed by the City Commissioner of Public Charity. He is supported vigorously

tions fear the State's encroachment upon their domain. They operate under a belief that they are especially ordained to decide who constitutes the deserving poor and who are the vagrants. They feel themselves an integral part of the social structure. And so they are. For under capitalism, as there must be private charity, Father Bedford in denouncing socialism argues that if we do away with capitalism there will be no opportunity for doing out charity and that would be a calamity for charity enriches him who gives as well as him who takes.

Let the workers do away with the possibility and need of private or public charity. For the mere change from private to public charity does not solve the problems of the workers. It is up to them to create a commonwealth where they will be the State and where provision for widows and orphans will be as much a public function as the carrying on of industry or the management of other social matters.

Rank and File of Furriers in Protest

Saturday afternoon, March 17, Webster Hall, New York City, was packed to overflowing by 1,400 furriers, that responded to the call of the Trades Union Educational League.

This meeting was addressed by rank and file members of the Furriers' Union, also M. J. Olgin, Alexander Bittelman and Joseph Manley. Enthusiasm ran high, due to the controversy raging between M. J. Olgin, Editor of the Freiheit, and Morris Kaufman, General President of the Furriers' Union.

The officials of the Furriers' Union, hearing of arrangements for the above meeting, sent out a call for an official meeting under the auspices of the International Union. The call for this meeting set forth its purpose as being to discuss the wage question, unemployment, etc., etc., and last but not least "to take action against those who are trying to disrupt and discredit the union." This meeting was called for the same date and time as the T. U. E. L. meeting, in addition, pickets were stationed at each end of the block in which the T. U. E. L. meeting was situated. In spite of these obstructive tactics, the "official" meeting was a fizzle, and the T. U. E. L. meeting the greatest that has yet been held in New York City.

Indignation long and loud was expressed by the T. U. E. L. meeting, against the action of the Furriers' officialdom, in seeking the office of the District Attorney, on a controversy dealing purely with an internal situation in the union.

The rank and file of the Furriers' Union represented so largely at the T. U. E. L. meetings rose up on their feet and stormed their approval of the "Freiheit" and its position on behalf of the rank and file movement in the Furriers' Union.

The meeting applauded enthusiastically the mention of William Z. Foster, Secretary of the T. U. E. L., Amalgamation, Labor Party and Protection of the Foreign Born. These latter being readily recognized as the constructive issues being so constantly propagated by the T. U. E. L. and papers like the "Freiheit" that endorse its program.

Buy Machinery for Russia

NEW YORK.—A tractor donated co-operatively by the workers of two cities, Cleveland and St. Paul, is now on its way to Soviet Russia. Following the example of these two communities—two others, even, more widely separated, have joined forces to raise funds for another tractor, namely, Ansonia, Conn., and Indiana Harbor, Ind.

The Communist Party of Holland has sent a telegram to the French Communist Party, expressing its feelings of deep respect for the heroic fight of the French proletariat against a new war. The trade unions of transport workers and painters in Holland have collected 240 million marks for the benefit of the workers in the Ruhr district.

Another Investigation

BERKELEY, Cal.—Following a protest by a University of California professor's wife on the low salaries of the college faculty, the department of social economics of the university has begun an investigation of salaries and living conditions among the professors and their families.

Militarism Brings Sex Diseases to the Rhine

LONDON.—Commenting on the report that French military authorities are compelling the Germans to supply women as prostitutes to be used by French troops in the Ruhr, E. D. Morel states that the evil is intensified by the fact that some 35,000 African troops are included among the French armies. "I am credibly informed," he adds, "that the proportion of sex diseases among the Rhineland population has increased by something between 200 per cent and 300 per cent since the occupation of the territory on the left bank began." Questions are being asked in the British parliament as to whether such arrangements are made also in British occupied territory in Germany.

Cannon Arouses Great Enthusiasm in Boston Meeting on Russia

The Cannon meeting on "Russia Today" drew a crowd that packed Paine Memorial Hall on Sunday, March 18th. Several hundred people were compelled to go home, because of the limited capacity of the hall.

The enthusiasm of the audience was boundless. Comrade Cannon has covered over a dozen cities of his New England tour and everywhere the report is the same. All the dates have been filled for the New England and Middle Atlantic States up to

May first, and requests are coming in daily for Cannon meetings in Michigan, Illinois, Kansas, Wisconsin and the Middle Western states which he will cover after May 1st. All locals that have not yet applied for a Cannon meeting must do so at once.

Militancy in "The Far East"

Militancy is getting a strong foothold in the central labor bodies along the Atlantic Coast. Passage of amalgamation resolutions by state federations was halted at Ohio last fall. But today the militants are gathering their forces in the "Far East" of the United States, showing special strength in such centers as Boston, New York and Philadelphia, while beginnings are also to be noticed in Providence, R. I., Baltimore, Md., and even Washington, D. C.

It will be interesting for militants west of the Alleghenies to listen from time to time to the crunch of the heavy wheels of progress as they pass over the stone-age labor reaction

struggle. Secretary Kehoe tells about the lobbying at Albany, against anti-labor legislation. He approached the assemblyman in his own district, who told him that his protest was the first and only one received from the workers of his district. The bosses had swamped the legislators with telegrams, letters and literature. Kehoe confessed the union secretaries had thrown the central body's requests to do the same for labor, into the waste basket.

But most denunciation was levelled at New York City's Tammany Hall Hyman administration. This is an enigma to outsiders, since Gompers' forces, repudiating political action for labor, put forth all their "non-partisan" strength for the election of Tammany Hall satellites in city and state. And they have been elected and are in office.

But the Tammany mayor, "Hon. est John" F. Hyman, was off on the warm sands of Palm Beach, in Florida. Sunny southern skies, and comfortable, tantalizing Gulf Stream zephyrs, help him look pleasant for the newspaper photographers and the movie camera men. His favorite Commissioner of Plants and Structures, Grover Whalen, was with him. But back in New York the chaos in city finances had resulted in hundreds, if not thousands, of workers having their pay held up. Not ordinary laborers, but boiler-makers, painters, carpenters, engineers, iron workers and other skilled craftsmen.

These Tammany officials of labor's central body heard that these workers, without pay for weeks and weeks, could not buy food for their children to eat, nor fuel to keep them warm. Kehoe lost his temper and scolded that there were "too many politicians" around. Another case of the pot calling the kettle black, for, I understand, Kehoe is one of the worst politicians of them all.

Mulholland's cure is some sort of a "punch board" idea for raising funds to get a better meeting hall, and to place a perpetual lobbyist on the steps of the City Hall. Mulholland wants to amalgamate the lobbying, even if he opposes other forms of amalgamation.

There was often talk of "strong" resolutions and "stronger" letters, as if words could be endowed with the muscular qualities of a Samson or Sandow, enabling them to get results.

Thus the delegates supported a strenuous resolution of Delegate Lefkowitz, condemning Mayor Hyman for his refusal to appoint a labor member to the board of education. Lefkowitz constitutes about all the intellectual leadership the New York central labor body has. He is to New York what Miss Margaret Haley, of the Chicago Teachers' Federation, has been for years in the Chicago Federation of Labor. But he is a step-at-a-time. He pleads with Mulholland and his outfit rather than defies them. When he asks for workers' representation on the school board he says he does not object to the presence of contractors, real estate sharks, lawyers and others who send their children to private schools. He is willing to have them around stealing \$50,000, 000 building deals, huge book contracts, while robbing the children in other ways. When asking for support of the war on criminal syndicalist laws he is always careful to announce he is opposed to, aye, he has fought the political faith of Communists. It is an attempt at progress by compromise rather than on the basis of the new deal.

The New York Central Trades and Labor Council offers the same possibilities for militants as the central labor bodies of other cities. Militants have too long considered it a useless appendix. But they are coming back stronger than ever, after Gompers' reorganization and what was temporarily a knock-out, established in their locals, and in the Trade Union Educational League groups of their crafts, they are moving up thru the district councils of their trades, and into New York's central labor council. It is admitted that central labor bo-

dies have little potential power. But militants can weld them into effective weapons in labor's struggle, and that is what they are learning to do in all sections of the country.

On behalf of New York's militant unions, consisting mostly of foreign-born workers, it may be said that they have a difficult time of it, so far as the central labor body is concerned. I cite the instance of one baker's union, in control of the militants, entitled to three delegates in the central labor body, but represented by none, since there is not one member of the union able to speak the English language. This is not an exceptional, but rather a dominating obstacle. But that should only call for greater efforts to overcome it. Since the Soviet Republic has taken a stand against mass immigration to that country, it is hoped that many militants will study the English language with the same spirited enthusiasm that they have been trying to learn Russian.

Many militants are also on the outside in the independent unions, the Amalgamated Clothing Workers, very strong in New York City, being entirely without the American Federation of Labor fold.

The New York militants, however, the last to move, on a large scale, in organizing their forces under the standards of the Trade Union Educational League, are beginning to make headway.

They have planted their standards in the New York Central Trades and Labor Council on the issue of war against Burns and Daugherty, and their anti-labor detective agencies, and support of the fight against the criminal syndicalist and other anti-labor laws. Will the Tammany Hall labor officialdom defend Burns in the fight against the militants? Later bigger issues will develop. The bosses will then gladly forget about charging for hammers, wrenches or other tools that drop off the Brooklyn Bridge into the river. They will be too busy maintaining their crumbling defensive against labor's invincible advances. The Trade Union Educational League has come to New York and its spirit is making itself felt in New York Central Trades and Labor Council.

Kuzbas Colonists Deny Starvation Reports

NEW YORK.—The Friends of Soviet Russia is in receipt of a significant resolution from the "Kuzbas" colony, Keremovo, Siberia, in which the American miners there denounce as false the tales of disease and starvation spread about them in America. The resolution reads in part: "Resolved, that we hereby condemn the false statements printed in the American newspapers that we are starving and that there are 20,000 Americans in the hospitals sick with disease, etc. In fact, there are not 500 colonists here and we have plenty of food, altho we have no pie and cake—which is a small concern to the class-conscious revolutionist."

The resolution ends on a high note, with "greetings to the revolutionary workers of America, with hopes for an early establishment of the World Workers Republic."

Gene Debs in Stand Against Hillquit et al

Eugene V. Debs, in a letter to the editor of "The Worker," admits he would have voted to seat the Workers Party delegates to the Cleveland Conference for Progressive Political Action. His statement also covers admission of the Workers Party to the recent conference of the New York American Labor Party.

In this Debs is in absolute disagreement with Morris Hillquit, Victor L. Berger, James O'Neal and the other Socialist Party spokesmen who, at Cleveland and New York, spoke and voted against admission of Workers Party delegates.

Thus Debs takes a stand near to Scott Nearing who recently declared that the Workers Party had fallen heir to the radical situation in the United States. Debs' letter to "The Worker," exhibiting in some parts a bitterness foreign to his customary declarations, is as follows:

MY DEAR LOUIS:—Your favor of the 12th inst. in duplicate has been received. In answer to your inquiry, it may be that the Socialist Party delegates at Cleveland and New York voted as they did in order that the delegates of the Workers Party might not suffer humiliation and imperil their revolutionary reputation by affiliating with "yellow-legged renegades," agents of the petit bourgeoisie, and "traitors to the working class."

As to myself, had I been a delegate of the Socialist Party, I should have voted to admit the delegates of the Workers Party notwithstanding their organs and speakers having screamed themselves hoarse in their denunciation of the party I represented. This would have been my answer to their silly screeds and their vicious calumnies.

The wonderful meetings we are holding out this way and will hold elsewhere including New York, consisting of all the hitherto discordant elements among the workers, give assurance, I think, that the matter you bring to my attention will be adjusted in due course and meanwhile you will excuse me for declining to waste your time as well as my own in needless and fruitless controversy.

No doubt Debs keeps but little in touch with developing events in the labor movement. If he did, we wonder if he would not more nearly agree with us that such "Socialists" in the labor movement as the Schlesinger officialdom in the International Ladies' Garment Workers' Union, buttressed by the Hillquits and Cahans, as they delivered themselves into the camp of Gompers, Woll and Co., of the American Federation of Labor, clearly deserved the title of "yellow-legged renegades."

He must know by this time of the actions of the "Socialist" Kaufman officialdom, in the Furriers' Union, in New York City, in appealing to the district attorney's office for support against the militants in his organization, and against the Jewish Communist daily, "Freiheit." If such are not the "agents of the petit bourgeoisie," in beating back progress, we would like to know what they are.

Debs has been selected by the Socialist party national executive committee to go to Europe this summer. There he will meet J. Ramsay MacDonald, spokesman of the British Labor Party in the House of Commons, who recently donned silk knee breeches and silk stockings, in order that he might wear correct attire in winning and dining with his Royal Majesty, King George V. Even the stomachs of veteran parliamentarians in the British Labor Party were turned at the sight, and have made their protest. Debs has often bitterly denounced Gompers and others of his ilk for banqueting with the big industrial kaisers under the auspices of the National Civic Federation. We would like Debs to answer whether he thinks a "Socialist" in a similar role is less a "traitor to the working class."

Of course, Debs may think that pointing these things out, as they develop from day to day, may be "silly screeds" and "vicious calumnies." The raw truth often hurts. Controversy may be distasteful, but it is sometimes the only way of discovering the truth.

Four Points of Disagreement
We may point out that Debs finds himself in disagreement with the

A Call for the United Front of All Labor on May Day, 1923

May First is Labor's International Holiday. Once more millions of workers will hold great demonstrations and mass meetings to show the strength and solidarity of the working class in the struggle against capitalist exploitation and oppression.

The workers in this country are faced with the most powerful and reactionary capitalist class in the world. The capitalist class thru its government has carried on a campaign of brutal oppression of the workers. The army is used for breaking strikes. In many states armies of hired detectives and bands of armed thugs terrorize workmen and prevent them from organizing. Posses of armed "citizens" institute lynch law, and take over functions of the local government. Spies and stool pigeons infest the unions. Bomb plots, as investigation has shown, are manufactured by detectives in order to frame up radicals. In this land of democracy the workers are familiar with the iron fist of government by injunction. The employing class is fighting the eight hour day. It seeks to establish the open shop. It wants to reduce wages while putting up the cost of living. New laws are being framed for the oppression of the foreign-born workers. Race hatred and race persecution are rampant in this country, where lynching of Negroes is a common occurrence.

But the workers have shown signs of revolt against the white terror existing in this country. Tremendous strikes, lasting for months, have shown that a new spirit permeates the workers. Partial victories have been won. But this is not enough. The victories must be followed up, or they will prove useless. The ranks of the workers are still split. One craft union scabs on another, as in the railroad strike, when Railway Shopmen were fighting alone while nine other railway unions served the bosses. To make such a condition impossible the workers must raise the slogan of **AMALGAMATION OF THE CRAFT UNIONS INTO INDUSTRIAL UNIONS**, as the most effective means of countering the Open Shop Drive.

The capitalists are not divided. They are lining up behind such organizations as the Ku-Klux-Klan and the American Legion. These reactionary organizations aim to follow the example of the Fascists of Italy, to set up the bosses' dictatorship in all its hideousness. If they succeed a greater capitalist tyranny than now exists will hold the workers enslaved to the ruthless capitalist class.

The workers must stir into action before it is too late. New wars are being hatched by the imperialist brood. Workers' blood is still flowing and will continue to flow so long as the workers permit themselves to be used for cannon-fodder in the plots of the master class. The First of May must be an occasion for the workers to consolidate past victories and to prepare for new struggles.

The workers must serve notice on their masters that they are ready to fight them on every field. They must do this by entering the political struggle against the government which is an instrument in the hands of the employing class.

A LABOR PARTY—A PARTY OF INDUSTRIAL WORKERS AND WORKING FARMERS, must be the answer of the workers to the force of the Republican and Democratic parties.

THREE—We do not doubt that Debs is opposed to such trading with the old political parties as the Wisconsin Socialists indulged in when they refused, last November, to run a candidate against La Follette, thus assuring the election of Bergen to Congress from Milwaukee. Debs is no doubt opposed to this expression within and drift of the Socialist Party toward the Johnson-Chamoff brand of nonpartisan politics championed by them at Cleveland, an underhand sabotage of the growing sentiment for an all-inclusive Labor Party.

There remains, of course, the big issue of international affiliation. The Socialist Party is today ostensibly affiliated with the Two and One-Half (Vienna) International. Hillquit, Berger and O'Neal will no doubt follow the Vienna International, at the forthcoming Hamburg Conference, into the camp of the Second (Socialist) International, of Scheidemann, Henderson, Vandervelde, Branting and the other war-traitors and collaborators in capitalist governments.

Debs has been chosen as a delegate of the Socialist Party to the Hamburg Conference. The question arises, "Will Debs allow himself to be used to lead what remains of the Socialist Party membership back into the Second International, that has declared for a truce with capitalism and is participating in capitalist governments in various countries?"

Verblin Is Cleared by Party Committee Report

Report of The Workers Party Investigation Committee on the Verblin Case to The Central Executive Committee, Workers Party.

Comrades—The following is the Committee's report on the Verblin Case. A detailed report for purposes of record on all phases investigated is being drawn up and will be presented at the next meeting of your Committee.

The Committee has examined into all evidence available. It has reviewed the findings of the National Defense Committee which originally investigated the alleged spy charge against Verblin and which cleared him of this charge; it interviewed the General Executive Board of the Amalgamated Clothing Workers as well as members of the Trial Committee of the Amalgamated which convicted him of the charge; it has read and investigated the confession of Bailin and the circumstances surrounding the confession upon which the alleged spy charge against Verblin was made; it has interviewed or received the statements of many persons who were either directly or indirectly involved in the case; and nowhere has any evidence been presented which could be recorded as justifying the maintenance of the spy charge.

The Committee's Recommendations—The investigations of the WORKERS PARTY INVESTIGATION COMMITTEE have been carefully made and we now recommend to the Executive Committee to dismiss, and publicly CLEAR Verblin of this charge.

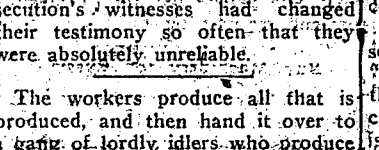

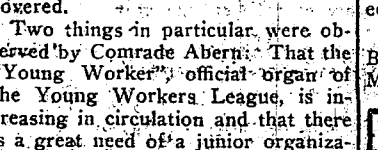

Now that J. Ramsay MacDonald has become a banqueter at the royal tables in England, perhaps there may be a chance for his friends Morris Hillquit and Victor L. Berger to shine in London society when they go abroad this summer.

Borah and Recognition of Russia

There are several motifs driving for recognition of Soviet Russia by the United States. Militant labor demands it, knowing it will be an aid to the Russian and the world revolution. Unthinking workers feel that it will provide more jobs, as it will, thru the development of trade, so they are for it. Farmers, similarly, see an outlet for the surplus from their fields. Industrial overlords behold new opportunities to profiteer. And all the time the old party politician assures himself of an opportunity to make political capital for himself.

We give U. S. Senator William E. Borah credit for being sincere in his desires for the opening of trade relations with and the recognition of the Russian Soviet Republic. Yet his speech at Madison Square Garden, Sunday night, left much to be desired. Since 16 different nations, among them Japan, have already cleared the way, it seems that a member of the foreign relations committee of the United States Senate, as Mr. Borah is, could make a much stronger fight for a thing in which he deeply believes.

Mr. Borah's address was more an apology to, rather than a defiance of the great capitalist forces in the this country that have not only successfully opposed recognition of Russia's government, but have exerted their utmost strength in an effort to overthrow the First Workers' Republic.

It can not be that Senator Borah is merely using the recognition issue as a political football to keep himself in the limelight. Those who have suspicions in that direction will watch closely his promised trip to Soviet Russia. They will eagerly scan any statement of position upon his return. They will be watching to see whether Senator Borah will support his belief in recognition with the kind of a fight that will bring it about.

The Hon. Meyer London, late lone Socialist in Congress, has broken into the pages of "The American Federationist," edited by Samuel Gompers, president of the American Federation of Labor, with an article on the supreme court. The Socialist Party has arrived—in Gompers' camp.

These Borers from Within

It is not beyond our modesty to accept of the recognition that comes thru republication of our editorial efforts. In fact we are rather enthused by the acceptance and the spreading of our ideas. So we cannot object if the New York Call saw fit, in its Sunday issue, March 18, to place in its guarded columns the brief article, "The Cossacks in West Virginia," that appeared on this page of "THE WORKER," dated March 3.

No doubt Brother Editor Oneal will go on a rampage. He will charge it is the underhanded work of the Communist International. Somewhere he will drag in the Burns Detective Agency. But the explanation is very easy.

When we wrote the editorial, "The Cossacks in West Virginia," we had no hope, or even desire of boring from within the columns of "The Call." But the editorial was extensively copied by Tom Mooney's Monthly, out on the Pacific Coast, that gave it the usual credit; by "Solidarity," official organ of the Industrial Workers of the World, that did not give credit to "The Worker." So "The Call" clipped it from "Solidarity" and gave the Wobblies the credit in its own columns that should have gone to "The Worker."

So it goes. Yet it might be well to comment on the fact that "The Call" regularly publishes extracts from "labor" papers stating their different views. It religiously omits any views from Communist publications. That we should have broken down this wall, inadvertently, will no doubt be considered a tragedy in "The Call" office.

Similarly the monthly magazine, "Labor Age." For a time it quoted from Communist publications. But even this slight concession to labor militancy suffered a fade out. In this we are much encouraged. The militants will thus learn to support and build up their own press—The Labor Herald, the Liberator, the Soviet-Russia Pictorial, the Voice of Labor, "THE WORKER" and their other publications. At least insofar as the anti-Communist press is concerned, there is no necessity for a boring from within policy. The Communist press can take care of itself.

Communist strength in Poland has forced the release of the Communist Deputy Krolkowski from prison. Krolkowski was sent to prison for three years after having been elected to parliament by the workers of Warsaw. The Communist amnesty campaign in Finland is also making headway. The oppressors of labor in the Baltic states must realize their grip is slipping.

A thousand women workers at Milan, Italy, have engaged in the first strike since the Fascist Dictatorship came into power. The spell of fear that has held the Italian working class paralyzed before this military monster is beginning to break.

Harding Seeks Re-election

In the favorable atmosphere of Florida's sun-warmed beaches the Harding ambitions for re-election have been nursed to life. The birth of second-term aspirations for the present incumbent of the White House have been announced by capitalism's most expert political quack, The Honorable, the United States Attorney General Harry M. Daugherty, himself.

Mr. Daugherty, infamous for his railroad strike injunction, notorious as the jailer of the class-war prisoners still remaining in America's bastilles, says, "The president will be renominated and re-elected because the country will demand him," which is the usual bluntness of every announcer of political candidates.

Daugherty's announcement will put life into democratic hopes. Wall Street isn't worrying. Governor "Al" Smith of New York is just as safe as Senator Underwood, or any other performer the democrats may trot into the political ring. Wall Street will encourage a shift back to the democratic party. It will make deluded workers and farmers again feel that they are getting somewhere, it will allay some of their discontent.

The militants in the labor movement must, therefore, put up the fight of their lives for independent working class political action. Real push must be put behind the drive for a labor party. Instead of allowing the workers and farmers to drift from the Republican party back into the democratic party, they must be won for class-political action. The referendum of the Trade Union Educational League offers the opportunity to carry on this work now. This is an opportunity that must not be neglected; that must be taken advantage of to the very utmost.

Albert Thomas, renegade Socialist, has telegraphed "Dictator" Mussolini, of Italy, thanking him for support given the Labor Proposals of the League of Nations. Pretty soon some of these Socialists will be kissing the feet of the capitalists for permitting labor even to grovel in the dust before the bosses.

MacDonald Dines with the King

British labor is lashing itself into a fury. It is using hard words and speaking them loudly, since the hero of the Second (Socialist) International, J. Ramsay MacDonald, went to Buckingham Palace and dined with the pet of British imperialism, King George V, and his queen.

MacDonald is supposed to be the spokesman of "His Majesty's Opposition" in the House of Commons. But in the words of David Kirkwood, Scotch-Labor Party member of Parliament, "the King is the pinnacle of a system which some of us are here to smash—the capitalist system—and it isn't possible for us to fight those whom he represents and at the same time wine and dine with them."

Evidently Mr. MacDonald has come to that point where he feels, like Branting, of Sweden, and Vandervelde, of Belgium, that the necks of the workers merely form a stepping block to a premiership. The King's invitation forced MacDonald to decide, as between labor and its bosses, and he decided to betray the workers.

It is said that the King had his tables decorated with daffodils and minnows. It is to be hoped that British labor will bury MacDonald's political career deep beneath the daisies with its toes turned toward the skies.

MacDonald is one of the bitterest foes of the Communist International. He hates it because it unmasked the treason he would commit long before he ever had an opportunity to commit it. MacDonald's visit to the King should have but one result—a tremendous increase in Communist strength in the British Labor Party, resulting in the dethroning of all traitors to labor.

Having failed to secure United States Negroes as strikebreakers for its imperialist ventures in the German coal mines of the Ruhr, the Paris diplomats are turning to the subjects of its vassal state, Poland, where we hope and expect they will meet with equal failure.

Freedom in Michigan

Assistant Attorney General G. L. Smith, of the State of Michigan, is suffering great agony because the Civil Liberties Union sent out 15,000 circulars in Berrien County discussing the issues at stake in the trial of William Z. Foster at St. Joseph. He charged that this interfered with the selection of a jury.

At no time have we ever seen a more complete unmasking of the hypocrisy of kept "justice" and capitalist "law and order."

This Michigan law officer expressed no horror when every prostituted sheet of the social system for which he stands poured forth an inky flood of vast proportions maligning those arrested at Bridgeman, and vilifying their cause. There has been no abatement in this attack. The Detroit "Saturday Night," an open-shop mouthpiece, with Foster on trial, continues its rabid bellowings calling for Foster's conviction. In this it is ably supported by the familiar propaganda of the Burns Detective Agency.

The Civil Liberties Union challenges Mr. Smith to point out a single misstatement in the circular it distributed in Michigan. It is asserted that, "the right of an organization interested in the principles at stake to circulate its views anywhere is just as lawful and proper as for a local newspaper to discuss those principles editorially."

The Michigan prosecutors must have little faith in the justness of their case. They have on their side the subsidized press, the courts and legal procedure fixed by precedent and things as they are, jurors mentally incapable of visualizing a new social order, and yet they are not contented. They want even that little ray of truth, that might come thru the distribution of a small leaflet, shut out from the people of Michigan. Surely the capitalists and their apologists fear greatly for the decaying social system disintegrating beneath their very feet.

BK-13 Bares Secrets of U. S. Reds in Exclusive Interview for the BOLCOMS

NEW YORK, March 31.—All the secrets of the Communist Party of America were revealed to-day by BK-13, Department of Justice agent, in an exclusive interview for the BOLCOMS.

A Fundamental Error

By H. M. WICKS

The current issue of the Labor Herald, official organ of the Trade Union Educational League discusses labor banks and concludes that the affiliation of Warren S. Stone with the Empire Trust Co. is a bad move.

"No good can possibly come from such an alliance, which, in a crisis, will be inevitably turned against Labor. Such class collaboration must be fatal to the workers' interest."

There is a fundamental error involved in the conclusion of the Labor Herald and that is the implication that labor banks under the control of progressives would not be class collaboration, equally as much as the other remained in the hands of reactionaries. Good or bad labor leaders, progressives or reactionaries or revolutionists, all when they enter the realm of labor banking must, of necessity, collaborate with the capitalist class. It is not at all a question of the honesty of the leaders of labor engaged in the business of banking, but it is a fundamental law of capitalism that no one can engage in the banking business successfully without becoming enmeshed in the financial network that has its roots in Wall Street.

I have shown in a whole series of articles, still running in "The Worker," the economic absurdity of labor banks under any considerations, and from a Marxian analysis of labor banks we must draw the inevitable conclusion that never, at any time, in any hands, so long as capitalism endures can labor banks function in the interest of the working class and that all such ventures "must be fatal to the workers' interests."

Human ingenuity can never devise a scheme whereby labor can profit by endeavoring to beat the bankers at their own game, which rests upon the exploitation of labor. Banks are not instruments of emancipation nor can they be used as instruments to forward the interests of labor before labor holds political power in its hands and can confiscate the banks for its own use.

The Labor Herald is such an excellent working class organ and it so seldom falls into even the slightest error that we feel that such errors as it does commit are more serious than those appearing in other papers, simply because of the prestige it enjoys in the entire international movement.

Russia's Agricultural Exhibition

The front page in American newspapers has been given over to the invaders of the Ruhr and to the grave-diggers at Luxor who have uncovered Tutankh-Amen's tomb. Hundreds of Americans are discussing the exalted subject of Tut's well-preserved towels, couches and other household articles. While the American doughboys hastened home from the war-torn Fuhr, a veritable army of other Americans of leisure and means made pilgrimage to Egypt to admire the dead king's jewels.

Granted that there is some merit in dead kings, we believe, however, that there are some more interesting things in the Old World at the present time than egyptology.

Soviet Russia is forging ahead slowly but irresistibly with her peaceful reconstruction. Despite the attempts at war and rumors of more wars in the West and in the Near East, Russia is settling down for hard productive work.

Her achievements and her shortcomings in agriculture and allied industries will be vividly presented at the coming All-Russian Agricultural and Home Industry Exhibition to be held during August and September of this year, beginning August 15th, in Moscow.

This great exhibition will be held near the famous "Sparrow Hills" where, over a hundred years ago, Napoleon stood vainly waiting for the keys to Moscow. Moscow survived Napoleon and she survived the other invaders.

The All-Russian Central Executive Committee has appropriated 5,000,000 gold rubles to defray the expenses of the exhibition.

The Surrender in Michigan

Voluntary surrender of 10 additional defendants in the Michigan Criminal Syndicalism case has proven a bombshell to the hopes of the prosecution. Thirty-two men and women have now been arraigned for trial, 22 having previously appeared.

Bond for these ten has been set at \$1,000.00 each. They announced on their appearance that it was only the excessive bail demanded that has kept them from surrendering long ago and that they expected that all or most of those named in the information will now appear.

Their appearance has effectively scotched the statements of the prosecution that most of those named in the information had slipped out of the country. As a matter of fact the prosecution has no appetite for further victims of the raid and the taxpayers of the county are up in arms over the tremendous additional expense which they will have to bear.

The surrender was staged very dramatically, the ten filing into the court room just as court was being opened to hear the argument on preliminary motions. The situation was not without humor for in the court room at the time were Jacob Spolanski and Max Berger, two of the prize sleuths of the Department of Justice which has advertised the fact that the country is being combed for the remaining defendants who were supposed to be in hiding and prepared to resist arrest with force.

Clara Zetkin Presides at Two-Day Conference of Women Internationalists Held in Moscow

During the Fourth Congress of the Communist International, Clara Zetkin, the Grand Old Woman of the World Revolution, set apart two days to confer with the women delegates and visitors from many countries.

The first day was devoted largely to the discussion of the methods of organization that should be used to interest and educate women in the principles of Communism. There were women from Persia, Turkey, Egypt, Ireland, France, Germany, Poland, Finland, Sweden, America, Siberia, Bulgaria, Hungary and other lands.

Herta Sturm, the right hand woman of Comrade Zetkin, managed the discussion. Co-operative Society workers emphasized the opportunity of reaching middle class women and workers thru their organization. Relief workers told of their work in interesting and educating the Youth thru the Famine Relief Work. Legislative work was discussed by the

women from countries where Labor Parties have elected representatives.

One of the most powerful women, Marthe Bigot, came from France. She looked motherly with her good statesman-like manner, easily dominating a larger outside world, as a sympathetic mother dominates her household.

She was much interested in educational work among women in Trade Unions. The second day's conference was devoted entirely to that subject.

Minnie Burch, a forceful young woman delegate from England, told of the work of the communist men and women for the union women of Great Britain. A man from Poland seemed to think it rather reactionary and bourgeois for radical organizations to even talk about special committees for work among women. This brought out a fiery, convincing oration from Comrade Clara Zetkin. She pointed out that these special committees, were not "WOMAN'S" committees, that in Germany and

France, men served always with the women in planning this special work.

She showed how successful they had been in Germany in enlisting thousands of women members for the political movement by the intelligent co-operation with them in the union movement. It seemed to her a manifestation of ignorance for any communist not to see the peculiar need of attracting the women away from the lure of the many women's organizations, constantly and consciously agitating and educating the working woman against the cause of working class solidarity.

Herta Sturm, told us of the terrible poverty of the women workers of Germany, and the work of Communist women on Shop Control Committees and in the unemployment organizations.

The young bride of Roderick Connolly (the son of James Connolly) from Ireland, told of the great courage of the revolutionary women of Ireland, and a young girl delegate to the League of Youth from the

Transport Workers of Ireland, told us of the spirit of co-operation between the men and the women comrades, and of the mass of Young Irish women intelligently and class-consciously pouring into the great struggle from the ranks of the Trade Union members.

Comrade Bloor spoke of the work of the women of America in the recent great railroad strikes, and told some incidents from the miners' strikes. She spoke also of the women of the west who erected commissary depot tents along the railroad lines, and there feeding the pickets all night long for many miles around the tents. The women were much interested in the work of Railroad and Machinery unions, women's auxiliaries in going from house to house during the strikes and keeping up the morale of the men strikers, and the courage of their wives.

Herta Sturm, Rosenthaler Str. 38, Berlin C. 54, Germany, and Marthe Bigot, 14 Rue Rotterdam, Paris, France, would appreciate very much

any letters from American union women as to their methods of work and their educational literature. Any brief articles would be gladly received by them for their woman's magazine.

The Bulgarian and Far Eastern women are very active and put their western women to shame by their stories of persistent organized efforts in spite of all their persecutions and the traditions of the slavery of the women of those countries. In India, followers of Ghandi have together with women from more revolutionary organizations instituted a feminist movement, the description of which sounds much like the stories told by our militant suffragists. Mary Winsor, Alice Paul, Lucy Brannham and others like them, these Indian women have the same high courage with just about the same kind of persecutions meted out to American pioneers, brutal police beatings, insults and vile jabs.

While the Russian Organizer of special work for the women of Rus-

sia was talking, Krupskaya (Lenin's wife) who sat next to me, became very much interested and she occasionally made illuminating remarks. She is especially awake on the side of educating the women, all women, in the broadest way possible. She is the directing force of the Executive Committee of the Educational Department of all Russia, and while she was sitting in the conference, which was held in one of the side rooms of the Great Palace, men were continually coming in to consult her, or calling her out. She remembered me as the American delegate to the Woman's Congress of 1921, and greeted me very cordially. She was much pleased with the "Labor Herald" which I gave her. I must not forget to mention the Italian woman delegate, wife of Bordiga, one of the leaders of the Italian Communist Party. She and her husband occupied the room next to us in the Hotel Lux, and although we couldn't talk each others language there was complete understanding

between us. She was motherly, devoted to her husband, but above all devoted to the CAUSE. Her room was the Mecca of dozens of Young Italian Comrades and we could easily understand her great influence on the workers of Italy.

It is especially gratifying to record and to remember these groups of women, for in the building of the new world INDIVIDUAL CHARACTER will be the foundation stone. Henri Barbusse in the preface to Goldring's play "The Fight for Freedom" says: "Humanity has not yet attained to the heights of its ideas. This is the source of all evil. If all who today dream of liberation and harmony were intimately, practically in accord with their dream, the people, the vast mass of slaves would be quickly set free."

It seems to me that these women of our international movement are in accord with our dream, their lives are part of the dream which will become a reality because of their devotion, efficiency, and loyalty.
